# INSTRUCTIONS

Your letter of 4 March 1981 addressed to my colleague, the Hon D J Killen, MP, has been referred to me for comment on your question *regarding* dealing with the examination of a photograph taken by Mr Norman Benstead of Albury.

*On 20 November 1978* The Melbourne Herald and TV Channel 7 each *presented* carried a story on 20 November 1978 concerning a photograph of an alleged unidentified flying object (UFO) taken by Mr Benstead at Lake Hume in October 1972.

It was *then* reported that CSIRO had pronounced the photograph to be a double exposure and that the negative should be destroyed.

*Although* CSIRO does no research on UFOs, *I have had* however, the matter was investigated and *can confirm* while it is true that a CSIRO scientist did examine the negative, *it was however, he did this* in a private capacity and not on behalf of the Organization.

During the *then* course of the examination it was found that if, *after several exposures,* a film cassette was removed from an Instamatic-type camera, the film rewound itself to the extent of one frame, *with the result* that, *if done* under blackout conditions, *when* the cassette was *then* replaced, *this had the result* that the last frame of the film to be exposed was positioned to receive a second image.

The *then* scientist *concerned* followed this procedure, *the scientist concerned* and was able to produce a picture similar to Mr Benstead's. He forwarded this manufactured picture to the Unidentified Flying Objects Investigation Centre (UFOIC) Sydney - which had approached him in the first place - together with his report on the original photograph. He no longer has a copy of his report and he does not recall advising the destruction of a negative, *but however, he* believes that if he had given such advice, it would have related to *the his own* photograph, *he manufactured himself.*

It is of interest that the RAAF has checked *its own* records of UFO reports in September, October and November 1972, in the Albury area, and has found that no reports *were made. of any sightings during this period.*

The amount of information you seek will involve a lengthy period of research. Accordingly a reply may take some time.

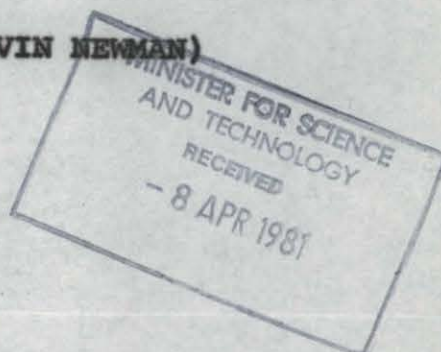

Dear Mr Killen,

Thank you for your letter of 24th June 1980;

1. Concerning Unidentified Submerged Objects and your advice that 'all reports' are investigated and none have been proved as unidentifiable. Can you please assure me they were therefore identified as conventional submarines or ships of Australian or other recognised earth bound countries.

Why was Professor James McDonald sent to Australia by the United States Navy in 1966 to investigate unidentified submerged objects. Are the results of his investigations readily available to the public, or are they classified documents. If classified, why?

In April 1970 at Rabaraba, Cheura and off Cape Vogel, Papua New Guinea (not yet independent) an unidentified submerged object was reported by Mr Albert Robins; also in 1968 Mr Otto Alder, then aide-de-camp, reported an unidentified submerged object off Rabarada, PNG. What were these sightings determined to be, please.

2. Regarding the Queensland University investigation of 1968 of a crashed Unidentified Flying Object; retired Queensland University Professor Brixius, conducted tests in 1975 of the material salvaged by Mrs Fraser, overseer of a property in McTaggart Road, Greenbank (owned by Tas Co Associated Forrest Holdings). The fragments of material (metal) found late during 1968 although the crash allegedly occurred in November 1966. Officers from the Amberley Air Force Base investigated, took samples for test (also maintain a file) and sent samples to Melbourne for transit to the Pentagon for further tests.
  - i. Please arrange release of Amberley and Defence Headquarters' files on the tests.
  - ii. Why were the fragments sent to the United States?
3. Why are Unidentified Flying Objects/Unidentified Submerged Object reports sent to the United States.
4. Are you able to investigate whether there are files on alleged U.F.O. crashes, explosions at Nowra 1976, Indooroopilly Dec 1970, and Church Point Sydney 26.4.1969.

5. In October 1972 Norman Benstead, Albury, took photo of U.F.O. over Lake Hume Dam (published in national newspapers). The CSIRO examined the photos (sent by William Moser of UFOIC Sydney) and made a two page report. The CSIRO reportedly suggested to Benstead that he destroy the negatives. If the RAAF is in charge of UFO investigations why would the CSIRO not forward photos onto such body. Will you seek Government Policy to ensure all agencies are requested to redirect UFO reports, photos, etc, to the RAAF. Can you advise details of the CSIRO report in this case.
6. Will you please advise details of the RAAF report, and the one the RAAF received from the United States Airforce, after the examination of a 16mm colour film by a Civil Aviation official in P.N.G.(Port Moresby) of August 1953. The then Minister for Air, W. McMahon, admitted that the RAAF sent the film to the United States Airforce for evaluation. Was the film returned from the United States, if not, why not.
7. Regarding the UFO landing of 6.4.1966 near Westall High School, Clayton, Victoria: Why did the RAAF burn the grass in the area to destroy the 'landing nest'.
8. Regarding the airplane with nine passengers aboard that vanished on 22.10.78 (12 hours after Valentich) over the Solomon Islands. An intensive search by the RAAF allegedly failed to find trace of the place or bodies. Can you advise relevant details of the investigations.
9. Re Valentich Case:
  - a. Referring to item 8 of my letter of 20.3.80; as you are aware, the photos I refer to were taken by Roy Manifold at approx 6.45pm at Cape Otway, shortly before Valentich was 'abducted'. Computer enhancement in USA revealed a solid object rising from beneath the surface of the water (U.S.O.) and when airborne it was surrounded by a cloud-like vapour exhaust residue. Why did officers from Laverton base examine the photos and not the negatives, and determine then as 'decaying cumulus cloud'.
  - Will you advise details of their report on this matter.
  - b. Is it not true that Control contacted Valentich first to look for the U.F.O.
  - c. Is it not true that the RAAF Orion was searching Saturday night for Valentich and not from Sunday morning as reported.
  - d. Was Orion actually already on standby in South Australia to search for Valentich at the time of his disappearance.
  - e. Why was the sophisticated Orion (equipped with airborne radar, LOW LEVEL RADAR) used when Fokker Friendships and F28's which have been regarded as adequate in the past for searches, readily available at Moorabbin at the time.

- f. The released transcript supposedly starts at 7.06 pm and has Valentich orbiting at 7.09pm, three minutes later, wouldn't it have taken him two minutes to do a 360 degree turn. Surely, he was therefore talking about the UFO for a longer period then.
- g. The microphone button on the particular Cessna had to be pressed manually to operate meaning Valentich would have been pressing button to stay in contact with flight service unit all the time right through the metallic sound and until he 'hit the water'. However, isn't it true that aircraft equipped with VHF radio cannot communicate below certain altitudes, ie, King Island, minimum communication height would be 900m. Therefore, surely the end of the communication ie. metallic sound was not at zero metres (hitting water) at all. What therefore is the reason for presuming he hit the water.
- h.
  - i. Is it true that classified U.F.O. material is at the Sale RAAF Base.
  - ii. Is it true Valentich had seen the classified material at the Sale Base.
  - iii. Who sent Valentich on the particular flight, and what was the reason for the flight.
- 10. What is Australia's involvement in Project Magnet and Operation Noah's Ark.
- 11. Re Pine Gap:
  - a. What was the function defined by the U.S.A. in seeking to establish the base. Was it a joint Australian-U.S.A. Defence space research facility.
  - b. If a space research facility only, why is it so top secret that access to Australian parliamentarians is denied.
  - c. Is there an underground city at Pine Gap.
  - d. Are UFO/USO experiments (antigravity-electrogravitic propulsion) conducted there or from there, and is Australia actively involved in such experiments.
- 12. On or about 7-8 July 1947, did the Australian Government request news media in Australia to suppress information regarding an alleged capture/crash of a UFO at Roswell, or elsewhere, in the United States. Did the Australian Government issue a D notice at the time.
- 13. Two USO sightings were 'explained' by the RAAF as tornado-like meteorological manifestations, i.e., February 1963 near Moe Victoria; and July 1965 on a beach near Vaucluse, NSW, (traces that an object had landed there).

Were these new 'unique' tornado manifestations referred to the meteorological scientists for research as surely they deserve world-wide attention and investigation.

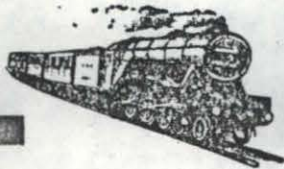

It has been said recently on T.V. that the C.S.I.R.O. has been given the task of collecting the information of U.F.O.s and other inexplicable things. This can be added to the files, for what it is worth.

Approximately 7 years ago, in our home back-yard in East Albury, in grass about 6" tall of the onion weed variety mixed up with paspalum seen one morning two circular beaten down areas, about a metre in diameter, the appearance of which could best be imagined as if a giant mushroom had been turned over and rotated and pressed down.....so that the grass was flattened in the centre and at the edges had a lean in one direction, but at this stage whether it was clock-wise or anti-clockwise I can't recollect.

At the time it was looked at with curiosity and both my wife and I thought, whatever the explanation was, it would come to light sometime.

On the "This Day Tonight" programme on the National Television network, sometime back, somebody in one session was going to dash up into central south Australia to look at a thing which might have been similar but with a vastly bigger diameter. Whether he ever got there and reported, we never found out.

There've been articles recently in "Border Morning Mail" about people seeing things in the skies in the highlands to our south-east, without anything tangible coming to light. One night a goodwhile back the northern wall of our house shook like in an earth tremor, and looking out the window the northern sky was alight like it can be with a bolt of lightning, but all over and not off quickly like lightning. No earth tremor was reported in the area. Could the sky be reflected off an aurora over the horizon? Maybe.

This isn't a search for personal information....but just to be added to what you already have and may collect..... for someday like in direction finding beacons, two lines will cross, and we'll all know where we are.

The Melbourne Herald and TV Channel 7 each carried a story on 20 November 1978 concerning a photograph of an alleged unidentified flying object (UFO) taken by Mr Norman Benstead at Lake Hume in October 1972.

It was reported that CSIRO had pronounced the photograph to be a double exposure and that the negative should be destroyed.

CSIRO does no research on UFOs; however, the report has been investigated and while it is true that a CSIRO scientist did examine the negative it was in a private capacity and not on behalf of the Organization.

During the course of the examination it was found that if, after several exposures, a film cassette was removed from an Instamatic-type camera, the film rewound itself to the extent of one frame, with the result that, if done under blackout conditions, when the cassette was replaced the last frame of the film to be exposed was positioned to receive a second image.

The scientist concerned followed this procedure and was able to produce a picture similar to Mr Benstead's. He forwarded this manufactured picture to the Unidentified Flying Objects Investigation Centre (UFOIC) Sydney - who had approached him in the first place - together with his report on the original photograph; he no longer has a copy of his report and he does not recall advising the destruction of a negative; but he believes that if he had given such advice, it would have related to the photograph he manufactured himself.

It is of interest that the RAAF has checked its records of UFO reports in September, October and November 1972, in the Albury area, and has found that no reports were made.

Mr Benstead took the photograph with a cheap plastic camera he had given one of his children at Christmas.

He said it was only the second time he had used a camera and he had no idea then of how to double expose a negative.

Mr Benstead said he did not see anything above the weir wall when he took his family out to watch flood water flowing through the gates.

"The first I knew of it was when the man who processed the film, John Gaudry, asked to see me when I came into collect the photos.

"He asked me if I had seen anything unusual the day I photographed the weir wall.

"At first I thought I must have photographed a body in the water, or something as serious as that, but when he showed me the photo I was amazed," Mr Benstead said.

Mr Gaudry, of Kokoda St., North Albury said today that the photographs had not been published before because he had sent the negative to the Unidentified Flying Objects Investigation Centre in Sydney and Mr Benstead had not sought publicity.

Mr Gaudry said the president of the UFOIC, Mr William Moser, had sent the negative to the CSIRO for examination.

"The CSIRO sent a two-page report to Mr Moser and he sent it to Mr Benstead and myself.

The CSIRO spent weeks examining the negative and double-exposed a film using the top of a lamp shade superimposed above a photograph of an office block to try to recreate the effect of the saucer-shaped object in Mr Benstead's photograph.

At the end of its two-page report, the CSIRO told Mr Benstead his negative should be destroyed.

Mr Benstead said: "When I got the report back saying that it was a lamp shade, I couldn't be bothered following it through with publicity, though I'm blown if I know how I double-exposed the negative."

The possibility of photographing a UFO at the time was not such a long shot, Mr Gaudry said today.

He said two men once reported seeing "a giant UFO" hovering above Lake Hume two days before Mr Benstead took the photograph.

The men, Clive Boyd, of Ryan Rd., and Jack Gibbs, of Andrews St., had left Albury early one morning to drive 100 km to Mitta Mitta, Mr Gaudry said.

The men had a gravel contract with the CRB at Mitta Mitta.

Mr Gaudry said the men had left Albury at 3 a.m. and as they passed the airport heading to the weir, they had noticed a bright light in the sky ahead.

The men had said that as they crossed the weir wall, the object became huge and was clearly visible.

Mr Boyd had described it as being "as big as a football field."

Mr Rod Hardinge, who examined Mr Benstead's negative, said it did not appear to be double-exposed and, if it was a fake photograph, it was a perfect fake.

Mr Hardinge said: "All the angles are correct and it is incredible how the weir wall outline and the spray from the water is so clear and yet the object is faded at the edges, similar to the distant headland, giving the effect that the object is some distance behind the wall.

I must acknowledge your letter of March 21st., enclosing a copy of Mrs. I. L. Gibb's letter from Kyogle and the fungal specimen in which she is interested (with respect to the reported "Flying Saucer" landing).

First, I have identified this toadstool as Lepiota gracilentia (Slender Parasol Mushroom) which occurs widely in moist grassy places almost throughout temperate Australia. The flattened "gills" underneath certainly look scorched, but that could easily have been caused by some animal trampling the fungus and then leaving its cap upside down to bake out in the sun. Toadstools of this kind are known sometimes to form "fairy rings" - perennial circles of fruiting bodies on lawns and open grasslands that widen slightly, year by year, as food reserves in the soil are exhausted inside the growing circle. Usually there is a distinct ring of dry dead grass immediately behind the circle of fungi, and this might well serve to explain Mrs. Gibb's "definite circle of scorched grass". It is my belief that she was witnessing a very ancient and intriguing phenomenon among certain grass-inhabiting toadstools.

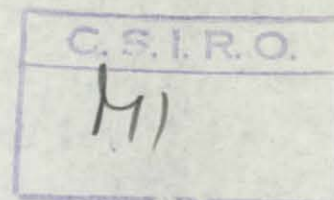

I have now had the opportunity of discussing the reports with the CSIRO groups most likely to be able to assist. Both have indicated that it is difficult to comment on the reports in your letter because there is so little factual evidence to go on.

As one officer commented, almost any explanation would fit the descriptive evidence. One important point is that there is no indication of the time of day of the sightings. This information is particularly vital if we are to be able to assist you with this type of report.

You may be interested to know that around about the date given, a New South Wales Police Officer reported to the CSIRO Upper Atmosphere Section that a spherical metal object had been found on an outback property in New South Wales. He was advised to refer the matter to the Weapon Research Establishment, Salisbury, South Australia, as the object could well have been a piece of space research hardware.

You may like to contact W.R.E. to see if they have any information about this report. I am sorry I cannot be more helpful.

2. We suggest that you might make the following  
points in reply to Mr Hennessey:-

- a) We have no reason to believe that the investigations carried out by the University of Colorado under the distinguished leadership of Dr Condon were other than scientific and objective;
- b) the history of this subject reveals that the more time and effort that is spent by experienced scientists in investigation the smaller becomes the residue of unexplained phenomena. Moreover in these latter cases there is usually insufficient factual evidence to make investigation likely to be conclusive;
- c) in spite of these difficulties the Australian Government continues to keep records of all "sightings" and associated phenomena reported within Australia and associated territories;
- d) if the United Nations were to take the matter up there is no reason to suppose that the Australian Government would not cooperate.

3. You may wish to discuss the subject further with the Department of Air which is the authority responsible for handling questions concerning unidentified flying objects in Australia.

I advised him to refer the matter to W.R.E., Salisbury, S.A., as it appeared likely to be a piece of space research hardware. Perhaps you could suggest RAAF contact W.R.E. to find the outcome, and the date of finding.

Incidentally External Affairs appear to be being consulted by the P.M.'s Department about how to reply to letters from abroad asking what Australia is doing about U.F.O.s. I enclose a copy of a reply I recently suggested to a Mr. Hennessey in Washington, which I think has been forwarded by the P.M.'s to Mr. Hennessey.

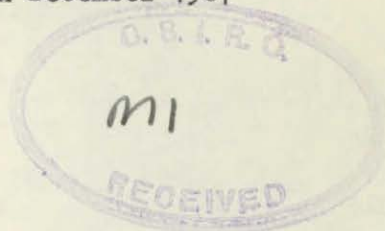

The following is a report on unidentified objects recently sighted by myself and Mr. Allan Leonard of Stanley Street, Derby.

The reason for the delay in making this report was due to us not returning to Derby until Wednesday 29th November.

On Sunday 26th November 1967, at approximately 8pm, we were camped alongside the main road East of Kimberley Downs Station. We were about to lie down and rest for the night when I noticed a vehicle passing along the main road towards Napier Downs. I called to Allan to have a look as the vehicle was strange and had only a rear yellow light approximately 36" long by 9" high. The vehicle was about 15ft long, 8 to 10ft wide and 6ft high. Its speed was about 25 miles per hour. It proceeded along the road for about 150 yards and appeared to turn right then back into the bush. Allan said to me, it is turning around and going to come back, when suddenly the light disappeared and it sounded as though the vehicle had broken a stick when backing. As the vehicle stopped, Allan walked down the road to investigate but there wasn't a sign of anything.

After returning, we discussed the situation for a few minutes and had not heard any sound from the vehicle either engine or tyre noises. In fact when the vehicle passed us it was completely silent.

Suddenly two streaks of light and a figure appeared resembling a human being. It stopped between two small bushes about 15ft away and a silver light appeared to be on either shoulder resembling a police officers number badge but much brighter. The silhouette of the form could be clearly seen and it looked like a man about 5'9" tall.

Allan called out "Leonard here, come on out" and the figure disappeared. Having been in a state of shock, we both were about to enter my utility truck when suddenly the first light we saw appeared in a different direction a quarter of a mile away. This disappeared within 5 seconds. We turned on our lights and two spotlights and searched the area. There was no sign of any tracks.

We came back, picked up our swags and drove down the road at high speed. We camped and returned the following morning at 5am and again checked the area, there was no sign of footprints or any vehicle tracks. A short time later we proceeded to Arthur Smith's camp about 4 miles away and told him and a man named Ray McClyments, they returned with us and searched for any evidence of a broken stick or tracks, nothing was found.

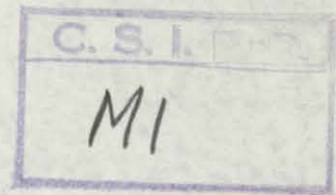

My organisation affiliates the principal Australian Societies concerned with investigation of unidentified flying objects (UFO) sighting reports.

Research in UFO's has been hitherto undertaken principally by defence organisations, such as the Royal Australian and United States Air Forces. Of recent months, however, the subject has become one of general scientific interest following hearings before a Committee of the U.S. Congress, and published statements made by Dr. J. Allen Hynek of North Western University who was for 18 years U.S. Air Force Scientific Consultant on UFO's.

Shortly after the Congressional hearings the U.S. Air Force announced the making of a grant of \$313,000 (U.S.) to the University of Colorado for the purpose of an analysis of the UFO problem by a team of University scientists.

The project has now been organised under the leadership of Dr. Edward U. Condon of the University of Colorado's Physics Department.

The purpose of my letter is to enquire whether the C.S.I.R.O. would consider establishing a similar investigation in Australia to the Colorado Project. No doubt, there are certain advantages to be gained in such an investigation being made here at this time, arising from the possibility of exchange of information, and correlation of procedures between the two projects.

I have no doubt that full co-operation can be expected from Colorado University, since I understand that some contact has already been made between



Thank you for your memorandum of the 3rd March on this matter.

Unfortunately, the organization of C.S.I.R.O. is not such that it would be possible for the Commanding Officer of the relevant R.A.A.F. Base investigating an U.F.O. to correspond directly with people at a regional level.

C.S.I.R.O.'s laboratories cover research work in both the agricultural and biological sciences and the industrial and physical sciences, and these laboratories are spread throughout the Commonwealth. There is no Officer-in-Charge on a regional basis as such.

However, it would be possible to nominate officers in Perth, Adelaide, Sydney, Brisbane, and Canberra through whom the relevant R.A.A.F. Commanding Officer might get in contact. Our officer could then get in touch with this office in order to determine where a specific enquiry might best be directed in C.S.I.R.O. Dear Squadron Leader Baxter,

Please excuse this handwritten letter but I wanted to catch the evening mail & may not have done so had I waited for the typists. I would like to add a few details to today's telephone conversation. Dr. Vallee an astronomer at the University of Chicago and Professor J. A. Hynek, whom I saw in Chicago a few weeks ago are very interested in the U.F.O. phenomenon from the point of view of a scientific investigation: so am I and so are many other scientists in other countries. These gentlemen have carefully documented files on many (about 6000) sightings in many different countries. Many of these sightings are doubtful but there are a large number which it has not so far been possible to explain in terms of natural phenomena — there are the cases of interest. Dr. Vallee has at his disposal a computer program for an automatic question — answering system (which was originally developed for stellar astronomy). He has asked Dr. O. Phanton in Brazil, Professor Michel in France, myself and several other scientists in different



countries to collect data on sightings and where possible interview those who originate the report in order to determine its reliability and so weight it for future statistical analyses. This information will be coded, so that it can be punched onto an IBM card and later fed onto a magnetic library tape for use with the question - answering system. Present investigations have indicated the existence of certain patterns in this phenomenon but unfortunately much more data is required before great reliance can be placed on the results of such an investigation. Several reports from isolated observers, contiguous in time and consistent in description would appear to suggest that perhaps some observations are made sequentially along great circle routes: again more data is needed. "banding" reports have been quite frequent in South America and, I believe, in the Southern Hemisphere on a whole. What is needed is information ① as soon as it is turned in - so that the case can be correlated with other information, if possible, at Dearborne Observatory ② results of the follow-up. I would like to investigate cases myself where possible and would be very willing to be of

Dr. Hynek is the scientific advisor on UFO's to the U.S. Air Force. I am enclosing a letter from him to substantiate my request. I stress that this is a scientific investigation and that, although my interest is extra-curricular, I feel that it is very necessary to subject those unexplained phenomena to scientific investigation.



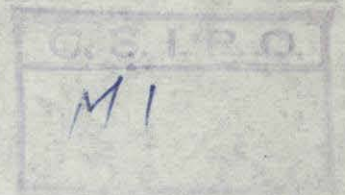

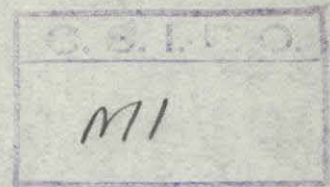

### UNIDENTIFIED FLYING OBJECTS

1. Sightings of Unidentified Flying Objects have during recent months been receiving considerable publicity. Although it is not considered that any of these sightings give cause for alarm or reflect a need to change the official view on this subject, it is important that the system of investigation should make the best use of resources available in AUSTRALIA.
2. As you are no doubt aware the Royal Australian Air Force is responsible for the investigation of reports of Unidentified Flying Objects (UFOs). Under existing arrangements anyone who sights an object which he cannot identify is invited to fill in a questionnaire which is designed to provide all the details necessary for an investigation. The nearest Air Force base is then required to investigate the incident and give an assessment as to the origin of the sighting.
3. The decision to investigate reports of UFOs at RAAF base level was made on the grounds that base personnel would be familiar with local phenomena, weather conditions and aircraft movements which between them give rise to many UFO reports. There are occasions however when the investigation points to some other phenomena such as celestial body, satellite, meteorological balloon, etc, as the likely explanation.
4. In many instances RAAF units have been able to obtain information and advice from local bodies to assist them in their inquiries, but it is now considered that all authorities that could throw any light on these incidents should be officially associated with the investigation system.
5. Your agreement is therefore sought to the proposal that whenever the UFO investigation suggests that your department might be able to provide some assistance a copy of the UFO report should be sent to you for your comments. It is felt that in this way better use could be made of the information available within your department, and that a more accurate assessment of the likely cause of the UFO report could be achieved.

UNIDENTIFIED FLYING OBJECT SIGHTING

I returned from patrol on the 14th of July, 1965. On the 20th of July, 1965 the Buaruade Mission reported to me that they had seen what appeared to be a flying object showing a bright light on the 12th of July and that one of their teachers had seen a similar object on the 18th of July.

The following is a summary of particulars from these two sightings.

12th OF JULY SIGHTING

Informant - Mr. T. Fial'ihel, Missionary in Charge, Buaruade.

Time - 1910

Direction from Buaruade - westerly - in vicinity of Kerorega Bay between Wandaga and Somatitai villages.

Appearance - An extremely bright light changing from red to blue and moving from side to side (a mile each way) at approximately 7000 ft.

Height - Approximately 5,000 ft.

Duration of Sighting - Approximately 15 minutes

Description of Disappearance - Appeared to grow dim and then disappeared in N.W. direction.

Noise - Nil

Other Information

First sighted by children who reported that it fell like a heavy weight for approximately 1,000 ft before mission was informed.

18th OF JULY SIGHTING

Informant - Fenedi/Sisina, a female teacher at Buaruade Mission.

Direction from Buaruade - Easterly - over sea.

Appearance - Very bright light "like a prism" spinning in a large circle at a fairly high and constant speed.

Height - "Lower than nearby mountains". My estimation - 1500 ft.

Speed - "A lot faster than a bird".

Duration of Sighting - Approximately 5 minutes.

Description of Disappearance - Disappeared in easterly direction at considerable speed.

Noise - Nil.

Other Information

The teacher watched object for 2-3 minutes and then reported to the Missionary in charge. When he arrived the object had disappeared.

The Wandaga people reportedly sighted a similar object at the same time and in the same direction.

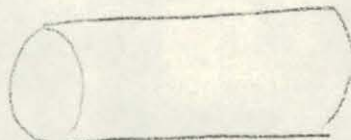

Un-identified Flying Object

On the morning of Sunday 18th. July I awoke hearing a noise like a diesel vessel approaching. I looked at my bedside clock and it read 11 p.m. Then I noticed a red glare outside on the hill side and immediately thought the dry grass in the plantation was afire so I immediately went outside the house to have a look. The red glow was coming from an object in the sky which was a glowing red colour and shaped like this:



It looked from my position to be about 3 ft long and 1 ft. thick and may have been about 1,000 feet up but this is difficult to judge at sight.

It cruised forward and backward three times not turning on the return run but reversing on its own tracks, the distance it travelled forward and backwards over my house being 1/2 mile. All the time it gave off a noise like a diesel vessel.

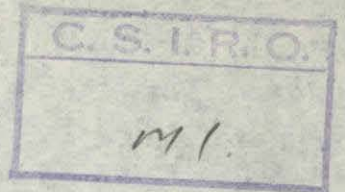
I went to the house and used the plantation phone and called my Overseer and he and several boys immediately came to my house. I went outside to meet them but the object had disappeared and also the noise. The boys say they also heard the noise and thought the vessel "Koonwarra" which was expected was coming. However, they did not see the object as they remained indoors with the shutters and door of their house closed.

I did not report this immediately as I was afraid of being ridiculed but several days later I visited Buaruada and three or four Europeans there reported having seen the same object on Saturday night the 20th. July and again on Sunday night the 18th. at approximately the same time of the night, i. e. 11 p.m. They saw it again Monday night.



LIGHT IN THE NIGHT SKY

On the night of Monday the 5th of July, a bright white light was seen from the Poseidon, at the time anchored at TEWATEWA. It was seen by myself, Mr. K. Furphy C.P.O., the ship's boatswain and members of the crew.

The light was sighted at 1856 local time and remained visible until 1903 when it went out or disappeared. It was on a bearing of West (270 compass) from the Poseidon, and at an elevation of about 10 degrees above the horizon.

The light was much brighter than any star visible then or later, and the clear white quality of its light, and its position in relation to land, rule out bush fires as an explanation.

The boatswain reported to Captain Faiteli, who logged the report.

Further to my reference telegram I respectfully advise that I conducted diligent inquiries through all villages and hamlets of SUPUPU and KEROROGEA Bay on 2/7/65 and 3/7/65 and was able to corroborate the information contained therein in that six (6) other persons of KESAGA Hamlet of WEIOKO Village saw the subject phenomenon. One reason why other witnesses were not found is that the night of sighting was so cold that most persons were indoors.

2. It is further advised that during the course of these investigations another recent sighting by village people was reported by Councillor David of MWATEBU who said that

"On 17th June an object passed over Sewataitai at about 7 pm from the direction of Sanaroa Island towards Sewa Bay. It made no sound but emitted a bright beam of red light directed towards the earth. The light fluctuated in intensity. It did not appear to be travelling very fast but did not stop or hover. This object was seen by approximately 100 people from MWATEBU who were camped in company in the open near Sewataitai after doing maintenance work on the MWATEBU - SEWATAITAI road".

This statement was taken by me from the Councillor in the presence of the other witnesses who agreed that his description was correct.

On Tuesday 25th May 1965 at about 8 P.M. in the evening I was relaxing after dinner when I noticed a flash of light in a South Westerly direction. The light was blue in colour and appeared unusual. I investigated to see what had caused the flash thinking it may have been the house girl in the spare room with a torch. This was not the case and put it down to lighting. However it was repeated a few moments later and I saw that it came from outside. When I went out I saw a light at what I estimated to be between 5,000 and 8,000 feet above sea level over Karogorea Bay. The light appeared to me to be yellow green in colour (I have a colour - red green - complex). My wife said when she saw it that it was changing from red to green which would explain my difficulty in identifying the true colour.

We watched the U.F.O. and it appeared to be wavering back and forth and moving up and down slightly. The appearance was one of a hovering light. We watched it for about  $\frac{1}{2}$  an hour (between 2000 and 2030 hrs.) The light given off from the U.F.O. was sufficient to light up the beach as a new or 1st quarter moon would. I attempted to take two photographs of it by time exposure and these may give some idea as to what it was.

Eventually the object dropped slightly then rose and disappeared in what we took to be a westerly direction.

The night was overcast to some extent in that area and now stars were showing - this appeared to be below the cloud layer. To the South at Karogorea village it was raining. No other people apparently saw this as I made enquiries with a negative result. The native house girl also witnessed the proceedings.

I would not like to make any suggestions as to what it was as it was nothing like I have seen before.

Whilst this Organization is concerned with research in a number of fields involving astronomical observations and investigations on phenomena in the upper atmosphere it has not been specifically concerned with unidentified flying objects. Research related to space exploration is also undertaken by the Commonwealth Department of Supply but we know of no special arrangement for investigation of unidentified flying objects.

With reference to my previous report under same heading and your reply thereto, for which I thank you, I wish to report another sighting of this or similar object on the 6th inst. My position this time being:-

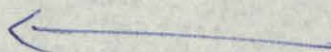

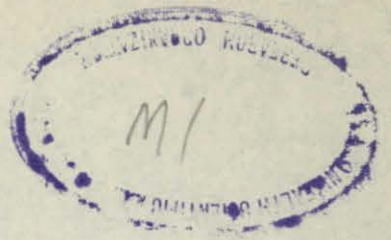

It has recently been drawn to my attention that in recent months certain members of your Organisation have been in attendance at places where Unidentified Flying Objects had been recently observed.

A particular instance of this was in relation to a sighting at Moe, Victoria. I was told of this particular instance by a person whom I usually regard as a reliable source of such information.

If this case was reported correctly, it would seem that your man asked certain questions of the observer which would indicate to me that he was pursuing a definite line of enquiry.

One pertinent question was directed to assess the effect of the phenomena upon the hearing of the observer. If in fact you are seeking objective information regarding these matters, I would be most interested in co-operating. I have a sound back-ground of technical training and experience and have spent some fifteen or so years during spare time in attempting to assess whether these phenomena have a real, or only a hallucinatory existence in the mind of the observer.

I feel that both cases are observable with various intermediate gradations.

However, some years ago, I decided that little more information could be gained by direct observation and assessment of reports, and I have since been carrying out experiments and collating data which would seem to indicate how such antigravitation and space drive mechanisms could be produced and operated by physical methods based upon principles which are at present unrecognised. These methods which are essentially non-electromagnetic and non-electrostatic in nature would in some circumstances be expected to have the effect upon the hearing as anticipated by the CSIRO questioner.

If these lines of enquiry are in fact of interest to your Organisation, I would as previously stated be prepared to co-operate in the matter.

On 12th June, 1961, an unidentified flying object was sighted by two residents of the Northern District. The District Commissioner of that District has reported as follows:-

"The object was seen by Mr. and Mrs. C.R. McCullough of Azerita Plantation at 4 a.m. and for a period of about 15 minutes. They say that the shining object approached the North East and was shaped like the hollow in a new moon, and could have been delta winged. The object was at an estimated height of 15,000 feet and kept moving backwards and forwards to and from the North East.

On one particular occasion it moved to the North East until it became the size of a pin's head then returned. Eventually it returned the way it came. No noise was heard and only the bright object was seen.

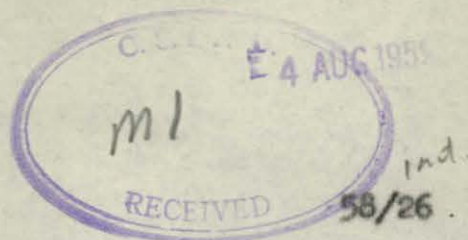

REPORTED SIGHTINGS OF FLYING OBJECTS

Reference is made to my memorandum AD.93/5/2 of 3rd June, 1959.

2. Written reports of the occurrence referred to in the above memorandum have been received from two Native Affairs officers, Messrs. R.G. Orwin and R.L. Smith. These reports are enclosed as Attachments 1 and 2.

3. Mr. E. Evenett of Samarai has given the District Commissioner, Samarai, an account of another "sighting" in the following terms :-

" On the night of the 26th June, I was at GIWA about eight miles below Baniara in Goodenough Bay. I had just listened to the evening news and between 7.15 p.m. and 7.30 p.m. went outside. I saw an object approach from a north to north-easterly direction, descend and then hover in the sky about 500 feet up. It was at an angle of about 45° up from me and when I spanned my hand out in front of me to measure it, my hand shielded about half of it from view with the remaining part visible. It seemed to me to be about 60 feet long. It had the silhouette of a rugger football, and had a kind of ring around it with about four semi-domed portholes visible in the side that I could see. A glow was coming from these portholes. It remained hovering for about four minutes and then disappeared rapidly in a southerly direction.

The following morning I went across to a village just below BOIANAI, and there the natives asked me if I had seen the 'new American Air Force' that had appeared the previous evening."

4. The following report has been furnished by Bishop Doyle of the Roman Catholic Mission at Sideia :-

" In June, 1958, there came from a Southerly direction a round object about the size of the moon pale blue in colour and emitting light brighter than the moonlight. Seemed to hover in the sky and about as high as the moon, over the Mission property. After about five minutes it moved in a northerly direction and disappeared in mid-sky. (Seen by five senior school boys at the same time).

About late October or early November 1958, on two evenings about 7 o'clock a light



about the size of a bright star, white in colour, moved high across the Western sky from N.W. to S.E. On the second occasion the light was not constant but appeared to flash on and off at regular intervals of about two seconds. This phenomenon was observed by a number of the Fathers, Brothers as well as a large number of school children.

One Saturday in May this year a large green elliptical object was seen by nine school boys. It was much larger than a star and moved rapidly.


On June 13th this year at about 6.15 p.m. twenty odd boys saw an elliptical object about the size of a football, a pretty green colour race very fast and low across the Eastern sky towards the North East.

At 8.30 p.m. on June 27th this year two of the Brothers saw a large fiery object about half the size of a full moon in the Western sky moving slowly either down the Western sky or away from the observers in a Westerly direction. At one stage the object of which the light was appearing to diminish to a pinpoint, suddenly glowed brightly again. It turned blue before finally disappearing. The whole phenomenon lasted about ten minutes".

... 5. Enclosed as Attachments 3 and 4 are reports of further sightings received from Messrs. Orwin and Smith.

6. At one stage, the Harbour Master at Samarai was inclined to the belief that it was the planet Venus which was being seen. He stated that this planet sometimes has the habit of emitting blue, green and red flashes of light, and also that light refraction due to temperature changes in the atmosphere gives the impression of the planet moving. However, the District Officer was recently at Baniara and discussed this matter personally with Mr. Orwin and other people there who have sighted these objects and he is inclined to the belief that these sightings are not to be dismissed lightly and that, in fact, something strange and as yet unknown was truly observed during periods mentioned by the reporting officers. The District Commissioner says that Mr. Orwin and the other eye witnesses to these occurrences are quite convinced that they are not sighting the planet "Venus".

7. The Regional Director, Attorney General's Department has been kept fully informed of these reports.

UNIDENTIFIED FLYING OBJECT SIGHTED FROM BANIARA - MILNE  
BAY DISTRICT

On the night of Sunday the 24th May, 1959 I was sitting on the verandah of my house in company with Mr. R.L. Smith, Cadet Patrol Officer. The night was very clear with no clouds and many stars.

I noticed a particularly bright light high in the sky to the west of Baniara. At first I thought that it may have been a bright star but the object began to move in an erratic direction to the south west. The object was first sighted at 1900 hours and was under constant observation from that time.

The first time it was sighted it appeared to be emitting a bright blue light. As it began to move towards the south west, sometimes rapidly and sometimes only perceptably it changed colours from blue to bright green and then this would be terminated by an orange flash. The changing lights appeared to come from the bottom of the object.

At 2015 hours, after being kept under close observation, the object finally disappeared in a south-westerly direction.

It was not possible with the naked eye to determine the shape of the object and it did not have the appearance of a star or meteorite. It appeared, at the distance, to be a regular shape but its size could not be estimated.

UNIDENTIFIED FLYING OBJECT SIGHTED FROM BANIARA - M.B.D.

On the night of Sunday the 24th May, 1959, an apparently unidentified flying object was sighted from Baniara. The following description of the object is as accurate as possible to my observations.

At 1900 hrs., on the said date, an object was sighted, high in the sky in a westerly direction from Baniara. In the first instance it was stationary. The predominating colour of light emitting from the object was of a brilliant irridescent blue. Soon after first sighting the object, it commenced to descend erratically in a south-westerly direction; sometimes quite rapidly and at other times almost coming to a halt. During these movements, the blue colour would change for an instant to a bright green, terminated by an orange flash. These colours appeared to come from a lower position on the object-as if from it's base.

The object completely disappeared from view, in a south-westerly direction at 2015 hrs.

SIGHTING OF FLYING OBJECT - BANIARA

Reference is made to my radiogram 6 of 29th June, 1959 and your 17-2-4/134 of 30th June, 1959, to the Assistant Administrator, copy of same being minuted to this office.

The following report based on the sightings of Mrs. R.G. Orwin and Messrs. R.G. Orwin and R.L. Smith is submitted for your information.

On Saturday 27th June, 1959, at 1940 hours Mr. R.L. Smith noticed a bright white spherical light NNW from Baniara and high in the sky. It appeared to be between 8 and 9 thousand feet from the ground. Both Mr. and Mrs. Orwin also saw this object after Mr. Smith drew their attention to it. The object remained stationary for some time and then slowly began moving across the sky in a westerly direction. It had the appearance of a "sparkler" which is commonly used in firework displays. Also arcs of light emanating from the object appeared to be blotted out at regular intervals. A green light also appeared at regular intervals at various points of the object. There did not appear to be any definite order in the appearance of this light. The object looked as though it had a red base or that a red glow was originating from its base.

At the time of sighting and while the object was under observation there were many stars present and few clouds in the area where the object was to be seen. There was a definite reflected glow on the few clouds in the area when the object passed in close proximity to them. It was also noticed that there was a reflection like a beam of light on the water between the mainland and the island and this emanated from the object. In contrast the reflection of the stars in the water, which was very smooth, were similar to pinpoints only.

As the object slowly moved across and downwards in a westerly direction it was kept under constant observation. From the wharf it was then seen that there was what appeared to be a round bronze coloured disc below and to the right of the bright light. As the light moved so did this disc keeping the same distance, about 500 to 1000 feet, each time. This was first noticed at 2025 hours.

The bright light and disc both finally disappeared behind cloud low in the western horizon at 2045 hours.

On Sunday 28th at 1820 hours the bright light was again seen by Mr. and Mrs. Orwin. It appeared in the same position as on the previous night although it was not as bright at first. At 2001 hours the bright light moved at great speed along the same track as the previous night but in a minute covered the same distance it had taken a half an hour to cover previously. The light became very bright during this rapid movement as did its reflection on the sea. It dropped about 5000 feet during the period and from my opinion it looked as though it was going to land to the north



west of the station on the mainland. The light was kept under observation during the rapid movement and Mr. Orwin ran to the wharf for this purpose. It slowed up ~~and~~ remained in the western sky and remained there until it slowly disappeared again low on the horizon at 2115 hours. The bronze disc was again sighted in the same relative position as the night before. Mr. Smith was present with Mr. Orwin to keep the bright light under observation from 2005 hours until it disappeared.

This office has been advised that the planet Venus could be expected to be seen from the station in approximately the same direction as the bright light was first seen. However the planet Venus was seen on the 4th July, 1959 by myself and The Naval Intelligence Officer who was visiting the district, and from its sighting I am of the opinion that it was not the bright light seen previously as this light was much lower than Venus and more to the north of the position of Venus.

APPENDUM TO 31-1-4/11

As stated in the attached report, the original object was first sighted from the 4th of July onwards. The planet Venus however was visible.

During the early evening of Monday the 6th of July, I watched for the original object between the times of its previous appearances. The planet Venus was visible at this time only. However, I awoke during the night at 0050 hrs., happened to look at the sky and noticed a very bright light.

On observing this light more closely, I was convinced that it was the same one as seen between the 27th of June and the 3rd of July. Venus was not visible. The object appeared to be lower in the sky than on previous occasions and closer to the point of observation. The bronze was not evident on this occasion.

After watching it for fifteen minutes, an object like a falling star seemed to come from near the base of the object and shoot earthward at tremendous speed and at about forty five degrees to the ground. After about five more minutes this procedure was repeated by another similar object, but this one went away to the other side. It is realized of course that these objects could have been shooting stars, and could have come from some distance behind the object.

After observing the object for almost an hour, it moved away in a similar direction to before (westerly) although when first sighted it was more to the south than on previous occasions.
