I am writing with reference to your report of an 'unidentified flying object', seen in May 2008, the details of which you left on our answerphone. This office is the focal point within the Ministry of Defence for correspondence relating to 'UFOs.'

First, it may be helpful if I explain that the Ministry of Defence examines any reports of unidentified flying objects' it receives solely to establish whether what was seen might have some defence significance; namely, whether there is any evidence that the United Kingdom's airspace might have been compromised by hostile or unauthorised air activity.

Unless there is evidence of a potential threat to the United Kingdom from an external source, and to date no 'UFO' report has revealed such evidence, we do not attempt to identify the precise nature of each sighting reported to us. We believe that rational explanations, such as aircraft lights or natural phenomena, could be found for them if resources were diverted for this purpose, but it is not the function of the MOD to provide this kind of aerial identification service. It would be at inappropriate use of defence resources if we were to do so.

The MOD does not have any expertise or role in respect of 'UFO/flying saucer' matters to the question of the existence or otherwise of extraterrestrial life forms, about which it remains totally open-minded. I should add that to date, the MOD knows of no evidence which substantiates the existence of these alleged phenomena.

With regard to your particular observation, I can confirm that we received no other reports of 'UFO' sightings from Needham Market in Suffolk so far for 2008. We are satisfied that there is no corroborating evidence to suggest that the United Kingdom's airspace was breached by unauthorised aircraft.



UFO OVER MEXBOROUGH: SOUTH YORKSHIRE (7th 9th 2007)

This is our personal witness statement from start to finish of what my wife and I observed on the evening of Friday 7th september 2007.

It was shortly before 2300 hrs,-my wife and I had been out walking our dog and we were heading on our way back home.

There was an abcence of the moon due to its lunar cycle and the sky looked very dark. There were no stars to be seen or cloud, .It was like a black sheet of eerie darkness overhead.

The light remained stationary for a while roughly two miles away above the fields and to the right of Grange Farm which stands on a wooded hilltop overlooking the village of Old Denaby.

We crossed over Adwick Road just as this light began to move north toward Mexborough on a flight path that would take it over the rear

We went into the house and I got my digital camera out of the pulldown of our display unit. I then immediately went outside the back kitchen door into the garden where I stood on the gardens bench seat for a better advantage view and to capture this light on camera as it passed overhead. Unfortunately the glow went out but I still managed to get a single photograph of the underside of a strange circular object passing overhead.

-This object was a greenish orange colour with a number of small lights on its outer rim.

My dog was barking frantically and running up and down the back yard setting off our PIR Security light -obscuring my vision. When the PIR went out again the object had gone.

The time now was exactly 2300 hrs by my wrist watch.

However it is interesting to note that shortly after the object had gone overhead, a large heavy sounding Plane followed in that same direction -north toward Adwick upon Dearne.

The plane was undercover of darkness with only its flight lights on, but no cabin or passenger windows lit or visible.







During the early hours of this morning (10th February) i observed an unfamiliar object in the sky, heading SE (under a civilian air corridor, not usually a path frequented by the RAF, in my experience, living here for 17 years) Its altitude was certainly lower of that than any commercial airliner ive seen pass over the area. It was travelling very slowly, a fixed wing cessna or similar came to mind, but its appearance ruled out any civilian aviator straight away. On closer inspection with a pair of binoculars, the object revealed itself to be triangular in shape, a yellow light in each corner, and a ! red light in the centre, the yellow lights pulsating quickly, before the red light too pulsed. The lights would remain off for at least 1.5-2 seconds between each pulse, in this time the object covered barely any distance, making no attempt at concealment etc. Ive been an aviation enthusiast for many years, and i have not seen anything like it in all my time observing the skies. This was no Eurofighter, no Harrier, no Hawk or no Tornado. I doubt this was even RAF.

Now, we get on to why im writing this in the "low flying complaints" section. You see, what i saw, i believe, is what is known as a "black aircraft" an aircraft that has not yet been revealed to the civilian public. The RAF hasnt the budget to invest in such projects, although the USAF do, leading me to believe the aircraft seen was of USAF origin, possibly operating out of one of the many restricted bases in the Nellis Ranges. Now why, would the United Kingdom, as an independent nation, allow the USAF to use its airspace (probably without the knowledge of the relevant RAF authorities) to test aircraft that to the untrained eye, scare the living daylights out of people? To me, it was a very rare glimpse of what the USAF is capable of, to someone else, it

might bring on a panic attack, pushing pictures into their heads of green men with

You probably already have my details on file, as i made a freedom of information act arding the once classified document "UAP's in the UK air defence region", and it the reading of this document that promted me to contact you. I know there is little anyone in the air ministry can do to prevent what i would call "uneccessary" if not "careless" use of airspace, but this aircraft was in OUR skies, using OUR airspace and maybe scaring OUR people, and i doubt the relevant UK authorities had any knowledge of it. So, my questions to you are:

- Where can i report what i saw officially? — and more importantly, where does the RAF and the air ministry stand on black projects using our airspace, does this not concern any of you? — If anyone can help me, it would be vastly appreciated. Regards


I am writing to you in regards to an unusual aerial observation that I witnessed on Saturday the 20th October 2007 at 12.10 pm above my fathers home, which is situated on the outskirts of Portsmouth below portsdown hill. Just after midday at 12.10 pm I observed from my fathers back garden an unusual oval / spherical shaped object that appeared to cross the flight path of a commercial aircraft, narrowly missing it, as the oval / spherical object approached the aircraft it appeared to accelerate very fast, in doing so it appeared to wobble from side to side as it passed directly in front of the commercial aircraft narrowly avoiding a collision, I briefly watched the object move off to the east before deciding to rush back in to my fathers home to retrieve my camcorder, but unfortunately when I returned to the garden the object was no longer visible, (see drawing enclosed, Attachment 1) However within 2 minutes I sighted & managed to film on my camcorder another object in the sky roughly in the same vicinity as the previous occurrence that I couldn't identify (see pictures enclosed, Attachment 2) the object remained virtually stationary throughout the duration of 10 minutes until it finally disappeared in to the clouds.

Mr Alain Hubrecht who is a Belgium national and a "NATO expert in peace support operations and critical infrastructure protection" wrote on my behalf to Airprox concerning this incident, Airprox passed on the information to the CAA (see enclosed; Mr Hubrecht's initial request to Airprox (Attachment 3) and the CAA's reply back to Mr Hubrecht concerning the radar data, Attachment 4). Mr Hubrecht has asked if he could communicate with you directly concerning this incident. Is this possible?

Dear Sir,

As a NATO expert in Peace Support Operations and Homeland Security, I'd like to request information about an Airprox that was observed last Saturday October 20, 2007, at 12:10 PM. The incident happened over the Paulsgrove area of Portsmouth, just before reaching Portsdown Hill.

One airplane was fairly high in the sky, coming from South and going North, when just close to this position, another object (UAP – UFO?) did cross his trajectory moving from west to east. The object appeared to be a third of the size of the airplane.

The attached drawing is from Section 40 who wittnessed the incidence at his father's home which is situated below Portsdown Hill, close to the radar base.

The drawing shows the avoidance path of the UAP.

Postdown Hill is indeed the place of a Qinetiq base doing radar researches. Section 40 was able to take a movie a few minutes later of a round object hovering above the hill. I wonder if we can get radar information (both civil and non-civil radar) about this Airprox, as well as the information coming from the pilot of the airplane if he made an AirProx report. If you are not able to provide this information, can you forward my request or tell me where to find information about planes trajectories and how to reach the pilots of identified flights? Dear Section 40

We have now reviewed the radar data for the date, time and location given in your email dated 27 October.

There were several airliners in the vicinity, at high altitude, at around 12:10pm that day. There were also numerous light aircraft, not under air traffic control, flying at much lower altitudes in the same area. The light aircraft pilots were providing their own separation from other aircraft by keeping a look out and using the 'see and avoid' principle, which is standard practice in uncontrolled airspace.

Having viewed the radar data, the most likely explanation is that there was an airliner tracking South to North at 25,000ft at 12:10pm. A light aircraft can be seen tracking West to East at this time, close to the lateral path of the airliner but at a much lower altitude. It is not possible to identify the light aircraft or its actual height using the radar information. However, it is possible that these aircraft tracks may have appeared to cross each other, when viewing the aircraft from the ground. It is notoriously difficult to judge horizontal and vertical separation from the ground, as aircraft may be separated by thousands of feet vertically but they appear to be at the same level depending on aircraft size and trajectory.

In the UK it is a legal requirement that, in respect of commercial air transport operations, an Airprox report is filed, by a pilot and/or an air traffic controller, within four days. This time has elapsed and I can confirm that we have not received a report corresponding to the details which you have provided - either from the air traffic controller or the pilot of the airliner. On this basis, there is no further action to be taken by the CAA.



The young woman I spoke to seemed to think it was a bit of a laugh although I explained to her that I was a Norfolk County Councillor and wouldn't have reported a UFO sighting unless I had actually witnessed it. She gave me a reference number - 705. As I have heard nothing from the Police since I thought it better to do an internet search to find out who I should report it to. The MoD came up as having accepted sightings in the past and so I found this page to contact you contact you.

It happened on the 21st November 2007 at 7.16pm. I live on the eastern edge of Norwich and was standing in front of my garage watching stars. (I'm interested in astronomy.) I was looking to the SSW and slightly to the left of a small star I had seen came a flash of white light. It wasn't like a star as there were no flares / radiant lines coming from it. To describe it correctly you have to imagine a white ball that has a light that flashes once inside it. The whole ball lights up. It was like that and lasted for about balf a second. The flash was larger than any star or planet in the sky. Probably twice the size of the current view of Mars. Immediately afterwards, what appeared to be a really tiny star moved rapidly to the WNW much faster than any aircraft or satellite I had aver seen. (We see many military aircraft around here.) If it was outside tha atmosphere, it would have been moving at many thousands of miles per hour. If it was high within the atmosphere, the speed w! ould have been in the region of 5000+ mph. Although surprised, I was shocked when it suddenly changed direction to the WSW without turning. It simply changed direction probably 60 to 70 degrees. No turn whatsoever. It then got lower in

Perhaps someone else has reported this. I couldn't possibly be the only one.

The Rt Hon Des Browne MP has received the attached correspondence from a member of the public, which this office has neither retained nor acknowledged. Please send a reply on behalf of the PM/Minister/Department.

Ministers attach great importance to correspondence being answered promptly, and your reply should be sent within 15 working days of the date of this message. If, exceptionally, this should prove impossible, an interim reply should be sent within the same timescale. You should be aware that No 10 periodically calls for a sample of letters sent by officials on the PM's behalf for his perusal.

If correspondence includes a specific request for recorded information then it should be treated under the terms of the Freedom of Information Act 2000, even if the Act is not specifically mentioned. In general, if you meet the Department's 15 working day deadline and respond fully to the request for information, then there is no need to follow the full procedures for FOI requests. However, you will still need to acknowledge that you have applied the Act and provide details of their right of appeal (see link below). If the correspondence requests information which is not already in the public domain, and particularly if you considering withholding information, then you should formally treat it as a FOI request. The correspondence should be logged on the Access to Information toolkit and you should consult and comply with the separate FOI guidance from DG Info. Note, the shorter deadline for responding to Ministerial and Treat Official correspondence will still apply. If you are in any doubt as to whether a piece of correspondence should be treated as an FOI request, you should ask your FOI Focal Point or refer to the guidance produced by DG Info. 
