Dear Mr. Greenewald:

This letter is in response to your Freedom of Information Act request dated March 17, 2009 for a copy of any and all releasable documents pertaining to an incident where Alabama National Guard allowed a German TV documentary to be filmed on post and all records generated about the visit, plans for their arrival, the shoot itself, and any policy/protocol changes that prohibit this from happening again. This includes all documents that pertain to this request, but is not limited to, electronic files, email, letters, reports, memos, photographs, videos, etc. Your request was assigned case #FA-09-0095.

A thorough search by the Alabama Army National Guard did not reveal any records on policy/protocol changes as a result of this event. A search of records on the documentary visit revealed 11 pages responsive to your request. After a thorough review of these documents, I have determined that portions of them are exempt from disclosure under the FOIA, 5 U.S.C. § 552 (b)(6). We are releasing a total of 11 pages in part.

Exemption (b)(6) protects personnel, medical, and similar files the disclosure of which would constitute a clearly unwarranted invasion of personal privacy. Under this exemption, we are withholding names of Department of Defense personnel and personally identifiable information, such as social security numbers for all parties, as release of this information would constitute an invasion of personal privacy.

This announces a decision on behalf of General Craig R. McKinley, U.S. Air Force, Chief, National Guard Bureau, who is the Initial Denial Authority for all Army and Air National Guard Freedom of Information Act requests.

You may appeal our determination to the Secretary of the Army through our office within 60 days from the date of this letter. Your appeal should include copies of your original request and this response, as well as a discussion of the reasons supporting your appeal. The envelope should be plainly marked to indicate that it contains a FOIA appeal. If you decide to appeal, please send your appeal to:
