This is a final response to your June 25, 2016, Freedom of Information Act (FOIA) request to the U.S. Department of Agriculture (USDA), FOIA Service Center (FSC). You requested "a copy of all complaints submitted about [USDA's] cafeteria" at the Headquarters location.

Your request has been processed under the FOIA, 5 U.S.C. § 552.

A search for responsive records was conducted in the Safety, Sustainability and Emergency Operations Division (SSEOD) within the Office of Operations (OO). SSEOD manages cafeteria operations and tracks complaints related to cafeteria management, government operations or government sponsored activities.

The SSEOD search for records did not locate any records that are responsive to your request. The FSC was advised that the cafeteria contract company handles all complaints directly with customers. As part of its complaint tracking responsibilities, however, SSEOD is aware of one complaint pertaining to customer service. Since the issue between the customer and cafeteria manager was resolved, no report was produced. Accordingly, I am not able to provide any records that are responsive to your request.

You have the right to file an appeal. The appeal must be made within 45 days of the date of this letter. Your appeal must be in writing and must clearly indicate that a FOIA appeal is being made. The appeal should be sent to:
