MEMORANDUM FOR: Deputy Director for Plans

Interim Progress Report (15 to 31 August 1967)

1. Implementation of Initial DDP Instructions: The following actions have been taken in compliance with initial instructions from the DDP to Chief CI Staff, received under memorandum dated 15 August 1967:

a. Designation of Dick Ober as focal point and coordinator of operational activity;

b. Briefing of [REDACTED]

c. System for coordination of Operations: Establishment of [REDACTED] slug and EYES ONLY distribution of cables and dispatches to the Chief of the area division, with information copies to Chief CI and ADDP only (DDP, D/DCI, and DCI to be added when appropriate). We are experiencing some difficulty in coordinating operations already in being which are now being directed toward the [REDACTED] target. We have no intention of spiking initiative but we believe that close coordination and a holddown is desirable on account of sensitivity. There is multiple liaison with the FBI on this target and we are taking the position that all domestic liaison with the FBI on this matter will be carried on by Chief and Deputy Chief CI and Ober only. We assume you agree.

d. Establishment of limited dissemination procedures: Information will be reported to the Director of the FBI by letterhead memoranda over the signature of the DDP or DCI as appropriate. FBI correspondence to CIA will be handled similarly. Other agencies will be informed as necessary.
