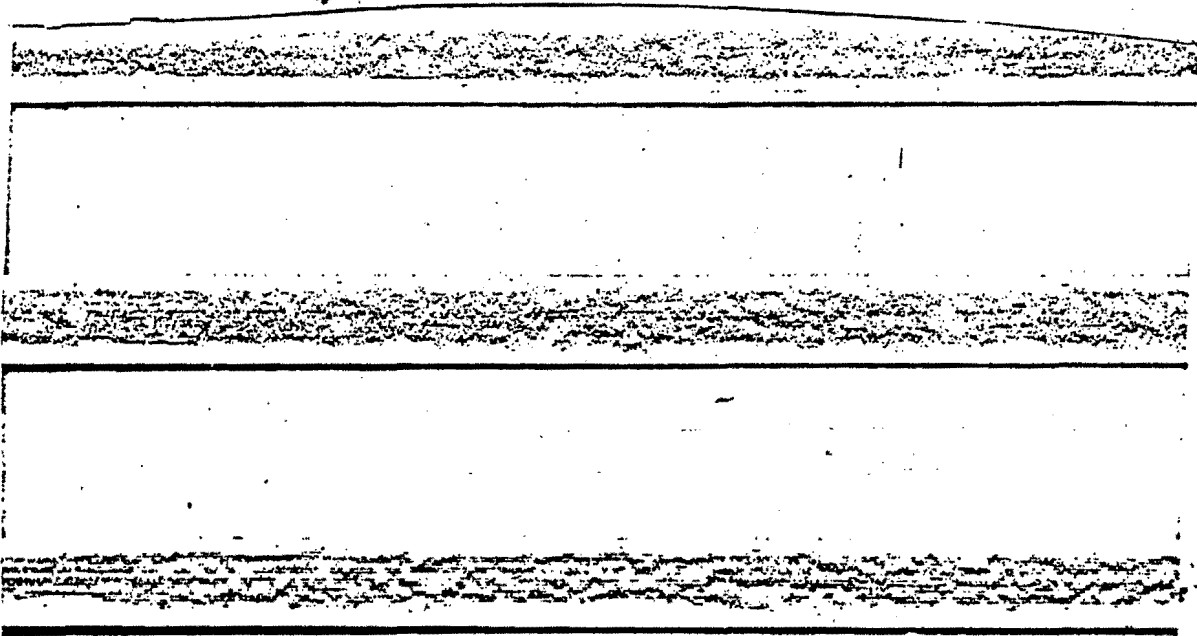
MEMORANDUM FOR: Chief, Security Research Staff

SUBJECT: Project MERRIMACK

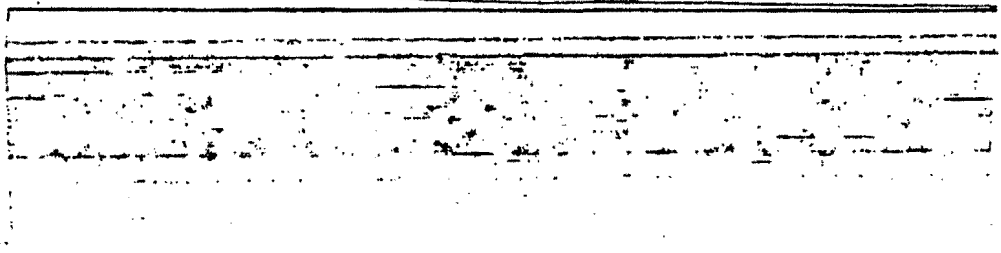
1. Reference is made to this office's memorandum dated 8 August 1967 relative to the above captioned subject. As reflected in Paragraph 2 of this aforementioned memorandum a number of license plates were ascertained during the conduct of several of our covert monitoring sessions during the period 26 - 30 July 1967. Attached is a copy of our investigative report dated 9 August 1967 which sets forth information relative to the subscribers to the license plates in question. Also, on 27 July 1967 records of the Motor Vehicle Department of the State of Ohio were reviewed in Columbus, Ohio and showed that 1967 Ohio License Plate _____ is registered to one _____ Columbus, and was issued on a _____ (no car color indicated).

2. On 27 July 1967 _____ was contacted and provided the following information from his records:

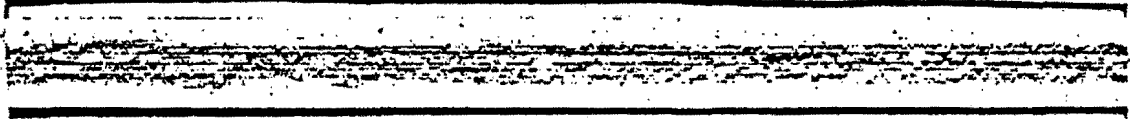
3. A review of _____ records in the name of _____ showed no record on file.

8. For your additional information, a very discreet special inquiry will be conducted on _____ who, according to our asset, is "very anxious to get a riot started in D. C."
