1. Reference is made to the memorandum submitted on 13 October 1967 relative to a surveillance conducted upon the premises of [REDACTED] where [REDACTED] the WSP met. The above address is the residence of [REDACTED], an active member of the WSP.

2. The referent noted that a rental vehicle leased to one [REDACTED] was observed travelling from the above meeting to the vicinity of [REDACTED]. At the close of the above meeting, a [REDACTED] observed leaving the [REDACTED] address and proceeding directly to the vicinity of [REDACTED]. The automobile was operated by a female who was later observed parking the above vehicle and entering the apartment building located at [REDACTED], carrying a packet of papers. She is described as caucasian, attractive and well dressed. She is aged approximately [REDACTED]. Investigation has disclosed that the above registration is assigned to a rental vehicle owned by [REDACTED]. Further investigation has disclosed that on the night of 11 October 1967, this vehicle was leased to one [REDACTED] Washington, D.C. This female could not be [REDACTED]

3. Investigation is in progress to determine the identity of the unknown female who attended the meeting at the [REDACTED] residence.

4. The apartment building at [REDACTED] is described as a "Hippie Pad." The names of residents in this building as appearing on the mail boxes are as follows:
