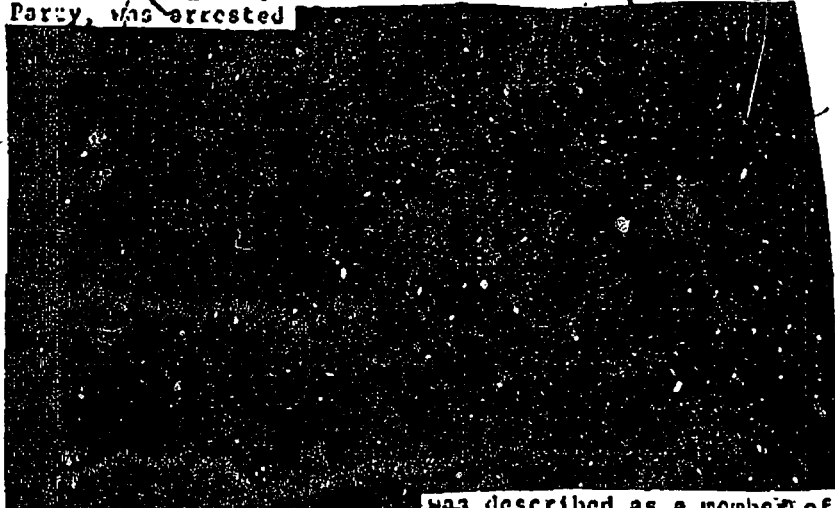

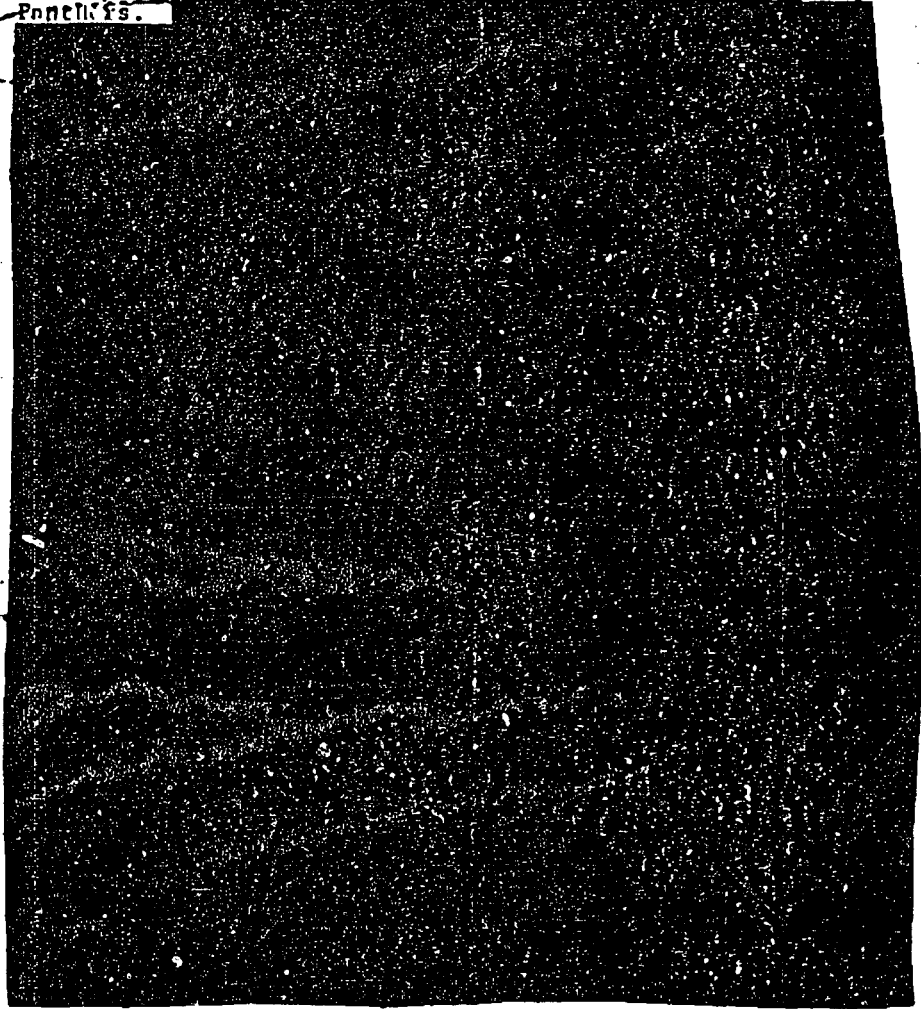

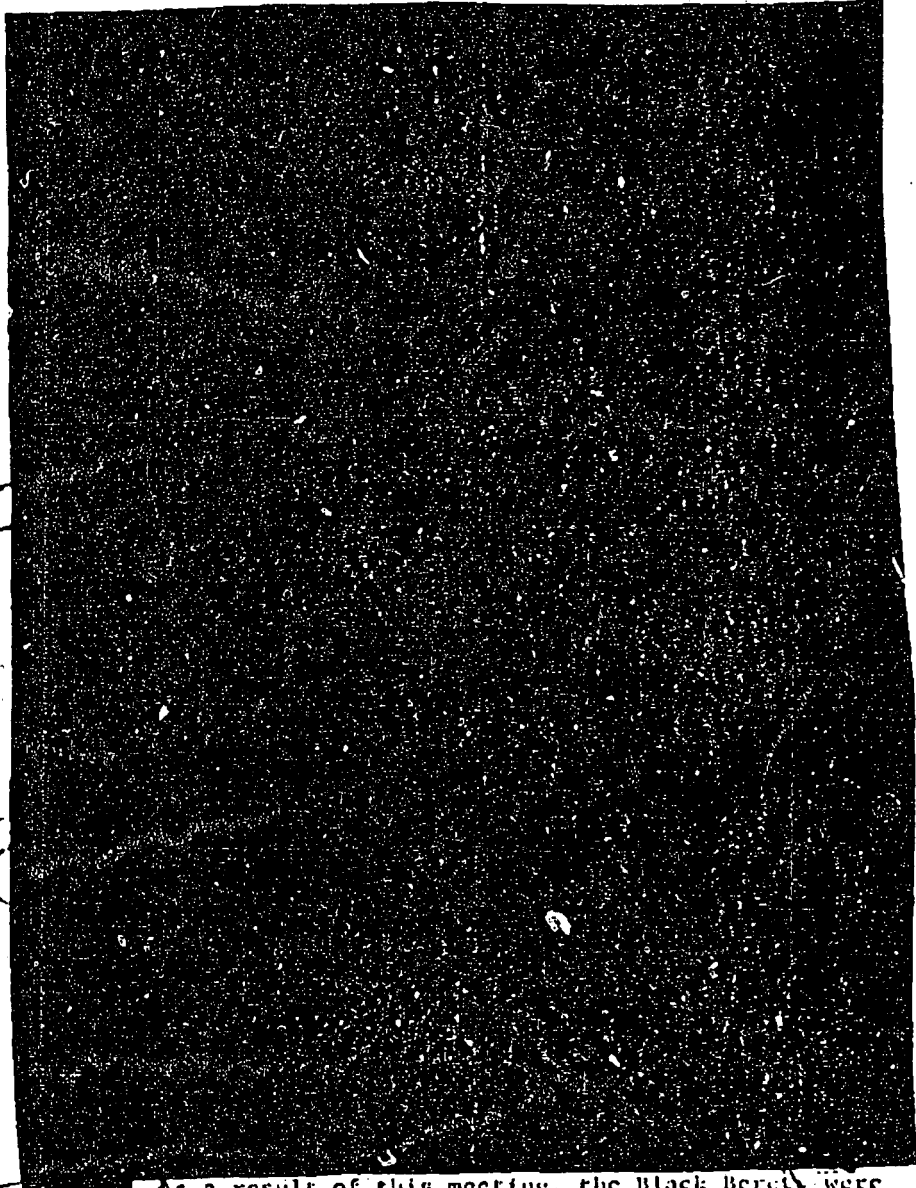
Black Perks and of NOV. The two latter organizations have now become the "Long Beach Tribe" of the Black Panthers.

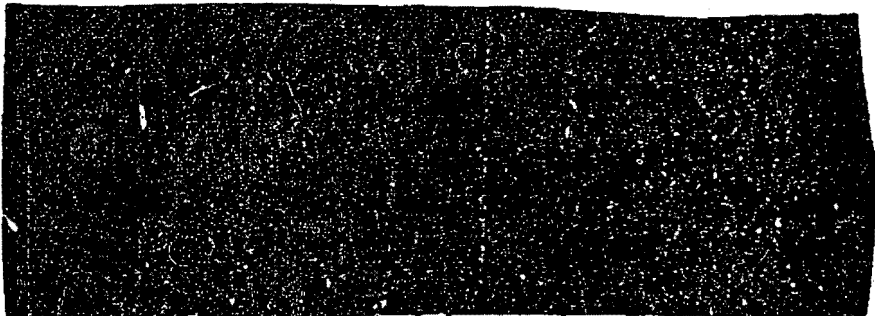

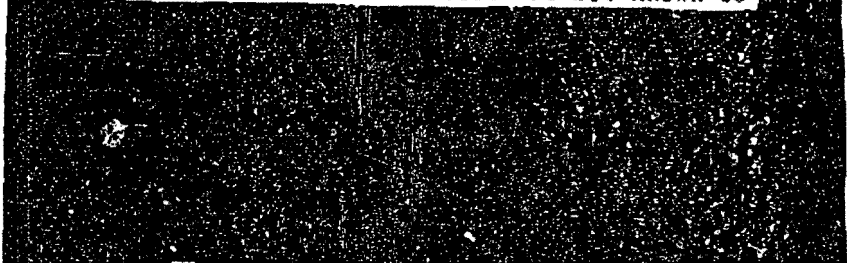

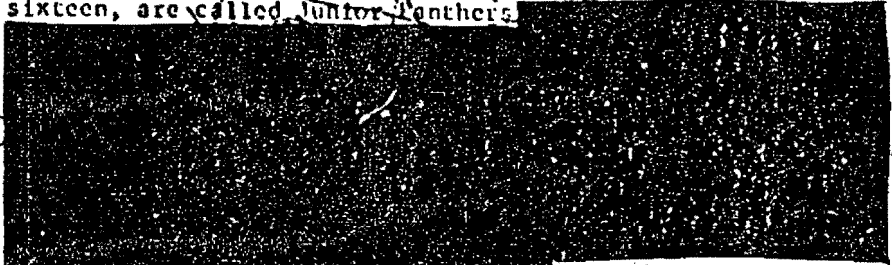

Attached is a list of the Long Beach Black Panther Party officers and members who are known to



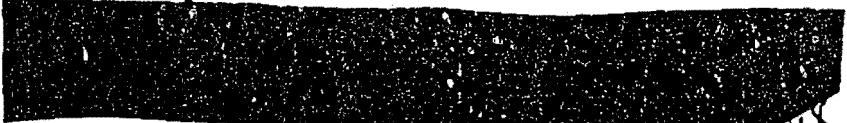

According to [redacted], the books contain revolutionary thoughts, possibly by Mao Tse TUNG. According to [redacted] members of the Black Panthers must be at least sixteen years of age. Those under sixteen, are called Junior Panthers.

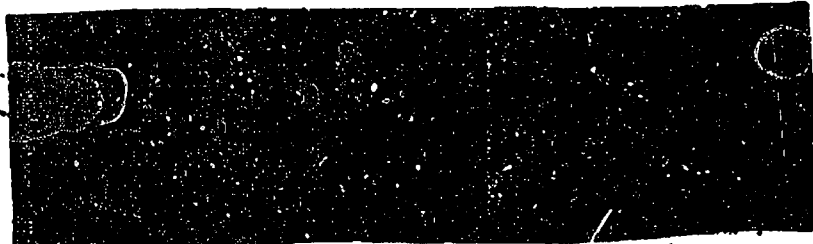

V. LONG BEACH PEACE AND FREEDOM PARTY

A. [redacted] learned that the Long Beach Peace and Freedom Party held a meeting at 1716 Gaviota on 20 September 1968. According to information available to [redacted] that residence is occupied by [redacted] who moved to that address in [redacted]. Other information available to [redacted] reflected that [redacted] indicated that she was living at 1716 Gaviota in August 1968. D. [redacted] stated that biographic information regarding the above unidentified persons would be furnished as soon as possible.

VI. INDEPENDENT STUDENTS

A. [redacted]

[redacted] that there would be off-campus newspapers on each of the high school campuses in the Long Beach area. [redacted] obtained a copy of CAT'S GLOBE at Jordan High School on 18 September 1963. The newspaper dealt with the need for an "underground" newspaper.

C. According to [redacted], the first edition of LOUD MOUTH appeared on 20 March 1967 as an unofficial off-campus newspaper at Wilson High School. In June of the same year, the name changed to LOUD SQUEAKER, however, the name was again changed to LOUD MOUTH. Michael Lee LUCAS, 2120 Clark, Long Beach, is the editor of the LOUD MOUTH which, in 1967, was printed at the Long Beach Peace Center (often known as Students for Democratic Society Center), 2628 East Anaheim. From its inception, according to [redacted] the newspaper has followed the "get out of Vietnam" line and claimed censorship of official high school publications as a reason for its existence. In August 1967, according to [redacted] met with twelve other editors of off-campus newspapers at a meeting sponsored by the Eastern Behavioral Sciences Institute, La Jolla. As a result of that meeting, all editors from various underground newspapers have formed what they call "Student Underground Press Association".
