Dear Mr. Greenewald:

This is in response to your request dated 13 April 2016 and received in the National Reconnaissance Office (NRO) on 14 April 2016. Pursuant to the Freedom of Information Act (FOIA), you requested a copy of *"a listing of all reports, completed and published by the NRO Office of the Inspector General, during the calendar year 2014 and 2015."*

Your request has been processed in accordance with the FOIA, 5 U.S.C. § 552, as amended. A thorough search of our files and databases located two documents totaling four pages responsive to your request. These documents are being released to you in part.

Material that is denied is being withheld pursuant to FOIA exemption (b)(1) as properly classified information under Executive Order 13526, Sections 1.4(c); and FOIA exemption (b)(3), which is the basis for withholding information exempt from disclosure by statute. The relevant withholding statute is 10 U.S.C. § 424, which provides (except as required by the President or for information provided to Congress), that no provision of law shall be construed to require the disclosure of the organization or any function of the NRO; the number of persons employed by or assigned or detailed to the NRO; or the name or official title, occupational series, grade, or salary of any such person.

You have the right to appeal this determination by addressing your appeal to the NRO Appellate Authority, 14675 Lee Road, Chantilly, VA 20151-1715 within 60 days of the date of this letter. Should you decide to do so, please explain the basis of your appeal.
