CHAPTER ONE

GENERAL (U)

1. (U) Purpose. The purpose of this document is to promulgate the Alert System of the Joint Chiefs of Staff and to prescribe the actions and responsibilities of applicable commanders when an alert condition (LERTCON) is declared or when selected alert actions are implemented.
2. (U) References. Close familiarity with the following documents is considered essential to a smooth functioning of the Alert System of the Joint Chiefs of Staff and related emergency action procedures:
- a. (U) Alert System of the Joint Chiefs of Staff, Part II, LERTCON Actions.
  - b. (U) Emergency Action Procedures of the Joint Chiefs of Staff (EAP-JCS), Volume I - General (TOP SECRET).
3. (U) General. The Alert System of the Joint Chiefs of Staff consists of seven LERTCONS which are divided into two subsystems, DEFENSE READINESS CONDITIONS (DEPCONS) and EMERGENCY CONDITIONS (EMERGCONS).
- a. (U) DEPCONS consist of five readiness conditions, with DEPCON 5 being the lowest and DEPCON 1 the highest.
  - b. (U) EMERGCONS consist of two conditions, DEFENSE EMERGENCY and AIR DEFENSE EMERGENCY which has three attack warning conditions: RED, YELLOW, and WHITE.
4. (U) Applicability
- a. (U) The Alert System outlined in this manual is applicable to the commanders of the unified and specified commands and to the Commander, Joint Task Force, Alaska (when activated).

f. (U) Applicable DOD agencies should provide support as required by the particular situation. 5

5. (U) Responsibilities 7

a. (U) Pre-positioned Data. Commanders of the unified and specified commands will keep the Joint Chiefs of Staff informed of any changes in the planned actions necessary to increase the readiness of their commands, in consonance with each LERTCON as promulgated in the Alert System of the Joint Chiefs of Staff, Part II, LERTCON Actions. This separate document includes: 8

(1) (U) Significant actions to be considered or taken upon declaration of each LERTCON which would be of interest to the Joint Chiefs of Staff and commanders of the unified and specified commands. These actions are listed in the following categories: 15

(a) (U) NCA Actions. Actions which must be considered/taken by the National Command Authorities. 20

(b) (U) JCS Actions. Actions which will be considered/taken by the Joint Chiefs of Staff. 22

(c) (U) CINC Actions Common. Actions which will be considered/taken by all or most of the unified and specified commands. 24

(d) (U) CINC Actions Unique. Actions which will be considered/taken by a particular unified or specified command. 27

(2) (U) The specific reference, i.e., OPLAN, OPORD, Fact Sheet, etc., which applies to each action.	<u>1</u>
(3) (U) The estimated average time required to complete each CINC UNIQUE action.	<u>2</u>
(4) (U) Related actions required of the Joint Chiefs of Staff or other commanders. This includes actions which may be triggered automatically by an action on the part of the commander submitting the list. This provides a means for the commanders of the unified and specified Commands to indicate to the Joint Chiefs of Staff and to lateral commanders the supporting actions that must be taken by others or supplementary decisions required of the Joint Chiefs of Staff when the commanders increase the readiness of their commands.	<u>3</u>

b. (U) Reports. Reporting procedures for the Alert System of the Joint Chiefs of Staff are prescribed in Chapter Two.	<u>5</u>

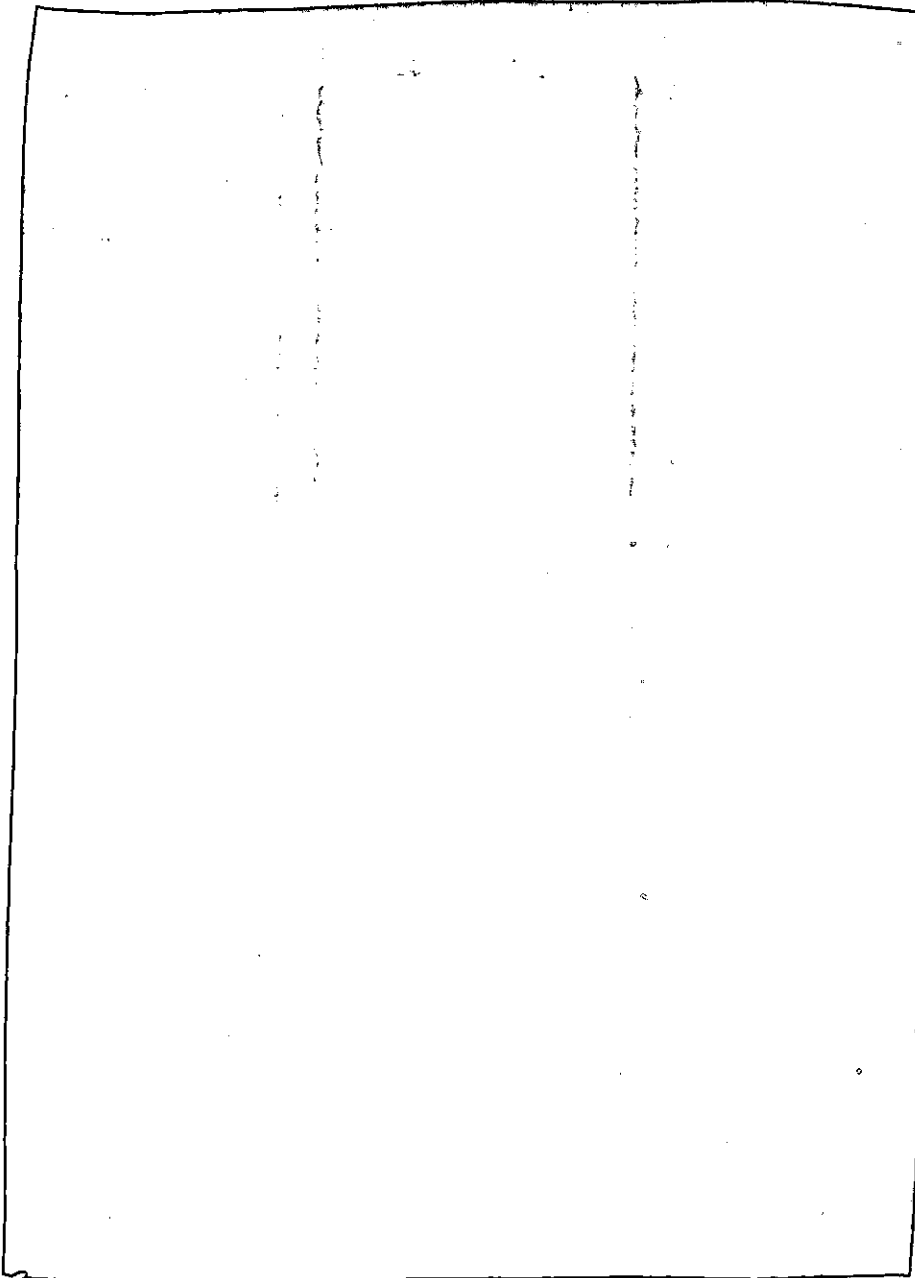

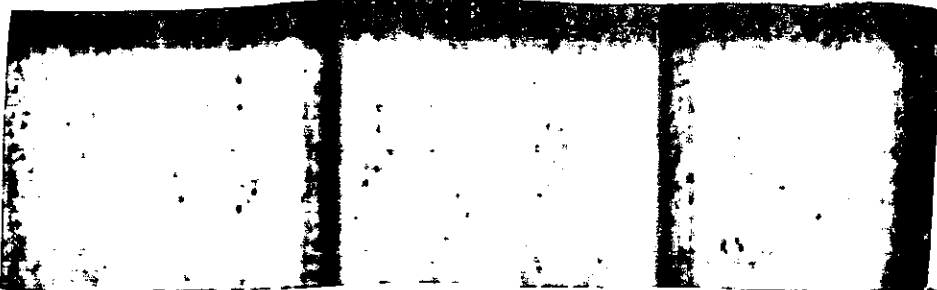

3. (U) Character. The Alert System of the Joint Chiefs of Staff is designed to be used as a directive and an authorization as follows:

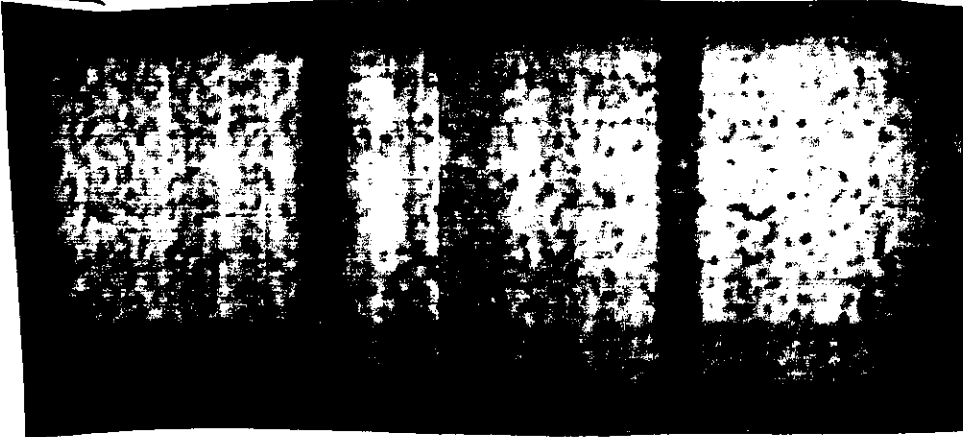


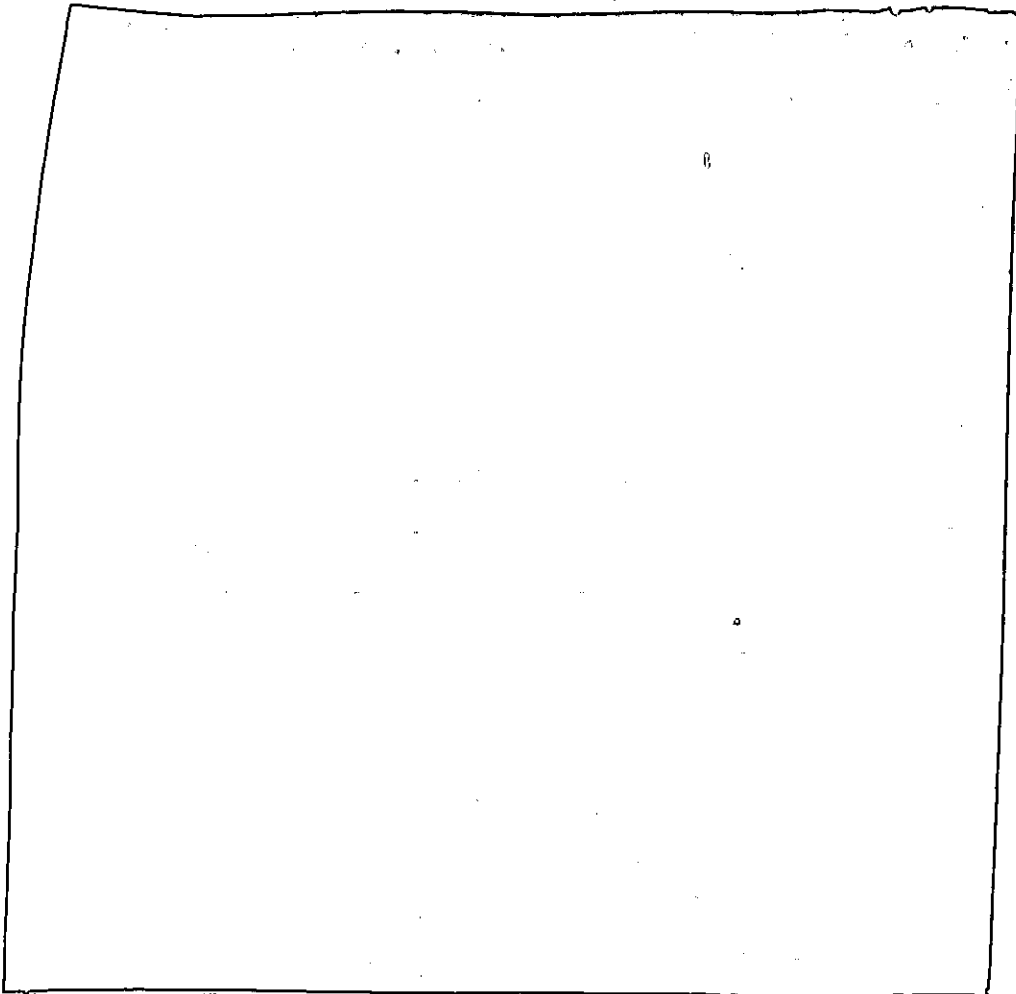

5. (U) Uniformity. To provide uniformity, all those actions which are COMMON to the commanders of all of the unified and specified commands have been identified for each LERTCON in Part II. During implementation, all commanders concerned normally would carry out the common actions declared, thereby providing a common or uniform worldwide base for monitoring readiness posture. However, the different missions of the individual commanders are recognized in the separate listing of actions UNIQUE to one or only some of the commanders.

6. (U) Authority to Declare

a. (U) DEFCONS 5, 4, 3, 2, 1, and DEFENSE EMERGENCY. The Joint Chiefs of Staff or higher authority are authorized to declare all DEFCONS and DEFENSE EMERGENCY.

8. (U) Security

a. (U) General. The Joint Chiefs of Staff wish to emphasize the importance of effective security control measures associated with increasing the readiness of US Forces under actual or exercise conditions. It is desired that commanders of all unified and specified commands continue to impress on subordinate commanders the importance of maintaining security with particular emphasis on periods of heightened tensions and increased readiness.

b. (U) Timeliness of Declaration. The declaring authority should consider the security requirements, the reason for making the declaration, and the guidance to be issued when assessing the urgency of notification. In deference to both security and guidance, some degree of delay is acceptable in formally declaring DEFCON changes so that the declaring authority may provide commanders with accurate information on which to base any related considerations, decisions, and actions. Even under impending nuclear or general war, a slight delay in notification in order to include in the declaration the reason and some guidance is considered acceptable. If amplifying guidance is impractical initially, it should be provided as soon as practical thereafter.

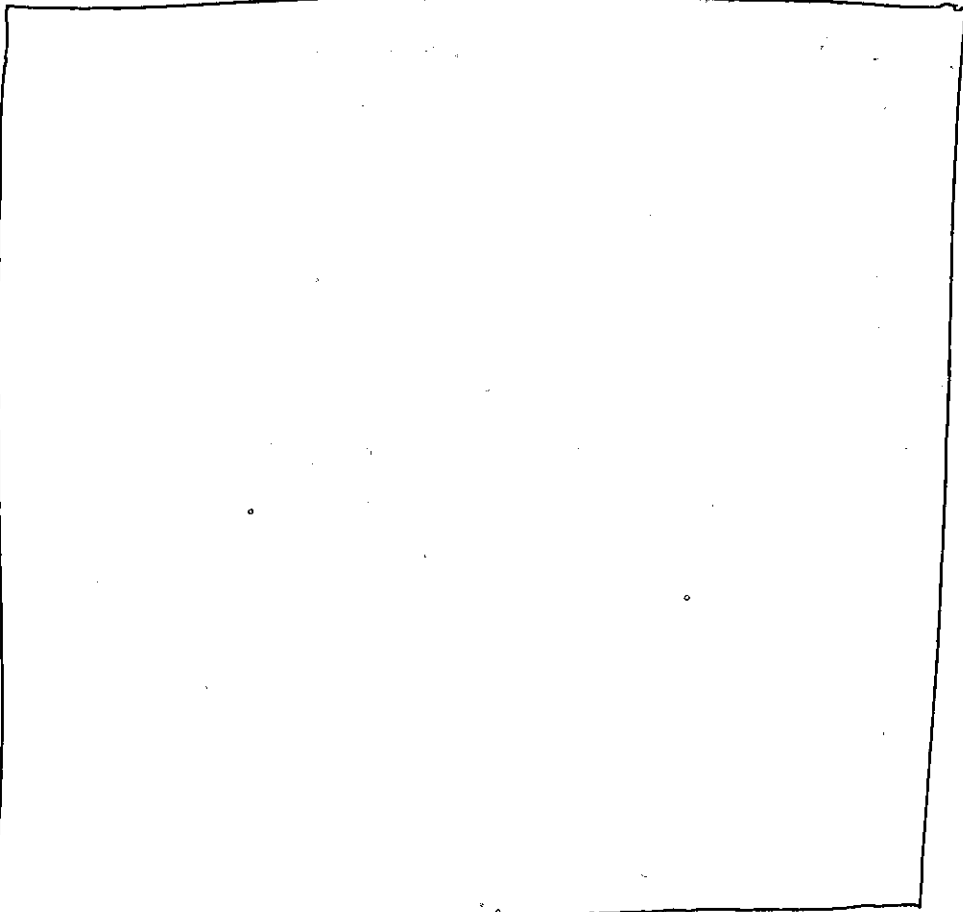
c. (U) Release of Information to Press and/or Public. Whenever an increased LERTCON is directed, the following guidance will apply:

(1) (U) Whenever possible, a basis for answering press queries will be provided concurrently with the LERTCON declaration.

(2) (U) If guidance is not provided, "RELEASE UNAUTHORIZED - PA GUIDANCE TO FOLLOW" will be used to answer all press and public queries.

(3) (U) Further public affairs guidance will be referred to/provided by the Assistant Secretary of Defense (Public Affairs).

e. (U) Classification. The following provides classification guidance:

(1) (U) UNCLASSIFIED

(a) (U) The terms DEFCON 1, 2, etc., or their exercise equivalents, when used alone; however, they will not be used in unclassified communications to announce a classified change in readiness.

(b) (U) The association of a DEFCON number or EMERGCON with the appropriate exercise term; e.g., DEFCON 3 - ROUND HOUSE or DEFENSE EMERGENCY - HOT BOX.

(c) (U) DEFENSE EMERGENCY and AIR DEFENSE EMERGENCY terms and situations.

(2) (U) CONFIDENTIAL. Review 20 years from date of classification, Reason: DOD 5200.1R, para 2-301c6.

(a) (U) The association of DEPCON numbers; e.g., DEPCON 3, or exercise terms, e.g., ROUND HOUSE, with the classified situations or descriptions for each DEPCON.

(b) (U) The association of DEFENSE EMERGENCY and AIR DEFENSE EMERGENCY, or exercise terms, with the classified description for each EMERGCN.

(3) (U) SECRET. Review 20 years from date of classification, Reason: DOD 5200.1R, para 2-301c6.

(a) (U) Unless otherwise directed, any reference to the fact that an actual or exercise change in readiness is being considered, is taking place, or has been accomplished.

(b) (U) The association of LERTCON codes or terms, whether actual or exercise, with specific actions listed in Part II.

(4) (U) LERTCON Action Checklists. The classification of LERTCON action checklists is a responsibility of the originator and will be classified according to content; however, applicable checklists should not be classified lower than CONFIDENTIAL.

g. (U) DEPCON Definitions. The following brief UNCLASSIFIED DEPCON definitions may be used:

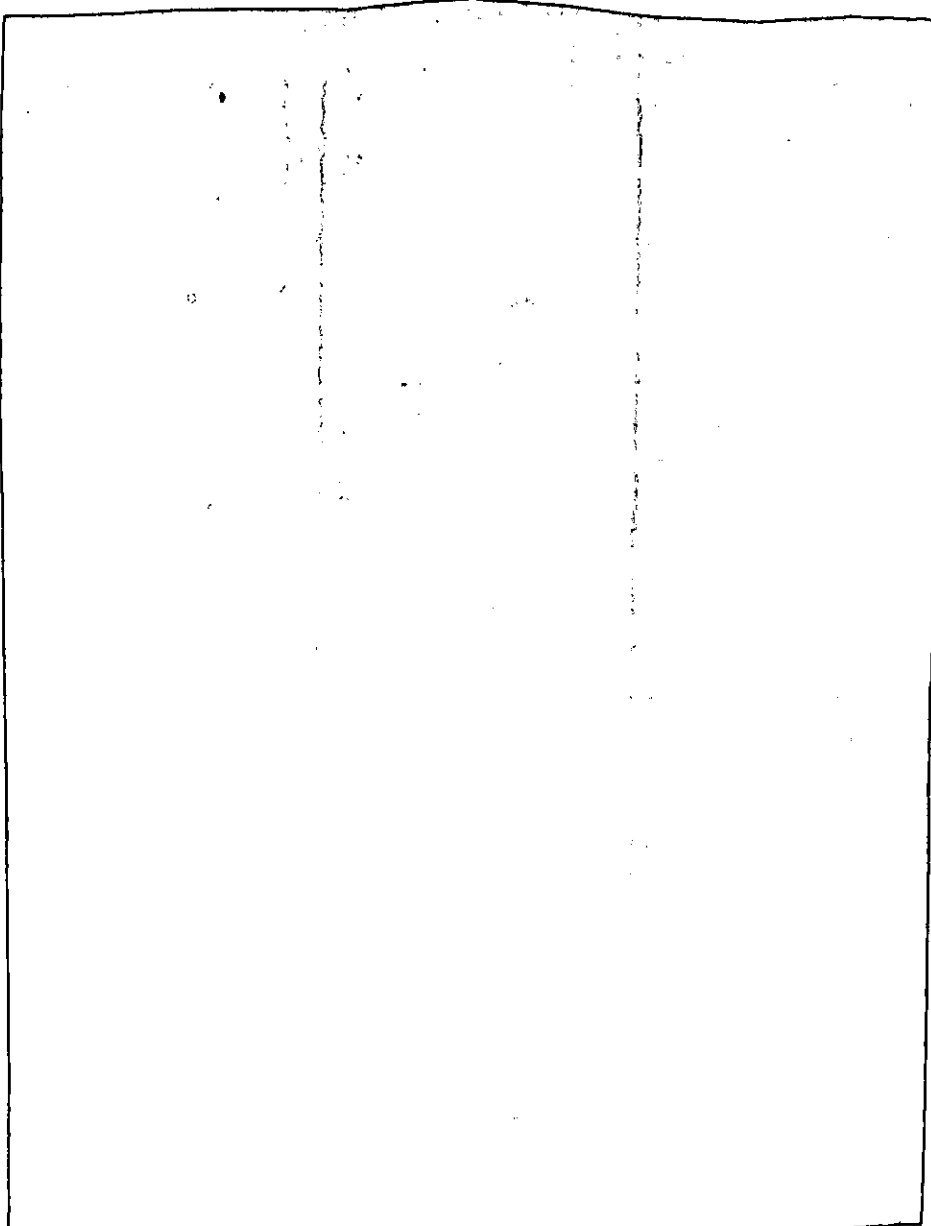

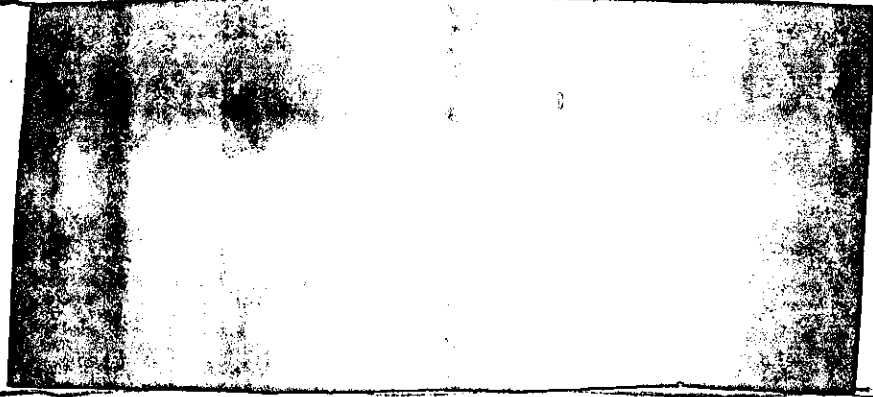

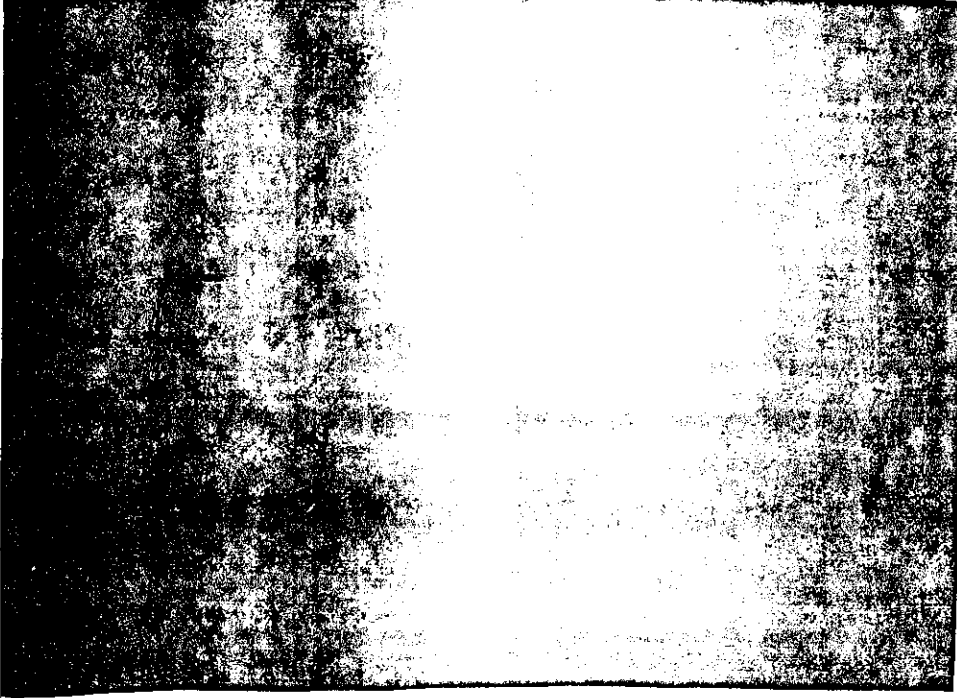

ALERT CONDITIONS (U)

1. (U) General. The Alert System of the Joint Chiefs of Staff consists of seven alert conditions (LERTCONS) which are divided into two subsystems, DEPCONS and EMERGENCY CONDITIONS (EMERGCONS), as follows:

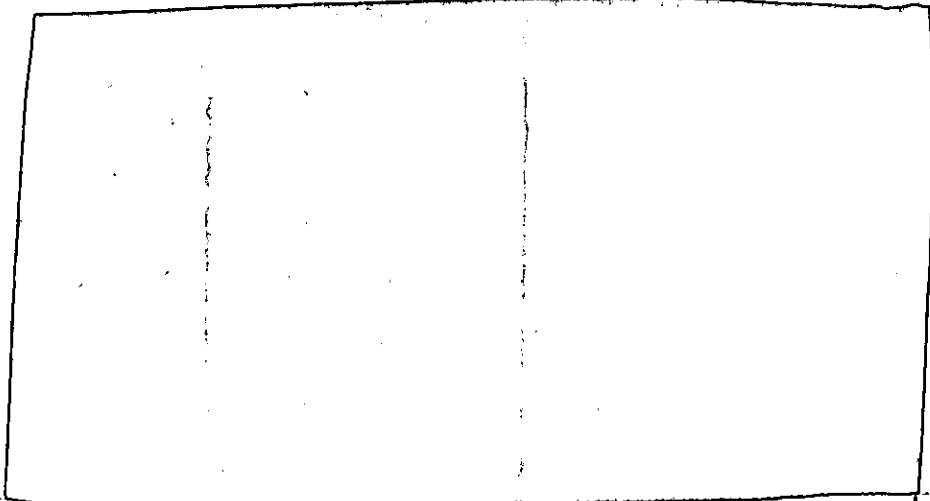
a. (U) DEPCONS consisting of five readiness conditions, with DEPCON 5 being the lowest and DEPCON 1 the highest.

b. (U) EMERGCONS consisting of two conditions:

(1) (U) DEFENSE EMERGENCY.

(2) (U) AIR DEFENSE EMERGENCY consisting of three attack warning conditions: Air Defense Warning RED; Air Defense Warning YELLOW; and Air Defense Warning WHITE.

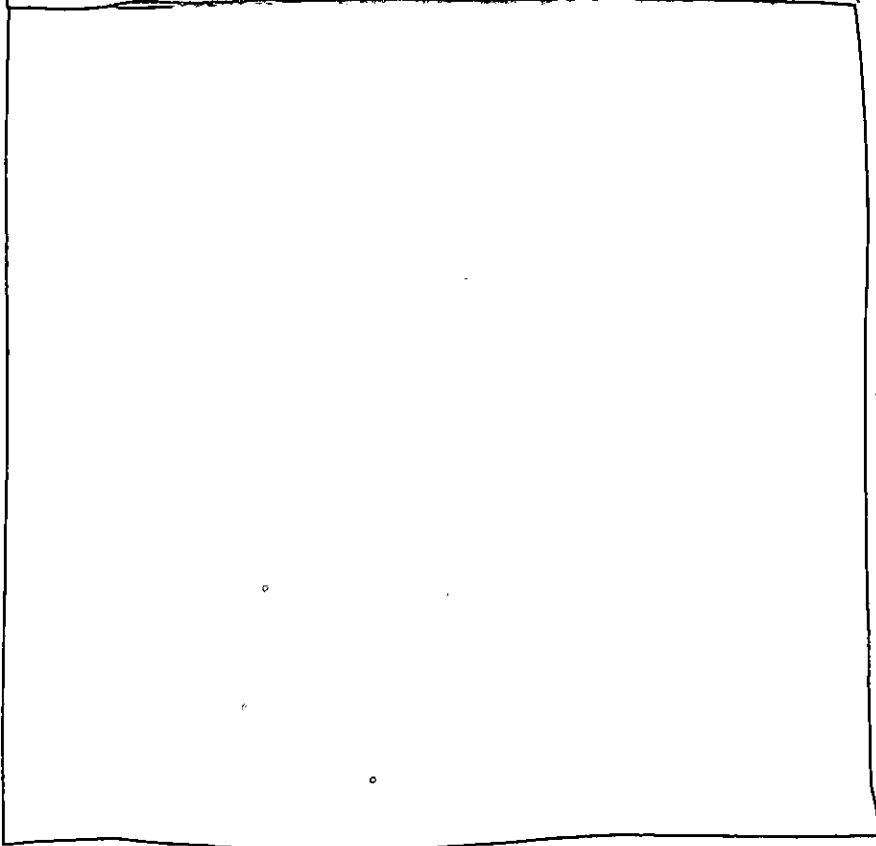

(3) (U) Air Defense Warning Conditions. Concurrent with the declaration of an AIR DEFENSE EMERGENCY, imminence of attack will be specified by one of the following conditions:

(a) (U) Air Defense Warning RED - (Exercise Term: "APPLE JACK"). Attack by hostile aircraft/missiles is imminent or taking place.

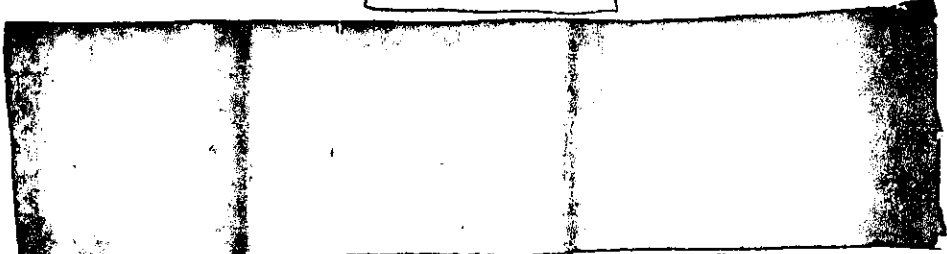
(b) (U) Air Defense Warning YELLOW - (Exercise Term: "LEMON JUICE"). Attack by hostile aircraft/missiles is probable.

(c) (U) Air Defense Warning WHITE - (Exercise Term: "SNOW MAN"). Attack by hostile aircraft/missiles is not considered immediately probable or imminent.

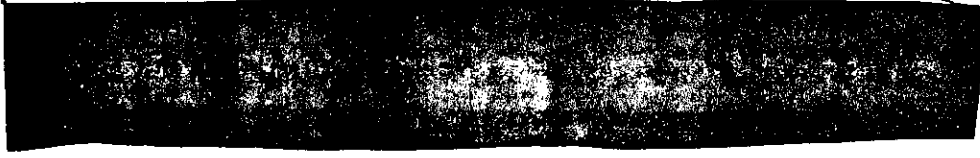

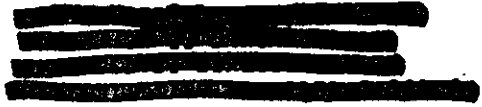

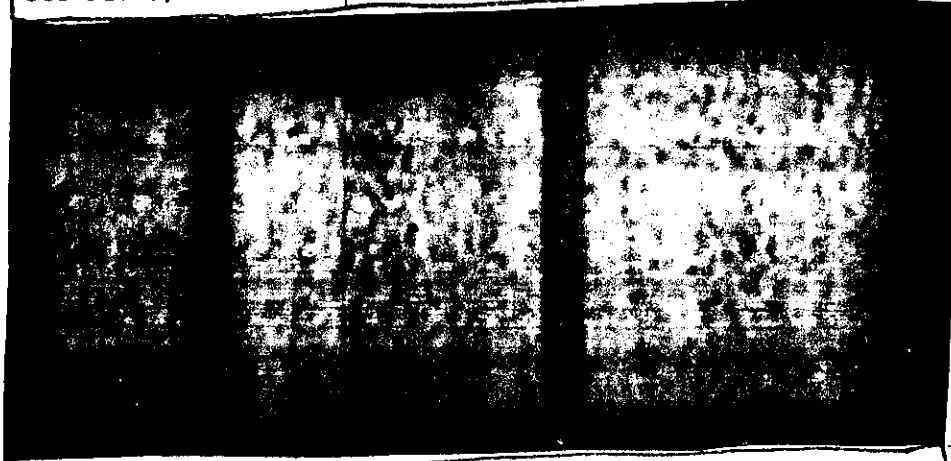

9. (U) Exercise Messages. Detailed instructions regarding the format and transmission of exercise messages are contained in Chapter 5 and in the Emergency Action Procedures of the Joint Chiefs of Staff, Volume I, General.

10. (U) Exercise Terms. An exercise term is a combination of two unclassified words used exclusively to designate a test, drill, or exercise. An exercise term is employed to preclude the possibility of confusing exercise directives with actual operations directives. The following UNCLASSIFIED exercise terms and meanings are assigned:

<u>Alert Condition</u>	<u>Exercise Term</u>
DEFCON 5	FADE OUT
DEFCON 4	DOUBLE TAKE

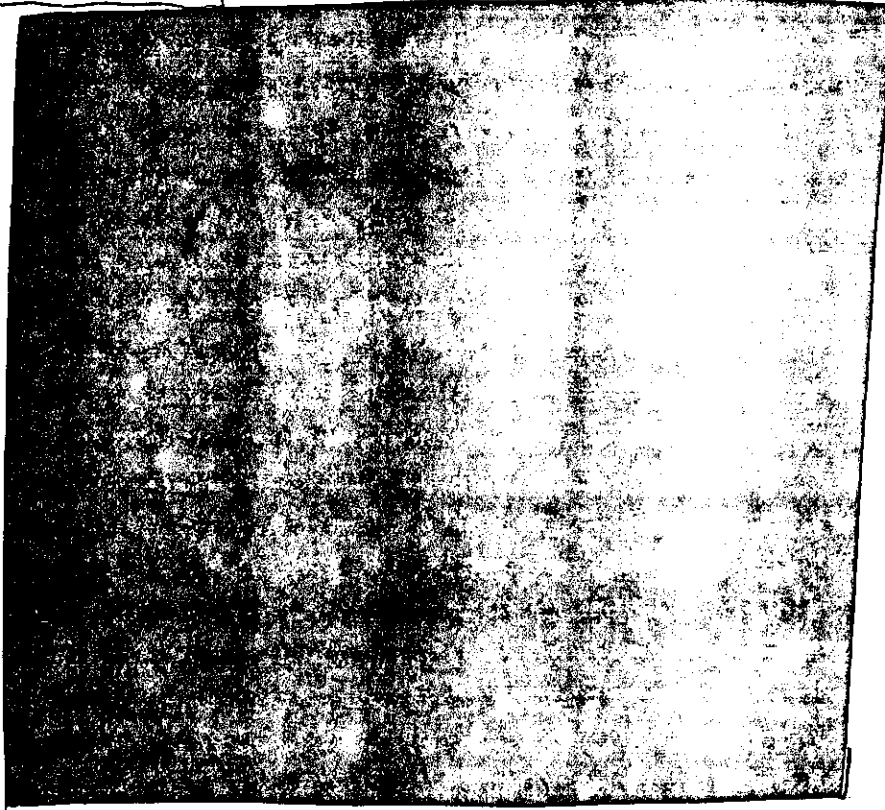

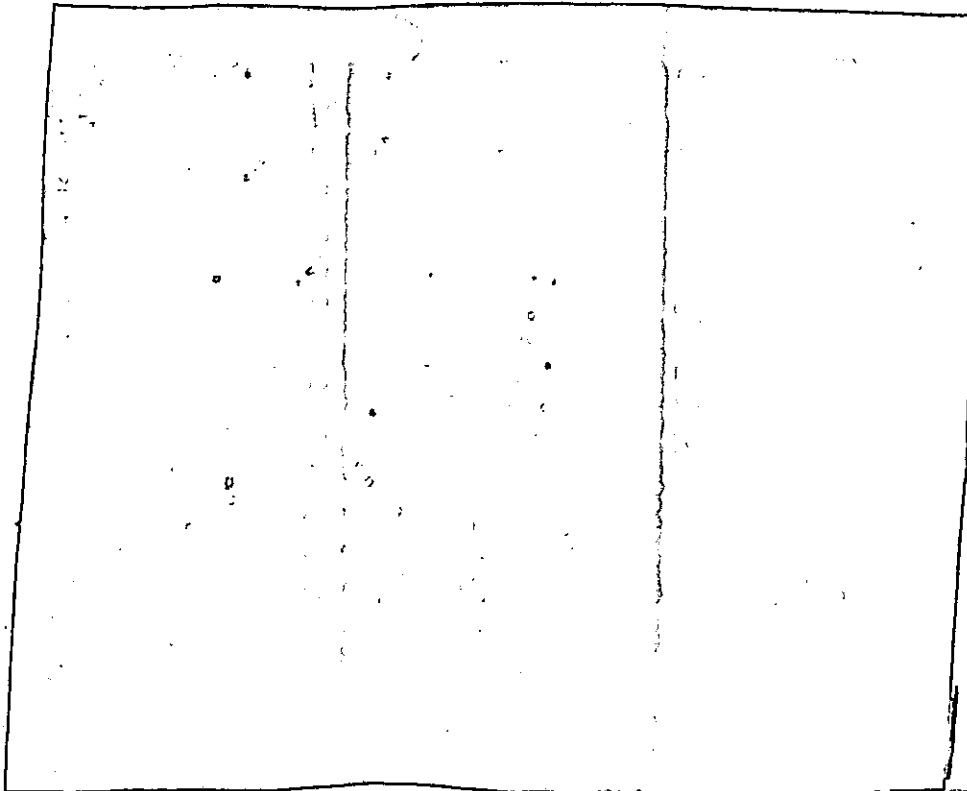

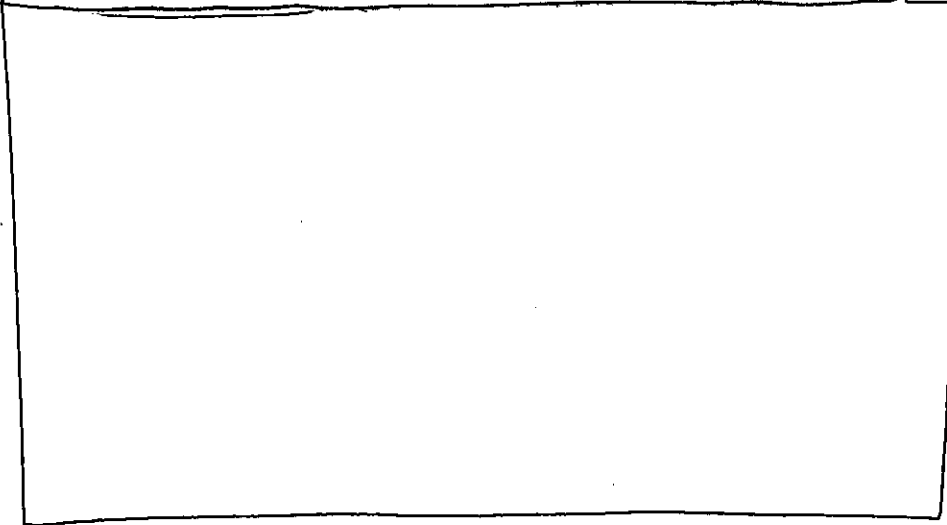

## CHAPTER SIX

## FACT SHEETS

1. General. Fact sheets provide additional information on JCS, CINC COMMON, and CINC UNIQUE Actions promulgated in Part II of the JCS Alert System.

2. Purpose. Fact sheets are designed to provide supporting information on each LERTCON action to assist decisionmakers when considering or responding to a request to increase the alert condition of US Forces. A fact sheet should be prepared for each action that may require additional information or amplification to properly portray what occurs when the action is implemented. Fact sheets are considered part of the JCS Alert System and will be programmed into the LERTCON Actions Data Base - WWMCCS when the Data Base is completed. Fact sheets should also be distributed by commands as hard copy printouts. A sample format for fact sheets is provided at Figure 6-1.

3. Preparation of Fact Sheets

a. JCS Action fact sheets are prepared and maintained for each JCS LERTCON action by the staff agency assigned primary responsibility. They provide information essential to understanding and implementing the particular action. All other supporting information is referenced in the fact sheet. Tabs are only used where example memorandums or sample implementers are appropriate. Fact sheets are submitted to the Chief, Emergency Actions Division, Operations Directorate, J-3, OJCS, semiannually NLT 15 March and 15 September in two copies, dated and labeled "Working Paper."

b. CINC COMMON Action fact sheets are prepared and maintained by the Emergency Actions Division, Operations Directorate, J-3, OJCS. They will be reviewed annually NLT 1 September, to be effective 1 October. CINC COMMON fact sheets will not be considered "working papers."

c. CINC UNIQUE Action fact sheets are prepared and maintained by the unified and specified commands. They should be limited to one page and contain sufficient information to provide a meaningful description of the action being implemented by the command. UNIQUE Action fact sheets should be reviewed annually and forwarded to Emergency Actions Division, Operations Directorate, J-3, OJCS, NLT 1 September, to be effective 1 October. CINC UNIQUE fact sheets will not be considered "working papers."

4. Contents. The requirement for fact sheets is satisfied only if they constitute a brief digest of policy, legislation, and cardinal procedures common to any situation. Therefore, all current and proposed fact sheets should be subjected to a critical review to insure their value and utility.
