SUBJECT: POW/MIA

ISSUE: Official U.S. Government Live-Sighting Position

FACTS:

-Since the fall of Saigon in 1975, the U.S. has received over 10,926 reports related to the POW/MIA issue, most of them from Indochinese refugees.

-Of the total reported, 1,249 are firsthand live-sighting reports.

-Some 90% of these reports have been resolved.

-Approximately 66% of these have been resolved through correlation with Americans who were in Indochina but have since returned to the U.S.

-Another 24% have been determined to be fabrications.

-However, some 129 or approximately 10% of the reports are unresolved and under continuing investigation in an attempt to confirm the information. Of these 129 reports, 69 pertain to individuals sighted in a captive environment and 60 pertain to individuals sighted in a non-captive environment.

-All reports pertaining to the POW/MIA issue are thoroughly investigated on a priority basis.

Official U.S. Government Live-Sighting Position Statement

Given the above circumstances, it would be irresponsible to rule out the possibility that live Americans are still being held. Thus, the U.S. Government's position is:

"Although we have thus far been unable to prove that Americans are still detained against their will, the information available to us precludes ruling out that possibility. Actions to investigate live-sighting reports receive and will continue to receive necessary priority and resources based on the assumption that at least some Americans are still held captive. Should any report prove true, we will take appropriate action to ensure the return of those involved."

SUBJECT: POW/MIA

ISSUE: Principal Source of POW/MIA Information

-At the present time, the principal source of POW/MIA information available to the U.S. Government is Indochinese refugees. The continued absence of political stability in the Southeast Asian region has resulted in an unabating flow of refugees from one or more of the three countries of primary concern; Vietnam, Laos and Cambodia. Interviews have been conducted with numerous refugees by both government and private individuals. Reported sightings of Americans by these sources continue to reach Defense Intelligence Agency (DIA) from any number of different sources.

-Since the fall of Saigon in 1975, DIA has acquired 10,926 reports pertaining to Americans in Southeast Asia. These reports are categorized as follows:

Crashsite/Gravesite/Dog Tag	6,710
Firsthand Live Sighting	1,249
Hearsay	1,957
Reeducation Camp Info/Other	1,010

-A misinformation program has been associated with recent reporting on missing Americans. Those reports all pertain to the alleged recovery of remains and identifying data (i.e., dog tags).

-DIA has received 4,238 "dog tag" reports pertaining to 3,087 individuals.

--Of those named, 89% returned alive.

--Remains have been recovered and identified on 7% of those named.

--Only 4% of the individuals named are unaccounted for.

-The U.S. Government position is to accept information on the POW/MIA issue from any and all sources. All reports pertaining to the POW/MIA issue are thoroughly investigated.
