1. JDA POLICY FOR SSC MEETING:
 (NINON KEIZAI, 8 AUG) - BY THE 7TH, THE JDA HAD DETERMINED A BASIC POLICY TO BE SHOWN TO THE U.S. AT THE FORTHCOMING SSC MEETING IN HAWAII. ACCORDING TO THE POLICY, THE JAPANESE SIDE WILL PRESENT TO THE U.S. SIDE AT THE MEETING THE JFY83-87 DEFENSE PROGRAM APPROVED RECENTLY BY THE NDC AND EMPHATICALLY EXPLAIN THAT MOST OF THE DEFENSE BUILDUP GOALS SET IN THE 1975 NATIONAL DEFENSE PROGRAM OUTLINE CAN BE ATTAINED THROUGH THE 5-YEAR DEFENSE PROGRAM. BESIDES, THEY WILL CONVEY TO THE AMERICAN COUNTERPART THE GOJ INTENTION (1) TO EXERCISES AND JAPAN-U.S. STUDY OF A FAR EAST EMERGENCY. REGARDING THE U.S. PROPOSED MILITARY TECHNOLOGICAL COOPERATION, THEY WILL EXPLAIN THAT JAPANESE GOVERNMENT OFFICES ARE IN HASTE FOR COORDINATION OF THEIR VIEWS ON THE MATTER, SO THAT THEY CAN DRAW OUT A CONCLUSION BEFORE JDA DIRECTOR GENERAL ITO WILL VISIT THE U.S. IN AUTUMN.

2. MILITARY TECHNOLOGICAL COOPERATION ISSUE:

 COOPERATION PROBLEM, THE GOVERNMENT HAD DETERMINED BY THE 82H A PLAN TO APPROVE OFFER OF MILITARY TECHNOLOGIES FROM JAPAN TO THE U.S. EVEN WHEN THE LATTER GETS INVOLVED IN A DISPUTE WITH A THIRD COUNTRY, IN CASE THE DISPUTE WILL AFFECT THE SECURITY OF JAPAN. THE GOJ 3-POINT ARMS EMBARGO RULES PROHIBIT ARMS EXPORT TO A DISPUTING COUNTRY, BUT THE GOVERNMENT DETERMINED THE ABOVE POLICY IN LIGHT OF THE JAPAN-U.S. SECURITY TREATY. HOWEVER, IT WILL NOT APPROVE CONTINUED OFFER OF SUCH TECHNOLOGIES WHEN OR AFTER THE U.S. GETS INVOLVED IN A DISPUTE HAVING NO RELATION WITH JAPAN. THERE STILL IS A WIDE DISCREPANCY AMONG GOVERNMENT OFFICES CONCERNED IN VIEWS ON CONCRETE TYPES OF DISPUTES IN WHICH JAPANESE MILITARY TECHNOLOGICAL COOPERATION WITH THE U.S. CAN BE CONTINUED. THE FOREIGN OFFICE AND JDA HOPE TO PERMIT SUCH COOPERATION AS WIDELY AS POSSIBLE, WHEREAS THE MITI IS ASSUMING STRICT POSTURE TOWARD THE MATTER FROM THE VIEWPOINT OF THE ARMS EMBARGO RULES.
