2. (U) Responsibilities. Every individual in an NMCS or SIOP command center responsible for the preparation of JCS emergency action messages must be completely familiar with the procedures contained in the EAP-JCS, and they will be certified in writing by the appropriate command center director. Command center training and evaluation programs will be developed to ensure that individuals charged with the preparation and transmission of emergency action messages are qualified in this task. These individuals and programs are subject to review by the OJCS.

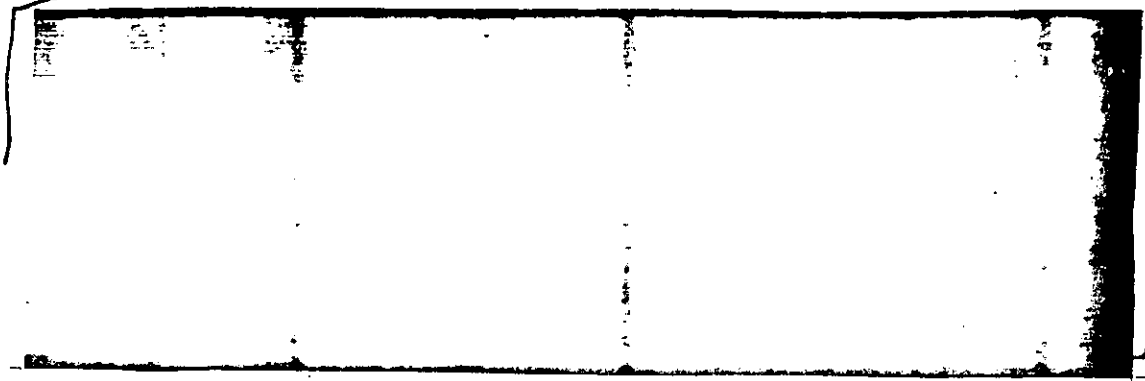

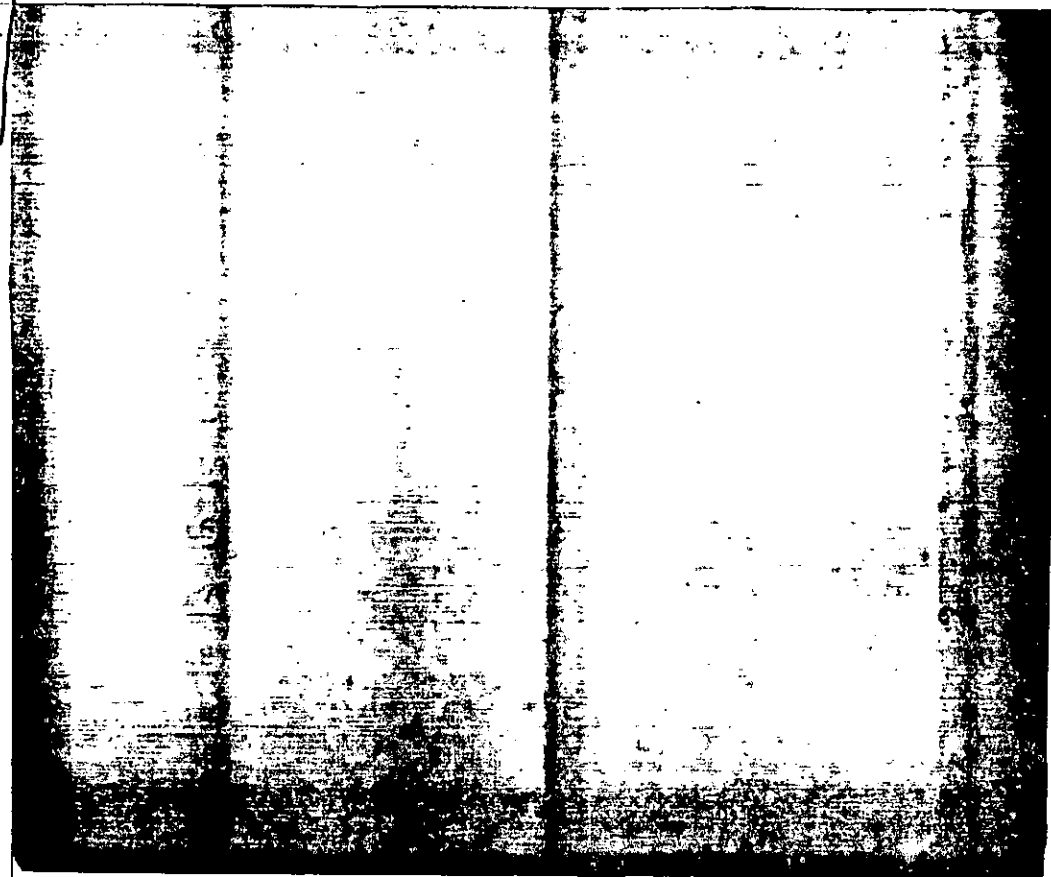

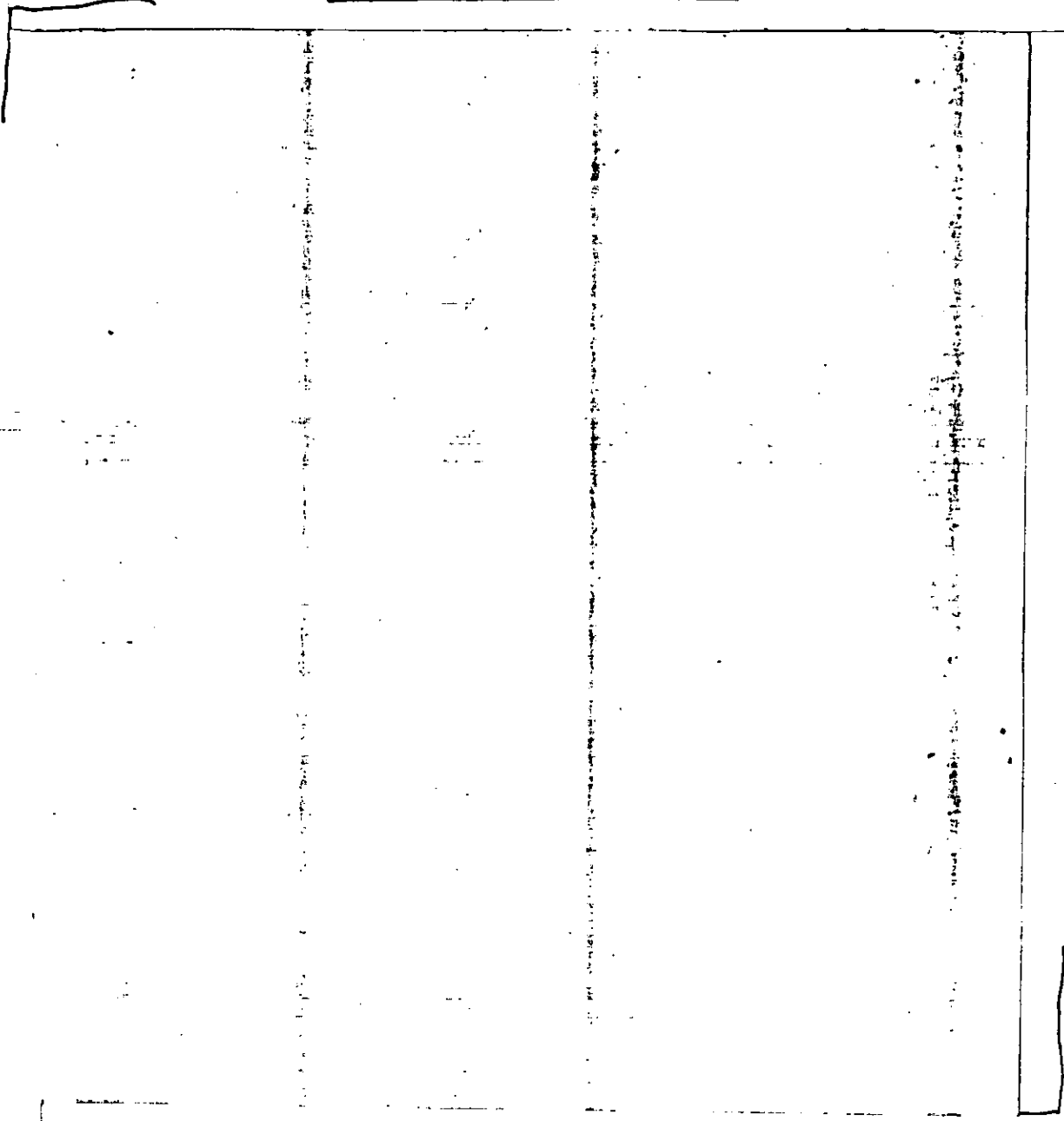
f. (U) Reference Times for SIOP Execution Messages
