Dear Mr. Loeffler:

This responds to Ms. Jennifer K. Harbury's request under the Freedom of Information Act dated 9 January 1995. Therein she requested records concerning Efrain Bamaca Velasquez and related matters from 1 January 1992 to the present. A search of DIA's systems of records located 284 documents. Of these, 244 have been referred to other government agencies for their review and direct response to you as they did not originate with DIA.

Only the relevant portions of these documents have been reviewed for a determination of their releasability. In addition, the unclassified data is also furnished. Should Ms. Harbury wish the non-responsive portions of these documents, please submit a request for this material. The new request will be placed in the same order for processing as the original request.

Upon review, it has been determined that some portions of 38 documents are not releasable. The information withheld is exempt from release pursuant to 5 U.S.C. 552 (b)(1), (b)(2), and (b)(6), Freedom of Information Act. Subsection (b)(1) applies to information properly classified under the criteria provided by Executive Order 12356. Subsection (b)(2) applies to information which pertains solely to the internal rules and practices of the Agency. Subsection (b)(6) applies to information which if released would constitute an unwarranted invasion of the personal privacy of other individuals. Portions of six of the documents contain information furnished by other government agencies and have been referred to those agencies for their review. Upon the return of the documents to DIA, any reasonably segregable information will be furnished to you. Except as noted above, all reasonably segregable portions of the documents are attached hereto.

All substantive portions of the remaining two documents are not releasable. The portions withheld are exempt from release pursuant to 5 U.S.C. 552 (b)(1), (b)(2), and (b)(6) Freedom of Information Act. Portions of one of the documents contain information furnished by another government agency and have been referred to that agency for their review. Upon the return of the document to DIA, any reasonably segregable information will be furnished to you. At this time, there are no reasonably segregable portions of this exempt material.

MG GONZALEZ WAS REFERRING TO SEVERAL LOCAL PRESS ARTICLES ON 941115 WHICH QUOTED STATE DEPARTMENT PRESS SPOKESPERSON CHRISTINE SHELLY AS DECLARING THAT THE USG NOW BELIEVED, BASED ON INFORMATION FROM DISTINCT SOURCES, THAT BAMACA WAS TAKEN PRISONER BY THE GT ARMY, THAT HIS WOUNDS WERE NOT LIFE THREATENING, THAT THE USG HAD ALWAYS WORKED UNDER THE PREMISE THAT BAMACA COULD STILL BE ALIVE, BUT THAT THERE IS NO INFORMATION TO INDICATE THAT HE IN FACT WAS ALIVE BEYOND THE FIRST FEW WEEKS OF HIS CAPTURE.)

THE USG HAS CREDIBLE INFORMATION THAT EFRAIN BAMACA WAS TAKEN CAPTIVE BY THE GT ARMY IN MARCH 1992. BAMACA HAD BEEN WOUNDED, BUT HIS INJURIES WERE NOT BELIEVED TO BE LIFE-THREATENING.

MG GONZALEZ THAT THIS INFORMATION RAISES DOUBTS ABOUT THE GT ARMY'S COMMITMENT TO RESPECT BASIC HUMAN RIGHTS, IN THIS CASE THOSE OF A CAPTURED GUERRILLA. THIS IN TURN CASTS A SHADOW OVER THE USG RELATIONSHIP WITH THE GOG AS A WHOLE, AND WITH THE GT ARMY SPECIFICALLY.






SUMMARY: (6.4HF) URNG REPORTEDLY HAS A UNIT INSIDE THE CAPITAL AND IS PLANNING TO STRIKE A GT MILITARY TARGET. NO INFORMATION EXISTS TO INDICATE AN ATTACK AGAINST U.S. INTERESTS. GT ARMY D-2 CONCERNED ABOUT SAFETY OF AMCIT JENNIFER HARBURY.

TEXT: 1. 40-47

THE D-2 HAS INFORMATION THAT A UNIDENTIFIED GROUP (NFI) FROM THE GUATEMALAN NATIONAL REVOLUTIONARY UNITY (URNG) IS CURRENTLY INSIDE THE CAPITAL CITY. FURTHER, THE D-2 HAS INFORMATION THAT THE GROUP IS PLANNING TO ATTACK A GUATEMALAN MILITARY TARGET ON 20 OCTOBER 1994 -- THE FIFTIETH ANNIVERSARY OF THE OCTOBER 1944 REVOLUTION.

THE D-2 IS CONCERNED FOR THE SAFETY OF AMCIT HUNGER STRIKER JENNIFER HARBURY AND ASKED THAT THE U.S. EMBASSY DO WHAT IT CAN TO PERSUADE HER TO LEAVE THE AREA IN FRONT OF THE NATIONAL PALACE FOR THE ENTIRE 20TH OF OCTOBER "CELEBRATION," INCLUDING THE EVENING OF 19 OCTOBER.







(CINF) NAME: Colonel Julio Alpirez, Army.

(CONF) POSITION: Second Commander, Military Zone 10, Jutiapa.

(SAIPANN) SIGNIFICANCE: Colonel Alpirez is currently at the heart of a human rights controversy. Alpirez was assigned to command billets in the areas where a US citizen was killed in 1990 and where guerrilla leader Efrain Bamaca disappeared in 1992. Recent allegations of ties to the CIA have made him even more controversial. Although no tangible evidence is available, many observers believe Alpirez was involved at least in the coverup in the first incident.

(SAIF) The colonel is a probably a kaibil, a special forces officer. (Although no specific training for this elite group is listed for Alpirez, it nonetheless is likely because he served two tours at the Kaibil Training Center.) He has a reputation as an excellent intelligence officer. He has served in the D-2 office and as the head of the presidential security team for former President Cerezo. Alpirez is also known for having served successfully in difficult and remote areas of Guatemala.

The colonel was a target of criticism for the dissident group, "Officers of the Mountain," in 1988. In 1993, the Guatemalan National Revolutionary Union (UNRG) also demanded that Alpirez be investigated for human rights abuses.

(CINE) POLITICS: Alpirez has strong anticommunist views. He was considered to be pro-United States prior to recent events.

(CANY) PERSONAL DATA: Julio Roberto Alpirez was born 5 October 1950 in Guatemala City. He is of medium build (5'5", 145 lb) with light brown eyes and blond hair. Alpirez has a scar on his left shoulder. He has an extroverted personality.

ALL THE OFFICERS APPEARED TO UNDERSTAND THE POLITICAL NATURE OF THE PROBLEM AND DID NOT EXPRESS RESENTMENT FOR THE CANCELLATION OF FY 95 IMET AGAINST (INTERNATIONAL MILITARY EDUCATION AND TRAINING) TO GUATEMALA. SPOKE WITH TWO (0,415)] TEXT: 1. MID-GRADE GUATEMALAN ARMY OFFICERS CONCERNING A WIDE RANGE OF ISSUES FACING THE OFFICER CORPS. ONE OFFICER BEGAN THE DISCUSSION BY BRINGING UP THE QUESTION OF USG SUPPORT FOR AMCIT JENNIFER HARBURY AND HER QUEST FOR EFRAIN ((BAMACA)) VELASQUEZ. THIS OFFICER WAS CONVINCED OF OFFICIAL USG SUPPORT FOR MS. HARBURY BASED UPON THE VISITS MADE TO THE PLAZA IN FRONT OF THE NATIONAL PALACE WHERE SHE STAGED HER HUNGER STRIKE DURING THAT THEIR OCTOBER/NOVEMBER 1994. PERCEPTION OF THE OVERT SUPPORT GIVEN TO MS. HARBURY HAS HAD A NEGATIVE, ANTI-USG BACKLASH AMONG MANY, IF NOT MOST, OFFICERS, AS THEY VIEW HER MARRIAGE A SHAM AND THE ENTIRE EPISODE ORCHESTRATED BY THE URNG (GUATEMALAN NATIONAL REVOLUTIONARY FOR ANOTHER --CITE IIR PERSPECTIVE ON A GROWING ANTI -AMERICAN SENTIMENT WITHIN THE OFFICER CORPS.)
