Reference is made to Department of State draft negotiating paper, TCT D-5/lb, dated 28 December 1951, subject "Korea".

The Joint Chiefs of Staff concur generally in this paper, subject to certain changes which, among other things, bring the paper into consonance with NSO 118/2. These changes are contained in the attached copy of Joint Chiefs of Staff comments, with which I concur.

In addition, the Department of Defense would like to suggest that the footnote on page 5 be expanded to read in substance as follows; for the more complete information of the President.

"The question of a naval blockade is still under consideration in the National Security Council. The second sentence in paragraph 5 above is therefore all that can be said at the present time in a paper reflecting a national position. However, Defense feels strongly that we should press for the adoption by the other major powers concerned of the second alternative in that sentence and only settle for the first alternative if the second proves impossible of attainment. This is in contrast with the views of the Department of State that the first is the preferable alternative."

Reference is made to Department of State draft negotiating paper TCT D-2/4b, dated 30 December 1951, "Exchange of Technical and Scientific Information Other than Atomic Energy Matters."

The Department of Defense, from the military point of view, concurs generally in the above paper. It recommends, however, that for the sake of emphasis, the substance of the following be added at the end of the final paragraph under the heading Position to be Presented:

"However, as I have previously stated, we are most reluctant to extend the release of secret data until both our countries are operating under the Principles and Standards of Security drawn up in Paris last summer."

The Department of Defense notes that the above paper omits the section headed Discussion which was part of the previous paper (TCT D-2/4a) from which the present paper was derived. The Department of Defense is of the opinion that the material contained in the Discussion would be useful in the current version of the position paper and suggests that it be included.

Reference is made to Department of State draft negotiating paper TCT D-6/5a, dated 2 January 1952, entitled "The Burden Sharing Aspects of the TCC Report."

The cover page of the draft states that, "This paper has been further revised in accordance with the sense of the meeting between State Department representatives and the Joint Chiefs of Staff on January 2. It is now approved at the official level." At the meeting between State Department representatives and the Joint Chiefs of Staff on 2 January 1952, it was the understanding of the Joint Chiefs of Staff that they would be given opportunity to comment on this paper before approval on the official level.

The Joint Chiefs of Staff are now studying the Temporary Council Committee (TCC) Report as well as the problem of burden sharing principles. Their study, however, probably will not be completed prior to the Truman-Churchill meetings. Accordingly, the Joint Chiefs of Staff must reserve their position on the findings in the TCC Report having military implications.

In the light of statements under the heading Position to be Presented in the Department of State draft negotiating paper entitled "Reorganization of NATO" (TCT D-6/3b, dated 28 December 1951) to the effect that the TCC recommendations represent a point of departure and should be considered within NATO at an early date, and in any event in view of the considerations set forth in paragraph 3 above, the Joint Chiefs of Staff recommend that the views in the subject paper be changed to read as indicated in paragraph 4 of their memorandum which is enclosed herewith.

I concur in the views of the Joint Chiefs of Staff.
