INDICTMENT

Violations:

18 USC §554(a)  
 26 USC §5861(d)  
 26 USC §5871

(Attempted Unlawful Export;  
 Possession of an Unregistered  
 Firearm)

15 THE GRAND JURY CHARGES:

16 COUNT 1

17 From on or about April 30, 2010, to June 3, 2010, at or near Tucson, in the  
 18 District of Arizona, CHARICE CHAUNTEL GAEDE, EMMANUEL BERMUDEZ  
 19 VASQUEZ, and ELIAS BERMUDEZ VASQUEZ, knowingly attempted to export and send  
 20 from the United States any merchandise, article, or object contrary to any law or regulation  
 21 of the United States, and received, concealed, bought, sold, and in any manner facilitated  
 22 the transportation, concealment, and sale of such merchandise, article or object, prior to  
 23 exportation, knowing the same to be intended for exportation contrary to any law or  
 24 regulation of the United States: to wit; CHARICE CHAUNTEL GAEDE, EMMANUEL  
 25 BERMUDEZ VASQUEZ, and ELIAS BERMUDEZ VASQUEZ bought, concealed, and  
 26 facilitated the transportation of 1,500 rounds Russian (Tula) .30 Carbine ammunition, 4,000



1 rounds Wolf 7.62x39mm ammunition, 2,000 rounds Wolf .45 ACP ammunition, and 2,000  
2 rounds Wolf .223 caliber ammunition, knowing said ammunition to be intended for  
3 exportation, and attempted to export said ammunition; in violation of Title 18, United States  
4 Code, Section 554(a).

5 **COUNT 2**


6 On or about June 3, 2010, at or near Tucson, in the District of Arizona,  
7 CHARICE CHAUNTEL GAEDE and EMMANUEL BERMUDEZ VASQUEZ possessed  
8 a firearm, that is; a Savage 12 gauge shotgun, no serial number, having a barrel less than  
9 18 inches, that is, approximately 12.5 inches; not registered to CHARICE CHAUNTEL  
10 GAEDE or EMMANUEL BERMUDEZ VASQUEZ in the National Firearms Registration  
11 and Transfer Record, in violation of Title 26, United States Code, Sections 5861(d) and  
12 5871.
