Charles Grassley wrote to Attorney General Eric Holder regarding guns allegedly used in the Dec. 14 shootout near the Arizona-Mexico border. Border Patrol Agent Brian Terry died in the shootout.

DOJ had earlier told Grassley that the allegation was false. Grassley's letter -- see the attachment -- says he has documents to back up his assertion that two AK-47 variants found at the shootout scene had the same serial numbers as two guns bought in an ATF operation by an alleged straw buyer.
