In response to your request for additional information on this case and the issue regarding the 6 Draco pistols, I encourage you to read the following e-mails, case proposal, op plan (1 of 3) and other documents. Once you've done that I'll be happy to discuss. You will clearly see that contrary to his statements on national TV where he states he was "forced" to "walk" guns, something he was "dead set against" and "vehemently complained about". Read the attached e-mails, and there are a lot more like it in which you'll clearly see the attitude that ATF had when dealing with a supervisor clearly asking him to document things as required by the Orders. We'll have these and much more on Monday.

E-mail dated May 12 – response to a request from GS ATF asking SA ATF for some basic information on a ATF he was proposing. At this time there were only 8 guns allegedly trafficked and the primary purpose was to gain information on some alleged ATF Obviously we want to know what he wanted to do with this, thus the strategy PROPOSED BY ATF	
E-mail dated May 27 - what he is saying he w	- SA ATF prepared a proposed ATF which he REQUESTED as forced to do.
E-mail dated June 4 – response to a request from GS ATF to properly place currency into custody. SA ATF had received several hundred dollars from the target in this case to purchase firearms and had this in his desk, unsecured. GS ATF told him to place it into evidence as required. SA ATF made the comment that GS ATF was trying to "set him up" to which GS ATF told him nothing could be further from the truth, just abide by the Orders.	
E-mail June 7 – response to a request from GS ATF to prepare a short synopsis and status of the case for ASAC Needles (after a request from me to both ASACs) in order to brief the Director who was coming to town for the GRIT.
