*At your request, I am forwarding the following information from ATF on when GOM personnel were briefed on Fast and Furious.*

The PGR rep in Phoenix, Carlos Luque Ordonez, was briefed by the ATF regional director in Phoenix in December 2009, when the case first began to develop. About every month after that the ATF Regional director briefed him on the status.

On December 3, 2010 at a "GC Armas" meeting in Phoenix, the case agent and supervisor briefed Rodrigo Archundia, head of UEITA.

On December 15, 2010 ATF again briefed Mr. Archundia and his prosecutorial team in Mexico City.

UEITA prosecutors Sacnite Ruiz and Amando Lopez Hernandez went to Phoenix for the

arrests under Fast and Furious on January 25. ATF included them in the operational briefing the day prior to arrests.

UEITA prosecutors were allowed to interview arrested individuals and they obtained one confession. The Phoenix PGR rep was present for all interviews conducted by UEITA of the arrested persons.

On January 25, the US Embassy issued the following press release on the arrests and the case.
