I have an exact breakdown of each seizure that I can provide once the USAO authorizes release per discovery process (hopefully next week) but I can tell you that most were pre-identification of suspects in the case or in other words before we were "onto them". Some however were after this but in those cases these were firearms that were purchased "legally" and thus we had no legal basis to seize without corroborating evidence of a straw purchase haven taken place. This also includes firearms that went from the store to someone's home and after a period of time (weeks and months) showed up in Mexico. At NO time did we follow a load of guns from the store to the border and "allow them to cross".
