Here are the #s we used in the letter back to Chairman Smith:

*For calendar year 2009, the Mexican government reported 9,635 murders in Mexico resulting from organized crime and drug trafficking – an increase of 50% from the number of murders in 2008 and three times the 2,837 killed in 2007.*

And here are numbers from a broader time period:

*From December 2006 through July 2010, the Mexican government reported almost 30,000 deaths in Mexico resulting from organized crime and drug trafficking, with 9,635 murders in 2009 alone.*

Hope these are helpful. If you need anything else, just let me know.
