Of the 2160 pages disclosed in our OIG response, 106 are public documents. These documents are the Fast and Furious press release (with Attached Indictment and Map); the **ATF** complaint filed on 12/16/10; the first **ATF** Indictment filed on 1/11/11; the second **ATF** Indictment filed on 1/19/11; and the Ortiz sisters Indictment filed on 9/14/10.
