During former acting Director Sullivan's last Senate appropriations hearing he offered for the record to provide info to members-- we can pull that testimony. Can't remember which FY it was right now but he said the raw data could be made available but what they couldn't do was make assumptions based on the data.

We have objected (though not officially) in the past to codifying that request in bill language and prevailed.

**Congressional Oversight of ATF** – The amendment would allow oversight committees (House and Senate Appropriations, Judiciary, Oversight/Homeland) to request gun trace data from ATF for the purposes of providing oversight of executive branch agencies. Under existing appropriations restrictions collectively known as the Tiahrt Amendment, the ATF cannot release any gun trace data, even to Congress, which has hindered the Congressional investigation into the ATF's Operation Fast and Furious.
