Ask 5 questions, including which ATF and DOJ employees had access to the shared drive.

8. Issa and Grassley 7/11/11 Incoming re: Document Requests of FBI Agents

Requests records of 8 individuals, and asks 7 questions re: paid FBI informants and 7 questions re: Zapata investigation.
