E. Based on existing trace data and case file information, how many of the US firearms recoveries are associated with a Violent Crime?

F. Based on existing trace data and case file information, how many of the MX firearms

recoveries are associated with a Violent Crime?

G. Are all unrecovered "suspect" firearms purchased by the suspect(s) entered into the Suspect Gun database?

H. Did ATF conduct surveillances/observe suspect(s)' firearms purchase transactions?

I. How many firearms transactions were subject of physical surveillances?

J. How many firearms were associated with these surveillances (number of "eyes-on" firearms)?

K. Did ATF observe any subsequent transfers of firearms to third parties?

L. Were any such third parties identified timely and if so, were any prohibited persons?

M. If third party transfers were observed, did contact or interdiction occur? (Specifically address any transfers to known prohibited third parties in which interdiction did not occur.)
