Jason, Mr. Newell seems to make reference to the ROIs to demonstrate how hard the agents were working during a particular time period, rather than with regard to the actual contents. Since we haven't yet finished our review, we can't answer your other questions about the ROIs at this point.

We've checked with Mr. Pelletier, who has advised that the Department did not provide him with ROIs or other documents. He noted that there was a Fox News article on 9/21 that states that he had access to case materials, but in fact, he had been speaking about a memorandum that he read on the New York Times website.

Finally, you asked about references that Mr. Newell made in his interview to events in 2007, when firearms crossed the border into Mexico. We have provided you with documents on such events with the following bates numbers: HOCR ATF 1905-1911; HOCR ATF 2239-2259; HOCR ATF 2269; HOCR ATF A 1515-1518; HOCR ATF A 2460-2464; and HOCR ATF A 2468-2469.
