EXPLANATION OF EXEMPTIONS

On April 10, 1956, Brigadier General Willard S. Paul, Deputy Director for Plans and Readiness, Office of Defense Mobilization (ODM), advised Mr. Bartlett of the Liaison Section that an invitation will be extended on either April 12 or 13 for the Director to attend a briefing by the President on ODM "Plan C." This briefing will be held at 2:30 p.m., April 19, at either the White House or the Executive Office Building. Only the heads of agencies and departments with their top deputies will be invited.

General Paul explained that "Plan C" will go into effect after a war has begun in which the U.S. is involved or may become involved and prior to an actual attack on the U.S. itself. General Paul said that no information has been furnished to any of the agencies of Government on the subject matter, and that the President's briefing will be the first information given out. The President will ask those attending the briefing to pass the information on within their agencies on a need-to-know basis.

"Plan C" is the designation for the above set of circumstances. There is no Plan A or B in existence. "Plan D" however, is the relocation of Government to their relocation sites during or prior to an actual attack on the U.S. This Plan will be tested during "Operation Alert, 1956," now scheduled for July 20 through 26, 1956.

There will be nothing for the Director to discuss at this briefing. There is no information in the Bureau's files on "Plan C."

I. RELOCATION

PLAN C

The Bureau relocation site is a going concern. Emergency communications equipment, the necessary furniture, office supplies, and other items of equipment are now at Quantico. Each field office has selected a relocation site.

- (a) Evacuees One hundred and eighty-four officials, supervisors, and clerical employees have been selected to operate the Bureau relocation site for the first 24-48 hours. Thereafter, additional employees will be called in as needed. A similar plan has been developed by each field office.
- (b) Transportation If an evacuation is ordered during normal working hours, employees designated for relocation will proceed to the emergency site via Bureau vehicles, personally owned cars, and, if necessary, AB&W busses. In addition, arrangements have been perfected with the Navy for a covered motor launch capable of carrying 50 key employees to Quantico. This launch will proceed from its mooring to the D.C. Municipal Mierging, 550 Main Avenue, S.W., on the sounding of an alert. Bureau employees will board the launch at that point.

During other than normal working hours, personally owned cars, with neighborhood car pools, will be used for relocation.

(c) Communications - The Bureau relocation site is equipped with CW (code) radio, telephone, teletype, and microwave installations. The Bureau CW (code) radio network is capable of contacting all Bureau field offices. The telephone switchboard has il trunk lines plus 2 stand-by emergency lines, one to New York and one to Shepherdstown; an extension from the Marine Corps switchboard; a direct line to the Justice Building; and a direct line to the High Point Communications Center, through which the relocation sites of all other Government agencies can be contacted.

There are three commercial TWX teletype circuits between Quantico and the Richmond teletype exchange. In addition, there are private line teletype circuits connecting Quantico with the Justice Building in Washington, the Department relocation site at Martinsburg, the communications center at High Point, and the Bureau radio station at Midland, Virginia.

The microwave installation consists of two microwave telephonecircuits - one to High Point and one to the CIA relocation site. There are also two microwave teletype circuits - one to High Point and one to the CIA relocation site.

II. EMERGENCY PROGRAMS

(a) Emergency Detention Program - The Federal Bureau of Investigation schedules for apprehension individuals whose affiliations with subversive organizations are so pronounced that their continued liberty in the event of a national emergency would present a serious threat to the internal security of the country. As of April 17, 1956, 12.949 individuals were scheduled for apprehension in an emergency.

Apprehensions under this program would be instituted upon instructions from the Attorney General after the declaration of an emergency.

Detailed plans for institution of this program have been drawn up and are in the possession of the various field offices of this Bureau. In addition, all necessary forms to be used in conjunction therewith have been made available to all field offices.

(b) Internment of Enemy Diplomats - When the President instructs that enemy diplomatic and official personnel be taken into protective custody, FBI will assist the Department of State. Soviet bloc personnel who would be involved number about 500 persons in Washington, D. C., and about 400 in New York. Diplomatic couriers in travel status would be taken into custody wherever found. FBI would enter enemy establishments with representatives of State and search such establishments for concealed nuclear weapons, radios, conventional explosives, et cetera. Disarming of nuclear weapons would be done by Army Explosive Ordnance Disposal teams. FBI would take enemy personnel into protective custody, supervise their packing, relieve them of any weapons, cameras, or radios and release them and any contraband other than nuclear material to the State Department. Nuclear material would be taken by the Atomic Energy Commission. Transportation of enemy personnel to detention hotels and guarding there would be done by the Immigration and Naturalization Service under State's direction.

Memorandum for Mr. Boardman

If evacuation of civilian population from Washington, D.C., was ordered and got under way before FBI and State Department personnel reached enemy establishments, it might be impossible to get to such establishments, enter and search them during critical period. It would also become necessary to locate enemy personnel dispersed over a wide area.

III. MARTIAL LAW

Under martial law the military will be in charge, and to put the emergency programs into effect, we must have military

Under martial law the military will be in charge, and to put the emergency programs into effect, we must have military clearance. Martial law might well compel the abandonment of the emergency programs, and at best would cause delay in putting them into effect while Defense Department clearance was being obtained. This problem was presented to the Attorney General in June, 1955, at which time we pointed out the necessity of resolving this problem in advance of a real emergency in order to avoid any interruption in the Bureau's work during such periods. To date the Department has not clarified this situation. On March 15, 1956, Mr. Rankin advised that the Departmental study of the problems involved was practically completed, that he had consulted Department of Defense, the Office of Defense Mobilization, and Federal Civil Defense Administration; that nothing definite had been decided pending completion of a re-examination of the entire subject of martial law.

IV. OTHER JURISDICTION

In addition to the above-mentioned emergency programs, we will continue to carry out our statutory responsibilities relative to espionage, sabotage, and subversion.

In the event of hostilities, the FBI will bring to the attention of the Attorney General and the Department of State the names of dangerous aliens of nations outside the Soviet bloc who are attached to international organizations in order that determination can be made as to action to be taken regarding them. Investigative reports on such aliens are furnished to the Department and to State as they are received from the field.

In event censorship is imposed, the FBI will give list of selected names and addresses involved in espionage and other

security cases to the censorship authority, so that special attention can be given to communications involving them.

> Sizoo Mr. Bartlett of the Liaison Section talked to Mr. Innes Harris, Office of Defense Mobilization (ODM), Holloman at 6:15 pm today in connection with the Director's request that I accompany him to the briefing by the President at 2:30 pm tomorrow concerning Mobilization "Plan C." Mr. Harris advised that they are using the largest room in the Executive Office Building for this meeting and that this room accomodates only 80 chairs. Each of the 79 persons invited have accepted and the other chair is reserved for the Vice President if he can attend. Mr. Harris stated that it is absolutely impossible to add additional chairs for this, meeting and that it will be impossible for persons to stand in the corridor and listen to the briefing. Mr. Harris further stated that the response to this briefing has been complete in that every person invited has accepted and in addition several agencies have called today asking permission to bring additional people. He mentioned that the Secretary of Commerce telephoned asking that more persons attend and that ODM had to refuse this request. Further that the Budget Bureau and several other agencies requested additional invitations and each has been turned down. He emphasized again that space is the big problem.

Mr. Harris mentioned that only three invitations have been sent to each department of Government with the exception of the Department of Justice which was for four persons to attend. In this regard Mr. Harris mentioned that if two were to come from Justice and two from the FBI there would be no problem. However, three have already accepted from Justice. He suggested that one of these three might step aside to give the FBI an additional person in attendance.

Reference is made to your memorandum to Mr. Boardman dated December 27, 1956, in the above-captioned matter. You will recall that Office of Defense Mobilization (ODM) in setting up the Mobilization Plan C" briefing for January 10, 1957, did not include the Bureau in its dissemination, however, made the dissemination to the head of the Department, in our case the Attorney General. This matter was late in arriving at the Bureau, and referenced memorandum recommended that we contact ODM and point out the importance of advising the FBI of contemplated tests of exercises as it affects the FBI in view of our heavy responsibilities in Internal Security Matters. On January 3, 4 and 7, Mr. Bartlett of the Liaison Section contacted Mr. Innes Harris, Mr. John Grady and Mr. William Elliot, ODM.

Mr. Bartlett emphatically pointed out the urgent need for the above-described material to be disseminated to the FBI immediately rather than through the Department of Justice. It was pointed out that the FBI has heavy responsibilities in the Internal Security field, and that contemplated tests and exercises affecting the FBI should be called immediately to the attention of the Bureau. It was also pointed out that previous arrangements called for dissemination directly to the FBI and that it appeared that the ODM System was not working in view of the fact that it took a full two weeks for us to get our hands on the material. All ODM representatives advised that they would do their best in the future to prevent a reoccurrence of this situation.

ACTION:

For your information. Liaison will continue to follow with ODM very closely to impress upon them the need for keeping the Bureau advised of all future planning affecting our interests.

In accordance with instructions I attended the ODM Mobilization Plan C briefing at 3:00 PM, Innuary 10, 1957, in Room 474, Executive Office Building. Dr. Arthur Flemming, director of ODM, presided. The meeting lasted until 3:30 PM. There were representatives of a considerable number of departments and agencies present, including Admiral Radford, Mr. Barba, and General Goodpaster from the White House.

Dr. Flemming merely reiterated what was in the booklet setting forth Plan C. He stated this was a plan for general mobilization without a direct attack on the United States. He said the plan was to identify the action steps we would have to take under such conditions and see whether we were ready to take such steps, what improvements could be made and thereafter submit a report to ODM by January 31, 1957. He said that the previous Plan C staff exercise last April was helpful in clarifying what should be done in an emergency and that such a staff exercise will be held about once a year. He stressed that the reports submitted to ODM should be blunt, frank, and should contain suggestions to improve the plan.

We will prepare the necessary report and submit it to ODM prior to January 31, 1957.

There was a period of about 15 minutes of questions, one of which had to do with the safety of relocation sites. The questioner pointed out that relocation sites anywhere in the eastern section of the country may be subject to fall-out and as all of the agencies have relocation sites in the eastern part of the country, this becomes an over-all problem. Dr. Flemming said that the task force presently examining this problem will ascertain just what the situation is as to the relocation site problem, bearing in mind that anywhere in the eastern part of the country fall-out may become a problem, and thereafter policy will be set and various agencies would be able to examine their relocation sites to see what work is necessary to be done. He said that once policy is set the agencies will then be able to submit budgetary requirements.

The purpose of the conference, according to Mr. Yeagley, was to brief the US Attorneys as the departmental representatives in the field concerning the problem of obtaining relocation sites, handling of their offices under emergency conditions, and action to be taken by them in case of emergency. The meeting was conducted by Mr. Yeagley and the previously submitted agenda (copy attached) was generally followed. The Attorney General made a few opening remarks as to the necessity for defense planning and went over some of the problems that would confront the Department. The Attorney General spoke generally on the survival and operation of the Government during emergency conditions. He commented on the outstanding work the Bureau had done in World War II in preventing sabotage

and espionage. He stated plans had been made to pick up dangerous persons during any forthcoming emergency, and that details had been worked out and placed in the Attorney General's portfolio.

During the course of the conference as various subject matters were introduced, particularly relocation and the functions of US Attorneys' offices during wartime, it became quite evident that the US Attorneys were confused as to their jurisdiction, responsibility, and exactly what the Department wanted them to do. Several of the US Attorneys raised such questions as the jurisdiction and authority of their offices, and that of Federal District Courts, should it be necessary for them to relocate outside their judicial districts (this was mentioned as it was the intention of several US Attorneys, particularly in New York, to relocate outside their judicial districts); the authority and jurisdiction of US Attorneys over US Marshals during periods of planning and emergency operations; and the matter of movement and liaison between US Attorneys and other Justice agencies in their districts.

Mr. Williams of New York and Mr. Tieken of Chicago were resentful of the fact that they are at this late date being brought into Departmental planning, relocation, and general functioning under emergency conditions. Others felt defense planning was a matter for the Department to handle and not the individual US Attorneys. Some felt they had complete jurisdiction over all US Government agencies of the Executive Branch of the Government in their. Federal districts if and when an emergency were declared. Others were more conservative, stating they would confine their emergency operations to normal bounds with the exceptions being dictated by the Attorney General. Although verious topics were discussed such as the portfolio, communications and relocation, the US Attorneys' major concern was jurisdiction and authority during a national emergency. The Justice representatives frankly admitted they did not know the answers to the questions being put forth, but stated they hoped they could work out the problems in due time.

The general instructions issued by Justice were to the effect that all US Attorneys must find a relocation site by July, 1957, and if possible, equip it with some type of communication system so that it might be used during the forthcoming Operation Alert 1957. Justice representatives stated they would examine a request that a manual be prepared in Washington, D. C., for use

of the US Attorneys in planning emergency operations.

Although most of the matters discussed were of interest to the Bureau and the Bureau's name was used frequently as an example of what had been done in advance planning, there were no complaints, criticisms, or requests made which affect or change our operations or emergency planning. The conference showed quite clearly that the Bureau is far advanced in its field and Seat of Government planning, particularly in field preparedness, SOG instructions to the field, field and SOG relocation, and communications. The conference very strongly showed that the US Attorneys are confused as to what they should do under emergency conditions, had developed little or no planning of their own, and were looking to the Department for guidance. The Department frankly admitted they did not have the solution to the problems raised and that they are "flubbing around," according to Mr. Yeagley.

ACTION:

In view of the fact that the 10 US Attorneys at the conference represent in their ODM Districts all Justice agencies with the exception of the FBI (this point was brought up at the conference and made quite clear to all US Attorneys) and may be in touch with our various SAC's on relocation and defense planning matters, it is felt advisable that we give the 10 SAC's who have been designated by the Bureau to handle Bureau liaison matters in the 10 ODM Regional Mobilization Districts the results of the conference so that they may be guided in their discussions with the US Attorneys. Such a letter is being prepared and will be submitted separately.

In line with current national defense planning concepts, as promulgated by Office of Civil and Defense Mobilization (OCDM) for the Nation as a whole and as adapted by all Federal Government agencies as applicable to their organizations, Bureau defense planning, with regard to procedures listed herein, is being modified as follows:

(1) Wobilization Plan Mobilization Flan D-Minus

Hobilization Plan C is a proposed course of action for the Federal Government to take at a time when the international situation is of the utmost gravity but short of general war and in which United States Forces have become engaged in overseas military operations. (Defense Plans Manual, Part I, page 3)

Under Mobilization Plan C conditions, the Bureau could order field offices to activate their relocation sites, prior to any actual attack. Should this situation occur, the Bureau's communications media will be in operation and the Bureau will issue appropriate instructions 5 to all offices as to number of personnel to be relocated, actions to be taken, etc. Although it will not be necessary for offices to make extensive plans or arrangements for such a situation (instructions will be issued at the time from Bureau Headquarters), nor will it be necessary to amend the office defense plan in this regard, all members of the office chain of command should be particularly aware of the possibility of a relocation under Mobilization Plan G conditions, when and if ordered by the Bureau.

Mobilization Plan D-Minus is a plan to provide for Federal Government actions and policies and to coordinate agency responsibilities that will be necessary to maintain government and wage a war in the event of a surprise nuclear attack upon the United States. Mr. Tospefense Plans Manual, Part I, page 3)

(2) Thirty-Day Planning Concent

To date, Bureau defense planning has provided for an Emergency Squad to occupy the office relocation site during the first 24-48 hours of an emergency. Thereafter, it was planned additional office personnel could be secured.

Effective immediately - the "26-48 hour planning concept" is abolished and replaced by a "Thirty-Day Planning Concept." Under this new concept, the assumption is that sufficient personnel must immediately proceed to the relocation site and remain there under "buttoned-up" or isolated conditions for thirty days operation at maximum efficiency.

(a) Personnel Designations

All personnel in the headquarters office will be designated in one of the following categories:

1. Emergency Royal - "Relocatees"

The office Emergency Squad consists of those employees designated to occupy the office relocation site for thirty days' operation at maximum efficiency in an emergency.

Sufficient personnel must be designated on the Emergency Squad to meet the field office responsibilities under the various emergency programs with maximum efficiency under the circumstances. Emphasis should be placed on the availability of Agent and communications personnel. All members of the office chain of command, as well as the office defense plans coordinator, should be designated on the Emergency Squad.

2. Office Evacuation Security Saud - "Last-Out-Of" and "Pirst-Back-Into" Areas and Buildings Squad

A limited number of Special Agents should be designated on this squad. The duties of this squad are outlined in the Defense Plans Manual, Part II, Section 5, page 1.

3. Non-Relocatees - "Civil Defense Evacuees"

Remaining office personnel will evacuate in accordance with local civil defense instructions and will keep in contact with the office relocation site for additional Bureau and/or field office instructions.

The majority of field offices will designate office personnel in only two of the preceding categories - the Emergency Squad (for relocation site duty) and the Office Evacuation Security Squad ("Last-Out-Of" and "First-Back-Into" Areas and Buildings).

Mowever, certain offices may desire to designate only a percentage of their total office personnel on the Emergency Squad, thereby naming the remaining employees in the office as non-relocatees. This may be necessary due to the large number of employees assigned in some offices or a particularly limited relocation site capacity. For example, according to information previously submitted by the New York Office, only about 33 per cent of the office personnel would be necessary at the relocation site in a "B+30 situation" (30 days following day of attack).

All resident agency personnel will fall in the category of non-relocates except members on the office chain of command and/or employees located in resident agencies sufficiently near the relocation site having specific duties at the relocation site, who should be designated on the Emergency Squad. All other resident agency personnel will follow civil defense evacuation procedures and maintain contact with the relocation site.

(b) Personnel in Wilitary Reserve

In the selection of personnel to be designated on the Emergency Squad, you are remitted of the Defense Plane Manual provision regarding the assignment of employees in the Ready Reserve to relocation site duty. (Part II, Section 3, page 2) Under the Thirty-Day Planning Concept, as long as the field office can utilize personnel from the standpoint of work to be performed and relocation site capacity, it is permissible to designate employees who are members of the Ready Reserve to the Emergency Squad. This is possible inasmuch as the Bureau may be able to obtain the necessary release from the employees' military obligations in connection with their Ready Reserve status.

The following procedure is set forth whereby names of male clerical personnel will be furnished to the Bureau for deferment purposes:

Office which designate their total office personnel on the Emergency Squad - excepting the limited number of Agents on the Evacuation Security Squad - will not submit any listings of names to the Bureau. However, these offices should advise the Bureau by June 22 of this fact. In these instances, deferment from military obligations will be sought for all male clerical employees assigned

in the field office on the assumption they are all members of the Emergency Squad.

Offices which designate a percentage of the total headquarters personnel will fall in the alternative group. These offices must furnish, by separate communication to reach the Sureau by June 22, the names of all male clerical personnel who <u>are</u> designated on the Thirty-Day Emergency Squad. In these instances, deferment will be sought only for those employees named. Any future changes in personnel on the Emergency Squad involving employees to be presently or subsequently listed must be brought to the attention of the Sureau for appropriate action.

Offices which have male alerical personnel assigned to resident agencies, which employees are not members of the Emergency Squad, also fall in the alternative group. These offices must furnish the Bureau by June 88, the names of all male clerical personnel who are included on the Emergency Squad in order that deferment may be requested only for relocatees.

(c) Relocation Site Canacity

On the basis of information previously submitted to the Bureau, it appears many offices have the capacity at their relocation sites to utilize and staff their total office personnel. In the event the capacity of a relocation site of any office is such that it is not possible to utilize all office personnel at the site, it will be necessary, of course, to designate a percentage of personnel to the Emergency Squad.

The capacity of the relocation ette may be figured on a "two-shift basis," that is, two twelve-hour work shifts, two employees assigned to one bunk, etc.

(3) Car Pool Transportation Arrangements

Car pool transpostation arrangements - whereby certain personnel were designated squad leaders and were responsible for providing transportation for other members of the squad - are abolished.

Transportation to the office relocation site by members of the Emergency Squad will be the responsibility of each relocates. Of course, the Sureau has no objection to arrangements made among members of the Emergency Squad who reside in the same general locality for ear pool transportation to the site during duty or nonduty hours.

This type of arrangement should not be included in the office defense plan.

Transportation facilities and routes for employees in a civil defense evacuation will be in accordance with local civil defense planning. Should civil defense order an evacuation of the office area, all personnel, including the Emergency Squad, will evacuate under civil defense guidance. Members of the Emergency Squad who are caught in a civil defense evacuation will proceed to the designated civil defense reception centers and thereafter, as possible - in accordance with civil defense procedures and by whatever means available - proceed to the office relocation site.

In view of the new Thirty-Day Planning Concept and the abolishment of car pool transportation arrangements, offices need only provide for notification arrangements of all Agent personnel and other members of the Emergency Squad.

(4) Care of Families

The procedures instituted - whereby mature, clerical personnel were designated to render assistance to families of relocated personnel - are abolished.

In the event civil defense orders an evacuation of an area, evacuating employees and their families will be cared for at designated civil defense reception centers or welfare areas.

Should the Bureau order a field office relocation prior to an over-all civil defense evacuation (such as an office relocation under Mobilization Plan C conditions) certain employees would proceed to, and activate, the relocation site. The Bureau would designate the category of personnel to activate the site, i.e., chain of command member, key communications personnel, a clerical employee, etc. The entire Emergency Squad would not necessarily be dispatched to the site. In this instance, remaining personnel would continue to staff the headquarters office, and families of relocated personnel could contact the headquarters office for any assistance necessary.

Employees who are non-relocatees, who live in the same general locality of other employees who are relocatees, are encouraged to arrange among themselves for the rendering of any possible assistance to families of employees scheduled for relocation. However, these arrangements should not be set out in the office defense plan.

The remaining care of families aspects of Bureau defense planning provides for:

- I. The furnishing of the telephone number of the office relocation site to:
 - Adult dependents of relocatees, in order that they may contact the relocatee at the office relocation este. (Location of the site should not be furnished only the city and telephone number.)
 - b. All employees and/or their dependents in order that they might advise the office of their whereabouts, leque messages, and seek information and assistance. (Location of the site should be furnished an a need-to-know basis, to relocatees only.)

This telephone number is furnished confidentially and is not to be set out in memoranda furnished to employees at the present time. All employees of the field office should know this number.

- 2. The furnishing to all employees annually, unless pertinent changes occur sooner, information concerning local civil defense evacuation and survival procedures, including available printed literature as furnished by national, state, and/or local civil defense.
- 3. The etressing to all employees that it is the employee's moral responsibility to plan for survival and for the care of his family, to see that his family is aware of such planning, and to go into such planning, in detail, with his family.

Revisions to the Defense Plans Manual and the Defense Plans Pilot Plan are being submitted under separate cover. Amendments to the field office plan should be submitted by each office within thirty days of receipt of the Manual and Pilot Plan revisions.

Communications from offices in accordance with Item (2) (b) - Personnel in Military Reserve - must reach the Sureau by June 22, 1950.

A concept recently propounded by the Office of Civil and Defense Mobilization (OCDM) provides that during increased international tensions, Mobilization Plan C would be put into effect, under which a limited number of employees would activate the relocation sites of the Bureau and field offices. imminent attack conditions, Mobilization Plan D Minus would go into effect and all personnel scheduled for duty at our sites would immediately relocate and be prepared to stay for at least a 30-day period.

Previously, our planning provided for two surges, under which a limited number of employees would man the sites and would be supplemented by a second surge within 24 to 48 hours.

Defense planning for the Executive Offices and Divisions at the Seat of Government has been revised to conform with the new 30-day concept. The attached letter to all field offices sets forth the 30-day concept, and the action necessary to bring field planning within this concept. Topics discussed are our relocation sites' capacity, car pool transportation arrangements, care of families, employees with military reserve status, "Lost-Out-Of" and "First-Back-Into" program, etc. All of the above categories have been incorporated in Seat of Government planning.

The field revisions which will be necessary will bring into uniformity the entire Bureau defense plans program, at field and Seat of Government levels and will be in conformity with the directives received from OCDM.

Revisions to the Defense Plans Manual and Defense Plans Pilot Plan will be handled separately.
