

While I would like to be of assistance, information in FBI files must be maintained as confidential in accordance with regulations of the Department of Justice and is available for official use only. In view of this, I hope you will understand my inability to comment in the manner you requested. I am unable to suggest a source where you can obtain data of the type you desire.

The Communist Party in this country has attempted to infiltrate and subvert every segment of our society. Its efforts are being thwarted by the FBI's internal security programs, by investigation, arrest and prosecution of Party functionaries, and by widespread, intelligent public opposition to the communist philosophy. These achievements are being accomplished through orderly, legal procedures. Despite this, the world communist conspiracy and its advocates in the United States continue to pose a basic threat to our country.

Regrettably, there is a tendency on the part of some to make exaggerated charges as to the extent of communist success in gaining influence within legitimate organizations and segments of our society, such as our religious institutions. We must continually be alert to communist attempts to penetrate and influence; however, our efforts must be rational and objective.



Many of my friends as well as myself are concerned about this matter and the influence it has on our lives and particularly the lives of our children who are growing up in this society.

Our own church literature seems to be leaning farther & farther to the left and in many cases has possed questions such as "Can we be sure that Christianity works better in a democracy than in a Communist country?"...and many other cases.

As a matter of record, and for my own personal knowlege, please advise me as to the extent of this influence in our church organizations as far as you know now.

The books I have read have been called "hatemongers " by our own pastor, and instead of trying to refute the information these writers give, he usually attacks the writers and denies that there is anybody in the National Council of Churches aiding the communist causes directly or indirectly by their acts or deeds.







My dear Mr. Hoover:

For many months the churches of the Southwest have been having a most difficult time due to the intensive political propaganda of the extreme right and the Birchers. Although the National Council of the Episcopal Church, Bishops and Deputies, voted to stay in the National Council of Churches, there is still widespread suspicion that there are many Communists among Episcopal priests. Even some of my most faithful parishioners are afraid and confused. They come to me seeking help and clarification. They have received mountains of material through the election campaign — always "authenticated" — against the church and the National Council of Churches.

If you have made any statement clearing the Episcopal Church of these charges, or some positive statement about your findings on the churches, I would so appreciate hearing from you. I know only too well that there are some extremely liberal clergy in the church; because liberal, the extreme right tends to feel they are Communists. I am sure, too, that there have been a few undesirable men, who have acted irresponsibly. This is true of most organizations.

Like so many of your fellow Americans, I have long admired your courageous stand on the importance of the role of the church, and the undergirding our youth with moral and spiritual values. At the moment, I find that the over 2000 sheep for whom I am the shepherd, need the same steady diet:







Information concerning captioned organization has come to the Bureau's attention on several occasions in the past. It has been characterized as a right-wing group which frequently magnifies the degree of communist infiltration into clerical circles.

J. B. Matthews, author of the book, "Communism in the Churches," mentioned in your enclosure to referenced letter, is a former member of the Socialist Party. He testified before the House Committee on Un-American Activities in 1933. He was thereafter employed by the Dies Committee from 1939 to 1945 and was Executive Secretary of that Committee in 1942. In 1953 he was Executive Stall Director of the Senate Permanent Investigations Subcommittee (McCarthy Committee). He wrote the article "Reds and Our Churches," which was published in the July, 1953, issue of "American Mercury," in which he alleged at least 7,000 Protestant clergymen had befriended communists. He voluntarily submitted tis resignation to the Subcommittee following considerable publicity over the pappearance of his article.


For a number of years allegations have been made by a number of people, including some clergymen, to the effect that the National Council of the Chirches of Christ has been infiltrated by communists. In view of this, I am sure you will understand why I cannot comment concerning the book, 'None Dare Call It Treason," the National Council of Churches or the other questions you asked. In addition, I hope you will not infer either that we do or do not have information in our files regarding the subjects of your inquiry.

You may also wish to refer to my books, "Masters of Deceit" and "A Study of Communism." The former was written with the hope that it would help readers gain an insight into the true nature of the communist conspiracy in this country. The latter contains an analysis of international communist practices and contrasts totalitarian methods with life in a free country. These books may be available at your local library.

I regret I am unable to be of help in this instance but trust you will understand the necessary reasons for this policy. It is hoped you will not infer either that we do or do not have data in our files relating to the National Council of Churches.

This Bureau does not have a list such as you mentioned available for distribution. I am, however, enclosing a copy of the list of organizations which have been cited as subversive by the Department of Justice pursuant to Executive Order 10450, along with other literature I trust will be of interest to you. Perhaps you may also wish to secure a copy of "Guide to Subversive Organizations and Publications," prepared and released by the House Committee on Un-American Activities. In it are listed groups and periodicals which have been cited by various state and Federal agencies, and a copy of it can be purchased for seventy cents from the Superintendent of Documents, Government Printing Office, Washington, D. C. 20402.

Will You may also wish to read my books, "Masters of Deceit" and "A Study of Communism." These were written in order to help readers gain an insight into the strategy and tactics of communists, both in this country and abroad. Copies may be available in four local library

What About the National Council of Churches?

In recent months a good deal has been said and written about the National Council of the Churches of Christ in the U.S.A., most of it derogatory. Quite naturally many are concerned and are asking: What About the National Council of Churches?

Since so many in other fields of endeavor have presumed to speak freely and at some length on this subject, it seems right and proper that those of us who are more deeply involved in ecclesiastical matters should also speak — not so much collectively through pronouncements, as individually and informally to our own congregations. This I propose to do here. You certainly have a right to know what your own pastor thinks about this subject, and I believe I have the right and the duty to tell you.

There are a number of things which should be said, which are not being said, and certain information made available which is not known by the average member of the average church.

In what I say I shall be speaking only for myself, but I shall try to reflect the general point of view of our branch of the Presbyterian fellowship as expressed from time to time by statements and actions of its highest court, the General Assembly.

L

There is needed very badly, it seems to me, a factual and descriptive statement setting forth the history, nature and functions of the National Council, and this is what I propose to do first. In doing so, I shall pose certain questions and then try to answer them. Necessarily these answers must be brief.

First, what is the National Council of Churches? It is a fellowship of 31 independent national denominational bodies who desire to pool their resources to accomplish their common tasks. The National Council is not a Church; it is a Council of ... Churches which exist independently and are members by their own deliberate choice. The National Council is not something above or apart from its member churches. It is the churches themselves working and serving together. It is the churches themselves doing those things which they can do better together than any could possibly do separately.

In the present membership of the Council are most of the major historic bodies of American Christianity except the Roman Catholic. (The only large bodies of Protestant Christians not in the Council are the Southern Baptist Convention and the Missouri Synod of the Lutheran Church.) These 31 communions have a total membership of around 40,000,000. In addition, some 40 communions or boards and agencies of communions, which are not full members of the Council, cooperate in one or more of the Council's activities. 73 Christian bodies then, have some working relationship with the National Council of Churches.

How did the NCC come into existence? It came into existence by the action of independent churches themselves, including our own. In 1950 a carefully drawn Constitution was officially ratified by the highest courts of the member churches. Prior to 1950 there were various inter-denominational agencies at work in cooperative efforts for the accomplishment of common tasks. The National Council combined these former agencies into one agency. The Presbyterian Church in the United States officially became a member of the NCC in 1950 through the action of its General Assembly, the highest court of the Church.

What is the relationship of the National Council of Churches to the former Federal Council of Churches? The NCC is the result of a merger on November 29, 1950 of the former Federal Council of Churches, the International Council of Christian Education, the Foreign Missions Conference of North America, and several other inter-denominational agencies, each with a long history of effective Christian cooperation. Whereas the Federal Council had been largely concerned with problems of Christian social ethics, the National Council has included within it many other interdenominational interests.

What is the basis of membership in the Council? "Membership is open to communions which are constituted as autonomous bodies, possess a history that demonstrates permanency and stability, have an established order of government and ministry, and acknowledge Jesus Christ as Divine Lord and Savior." The preamble of the Constitution of the Council reads as follows: "In the providence of God, the time has come when it seems fitting more fully to manifest oneness in Jesus Christ as Divine Lord and Savior by the creation of an inclusive co-operative agency of the Christian Churches of the United States of

America." The membership of the Council is open to all churches which declare their acceptance of this faith if approved by a two-thirds vote of the communions represented and voting at any regular meeting of the General Assembly of the Council.

Do laymen have representation in the Council? Yes. The General Assembly of the Council (which meets every three years) has 734 delegated representatives — 490 of whom are clergymen and 244 are laymen. The General Board (which meets three times a year) has 260 representatives — 165 of whom are clergymen and 95 are laymen. In specific programs and general policies, the Council is supervised and governed by representatives of the communions that comprise it — 2,763 laymen and women and 2,670 clergymen. The much discussed Fifth World Order Study Conference held in Cleveland, Ohio in 1958 was composed of 515 conferees — two-thirds of whom were laymen from 37 states and the District of Columbia. The chairman was a layman, the Honorable Ernest A. Gross, a New York attorney.

What are the basic organizational features of the NCC? The council is governed by the official representatives — ministers, laymen and women — of the 31 denominations which comprise it. The General Assembly meets every 3 years and acts as a central body of inter-denominational decision. The General Board of the Council meets three times each year, and is responsible for the policies and programs of the Council. It reports regularly to each of the denominations, and is subject to their review.

How is the National Council financed? The Council makes no financial assessments, but is wholly dependent upon voluntary contributions from member churches and from individual donors, corporations and foundations. The Council's funds come from the following sources: About 61% is contributed by denominations, local churches, and related organizations; another 12% consists of gifts from individuals, corporations and foundations; approximately 26% is derived from gross sales of Council materials; and 1% comes from investments.

The National Council is but one of several Inter-Church agencies to which our denomination contributes through its benevolent budget. Others in this group are: The Lord's Day Alliance, Religion in American Life, The American Bible Society

and The World Council of Churches. Our denomination's Permanent Committee on Inter-Church Relations recommends to the General Council of our Church an amount for the support of each of these causes. The General Council studies this recommendation and in turn recommends to the General Assembly a budget in which these various Inter-Church agencies are included. This budget, when approved by the General Assembly, is sent down to the Synods, Presbyteries and local congregations. The Highland Park Presbyterian Church of Dallas contributed to the NCC in 1963 a total of \$74.81, out of a total benevolent giving of \$499,000.00.

Who selects those who represent our Presbyterian Church, U. S. on the Council? Our church has 19 people representing us on the Council — 10 laymen and women, and 9 clergymen, and these are named by the General Assembly. Their names appear on pp. 14 and 15 of the Minutes of the 1964 meeting of the General Assembly.

How does the NCC accomplish its work? The program of the Council is carried on by four Divisions — Christian Education, Home Missions, Foreign Missions, Christian Life and Work; by three Central Departments — Evangelism, Church World Service, Broadcasting and Films; and by two General Departments — United Church Men and United Church Women. The following agencies and boards of our branch of the Presbyterian fellowship are related to the Council departments and share in its program: The General Council, the Board of World Missions, the Board of Church Extension, the Board of Christian Education, and the Board of Women's Work.

Are the individual denominations bound by the pronouncements of the National Council? No. The official pronouncements of the Council are formulated by the duly elected representatives of the churches which make up the Council. They are discussed in open debate and represent group opinion. Any denomination represented in the Council may dissent from the pronouncements, and the dissenting vote is made a matter of record and released to the public along with the pronouncements. Hence, we may be officially disassociated from any action with which our denominational representatives are in disagreement, and thus do not give tacit approval to it by virtue of our membership in the Council. This has been made clear in a report from the National Council published in the minutes of

The same of the sa

the 95th General Assembly of the Presbyterian Church in the United States (p. 155), which reads as follows: "The General Board calls to the attention of its Constituent Communions and their members that when it approves a pronouncement, it does so on the authority given to it by its constituent Communions according to the Constitution of the National Council of Churches. It is clear, however... that the constituent Communions or any of their members have full right and responsibility to protest and to differ when their own convictions, under the authority of the Scriptures illumined by the Holy Spirit vary from the Council's pronouncements."

You will be interested in the following action taken by the General Assembly of our church in May 1959: "The General Assembly unequivocally opposes the atheistic dictatorship and other evils of Communism, whether in recognized Soviet Russia or in unrecognized Red China. The General Assembly deplores the misunderstandings resulting from publicity of the Fifth World. Order Study Conference at Cleveland, Ohio, November, 1958... The General Assembly registers its disapproval to the National Council of Churches of Christ in the U.S.A. of the action taken by the World Order Study Conference, when they proposed that Red China be granted diplomatic recognition by the United States Government and that it be admitted to the United Nations."

Often the statement is made in press reports that the Council, in a certain action, represents 40,000,000 Protestants. This is unfortunate, for it simply is not true. The Council does not presume to speak for individual members of the constituent churches. This impression may be the fault of the public relations department of the Council, it could be the fault of a press reporter who does not understand the organizational set-up and purpose of the Council. The 1960 General Assembly of our denomination said: "It should be pointed out that the NCC is not authorized, by its own admission, to speak for its member, churches, but rather, from time to time, it does speak to them, and to our society. We feel that the Council's prophetic voice is very much needed in our day, but like any prophetic voice, it must be weighed and evaluated by the individual Christian conscience."

The 1964 meeting of our General Assembly adopted the following recommendations of one of its standing committees: "We

recommend that the General Assembly instruct our representatives to the NCC to continue to convey our concern that some activities of the Commission on Religion and Race are ill advised, and that in the future the Commission consider the conscience of local ministers and sessions and consult with and seek to work more closely with local ministers, councils of churches and dedicated Christians, as we believe this course offers a far better way of solving our racial tensions.

"The General Assembly of the Presbyterian Church in the U.S. declares that the policies, activities and pronouncements of the Commission on Religion and Race should be interpreted as representing the policies, activities and pronouncements of the Presbyterian Church in the U.S. to the extent, and only to the extent, that the same are consistent with previously approved action and policy of the General Assembly of the Presbyterian Church in the United States." (See p. 83 of Assembly Minutes).

What is the procedure by which denominational groups or member churches respond to an action of the NCC? The National Council is wholly responsible to the member churches. Any pronouncement, recommendation or program proposal made by a study conference, by a division or department of the Council, by its General Board or General Assembly, is referred to the proper official body of the respective member churches for study and action. Once official approval is given by, say, our General Assembly or by one of our official boards or agencies, the NCC proceeds to promote and develop the programs thus approved. Unless and until such official authorization is forthcoming, the Council does not presume to act for any member Church nor for all of them together.

What powers do the member churches delegate to the NCC? No legislative powers whatsoever, and no executive powers save as these are specifically authorized by an official action of the appropriate policy-making and legislative bodies of the churches. The member churches authorize the NCC to coordinate the activities and interests of the respective churches through the various boards and commissions of the Council, to conduct collaborate studies — the results of which may then be referred to the churches for consideration and action — to undertake promotional and educational programs of common interest to the churches, and to provide facilities for the collaboration and cooperation of the member churches in Christian

Education, in pastoral services, in Christian social concerns, in Christian missions, in inter-church world service, and in the discussion of problems of Christian unity.

And finally, why does our Prosbyterism Church, U.S. belong to the NCC? First of all, because the Presbyterian Church is deeply interested and committed to the ecumenical movement and the cause of Christian cooperation. Not all in our church to be sure, but the church as a whole is so committed. Second, because the NCC affords the only really representative opportunity for inter-denominational cooperation and ecumenical action at the national level; and third, because we can use the facilities and the resources of the Council without surrendering any part of our autonomy and independence as a denomination.

Ħ

Most of the criticism leveled against the National Council relates to the work of one of its four major divisions—the Division of Christian Life and Work, for the reason that this particular division has under its purview the following fields of Christian concern: Racial and Cultural Relations, Religious Liberty, International Affairs, Social Welfare, and Church and Economic Life. Some individuals may find fault with the activities of other divisions and service units, but the bulk of the criticism, as I hear it and read it, has to do with this division of Christian Life and Work.

There are not a few Protestant Christians in this country who feel that corporate religious groups ought not to have any direct concern with the un-Christian aspects of our present social order. The Church, they say, ought to limit its activities to matters of personal faith and evangelism, and not have anything directly to do with such menacing social evils as racial injustice, war, alcoholism, juvenile delinquency, divorce, or proverty. It is because the NCC has attempted to apply the Christian religion in these areas that harsh accusations have been hurled.

These critics have said that while the Church and its Councils have a right to speak, they should confine their speaking to purely doctrinal or ecclesiastical matters — "legitimate church purposes", as one local writer calls them — and should leave all social, political or economic issues alone. They contend that any attempt to speak concerning the application of the Christian faith

and ethic is not the legitimate concern or responsibility of organized Church groups, and especially the clergy. Religion is a "personal" matter, and should not attempt to give group consideration to the application of the Christian gospel in these important areas of our common life.

Now of course, this is a matter of judgment and opinion. I may disagree heartily with what is said by this Division of the National Council, or by its General Board or Study Conferences, but I see no reason why a responsible group of Christian men and women (lay and clergy) should not meet and talk together regarding some of the crucial problems confronting America and the world in these days, and, if they desire, make pronouncements about them. Whenever Christianity and its implications are divorced from the practical issues of everyday life and thought, we are in a bad way.

Our own church, through its various courts, has not hesitated to speak out on a number of such issues. Our church courts (Assembly, Synods, Presbyteries) have had something to say from time to time on a number of important moral and social issues such as: Marriage and Divorce, Crime, Alcoholism, War, Racial Discrimination, Religious Liberty, Pornography, etc. Some excellent statements have been prepared and presented to the Assembly dealing with these problems. For the most part these statements have been received simply as information, and sent down to the churches for study. A minority of our people have not been happy about this, but a very large majority have felt that it was incumbent upon the Church so to speak.

The Bible certainly does not keep quiet on social issues. One has only to read the Old Testament prophets and the four Gospels to see how much the Scriptures have to say on practical human relations. I for one must uphold the right and duty of the churches and of their Councils to study and comment upon issues of human concern, however controversial they may be. I must also resist all effort to "muzzle" the preachers, and all efforts to discourage full freedom of discussion. These questions are freely discussed by other corporate groups in this country; why not then by the Church? The fact that some issues are "controversial questions upon which sincere Christians are sincerely divided" does not, it seems to me, prove that they are "off limits" for Church groups, and ought not to be studied by them. And let me comment further that simply because a matter has been taken

into the political arena does not mean that it is no longer a moral

It is inevitable that many will not agree with certain statements by church bodies. The full meaning of the Gospel in its application to life's problems will always involve differences of opinion, and will sometimes create opposition on the part of some very good and sincere people. But must the Church always reflect only the conventional outlook of the average church member? Is it not her responsibility to seek the mind and will of Christ in all human affairs whether that is conventional or not?

But having said all this, I would go on to state that when any corporate church group presumes to speak on these controversial matters, it should exercise great restraint and care and should have a sound Biblical and theological basis for what it says. The Christian confrontation of social, economic and political issues is an exceedingly difficult matter, where much technical knowledge, much statesmanship and much humility are needed. In this area of Christian responsibility the greatest wisdom, the greatest competence and the most mature judgment are absolutely essential.

Any church group should keep constantly in mind that while these pressing problems are a legitimate concern of the Church. they are not her first concern. Her function is primarily spiritual in nature. Writing on the role of the Church today, in which he stressed the Church's right and duty to speak on social questions, Dr. Robert J. McCracken said: "The Church's first business now as always is to be the Church. It exists to turn men's hearts and thoughts and wills toward God and to enable them to see their life and their institutions in the light of God. It exists to inspire prayer and worship and faith and through them to send men and women of character and intergrity into the everyday life of the world ... This is the primary task to which the Church is called and for which it is specially equipped. It is a task which no other organization is discharging or can discharge. It is an agency for the making and remarking of character. It preaches first and foremost a gospel of moral and spiritual regeneration."

This is very true, and the Church should never allow herself to get sidetracked from this primary function. It is so easy for religious groups to become so absorbed in the area of human

relations that they forget or neglect the area of God-man relations. It is, as I see it, a matter of holding things in proportion. It is possible for certain Christians to overemphasize these matters, as important as they are, and so to press for their own views of social theory as to break the fellowship and hinder the other and primary work of the Church.

One further comment along this line. While the Church may be right in the enunciation of Christian principles, it can be faulty in its application or implementation of those principles. It is one thing to enunciate principles; it is quite another thing to say exactly how those principles apply. Actively to lobby for the passage of specific legislation is, in my judgment, an unwise activity for any corporate church group to engage in.

As I bring this part of my address to a close, let me quote from a statement issued by our Assembly's Permanent Committee on Inter-Church Relations. This statement was prepared while I was serving as Moderator of the General Assembly, and was signed by me as a member of that committee. It was presented to the 1958 General Assembly meeting in Charlotte, N. C. "Your Committee shares in the deep concern of many over the questionable nature of some of the National Council's pronouncements on social, economic, and political questions. We are in agreement that the Christian faith must be announced not in principle alone, but must be applied to the concrete realities of the sinful situation in which we find ourselves. For that reason, we do not quarrel with the efforts of the National Council to relate the faith to all aspects of our individual and corporate life. It is all too easy at times, however, for religious leaders to make pronouncements on intricate questions in which they are amateurs, and to go beyond the persuasive role of the church in confronting the world with the gospel by becoming political lobbyists or partisan advocates. We are convinced that, with all good intentions, the Council has on some occasions succumbed to this temptation, and has thereby embarrassed the members of its constituent churches. As a church, we deplore this. Although we feel that we ought to maintain our fellowship in the National Council, we also feel that the Council should be more considerate of the constituent members by avoiding extreme public pronouncements which may compromise the role of the church as a witness to the gospel above party, class, or social theory."

The charge has been made that the NCC is communistic. This charge is expressed in several ways, depending upon the person making the charge. Some state rather categorically that the Council is communistic. Others aver that while the Council may not be communistic, it is abviously "soft toward communism." Some critics say that certain of the Council's leaders are sympathetic to communism—that they are "pink" if not out-and-out Communists. Still others put it this way: the pronouncements of the Council on social, economic, racial and political issues "follow the communist line". This is, of course, a serious charge, and I'd like to say something about it.

Let me state positively and unequivocally that the National Council of Churches as such is in no sense communistic, or a friend of communism. The National Council is and always has been unalterably opposed to communism. Again and again it has reiterated its unequivocal stand against this sinister ideology. The General Board of the Council, meeting in Seattle in June 1959 reaffirmed "the consistent position of the National Council of Churches expressed in many official actions opposing the evils, the-violence and the violation of human rights by communist and other tyrannies." At this same meeting the General Board expressed "profound sorrow for the people of Tibet suffering under Chinese communist oppression" and called for "increased aid from our churches in humanitarian ministries to those who have fied as refugees."

Before his retirement as General Secretary of the Council, Dr. Roy G. Ross sent a letter to members of the Congress indicating the unqualified opposition of the Council to communism. This letter was approved by the titular heads of the majority of the communions holding membership in the Council. The Congressmen who received this letter read into the Congressional Record over 36 pages of testimony on Religious freedom, supporting the Churches as the greatest bulwark against communism.

The General Council of our denomination, meeting in Atlanta, Georgia a few years ago stated that "it is convinced that all accusations made against the National Council implying that it is 'Red' and 'subversive' are without foundation whatsoever."

But there are those who will say: "Maybe the Council itself is not a communist front, but some of its leaders are certainly guilty

of being members of the communist front organizations." It is not my responsibility here to try to defend in detail each individual who is being so criticized. He will have to answer for himself. I do know some of these men personally, having been associated with them in church conferences and in preaching missions, and I must say regarding these particular individuals whom I know personally, that I have no question at all concerning their loyalty to this country and its democratic way of life. They are loyal Americans and Christian gentlemen of the highest type.

I cannot refute what is being said concerning the nature of the organizations with which certain religious leaders have been associated, and I have no slightest desire to protect, excuse, gloss over, or condone any real guilt or any mistakes in judgment. Here again the accused will have to answer for themselves, and the proper governmental agencies will have to act. But in the interest of truth and fairness. I would point out that it is not made clear in the accusations which I have read that these religious leaders are still connected with these "questionable" organizations. The fact that an individual was once affiliated with a particular movement or organization does not mean that he still is. Nor is it made clear by the critics of the NCC that these organizations were suspect at the time these individuals were first connected with them. Let us make sure in dealing with a matter as serious as this that we are scrupulously fair, and that we have all the facts in the case.

A leading clergyman of our country was labeled as subversive by an anonymous propaganda sheet because he participated in a rally of "Soviet-American Friendship." This sheet did not indicate however, that this rally was held in November 1942 when Russia was our ally in arms, and that the same meeting was attended by Cordell Hull, Secretary of State; Jesse Jones, Secretary of Commerce; Owen D. Young; Senators Kapper and McKellar, Edward Stettinius, Jr., and other high-ranking patriotic leaders. Nor did it mention the fact that this rally was sponsored by Senator Saltonstall and Christian A. Herter, later Secretary of State.

In response to the charge that the NCC is led by men, some of whom are disloyal to our form of government and are set to undermine it, our Assembly's Permanent Committee on Inter-Church Relations issued this statement in 1958 which I personally approved and signed: "This charge is a grievous one, indeed,

and one which impugns the motives of men in a very serious way. Your Committee cannot appraise motives, but at this point is willing to accept the judgment of our own denominational representatives who work closely with the leaders of the National Council, and are forthright in estimating their integrity. One of our representatives on the General Board, Dr. John S. Land,* has stated: 'During my service on the General Board of the National Council I have had the opportunity of knowing rather intimately the officers of the Council, the leaders of the Divisions, and the members of the General Board. In addition to attending the meetings of the General Board, I have served on a great number of committees, by which I have gotton to know most intimately the ministers and laymen in the top organization. I can truthfully say I have never detected any evidence of disloyalty to our Lord or our country on the part of anyone. To me it has been a heartening thing to see our cooperative Christian enterprise in America handled by men of the stature and soundness of those chosen by the respective denominations',"

In a syndicated column dated December 17, 1957, Fulton Lewis, Jr. made several charges against Dr. Edwin T. Dahlberg, president of the NCC. Following is a statement from Dr. Dahlberg as to his position regarding these accusations:

"In reply to questions that have been raised in response to the Fulton Lewis attack on me as President of the National Council of Churches, I can conscientiously say that I have no Communistic sympathies, have never had any connection with the Communist party, and have never signed a petition which I knew to be sponsored by a Communist front group. Whenever I have suspected a petition to be by a Communist front group—and like many other clergymen I have received dozens of them—I have rejected it. I would not knowingly lend my support to any group which was an agency of the Communist party, since I am fully aware of the fact that Communism has as its ultimate aim the crushing of all our liberties.

"I did sign some petitions during the war period when Russia and the United States were military allies and during the 30's when as Americans generally we were not so alert to subversive Communistic activities as we are now. But I

repeat, I have never signed a petition in behalf of a Communist front organization when I knew it to be such.

"As for the Morton Sobell case, I interceded in that instance purely on the pastoral and not the political level. Mrs. Sobell came to my study, in tears for her children, and in a spirit of Christian compassion I wrote in behalf of a fair and just consideration of his case as I would write to the judge in behalf of an alcoholic or any other offender against the law whose wife came to me to make a plea for her husband.

"I trust that the above statement will clarify whatever questions may have arisen as a result of the Fulton Lewis article referred to."

It would not be at all surprising, of course, if the communists did try very hard to infiltrate the churches and the clergy. They have tried to infiltrate every other area of American life, so one would naturally expect them to be unrelenting in their efforts to lay their dirty hands on the churches and their leaders. Dr. W. A. Welsh, former pastor of the East Dallas Christian Church, had a fine statement along this line in the Dallas Times Herald on April 24, 1960. Here is what he said: "I should expect the Communist Party to be constantly trying to 'infiltrate' the Protestant Church in America. Certainly, it has tried to infiltrate the newspapers, the movies, the radio-television and the legal profession - and, if the Church and its clergy were left off the list, this could only mean that the Communists did not think either had any influence whatsoever on American life and thought. Since preachers are human, too, and since newspapermen and actors and lawyers have all to some extent been "taken in" by the Communist line, I would not be surprised if some preachers were also. But I am quite sure their number must be very small."

I would like to make two other comments with respect to the charge that the Council's leaders are communistic, and the first is this: The tendency to call a man "pink" or a "communist sympathizer" simply because he differs with other Americans in his point of view on some debatable social and international problems is manifestly unfair and malicious, and ought to be challenged. Such irresponsible name-calling is reprehensible, to say the least. I disagree heartily with the opinion of some of our ministers and laymen that Communist China should be recog-

nized by our Government and admitted to the United Nations, but to hold to that point of view does not mean per se that one is a communist sympathizer. There are a great many loyal Americans who feel that the present world situation calls for such recognition. I personally feel that anyone who champions this view is mistaken in his judgment, but I cannot impugn his motives nor call him "a tool of Moscow."

And one is not necessarily a communist or a "fellow traveler" because he takes a liberal or moderate position on the issue of racial segregation. The implication that those who take such a stand have been "influenced" or "duped" by the communists is just not so, and to contend that it is is manifestly unfair, and I for one deeply resent the shur. I suppose I might be termed a "moderate" on this touchy subject, but I did not get my point of view from the communists. I came to it back in the twenties, not from reading Karl Marx but from reading the New Testament! Let us be exact in our thinking these days, and scrupulously fair in what we say about other Americans with whom we disagree.

My second comment is this: The thing that disturbs me most deeply about all these charges which are being bandied about is that some who make them do so in such a manner as to create an attitude of suspicion and distrust toward all our Protestant clergymen. I am distressed, not to say angered, by the rather glib way in which attacks are being made by certain individuals on the Protestant ministry of our major denominations. And this suggestion that ministers of the Gospel are naive, fuzzy-minded, impractical, starry-eyed visionaries who are so gullible and guileless they cannot recognize atheistic communism when they see it, is simply fantastic. Such undisciplined talk can do a great injustice to our ordained men, and it can do immeasurable harm to this country.

Some clergymen may have been "taken in" by the communist line. Some may have become communists or "fellow travelers," but I am sure that their number is infinitessimal, and it is nothing short of tragic that matters of this kind should be discussed in such a way as to make all clergymen suspect. I listened some time ago to one individual as he attacked certain ministers of some of the major Protestant communions in this country, and not once did he reassure his audience that what he was saying did not relate to the overwhelming majority of our clergymen.

This man wrote something to me in a letter which I wish he had said in the address to which I refer. In a postscript of a letter to me he said: "Let me add that I have always tried to make it clear that the pastors who are fostering causes which we consider undoctrinal and un-American make up less than 1% of the Protestant ministry." Well, he didn't make that clear the night I listened to him. Don't you think he should have?

IV.

It is frequently proposed that since we Presbyterians cannot always agree with the actions and pronouncements of some Division of the National Council or of its General Board, our denomination should withdraw immediately from membership in it. May I speak to this?

First, let me acknowledge that the National Council has made mistakes. It is inevitable that it should make mistakes, for it is composed of fallible men and women like ourselves; but is that sufficient grounds for the withdrawal of our membership in this cooperative venture? All religious groups err, for all are composed of sinful human beings. Our own Presbyterian Church, U.S. has sometimes erred, but we have no thought of repudiating membership in it. To do so would mean that we would either cease to be a church member, which would in itself be a great error, or we would unite with some other Christian fellowship which has also made its share of mistakes, and will make mistakes — perhaps some of them serious ones.

So I favor our Church's continued membership in the Council. It is not perfect, but it is made up of representatives of most of the leading Christian bodies of the nation, and it is better to work from within for its improvement than to take a position of isolation where nothing at all can be accomplished. By continuing our membership we can help the Council to become better than it is, and at the same time we can still have a voice that can be heard when we feel that it is in error.

The Presbyterian Church has never, from its inception, been an isolationist church. Presbyterians have never drawn away from other churches. Instead, we have sought a deeper fellowship with all who claim Jesus Christ as God and Savior. We have been in the vanguard of the ecumenical movement all along, and have been among the first to accept membership in local, national, and world councils of Churches. Ours certainly is not

a narrow, sectarian, divisive group, but one which gladly joins hands in every way possible with Christians of other evangelical groups.

These are days when Christians should stand together and pull together. And we can do this without sacrificing anything that we cherish in our particular denominational heritage. Let us contend for our convictions, but let us never lose our sense of kinship with all who love and serve our Christ. We Christians had better hang together, or we may hang separately! When Communism moved into China and Korea it made no nice distinctions between Christians. All were suspect, and all who refused to 'knuckle under' were liquidated. All missionaries were told to get out, and all Christian institutions — churches, schools and hospitals — were taken over 'lock, stock and barrel'.

Whatever its weaknesses and mistakes, the NCC attempts to speak to the world of our essential Christian unity. We desperately need such an organization which symbolizes our solidarity—our common faith in and loyalty to Jesus Christ. We must see to it that the unity of Protestantism is not broken, or its Christian cooperation imperilled. We need the National Councilnot only as a symbol of our oneness, but also as a means of effectively expressing that oneness. The survival of the Protestant Church as a controlling moral and spiritual influence in modern life depends in large measure upon the willingness of the different evangelical groups to establish and maintain a united front—against bold secularism on the one hand, and against political Romanism on the other. Each of these systems is vigorously assailing those great principles, ideals and values of which Protestantism stands.

The NCC is "the only considerable body which can express our united Protestant voice in this fateful hour in our history. If we were to withdraw from cooperation with this body we would weaken its witness, and we would lose the influence which, under the will of God, we should exert for those things which we believe to be of supreme and abiding value." The General Assembly of our church, meeting in Jacksonville, Florida made the following statement: "The National Council of Churches is certainly not perfect. There is much about it that can and should be improved. But we deplore the unmerited attacks made on the National Council which result inevitably in a distrust and weakening of the Christian witness in our land and throughout the

world. We regard our united work with other Christians as being of paramount importance in today's world and we urge our representatives on the National Council to support, encourage and mutain this vital effort."

Soviet Russian would welcome the weakening of the Churches in this country, and those who make indiscriminate attacks upon the established denominations — who sow the seeds of disharmony and discord among Christians — are unwittingly playing into communist hands. If we got out of the National Council today, we would certainly organize another along the same lines tomorrow, for the simple reason that such a cooperative body is essential and inevitable.

I am for the Council. I am not for all its actions and pronouncements, nor am I for all the points of view expressed by its employed staff and elected officers. With these actions and leaders I often disagree. But I am for the Council. It is the best organization of its kind now on the scene, in which we can express our evangelical oneness and in which we can work together for common ends. In no other cooperative body are the opportunities as great for mutual helpfulness. Our own General Assembly has repeatedly reaffirmed its conviction that our Church should remain in the Council in spite of a number of overtures from some presbyteries asking that we withdraw.

The Council has undoubtedly made mistakes, but it has achieved victories and rendered services which the constituent communions could ill afford to do without. In the Council all the member churches pool their knowledge and resources in a spirit of mutual helpfulness. In the Council we learn from one another. It provides channels through which we Presbyterians can work more efficiently and effectively than we could possibly do going it alone. There are many areas of common Christian endeavor which could not be done at all, or could not be done as well, if our Church had no membership in the National Council or the World Council.

I disagree rather strongly with some of the things which the Council has done and is doing, particularly through its new Commission on Religion and Race (The Delta Project, etc.) and have so expressed myself. But when I think of what the Council means to the Boards and Agencies of our own Church, and to our united Protestant witness in so many areas, I cannot conceive of our withdrawing membership. I have been a member

of the Board of World Missions of our Assembly for twentysix years, and I can testify that the fellowship which we have with other Christian missionary societies through the Division of Foreign Missions has been of inestimable value to our Christian witness around the world.

"Time would fail me to tell" of the many services which the Council renders its member Churches, or of the various advantages which accrue to our own denomination through such joint endeavor. In 1958 our Permanent Committee on Inter-Church Relations prepared and published a pamphlet indicating the many ways in which the various Boards and Accordes of our Assembly work with other churches in the Council and profit by membership in it. The Staff members of our various boards are. through membership in the Council, related to Staff members of similar departments in other churches. Through this mutual association, much is learned which facilitates the work of the various departments of our own church. Through our membership in the National and World Councils of Churches. "our church has an opportunity to contribute, out of the richness of her own life, the resources of her leadership to the larger life of the Church . . . By membership in these councils, our representatives can aid them in self-criticism, and can earith the life of the whole Church of Christ by sharing the riches of our Church's theological heritage and practical wisdom. To refuse to do this would be to renounce a part of the mission which the Holy Spirit has set before us at this time." For these reasons and many more, it would be, in my judement, a mistake for us to withdraw from the NCC

Certain pronouncements on social and political issues get much publicity in the press, so that people gain the impression that this is all that is ever done by the National Council. This is a great pity, but, after all, we cannot determine what the newspapers consider news.

The NCC renders an indispensable service to the churches in the area of Religious Liberty. That is a crucial issue in the world today and I am both surprised and dismayed that so few Protestants seem to have any concern about it. Several years ago now, the Roman Catholic hierarchy brought pressure to bear upon our government to have the State Department deny visas to Protestant missionaries going to Brazil because, they said, Protestant "propaganda" might endanger the good relations ex-

isting between our government and the Brazilian people. Here was a real threat to religious liberty, and had it not been for the timely, united and effective voice of Protestantism speaking through the Council, it is possible that the State Department might have succumbed to this pressure.

Maybe the NCC has spoken at times when it should not have spoken. Maybe it has spoken too often, about the wrong things, and in the wrong way. But there are times when it had better 'speak, and when religious liberty is at stake is one of those times. If you and I as Protestants are not concerned about this matter we had better be! In our zeal for locking the front door against communism, we must be ever vigilant lest some other totalitarian system slips in through the back door to threaten our freedom. The NCC is the most potent united Protestant voice now available to us, and we had better not silence it!

Some of those who are attacking the NCC most vehemently are against all of the great denominations as well. They have been fighting these and their leaders for years. In their philosophy, and in their theology of the Church, they are independent and divisive. If they succeed in crippling or destroying the National Council, this will not satisfy them, for they live on detraction, denunciation and discord, and will immediately intensify their attacks on other phases of organized church life. These individuals have a reputation for creating disharmony and discord among Christians, and they always oppose any kind of Christian cooperation which they do not or cannot control. They have seized upon certain weaknesses of the Council or its leaders to torpedo the whole Protestant denominational movement in this country.


The National Council of Churches has its unwise tendencies and its weaknesses. These we must faithfully recognize, guard against and correct. As our Confession of Faith says, "All synods or councils since the apostles' times, whether general or particular, may err, and many have erred" (p. 169). The National Council is no exception; it too, has erred, and will err. But I cannot see this as just cause for withdrawal from membership in it. If we withdraw from every group which errs, and in which there are convictions and opinions contrary to our own, we would have to withdraw from all connection with the nation, the state, the Church, civic clubs and the individual family unit.

In closing, let me indicate certain tendencies which could endanger the life of the NCC and its effectiveness. There is first the tendency for the Council to become a kind of super-church. There is no such idea in the Constitution of the Council, but it may creep in at times if we are not careful. Some may indeed wish to see the creation of such a super-church. They are impatient with the fragmentation of Protestantism in this country, and sincerely desire one organization which shall bring all evangelicals together in a single organic body. This certainly is not the purpose of the Council, and it is not now the purpose of the overwhelming majority of those who participate in its life and work. But there is the temptation that a few, because of their hunger for organizational unity, shall try to lead the Council away from its original purpose and direction.

Another weakness in the Council is the tendency toward an expanding bureaucracy. This is always a threat, and must be resisted. Such a growth of bureaucracy would pyramid the Council's organizational structure until it could become an intolerable financial burden upon the member Churches.

A third weakness of the Council is its tendency to emphasize one phase of its responsibility to the practical eclipsing of all others. The temptation is strong just now, in its zeal for racial justice, for the Council to become so preoccupied with this particular matter that it seems to neglect or to minimize other highly important phases of its Christian responsibility. The race question is very important, but it is by no means the only crucial issue confronting the churches in these days. Would it not be wise for the Council to shift its emphasis from time to time, so that all departments of its work will have the attention, promotion and publicity which they require?

And then there is the temptation for certain individuals who are active in the departments of the Council to use the Council and its facilities to further their own social or political views. The representatives of the member Churches should constantly be on guard against this temptation. Nothing could do the Council more damage than to have it so used by persons who are zealous to promote their own private social or political theories.



This has been a lengthy discussion, but even so I am sure that I have not answered all your questions regarding the National Council of Churches. It is possible, of course, for you to inform yourself concerning the Council and concerning the justice of the charges which have been made, and are being made, against it. I hope you will feel free to write to the head-quarters of the National Council regarding any matters which relate to its life and work. It is unjust and unfair to hear only one side of a controversial matter. The accused has a right to be heard. Secure a copy of the Council's Constitution and of its official publications and read them carefully. Address all inquiries to Dr. R. H. Edwin Espy, General Securtary of the National Council of Churches, 475 Riverside Drive, New York, N. Y. 10027. He, or one of his associates, will be glad, I am sure, to try to answer frankly and fairly any question you may wish to ask.

Page A5487. Congressman Colmer, (D) Mississippi, extended his remarks to include a resolution adopted by the Long Beach, Mississippi, Chamber of Commerce condemning the reporting by radio, press, etc., of certain activities in that I take. The resolution makes reference to the activities of the intimal Council of Churches in connection with the sending of student caucators into Mississippi. We have poured over your books regarding the plan of The Communist Party to infiltrate our American Churches, we have examined the books issued by the Circuit Riders Inc in relation to their compilation of public records of several hundred clergy and lay members of the Council and compared the activities as listed by organizations with the list of cited communist and communist-front organizations shown in the " Guide to Subversive Organizations and Publications "issued by the House Committee of Un-American Activities issued or revised in 1961, and we have also checked those activities and pronouncements with those of the communist party. We are concerned with the results these comparisons show.

We wonder if you are in a position to furnish us with any information regarding this subject in relations to activities andevents that have occured since 1960 and 1961 and up to the current date? Also, if any list of organizations and and personnel activities has been released lately? We need help to clarify this picture which in itself seems more or less invisible yet very dangerous. If you can assist us in any way with further knowledge we will surely appreciate it.

The charges of Communist infiltration into the National Council of Churches has been completely disproved by the FBI. Indeed, a high F.B.I. Official has evidence that the present campaign of spreading distrust and dissension in the churches has brought encouragement to the Moscow directed Communists who have never before been able to break through the faith of the people in the Churches.

As Presbyterians, we have every confidence in our Biblically based System of Government and in the Church of our Lord and Saviour, Jesus Christ. We, the Session of the Central Presbyterian Church do hereby restate our belief and confidence in our Church, recognizing that, though our Lord is supreme and errorless, we, His Human . servants are not. We call the entire congregation to join us in a sincere repentance for our past failures, to a revival of devotion to the Head of the Church, Jesus Christ, and to a deeper commitment of a growing Christian faith and work under the guidance of the Holy Spirit for the future.







Dear Mr. Hoover:

We, the undersigned, are members of a sub-committee of a larger group created by the Conference of The Methodist Church to study the National Council of Churches in the USA and to report, with recommendations, to the next session of our Conference in May 1965. The particular responsibility of our sub-committee is to examine accusations that have been made against the Council.

One of the chief charges has been that the Council is infiltrated by Communists and/or Communistic ideology. Believing that this is something of which the FBI would be sware if it be true, we are writing to inquire concerning this.

Does the FBI have evidence that the National Council is infiltrated by Communists or that Communist ideology is present in its actions and policies? Has the FBI ever officially stated or suggested that the National Council of Churches has Communists in its organization, or that it has Communistic tendencies in its program?

In a study of the National Council of Churches by the Alabama Legislative Commission to Preserve the Peace it is asserted that Dr. Harry E. Ward, formerly a professor at Union Theological Seminary in New York and founder ,, of the now defunct Methodist Federation for Social Action, "has been officially identified as a member of the Communists Party." Is there any basis for this assertion? Has the FBI so identified him? If not, who in your opinion other than the FBI or Dr. Ward himself could "officially" identify him as a Communists?

We know that you are limited by practical considerations as to what you can say. On the other hand, great issues are at stake. When accusations of this sort are made, if they be true, our church people need to know. We do not wish to support Communism in any fashion. If they are not true, the welfare of the church is threatened, for these charges cannot but breed suspicion and distrust in the minds of many people. Where suspicion and distrust of the church exist, the church is irreparably damaged.

SUBJECT: COMMUNIST INFILTRATION OF CHURCHES

United States Attorney Vernol R. Jansen of Mobile telephoned me this morning and said he had a request which he thought should be most properly handled at Bureau Headquarters rather than through the SAC at Mobile as it concerned quoted statements of the Director.

Mr. Jansen said that in connection with the current political campaign an early statement which the Director made supposedly to the Un-American Activities Committee as to communism in the National Council of Churches is being quoted widely throughout Alabama.

United States Attorney Jansen said that numerous protestant ministers had come to him pointing out they were aware of a second statement made by the Director about the National Council of Churches and asking that Jansen make this available to them so they could refute the current charges being made against the church.

Jansen went on to say that he had available on his desk a copy of the Director's latest book and had called appropriate pages therein to the attention of the visiting clergy but that didn't seem to satisfy them.

He indicated his belief that the statement being referred to by the ministers was probably made about three years ago. He ask if we could give him some guidance as to the Director's latest views on the National Council of Churches and any public source as to where this material might be located by him.

I cannot write to you without telling you how much I appreciate all you have done, are doing and, I hope, will continue to do to keep this country of ours free.



My dear Mr. Morton:

I am instructing you to erase my name from the roster of the ministers of the Presbytery of Phoenix, of the United Presbyterian Church, U.S.A.

I cannot longer give loyal support to a church that, through official action and pronouncements, unites with the forces of evil and goes on record as opposing the historic beliefs and doctrines that made us great and lent dignity and meaning to our preaching. I refer to the recent General Assembly's action relating to "public prayers, religious observances, religious holidays, Christian scenes, Bible reading in the schools and on school property; opposition to Sunday closing laws" and other deliverances one would expect atheistic groups to take but never such action from a church bearing the name and banner of our Lord and Saviour.

I cannot longer find fellowship in a church that blindly submits to the rule of Dr. Eugene Carson Blake who seems dominated by an omnipotent complex, associates with listed and known communists, deliberately breaks the laws of a sovereign state, and leads marches that can only inspire hate and provoke violence. 



Could you possibly furnish me with a certified copy of this pamphlet, or tell me where I may obtain one?



My concern is for reports concerning the National Council of Churches, which seem to be conflicting and both of which refer to the F. S. I. or the House Committee on Un-American Activities for support.


On the one hand, newspapers, peophlets, etc. refer to the National Council as definitely a Communist conspiracy, or at least overrun with Communist sympathizers. An illustration of this is a printed peophlet prepared by a Committee of the Session of the Pitts Presbyterian Church of Sunter, S. C. charged to investigate certain official records concerning the National Council. Since the chairman of this study committee, Harold R. Bauer, happens to be the highest ranking officer in the South Carolina National Guard (Major Beneral) I assume he is well informed. The peophlet claims to quote from a hearing Sefore the Committee on Un-American Activities on February 25, 1960 in which a Mr. Arens, Staff Director for the Committee said of a then incomplete check...

"thus far of the leadership of the National Council of Churches of Christ in America, we have found over 100 persone in leadership capacity with either Communist front records or records of service to Communist causes". This quote goes on to name Malter Russell Bowie, Henry J. Cadbury, Bearge Dehl, Leroy Maternan, and Fleming Jones as those with numerous affiliations with Communist fronts and causes. I know of most of these men as professors in Theological Seminaries.

On the other side, I have before me "Supplemental Report I, Report on National Council of the Churches of Christ in the United States of America, by the JOINT COMMISSION ON ECUMENICAL RELATIONS OF THE GENERAL CONVENTION OF THE PROTESTANT EPISCOPAL CHURCH IN THE UNITED STATES OF AMERICA (release Note January 30, 1964). On page 14 of this report the study committee says "We have tried honestly to investigate their accusations to the effect that the National Council of Churches is a Communist conspiracy or that it herbore Communist sympathizers and allies. In their examination, therefore, the manbers of our Study Committee met with personnel of the House Committee on Management Activities and the Federal Bureau of Investigation, but were not able to discover any fact or record that would support such charges. 




D ar Mr. Hoover:

I have in hand an article written by Mr. Louis Cassels, of United Press International, dated April 29, 1961, which appeared in a number of newspapers throughout the United States. The thesis of Mr. Cassels' article concerns Communist infiltration in sundry churches and organizations in the United States. The article states that the Communist party "has not achieved any substantial success in exerting domination, control or influence over America's clergymen or religious institutions on a national scale!". This statement was attributed to Mr. William C. Sullivan, at that time and perhaps still, Chief Inspector of the FBI.

The charge of Communist infiltration particularly in the National Council of Churches of Christ, has again been raised both by the newspapers and in the minds of a number of people in this community. The climate in Lynchburg is tense with regard to this matter, especially since the National Council of Churches became the sponsor of the Mississippi delta project this summer with its attendant school in Oxford, Ohio. Would it be possible for you or someone in your office to furnish me an authoritative, current statement concerning whether there has been Communist penetration into the NCC organization or any other church-dominated organization; and if so, the extent of such penetration. It is hoped you will not infer either that we do or do not have data in our files relating to the matters you mentioned.

The FBI, being an investigative agency of the Federal Government, neither makes evaluations nor draws conclusions as to the character or integrity of any organization, publication or individual. Therefore, I trust you will understand why I am not in a position to direct you to sources to obtain the information you have requested.

Enclosed is some literature which includes suggestions all of us can use in combating the menace of communism. I am also sending you a copy of one of my recent speeches. In addition, you may wish to read my books, "Masters of Deceit" and "A Study of Communism." These were written in order to help Americans gain an insight into the strategy and tactics of communists, both in this country and abroad. Copies may be available in your local library.




Dear Mr. Hoover:



J believe you have been accurately quoted. Will you give me a brief statement of your opinion of the National Council of Churches, that I may present it to the members of our congregation?






