The indictment alleges the defendants conspired to murder, bomb and maim. Specifically, the defendants were part of an international terrorist group dedicated to opposing non-Islamic governments with force and violence. The group calling itself "AL-QAEDA" was formed by defendants UBL and Muhammad Atef and others. It was a part and an object of said conspiracy that the defendants, and others known and unknown would and did murder United States nationals anywhere in the world. In furtherance of said conspiracy, and to effect the illegal objects thereof, the following overt acts, among others were committed:

Guesthouses and training camps for Al-Qaeda and its affiliated groups were established. American citizens were recruited in order to utilize the American citizens for travel. Surveillance of embassies took place. Financial dealings took place on behalf of Al-Qaeda, including, but not limited to: purchasing land for training camps; purchasing explosives; purchasing communication equipment; and transporting currency and weapons to members of Al-Qaeda worldwide.

Due to the large amount of documents being generated in the above referenced case files and the variety of classification levels involved, New York is requesting all offices proceed under the following guidelines when generating paperwork on these matters.

The [REDACTED] file is the criminal portion of the USAMA BIN LADEN investigation and any requests/responses for toll records, financial records or other subpoenas and other leads should be UNCLASSIFIED. Responses to leads should be contained on FD-302s, inserts or other appropriate documentation and forwarded in an unclassified manner. If the response/request contains information that should, by its nature, be classified, it should be directed to [REDACTED]. In addition, it is requested that all responses to New York contain the appropriate sub-file, which are referenced in the outgoing communication sent by NYO setting the lead. FD 302's should contain file # [REDACTED] for direct uploading in ACS under the [REDACTED] file. Additionally, [REDACTED]

Like previous suspected Usama Bin Laden-sponsored attacks in East Africa in 1998, and planned attacks in Jordan in 1999, the United States was the intended target for an attack designed to bring about the deaths of American citizens. In totality, two hundred and forty-one (241) persons, including 31 Americans, were killed in the terrorist bombings in Kenya and Yemen.

(U) In addition to targeting U.S. interests overseas, terrorists operating in support of the international jihad movement have also conducted acts of terrorism on U.S. soil. Specifically, on February 26, 1993, Islamic extremists of various nationalities aligned with Sheikh Omar Abdel Rahman, spiritual leader of the Egyptian Al Gama Al Islamiyya (AGAI) and the Egyptian Islamic Jihad (EIJ), bombed the World Trade Center (WTC) in New York City. Six persons were killed and another 1,000 were injured in this attack. Subsequent to this attack, the FBI thwarted a plot in June 1993 by other Islamic extremists operating under the guidance of Sheikh Rahman to bomb several targets in the New York metropolitan area. Ressam, who was carrying multiple forms of identification in varying names, was transporting items which could be used to make several explosive devices. To date, Ressam's target(s) in the United States are unknown. It is also unknown how many others were involved in the plot, and the organizational structure of the group of individuals associated with this case. In addition, it is unknown if Ressam was acting on behalf of a specific terrorist group/sponsor. Ressam and some of his conspirators have been linked to the overall Sunni Islamic extremists network.

~~(S)~~/NF) Guided by radical spiritual leaders, such as Sheikh Rahman, and extremist Islamic benefactors, such as UBL, terrorist attacks conducted by the international jihad movement are increasingly overshadowing attacks conducted by other terrorist groups and state sponsors. Further, the level of sophistication and lethality of attacks has significantly increased over the years. This is believed to be attributed to the conjoin of former Arab-Afghan mujahadeen with extensive explosives and combat experience into a movement dedicated to

Intelligence gleaned, thus far, from these operations indicates that the United States continues to be a primary target for attack by UBL and his supporters. In addition, intelligence suggests that there may be plans for additional attacks targeting U.S. interests. To date, however, the FBI is not in receipt of any specific target, location or time frame for reported UBL-supported attack(s). Nevertheless, disruption operations in the past have resulted in terrorist reprisals. As an example, in October 1995, the AGAI claimed responsibility for the suicide car bombing of local police headquarters in Rijeka, Croatia. This attack was in response to the detainment of an AGAI leader in Croatia. Further, in mid-November 1999, the FBI received information indicating that a Yemen-based UBL-aligned terrorist and unidentified terrorists residing in Pakistan had made plans to bomb U.S. targets in Saudi Arabia and Yemen.
