

On December 15, 1950, Confidential Informant T-16, of known reliability, who was in a position to observe ANNA M. ROSENBERG's activity during the early years of

He added that from his observations of her work as head of the local office of the War Manpower Commission, he had formed the opinion that Mrs. ROSENBERG was an absolutely loyal American, well chosen in her capacity as War Manpower Director for New York, and devoted only to "winning the war for the United States."

The informant stated that ROSENBERG to his knowledge was not a member of the Communist Party or any of its fronts or splinter groups and added that he knew personally that she had refused many invitations to functions sponsored in the early 1940s by the Communist Party as well as by the American Committee for American-Soviet Friendship.

According to Confidential Informant T-13, of known reliability, BELLA MIRIAM JOSEPH was estranged from her husband and was reported to be getting a divorce at Las Vegas, Neveda, in November, 1946.

On March 31, 1949, Confidential Informant T-15, of known reliability, reported that JULIUS JOSEPH JOSEPH, who at thattime was residing in New York City, had attempted to obtain employment with the Foundation for World Government, whose New York headquarters was located at 58 Park Avenue, which was the address of STRINCFELD BARD. According to the informant, BARD was a former professor at the University of Virginia and had been active in the Progressive Party.

The informant reported that it was believed that the Foundation for World Covernment was a Communist front organization. According to the informant, this organization was financed by one ALICE MC CORMICK BLAINE of Chicago, Illinois, who also contributed considerable money to the Progressive Party.

Confidential Informant T-16, of known reliability, reported that in April, 1949, one JOSEPH JOSEPH was active in the Mational Gouncil of Arts, Sciences and Professions and lived at 41 King Street, New Jork City. He stated that JOSEPH left the aforementioned address, however, and moved to 1535 Shore Parkway, Brooklyn, New York, Apartment 6-G. The informant stated that JOSEPH was married to one EVA JOSEPH, who was a Czech or Yugoslav whom he had met while working for the UNRRA in Europe. NY 62-106+1

LOUIS LOZOWICK 62 Massel Terrace South Orange, New Jersey (June 20, 1949)

Reference is made to the report of SA JAMES P. MARTIN, dated December 13, 1950, at New York, which sets out information concerning the John Reed Club of New York. One of the associates of this club, mentioned therein, is LOUIS LOZOWICK. Background information concerning LOZOWICK is being reported below.

According to Confidential Informant T-1, of unknown reliability, LOUIS LOZOWICK was co-author of the book, "Voice of October," which concerns art and literature in Soviet Russia, published in 1930.

A review of the "New Masses" magazines by SA JAMES R. SHINNERS reflected that as of May, 1932, in the magazine for that month, LOZOWICK was mentioned as a member of the Editorial Board of that magazine.

Confidential Informant T-2, of unknown reliability, who admitted being a member of the Communist Party until 1937, stated when interviewed in March, 1949, that in the 1930's while he was in Moscow, he met the wife of an artist, a Russian by birth, whose name was LOUIS LOZOWICK. The informant said that LOZOWICK'S wife worked at a publishing house in Moscow.

According to the informant, she often asked him if she should give up her American citizenship. She indicated to the informant that the Russian Foreign Office desired her passport. The informant stated that at that time he believed she was a Russian citizen. It is possible that this person is identical with the LOUIS LOZOWICK referred to previously.

The 1936 Icor Yearbook, a publication of the Icor Association for Information on the Economic, Cultural and Social Life of the Jews the World Over, Inc., reported that LOUIS LOZOWICK sponsored a delegation of American Jews invited to visit Biro-bidjan as guests of the Soviet Urion. Other sponsors listed were WILLIAM CROPPER and MICHAELAGOLD, Editor, "New Masses."

According to Confidential Informant T-3, of unknown reliability, LOZOWICK was a member of the Subjects and Approvals Committee, Works Progress Administration Art Project, New York City. This information was furnished on July 12, 1940. The informant also stated that LOUIS LOZOWICK was a Communist.

Confidential Informant T-4, of known reliability, in 1941 furnished records of the Amtorg Trading Corporation reflecting the names of members of the CIO who were agents of the Amtorg Trading Corporation within the CIO and recipients of money from Amtorg. According to the list of recipients, LCUIS LOZOWICK, New York, received the sum of \$6,000.

Confidential Informant T-5, another governmental agency which conducts investigations, advised in August, 1942, that LOUIS LOZOWICK was listed as one of the persons who supported the Communist Party candidates for President and Vice-President in 1932, namely. FOSTER and FORD. The informant also advised that LOZOWICK'S name appears on the pamphlet entitled, "Culture and the Crisis," which was issued by the League of Professional Groups for FOSTER and FORD.

The informant also advised that information had been reliably reported that LOZOWICK was a member of the Communist Party and as a Communist organizer had received money from the Third Internationale. The informant also reported that LOZOWICK was a member of the United American Artists and signed a letter to President ROOSEVELT urging aid to Britain. He contributed art work to New Masses Art Auction on April 5, 1942. According to the informant, LOZOWICK was also associated with the New Theater Group.

According to a memorandum of the Cultural Committee of the National Council of American Soviet Friendship, Inc., which was furnished to this office on May 4, 1944, Mr. CORLISS LAMONT reported that in connection with the Artists Committee of the Council, a portfolio of American black-and-white drawings had been presented by a group of artists, among whom was LOUIS LOZOWICK. These drawings were to be exhibited at the Metropolitan Museum of Art and later to be sent to the Soviet Union.

A letter on the stationery of the American Committee for Spanish Freedom, 55 West 42nd Street, New York City, which is dated December 7, 1946, listed LOUIS LOZOWICK as a sponsor.

A form letter of the American Jewish Cultural Congress, whose headquarters are located at 189 Second Avenue, New York City, which is dated August 25, 1947, reported that LOUIS LOZOWICK was a sponsor of the organization. Confidential Informant T-6, of known reliability, advised on September 4, 1947, that LOUIS LOZOWICK was a sponsor of the American Committee for Yugoslav Relief, Inc.

The "Daily Worker," May 17, 1948, page 13, column 3, reported that LOUIS LOZOVICK was a sponsor for a conference to be held at the New School Auditorium, New York City, on June 18 and 19, 1948, to disclose the status and perspective of American Jewish culture in English.

A letter of the Joint Anti-Fascist Refugee Committee, Suite 1501, 192 Lexington Avenue, New York City, furnished by Confidential Informant T-7, of known reliability, listed LOUIS LOZOWICK as a national sponsor.

According to Confidential Informant T-8, of known reliability, LOUIS LOZOWICK was a sponsor of the "Action Committee to Free Spain Now." This information was furnished on May 18, 1946.

In connection with this investigation, it is noted that on December 9, 1950, when being interviewed concerning another matter, Mrs. HAROID D. HOOPER, 504 Lee Street, Evanston, Illinois, telephone University 4-6563, advised that in connection with the recent newspaper publicity regarding Mrs. ROSENBERG's alleged membership in Communist front organizations in the 1930's, she recalled that her sister-in-law, CARMEN S. LEE, was well acquainted with Mrs. ROSENBERG during that period.

Mrs. HOOPER stated that she herself had met Mrs. ROSENBERG in the 1930's while Mrs. HOOPER was doing charitable work in New York, but does not recall anything concerning her other than that she was doing social work. She did not recall how Miss IEE met Mrs. ROSENBERG, but remembered that they came to associate socially. She said Miss IEE presently resides with a wealthy family named GIFFORD on Chestnut Hill Road, Wilton, Connecticut, where she is a governess for the GIFFORD children.

INFORMATION CONCERNING MRS. ISIDORE KLEIN, nee ANNA ROSENBERG

Re: Horace Gregory

It is noted that information has been previously set out in this investigation concerning the Petition of the John Reed Club which appeared in the May 19, 1930 issue of the "New York Times". An examination of the list of signers of this petition reflects that included thereon was the name HOLACE GREGORY.

Further, the report of Special Agent JAMES P. MARTIN dated December 13, 1950, at New York, reflects information from an article by MICHAEL GOLD, appearing in "New Masses" issue of January, 1930. This article describes the early activities of the John Reed Club and makes mention of one "GREGORY" and also of one "MLEIN".

On December 18, 1950, HORACE GREGORY was interviewed at the New York Office by SA ELMIR M. ROTH and SA JAMES P. MARTIN. The following information was obtained:

HORACE GREGORY, lecturer on Poetry and Critical Theory Stat Sarah Lawrence College, Bronzville, New York, since 1934, presently resides at 59 Horatio Street, New York City.

During the early 1930's, GREGORY stated, he was very strongly in favor of Communism, associated with numerous individuals sympathetic towards Communism, and as a free lance writer contributed articles to the "New Masses".

By approximately 1936, he becaue disillusioned with Communism, having observed that it restricted writers in their Freedom of thought and expression. Having turned against the movement, in 1936 he wrote an article which he said was published in the "New Masses", entitled "Why I im Not a Communist". GREGORY asserted that he thereafter completely divorced himself from Communism, fost many of his friends, and is strongly opposed to Communism to this day.

After reading a newspaper account recently in the "New York Times" about the accusations against ANNA M. ROSENBERG, Assistant Secretary of Defense, and discussing it with his wife, the former MARYA ZATURENSKA, it occurred to both GREGORY and his wife that the ANNA ROSENBERG who had been a member of the John Reed Club, is very probably the present Mrs. ISIDCRE FLEIN, whom GREGORY had met during the 1920's, and whom Mrs. GREGORY subsequently came to know.

GREGORY recalled that he first net ANNA ROSENBERG (the present Mrs. KLEIN) through JOSEPH FREIMAN, during approximately 1924. He learned from FREEMAN at that time that ANNA ROSENBERG came to New York City from the State of Pennsylvania, and had endeavored to pursue a career of painting. It was his recollection that when she was unsuccessful in this ambition, she obtained a position as a stenographer.

Shortly after her arrival in New York City, ANNA ROS INBERG met an individual named FREDERICK FIELD, whose original name GREGORY recalled to have been SIMON FELSCHICN or FELSHION, whom she married.

GREGOLY learned at that time that FIELD, a school teacher in the New York school system, stemmed from a well to do family outside New York City, which family had invested considerable time and money in the cause of Zionism. FIELD however became greatly disillusioned with the cause of the Jewish homeland, and became a very enthusiastic Communist.

To the best of GAEGORY'S recollection, the marriage between ATNA ROSENBERG and FREDERICK FIELD broke up during the late 1920's or early 1930's. GREGORY stated that from approximately 1924 on he frequently met ANNA ROSENBERG at social and literary functions.

GREGORY said that during the latter part of 1029 of the early part of 1930, he was one of the earliest or charter members of the John Reed Club, although he only attended meetings spasmodically, that is, three or four times a year. GREGORY did not recall having seen ANNA ROSEVELAG or RALEY DESOLA at Acetings" of the John Reed Club, but did recall having seen JAMES MAGRAM.

To the best of his recollection, sometime during 1929 GREGORN became acquainted with ISIDON ALEIN, generally known as I. KLEIN, who at one time worked as a cartoonist on the "New Yorker" magazine. He recalled that KLEIN made numerous sketches of the members of the John Reed Club of which KLEIN himself was a member. He stated that shortly after the marriage of ANNA ROS_NBERG and FREDERICK FIELD broke up, ANNA ROSENTERG married I. KLEIN.

GREGORY also positively recalled that sonctine during the latter part of 1929 or possibly during 1930, I. HLEIN informed GREGORY that ANNA ROSENBERG was then a member of the John Reed Club.

GREGORY stated that when he first net ANNA ROSENBERG che was approximately eighteen to twenty-one years of age, short of stature, with dark eyes, dark brown hair, possessing good features and an attractive personality, and rather on the plump side. He stated that on a few occasions he heard her sing at social gatherings.

GREGORY said that he and his wife maintained social contact with the KLEINS up until some three years ago, and that the last time they met was at the residence of ISIDORE KLEIN, 18-32 38th Street, Long Island City, New York.

GREGORY recalled that some several years ago in discussing Mrs. ISIDORT KLEIN with JOE FREEMAN, the latter mentioned that Mrs. KLEIN'S maiden name had been ANIL ROSENDERG and FREEMAN made mention of the fact that this ANNA (SEMBERG had been associated with the John Reed Club.

Photographs of ANNA M. RCSLNBERG, Assistant Secretary of Lefense, were exhibited to GREGORY, and he stated that these bore no resemblance to the ANNA ROSLNBLRG he knew in the John Reed Club.

Re: Interview of Mr. and Mrs. Isidore Klein

During the evening of December 18, 1950, Mr. and Mrs. ISIDORE KLEIN were interviewed at their residence, 48-32 38th Street, Long Island City, New York, by Special Agents THOMAS E. C BRIEN and ELMER M. RCTH.

ISIDORE KLEIN stated he is an artist and cartoonist by background, presently employed as story-writer or gag-man for animated cartoons by Famous Studios, 25 West 45th Street, New York City. He said he generally signs his cartoons and illustrations as I. KLEIN.

KLEIN asserted that he became a member of the John Reed Club sometime after 1930, although he could not recall the exact date, and belonged to the club for about a year. During his membership he recalled having attended numerous meetings, and he exhibited a number of sketches which he made of the members.

According to KLEIN, at the time he joined the John Reed Club he was a free lance artist, and aside from the social aspects of the club he was prompted to join in an endeavor to arrange an exhibition of his work. This plan, however, never materialized, and he gave up attendance at club functions because he "did not like the atmosphere." He explained that he concluded that too much emphasis was placed on politics at the club meetings and not enough on art.

Both Mr. and Mrs. KLEIN readily stated that Mrs. KLEIN'S maiden name was ANNA ROSENBERG, and that during the time I. KLEIN was a member of the John Reed Club, ANNA ROSENBERG attended a number of meetings of that organization in KLEIN'S company. They both pointed cut that membership in the club involved practically no formalities, and no dues were collected.

Mrs. KLEIN furnished the following background information concerning herself:

As ANNA ROSENBERG, she was born in Lublin, Poland, on April 7, 1904. She came to the United States with her parents sometime around 1911, although she was unable to recall

the exact year or date. She stated she received derivative citizenship through the naturalization of her father, on May 25, 1915, and exhibited a photostatic copy of the naturalization papers which contained the following information:

MORIS ROSENBERG, age 44, height 5' 5", residence 36 Townsend Street, Pittsburgh, Pennsylvania, born in Russia, became a naturalized United States citizen in the United States District Court at Fittsburgh, Pennsylvania on May 25, 1915. The age of his wife was given as 42, and his children were listed as follows:

After finishing the Fifth Avenue High School at Pittsburgh, ANNA ROSENBERG attended the College of Fine Arts, Carnegie Institute of Technology, Pittsburgh, on a scholarship, during the years 1919-1920.

In 1924 she came to New York City and continued her art studies at the Art Students League of New York. She became friendly with SOPHIE FRANKEL, later SOPHIE GROPPER; and through her she met JOSEPH FREEMAN sometime during 1924 or 1925.

During 1924 or 1925 ANNA ROSENBERG married FREDERICK FIELD, and this marriage terminated in divorce during 1931.

During June, 1928, ANNA ROSENBERG, then Mrs. FREDERICK FIELD, went to Paris, where she met ISIDORE KLEIN. The then Mrs. FIELD, returned to the United States in November, 1928, and ISIDORE KLEIN preceded her to the United States. Following their return to the United States, Mrs. KLEIN stated they were married, "for the record", on August 2, 1932. She has one born in from this marriage, and another first name presently married, from the first marriage. NY 62-106+1

The KLEINS stated that during the end of 1934, they moved to Hollywood, California, where KLEIN for a time worked for the Walt Disney Studics. They returned to New York State during 1940 and have resided here since. Both Mr. and Mrs. KLEIN professed never to have met ______ or JAMES MAGRAW at the John Reed Club or elsewhere, and stated they could not recall being acquainted with these individuals.

A photostatic copy of an article which appeared in the "New York Times" on May 19, 1930, ontitled "'Red Scare' Protest Issued by Liberals", purporting to be "A protest against the imprisonment of men and women for expressing their political opinions..." and containing the names of the signers was exhibited to the KLEINS. When it was pointed out that the names of the signers included the names I. FLEIN and ANNA HOSLNDERG, they stated they could not recall having signed the particular document in question, although I. KLEIN added that during his membership in the John Reed Club he had signed many papers withcut inquiry, and that I. KLEIN would be the manner in which he would ordinarily sign his name.

Mrs. KLEIN stated that in addition to having no recollection of having signed the statement in question, she was at a loss to understand as to why, if she was actually the signer, she signed in that manner rather than as Mrs. FREDERICK FIELD, or as MRS. I. FLEIN. She did state, however, that, during that period, her art productions, such as pertrait paintings, were signed as ANNA ROSENBERG.

The KLEINS asserted that they had never known any other AMMA ACSEMBERG associated with the John Reed Club. Mrs. KLEIN stated that it has amused her to follow the career of the present Assistant Secretary of Defense because of the similarity in name; further, that when she recently read newspaper accounts of the charges against ANNA M. ROSENBERG, the thought occurred both to her and her husband that she, Mrs. KLEIN, night be the ANNA ACSENBERG involved as a member of the John Reed Club, but that they dismissed the matter by reflecting that during the pertinent period, as above indicated, Mrs. KLEIN would have been known by some name other than AMNA ROSENBERG.

In this connection, both Mr. and Mrs. KLEIN readily concoded that a number of individuals with whom Mrs. KLEIN became acquainted when she first arrived in New York may still think and speak of her as ANNA AOSENEERG, and that undoubtedly come members of the John Reed Club thought and spoke of her under this name during the time she was associated with the Club.

During the interview it was observed that Mrs. KLEIN is rather inclined to be corpulent, although not fat, and she stated that her stature had been substantially the same for many years. She gave her height as five feet.

Re: Reinterview of Mrs. ISIDORE KLEIN

During the afternoon of December 19, 1950, Mrs. ISIDORE KLEIN was again interviewed at her residence by SAS RUDOLPH V. GLINIAK and ELMER M. ROTH.

At this time, Mrs. KLEIN said she was able to recall definitely that she and her family moved to Hellywood, California during January 1935 rather than during the latter part of 1934, as stated the previous evening. She advised that in April, 1940 she and her family moved to New Rochelle, Westchester County, New York, where they remained until 1945. Since 1945 the KLEINS have resided at their present home at 48-32 38th Street, Long Island City, New York.

Mrs. KLEIN furnished the following signed statement:

"New York, N.Y. "December 19, 1950

"I Mrs. Isidore Klein, nee Anna Rosenberg, make the following statements to RUDOLPH V. GLINIAK and ELMER M. ROTH, who have identified themselves as Special Agents of the FBI. I make these statements freely and voluntarily:

"As Anna Rosenberg I was born in Lublin, Poland on April 7, 1904, and came to the United States around 1911, although I am unable to recall theexact year. I became a U.S. citizen through the naturalization of my father on May 25, 1915 at Pittsburgh, Pa.

"After finishing high school, I attended the College of Fine Arts, Carnegie Institute of Technology, Pittsburgh, during 1919-1920.

"In 1924 I came to New York City and continued my art studies at the Art Students League of New York.

"In 1930 I was residing in New York City at which time I was generally known as the wife of ISIDORE KLEIN. During approximately 1930, my husband was a member of the ER:MMCM

"John Reed Club at New York City, which membership lasted about a year. While he was a member both he and I attended gatherings of the John Reed Club on Fourteenth Street, although I am not certain of the location. I was principally interested in exhibiting my oil paintings.

"After my husband and I severed our connection with the John Reed Club, we continued to meet at the homes of friends which gatherings included occasional members of the John Reed Club.

"Both at meetings of the John Reed Club and at private gatherings I was known either as Mrs. I. KLEIN or as ANNA ROSENBERG. All my works of art during the period under discussion were signed as ANNA ROSENBERG.

"I recall that around 1930 two of my paintings provoked some comment. One was a portrait of a friend exhibited at the Opportunity Gallery, and the other portrayed another friend displayed at the then Anderson Galleries. Both of these paintings were signed by me as ANNA ROSENBERG.

"I do not recall having met at any time JAMES MAGRAW or BENJAMIN H. FREEDMAN. Nor am T ware that any other ANNA ROSENBERG had ever been a member of the John Reed Club.

"In January, 1935, when I was an expectant mother, I moved to Hollywood, California with my family. During 1937, I visited in Pittsburgh for a week and spent another week in Rewark, N.J., accompanied by my two daughters. During this visit I do not recall meeting any member of the group above discussed, and returned to Hollywood.

"During April 1940 my family and myself moved to New Rochelle, Westchester County, N.Y. and remained there until 1945. Since 1945 we have been living in our present home, Long Island City, N.Y.

"Upon reading the November 9, 1950 account in the 'New Kork Post' concerning the testimony of alleging that ANNA M. ROSENBERG, Assistant Secretary of Defense, had been a member of the John Reed Club, my first reaction was that I may be the person being confused with ANNA M. ROSENBERG. However, in discussing the matter with my husband ER:MMcM

"he pointed out that according to the news article the dates included were 1935 and 1938 at which time we were in California, whereupon I dismissed the matter from my mind, especially after my husband called my attention to the fact that there are numerous individuals named ANNA ROSENBERG in the New York area.

I now realize that although I did not know all members and visitors who frequented the John Reed Club, I cannot recall any other person known there as ANNA ROSENBERG. Therefore, in spite of the discrepancy in dates, above referred to, I feel it may be possible that I am the person who has been confused with ANNA M. ROSENBERG.

"I have read the foregoing five handwritten pages, have placed my initials on corrections, and affirm that the contents are true to the best of my knowledge.

The following investigation was conducted by Special Agent ELMER M. ROTH:

Throughout the interview on December 18, 1950, Mr. and Mrs. ISIDORE KLEIN exhibited a highly cooperative attitude.

Mrs. KLEIN indicated that she was greatly concerned about possible publicity attached to her past membership in the John Reed Club, and she stated that she was most anxious that her ______ whose married name she would not divulge, presently an expectant mother and highly nervous, be spared any unpleasantness.

She made available a small photograph of herself taken during 1930 or 1931 but only with the stipulation that this picture will not be released by the Bureau or given to an outside agency. It was pointed out to her that the <u>purpose</u> of the photograph would be to exhibit it to ______ and possibly others, but that this Bureau would do everything possible to accede to her wishes in this regard.

ISIDORE KLEIN also made available, with similar stipulations, a sketch which he stated he made of ANNA ROSENBERG during the early 1930's.

The photograph and the sketch are to be returned to the KLEINS after they have served their purpose.

During the interview with Mrs. KLEIN on December 19, 1950, she stated that in the interest of clearing the accusations made against ANNA M. ROSENBERG she had no objection to having the above photograph and sketch exhibited to any proper committee or governmental agency, provided that such action would not result in newspaper publicity. She reiterated her desire to avoid publicity, pointing out that as a prospective grandmother she was desirous of protecting her reputation, and that her association with the John Reed Club was actually prompted by artistic rather than political motives. b6 b7C

No commitments regarding publicity were made to Mrs. KLEIN, although she was assured that her wishes would be conveyed to the Bureau.

In the statement furnished by Mrs. ISIDORE KLEIN, nee ANNA ROSENBERG, the names of former friends, associates, and family members were omitted at her specific request.

It is to be noted that ANNA ROSENBERG took a trip to Paris during 1928, by which time she was estranged from her first husband, FREDERICK FIELD, although, according to her, a divorce was not obtained until 1931, and her marriage with ISIDORE KLEIN was not consummated until August 2, 1932. Mrs. KLEIN volunteered the information that prior to 1932 she had been a common-law wife to KLEIN, which set of facts may explain her use of the name of ANNA ROSENBERG on occasions.





ROSENBERG, nor did she know any individual by the name of ANNA ROSENBERG.

On December 19, 1950, Special Agents THOMAS W. KELTY and JAMES H. HIGDON, Jr. interviewed LOUIS LOZOWICK at his art studio, The Art Corner, 104 West South Orange Avenue, South Orange, New Jersey.

Mr. LOZOWICK advised that he was a member of the Artist's Section of the John Reed Club, New York City, New York, from about 1930 to 1932. He stated that this club at that time consisted primarily of artists, writers and persons who were affiliated with the motion picture industry. He related that the total membership of this club did not exceed 100 persons during the period 1930 to 1932. LOZOWICK continued that he believed there were approximately thirty to forty active members in the John Reed Club and he noted that the artists and the writers sections of this club probably consisted of fifteen members each.

Mr. LOZOWICK identified the John Reed Club as being a club that was organized primarily to aid and help fellow artists and writers. He continued that to his knowledge, the John Reed Club was not a Communist club or a Communist Party club, but he added that its members perhaps included some Communists or Communist Party members.

Mr. LOZOWICK went on to state that on some occasions the John Reed Club had political issues of the day discussed and that on some of these occasions these discussions may have been "politically left."

Mr. LOZOWICK advised that he did not know of any ANNA ROSENBERG ever being a member of the John Reed Club during the period 1930 to 1932 and he added that he had never heard of a person by the name of ANNA ROSENBERG ever attending any meetings of the John Reed Club during this period of time.

Regarding the John Reed Club Petition to the "New York Times" on May 19, 1930, Mr. LOZOWICK related that he did not recall signing this petition, although in all probability, he stated, he was identical with the LOUIS LOZOWICK who was referred to in instant petition.

In this connection, Mr. LOZOWICK continued that it was customary in the John Reed Club that blanket endorsements be given by the entire membership of the club without the specific knowledge or approval of the members concerned.

He related that the name HELEN WINNER was not unfamiliar to him but he stated that he could recall nothing about her.

In connection with the WPA, Writers Project Communist Cell, LOZOWICK stated that to his knowledge no such Communist Cell existed within the Writers Project of the WPA, although, he stated, it was quite possible that persons with Communist leanings or persons who were actually members of the Communist Party were employed on the Writers Project of the WPA.

LOZOWICK volunteered the following information concerning himself.

He stated that he was never a Communist, a member of the Communist Party or a Communist sympathizer. He stated, however, that on numerous occasions in the 1930s and the early 1940s he lent his name to various organizations which have subsequently been identified as Communist front organizations. LOZOWICK did not elaborate on the identity of the Communist front organizations to which he had loaped his name, but he did state that he was aware at the time that some of these organizations had "Leftist tendencies." Still in this same connection, LOZOWICK stated that on many occasions his name appeared as being a sponsor of or affiliated with various "Communist front organizations" when he, LOZOWICK, had no personal knowledge that his name was being used as a sponsor or mentioned as being affiliated with such organizations.

LOZOWICK stated that he had never been in contact with the Communist Party of New Jersey nor to his knowledge had he ever been contacted by any members of the Communist Party of New Jersey. He stated that although he was not a member of the Progressive Party in New Jersey, he had on several occasions attended meetings of the Progressive Party and had loaned some of his paintings to Progressive Party sponsored gatherings. b7D

Chicago report regarding CONRAD ALEXANDER KOMOROWSKI, was, dated March 5, 1945, reflects that at this time KOMOROWSKI was residing at 3648 South Lake Park Avenue, Chicago.

Chicago letter to New York, dated October 30, 1946, shows that the above KOMOROWSKI was formerly married to one MABEL WORTHINGTON.

New York letter to Chicago, dated December 3, 1946, shows that KOMOROWSKI married MABED PARKER WORTHINGTON on June 12, 1930 at the Municipal Building in New York City.

Chicago letter to New York, dated December 10, 1948, indicated that possibly the maiden name of KOMOROWSKI'S present wife is NAOMI SCHOENBAUM. Chicago letter to New York, dated March 30, 1950, showed that the above NAOMI KOMOROWSKI came to Chicago from New York City in 1941 or 1942. Information received from the Chicago Office indicated that Mr. KLEIN can be located at 261 Broadway, New York City.

EDWARD DAHLBERG, Book Reviewer for the "Free Man", an anti-Communist magazine, when interviewed at the New York Office on December 11, 1950, suggested the names of several individuals, described by Mr. DAHLBERG as former members of the John Reed Club who might be in a position to furnish information concerning ANNA ROSENBERG. Among those individuals not interviewed but suggested by Mr. DAHLBERG were MALCOM GOWLEY, FANNY FOSS, JOHN HOWARD LAWSON, ALBERT MALTZ, WILLIAM SAROYAN, and ORRIK JOHNS. It is noted that inquiry reflected that ORRIK JOHNS is deceased.

WILLIAM HENRY ALEXANDER CARR was suggested by the Chicago ffice as a possible source regarding the activities of the John Reed Club in the 1930s. He is now presently believed to be residing in New York City. This individual has not been located by the New York Office.

Dr. WILLIAM DOHM, a veterinarian, 55 Bryant, Roslyn, Long Island, New York, was suggested by Miss CARMEN S. LEE of Wilton, ^Connecticut as an acquaintance of an unidentified Hungarian woman whom ANNA M. ROSENBERG is supposed to have aided in obtaining employment with the NRA during the mid-1930s.

MAURICE MALKIN, who, according to NORA DE TOLEDANA, was told by HOWARD RUGHMORE that MALKIN could definitely place JAMES MCGRAW as a member of the Communist Party in the past. MALKIN was not interviewed, pending Bureau authorization.

ABE SAVAGE, described by ARTHUR HALLIBURTON, present whereabouts unknown, was public relations man with the War Manpower Commission at the time Mrs. ANNA M. ROSENBERG was directing its activities at New York. HALLIBURTON suggested that SAVAGE might possibly have some knowledge of the activities of the John Reed Club.

BEN RESKIN, according to Mr. HALLIBURTON, was an individual who was with the Writers Froject of the WPA in 1935. He reportedly left the Writers Project in 1936 to become the editor of a UEW-CIO publication. Mr. HALLIBURTON indicated that RESKIN may have been active in the Communist Party around 1935 and may have information regarding the activities of the John Reed Club.

CLINTON SIMPSON was described by WALTER SNOW of Willimantic, Connecticut, as a former member of the John Reed NY 62-10641

Club, a former editor of the "Partisan Review", and presently associated with Alfred Knoph, Incorporated, New York City. Mr. SNOW was of the opinion that SIMPSON was at one time affiliated with the Communist Party and suggested the possibility that SIMPSON may have broken with the Communist Party.

MAX EASTMAN, 81 West 30th Street, New York City, signed the John Reed Club petition in 1930 which contained the name ANNA ROSENBERG.

JOHN DOS PASSOS, Snedens Landing, Palisades, New York, signed the John Reed Club petition in 1930.

An individual who described himself as Mr. HALLAM M. RICHARDSON of Brooklyn, New York, telephonically contacted the New York Office on December 12, 1950, during which time he advised that ANNA M. ROSENBERG was quoted as stating in the public press that she had completed her education in New York City andhad never been abroad, except on three official occasions. Mr. RICHARDSON referred to "Time" Magazine, issue of March 21, 1935, page 18, which quotes Mrs. ROSENBERG as stating, "After I returned and continued my education there (Budapest) for a short period of time. Then I came back here and looked for a job."

Mr. RICHARDSON stated that according to the newspaper articles, during ANNA M. ROSENBERG'S testimony before the Senate Armed Forces Committee, she was always careful to use the middle initial "M" when referring to herself.

Mr. RICHARDSON stated that the "New York Times" issue of September 17, 1934, page 1, column 6, quotes General HUGH JOHNSON of the NRA as referring to Mrs. ROSENBERG as ANN L. ROSENBERG. He said that accordingly he desired to point out that ANNA M. ROSENBERG might also be known as ANN L. ROSENBERG.



<u>Re EDMOND WILSON</u>

At Wellfleet, Massachusetts

The following investigation was conducted by SA's WILLIAM H. CARPENTER and BARTON N. HAHN.

EDMOND WILSON, Money Hill, Wellfleet, Massachusetts, who identified himself as a summer staff member of "New Masses" and "New Yorker" magazines at New York City, and who is currently writing fiction, was interviewed on December 20, 1950. He stated he was not acquainted with ______ JAMES MAGRAW, and did not know any person nemed ANNA M. MOSENBERG.

In addition, WILSON stated he was not acquainted with and never belonged to the John Reed Club in New York City or elsewhere. He asserted he never knowingly attended any meetings of the John Reed Club or any meetings sponsored by the John Reed Club, but stated he may have signed petitions protesting Red baiting which was sponsored by the John Reed Club and which were circulated during the early 1930's. Mr. WILSON could not recall with certainty whether or not he had signed any such petitions.

WILSON acknowledged that he knew of the existence of the John Reed 'lub of New York City during theearly 1930's and that he was friendly with members of the Club and had also association with some persons who were known to him to be "Communists"; and, under such circumstances, he did sign several petitions reportedly directed against Red baiting but that he now has no specific recollection of the persons in question who were associated with the John Reed 'lub, nor could he identify the persons. During the course of discussion with relating to the individuals with whom he was associated during the early 1930's and who were identified with the Communist Party, Communist Party interests, Marxist study groups, and related associations, provided the following information: In connection with a series of Marxist discussions held at New York City, during the early 1930's, stated that among those present were JAMES MAGRAW, previously identified; and the following: ABE SUGARMAN. stated SUGARMAN was an openly avowed Communist Party member who was a New York book seller and dealer in books: WALT KUHN. KUHN was an artist who openly stated he was a member of the Communist Party and b6 who was believed by to be deceased. b7C b7D TOM SPENCER. Member of W.P.A. Writers Project and admitted Communist Party member. CHARLES GORHAM. Admitted member of the Communist Party who served in the RCAF during World War II. During this period also had contact with MENRY ALLSBERG of New York who was the National Director of the W.P.A. Writers Project. ALLSBERG did not attend the Marxist classes referred to above and was not an openly admitted member of the Communist Party but was a very close friend of JAMES MAGRAW and was felt was willing to associate a person whom himself with individuals who were Communists and the then interests of the Communist Party. It should be noted that is not in position to specifically identify by date or otherwise many of the facts set forth herein due to his current mode of living wherein he lives on a day to day basis from Welfare Agencies to Rescue Mission and is periodically under the influence of alcoholics.

During the course of these interviews, he appeared to be friendly and cooperative and made an effort to recall to mind the factors contained herein. He stated he had no papers of any kind which would be of assistance to him in connection with these factors.
