Mr. DUDLEY W. REYNOLDS, 126 Barksdale Drive, NE, Atlanta, Georgia, advised that while waiting for a bus in June of 1946 he had conversed with a neighbor of his, KENDALL WEISIGER, of 206 17th Street, NE, Atlanta. REYNOLDS stated that WEISIGER told him that he had made a speech at the Lula High School, Lula, Georgia, at the request of DONALD LEE WEST when he had been principal of the high school and that because of his, WEISIGER's, speech the patrons of the Lula High School had fired WEST. REYNOLDS stated that WEISIGER told him he had arranged and obtained a position at Oglethorpe University for DONALD LEE WEST as a professor.

REYNOLDS advised he was not well acquainted with WEISIGER but that he understood WEISIGER had taken a tour through Texas and had made quite a few speeches at different high schools and that he was retired on a pension from the Southern Bell Telephone Company. REYNOLDS further advised that WEISIGER, as he recalled, had been very much interested in labor while employed by the Southern Bell Telephone Company and it was his understanding he had been a "trouble maker".

Mr. REYNOLDS stated that he was bringing this information to the attention of the Federal Bureau of Investigation because KENDALL WEISIGER has been appointed a member of a board to review loyalty cases in the Atlanta area.

Mr. ERNEST W. HAYES, Civil Service Commission, Atlanta, advised that Mr. KENDALL WEISIGER of 206 17th Street, NE, was one of the four members of the Loyalty Board for this area.

WHITNEY of the Railroad Brotherhoods which was held in the Hermitage Hotel during the spring of 1948. Informant stated that this banquet was attended by representatives of the Railroad Brotherhoods, CIO, A.F. of L., independent unions and all manner of labor representatives. He stated that he attended this banquet, and that he recalls subject having been present but does not recall his having taken an active part in the proceedings. He stated that there were a number of meetings held during the course of the gathering of labor representatives and he vaguely remembers that WEST attended one of these meetings. However, he stated that he did not recall the name of the group or the nature of its business. He stated that he had known WEST for quite sometime and considered him to be very radical. stated he did not recall anyone else who attended the meeting that WEST went to, nor did he recall anyone else at the banquet who might be able to throw further light on the subject.

Temporary Confidential Informant T-1 advised that on April 18, 19 and 20 the Dixie Conference of Railroad Train Men was held at the Hermitage Hotel, Nashville, Tennessee, and that a number of prominent labor leaders addressed the gathering, including A. F. WHITNEY and JAMES CAREY, CIO leader. Informant stated he did not recall subject's name and stated that he did not stay at the Hermitage Hotel during that period. It is noted that referenced report reflects that subject was in Nashville for only one day.

He is being given a temporary confidential informant symbol by virtue of the information furnished by him.

Bragg says the camp program is designed to provide the youths a sense of sharing in useful enterprise and an experience in group living. He said the program evolved from the war, when youth-work bands were organized to help harvest crops.

West was reluctant to discuss the camp, saying it was none of The Constitution's business. When asked whether or not he was a Communist, West refused to answer.

Bragg, however, said the camp was operated strictly on a non-sectarian, non-political, non-racial basis and a man's politics did not enter into one's relationship with the camp.

West said the camp was connected in no way with the People's Institute of Applied Religion, an organization, with headquarters in Birmingham, which U. S. Atty. Gen. Tom Clark has called subversive.

West says he is participating in religious activities of the community and has made talks in various churches. He said he is a minister of the gospel, as well as an educator. He said he formerly was a Baptist, but now is a Congregationalist.

The two boys enrolled in the camp refused to give their names for publication and also refused to be photographed. They said their refusal was based on newspaper criticism of West.

The girls, all of high school age, are Nona Baird, of New York City; Marcia Haseltine, Belmont, Mass.; Jean Roethlisberger, Cambridge, Mass.; Helen Devine, Duluth, Minn.; Renee Neu, of New York City, and Ann West, daughter of Don West.

Maurice Filler, of Lowell, Mass., is Director of the camp. John Teger, Director of all Unitarian work camps, is also helping to organize the Georgia camp.

People of the community in which the camp located say they don't know much about it other than they have heard West intended to bring in underprivileged children. C. E. Hall, a farmer, exhibited a copy of West poems, "Clods of Southern Earth," which he said West gave him to read.

Don West Helps Organize Youth Work Camp

By BILL BORING.

Don West, Georgia educator and poet (a line of one of his poems reprinted in The Daily Worker, official mouthpiece of the Communist Party in this country, states, "I am a Communist . . ."), is helping to organize a work camp for teen-aged youngsters in a rural

The camp, now populated by six girls and two boys from Eastern and Midwestern cities, is situated on a 200-acre farm owned by West. It is sponsored by the Unitarian Service Committee of the Unitarian Church as one of nine such camps in the U. S., according to Raymond B. Bragg, Executive Director. Bragg was at the Georgia camp yesterday on an inspection tour.

West says that while the camp currently is being operated as a work camp for youths, he hopes to develop it eventually into a camp for underprivileged Georgia children.

Present guests of the camp have been there since July 1 and will remain two weeks longer, according to the directors. They are all high school youngsters who say they are finding the pursuit of social studies in the South exciting.

A typical day at the camp begins with breakfast at 7, followed by a two-hour work period, usually of remodeling into a dormitory one of the old barns on the place. Another two-hour work period comes in the afternoon. Evenings usually are taken up with discussions of social and economic problems of the South (such as sharecropping, the Negro problem, the Ku Klu Klan) and recreation.

The youngsters are taken on tours of the rural countryside, where they say they gain firsthand knowledge of conditions in the South. One tour also took them, as observers, to a recent cross-burning ceremony staged on Stone Mountain by the Ku Klu Klan. They attended church services in

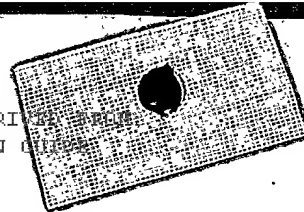
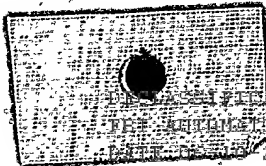

Daily Worker reflects the following: subject wrote poem "Listen, I Am A Communist" in 1934; fled Atlanta, Georgia, 1934 when sought on charges of inciting to insurrection; spoke at Boston, Mass. 1934 under auspices International Labor Defense demanding release of ERNST THAEIMANN; jailed 1935 Pineville, Kentucky for activities in connection with miners strike; subject on National Committee of C.P. in 1936 drive for election of BROWDER and FORD when subject was in Louisville, Kentucky; also listed as State Organizer of Workers Alliance of Kentucky and member of National Unemployed Committee for BROWDER and FORD in 1936; subject was present at reception to MAUDE WHITE, only negro member Central Committee of C.P. at New York City 6-21-37; subject listed as Georgia born organizer of C.P. in Kentucky at the time. Confidential informant advises subject became a Communist in 1934 and was a member in 1945 and 1948. Subject continues to be a contact of HOMER BATES CHASE, C. P. District Organizer for Georgia. Other contacts set out. Subject presently residing on farm, Route 4, Douglasville, Georgia.

EVIDENCE OF MEMBERSHIP IN COMMUNIST PARTY

The following poem entitled "Listen, I Am A Communist" under the byline of DON WEST appeared on Page 5 of the Daily Worker under date of March 13, 1934. It is noted that the masthead of instant Daily Worker is set up as follows:

The Daily Worker, with masthead as described above for Monday June 11, 1934, contains a news item which reflects that subject WEST was in New York "following his escape from the Atlanta police and fascist gangs which have terrorized the negro and white workers neighborhoods in a frantic and bestial campaign

to stop the wild fire spread of revolutionary struggle in the South." The article also reflects that WEST left Atlanta on Saturday June 2, 1934 after the Police and the "Men of Justice"--a group similar to the White Legion in Birmingham--had spread word throughout the city that they were out to "get WEST, dead or alive." The article also stated "DON WEST, a Communist, was being sought on a charge of 'inciting to insurrection'". The article also stated that WEST told his story of a flight from Georgia at the offices of the National Committee for the Defense of Political Prisoners at 156 5th Avenue, New York City, on June 10, 1934.

The Daily Worker, with same masthead as previously referred to, under date of Tuesday June 19, 1934, stated that DON WEST, C. P. Organizer in the South, was to speak at an ANGELO HERNDON protest mass meeting on Wednesday night at the Dudley Opera House in Boston, Massachusetts; that the meeting was under the auspices of the International Labor Defense and that the meeting would demand the release of ERNST THAEIMANN.

The Daily Worker, with identical masthead previously referred to, under date of Friday November 1, 1935, contained a news item entitled, "A Communist Organizer in Court." News article under date line Pineville, Kentucky October 28, is quoted as follows: "NORMAN LINK and D. I. WEST, members of the United Mine Workers of America were remanded to jail under \$5,000.00 peace bond by Judge B. M. BINGHAM, following the collapse last Friday of the original charges against the two defendants of 'banding and confederating' based on their activities in the strike of miners here. The court room was crowded with miners who had turned out to protest the attempted frame-up of their fellow trade unionists. With the collapse of the original charges the prosecution induced four persons to swear out a peace warrant alleging threats against them by WEST and LINK. Although under cross examination by the defense, the complainants admitted that neither defendant had ever threatened them the Judge nevertheless ordered the two defendants held in \$5,000.00 peace bond."

The Daily Worker, with masthead as mentioned above, under date of Monday July 20, 1936, reflected a news item under the caption "FOSTER announces National Committee for Election Drive." Instant article reflected WILLIAM Z. FOSTER, Communist leader, and Chairman of the National Committee for the election of EARL BROWDER Chairman of the National Committee for the election of EARL BROWDER and JAMES W. FORD in the 1936 Presidential campaign announced the members of this committee. The name of DON WEST, Louisville, Kentucky, was contained in this list of Committee members.

The Daily Worker, with masthead as previously referred to, under date of Monday October 5, 1936, contained an article which reflected that DON WEST, State Organizer, Workers Alliance of Kentucky, was a member of the National Unemployed Committee for BROWDER and FORD.

The Daily Worker, with masthead as reflected above, for Tuesday June 22, 1937, contained an article which reflected that DON WEST, Georgia born organizer of the Communist Party, Kentucky, was among those present at a reception given to MAUDE WHITE, only negro woman member of the Central Committee of the Communist Party. The article also stated that instant reception was held in the home of REVA GILBERT, Organizational Secretary of the Lower Harlem Communist Party at 2 West 120th Street and that the date of the reception was June 21, 1937.

Photographic copies of pages of the Daily Worker reflecting the foregoing are on file at the Atlanta Division and are properly identified.

T-1 has advised that WEST attended the 5th National Convention of the Workers Alliance in Chicago on August 29, and 30, 1940, as a delegate from Columbus, Ohio, and stated that he had come in contact with various Communist party members while in Chicago. One of these Communist Party members so contacted by T-1 was DONALD WEST, Bethel, Ohio, minister and writer for the Daily Worker.

T-2, who was a member of the Communist Party for approximately twenty years, stated in part in a signed statement dated April 14, 1948:

*Rev. and Prof. DON WEST (Jim Weaver)

*Congregational minister; one of founders of Highlander Folk School; Communist Party trade union director; State Sec'y, Communist Party of Kentucky; County Sup't of school in Georgia, now professor at Oglethorpe University in Georgia and now state officer of Wallace for President organization --- brother-in-law of NATY ROSS and BARTALOGAN; poet, recently author of published book. ✓

"About 47 or 48 years of age, DON WEST is a native of the hill country of North Georgia-- one of the many children in a large family. DON worked his way through college (part of the time, by radio singing, he said); obtained scholarship for study in Denmark. Became ordained minister of Congregational Church, joined Socialist party and helped organize Highlander Folk School (he and MYLES HORTON were the two founders) at Monteagle, Tenn. Joined Communist Party early in 1934, assigned to North Carolina district as trade union organizer September, 1934, using the name of JIM WEAVER. Not successful in work with unions but very effective among intellectuals at Chapel Hill. Led Burlington defense campaign; raised large funds with aid of PAUL GREEN, W. T. COUCH (Head of Univ. of N.C. Press) and many faculty members at the University. ✓

"After about a year in North Carolina WEST went to Kentucky as party district organizer, remaining there about a year and a half or two years. I don't know whether he was removed or asked to leave. Succeeded by PAUL KELLOGG.

"WEST's reports to the national office had been very encouraging, showing considerable progress, and rapidly increasing membership which reached a registration figure of over 200. (as in most Southern states, initiations and dues were used by the district organizer as a subsidy). When KELLOGG arrived and took over the District he could locate only a total of about 25 members. Most of the branches and sections reported in WEST's reports were never located and over 175 paper members of the party disappeared from the face of the earth. As a result, WEST's stock in the party dropped to a low, little above zero. For a year or two he remained as inconspicuous as possible. Then he began writing extensively, especially for left-wing press.

"I know of his subsequent activities primarily from newspaper publicity. After being county supt. of schools in a North Georgia county he became a professor at Oglethorpe University. Now reported to be officer of Wallace campaign. A published volume of poems about two years ago received considerable publicity in literary reviews. . . ."

Dr. T. M. BARNETT, 3609 Kingsboro Road, N.E., Atlanta, Georgia, advised in 1948 that Reverend I. J. DOMAS was pastor of the Unitarian-Universalist Church of Atlanta, Georgia, and that DOMAS was a close associate of DONALD WEST. BARNETT also stated that

DOMAS was influential in having WEST join instant church and that he, DOMAS, was attempting to infiltrate instant church with Communists, basing this belief on the fact that WEST, at a meeting of the Church, was presented by DOMAS as a model for the Church to emulate, that he, DOMAS, had read from one of WEST's books and that WEST, in 1948, had spoken at the Church, advocating the weakening of our national defense and had spoken of those who differ with them as Fascists and Capitalists.

T-4 on 7-29-48 advised the New York Office that DON WEST, who is a poet and who is connected with the Unitarian Church, is a Communist. The informant believed the subject was in Texas, for on a recent trip by the informant to Texas he was told by a Lutheran minister in Houston that WEST was "playing with" the "left wing" in the church.

T-4 further stated that he knew WEST was a Communist because WEST came to the Daily Worker Office, New York City in 1945 to check some files. The informant checked with Communist Party Headquarters before allowing WEST to look at the files and was told that WEST was a member of the Party and was "o.k."

CONTACTS MADE BY WEST

T-5 advised that WEST was in communication with one J. ~~KRENWINKLE~~, 7635 North Rogers Avenue, Chicago, Illinois. The Chicago Office advised in the report of SA MAURITZ E. GAHLON dated at Chicago 7-1-47 and captioned DONALD LEE WEST that JULIA CEDER ~~KRENWINKLE~~ was. resides at 7635 North Rogers Avenue, Chicago, Illinois, and that she is a reported Communist and is active in the American Federation of Teachers and has done educational work for the Communist Party.

In 1947 T-3 advised that subject WEST was paying the box rent for Atlanta Post Office Box 1178 which was rented to the Peoples Institute of Applied Religion.

On 10-1-47, WEST was observed by former SA DONALD B. CLEGG of the Atlanta Division having lunch at the Atlantan Hotel, Luckie Street, Atlanta, Georgia, with HOMER BATES CHASE, District Organizer for the Communist Party in the State of Georgia.

On 12-4-47, former SA DONALD B. CLEGG and SA CHARLES T. HAYNES of the Atlanta Division observed subject WEST with ~~MARVIN SHAW~~.

National Student Secretary of the Communist Party at the Terminal Station in Atlanta, Georgia. Instant meeting with SHAW occurred at approximately 9:15 P.M. At approximately 10:45 P.M. On 1-2-48, subject WEST met an individual at the Robert Fulton Hotel in Atlanta, Georgia, instant meeting being observed by former SA DONALD B. CLEGG of the Atlanta Division. Above individual was later positively identified as M. WIONCZEK whom the New York Division advised was in May 1937 Chief Editor of the Polish Press Agency.

On 3-13-48, Special Agents PAUL F. TIERNEY and CHARLES T. HAYNES of the Atlanta Division observed subject WEST and his wife MABEL with HOMER BATES CHASE at the Pig 'N Whistle Restaurant on Ponce de Leon Avenue, Atlanta, Georgia. Above meeting occurred at approximately 3:15 P.M.

On March 26, 1948, Special Agents PAUL F. TIERNEY and CHARLES T. HAYNES of the Atlanta Division observed subject WEST with HOMER BATES CHASE and WILLIAM W. STAFFORD. Above meeting occurred at approximately 3 P.M. on the above date at the Sears Roebuck Parking Lot, Ponce de Leon Avenue, Atlanta, Georgia. WEST and STAFFORD came to the above parking lot in STAFFORD's automobile and picked up HOMER BATES CHASE. WILLIAM W. STAFFORD is the United Public Workers of America, CIO Organizer for the State of Georgia.

On 5-10-48 Special Agents PAUL F. TIERNEY and MASON FILMER and CHARLES T. HAYNES of the Atlanta Division observed subject WEST meeting with HOMER BATES CHASE at approximately 1 P.M. on the above date on Parkway Drive near the Henry Grady High School, Atlanta, Georgia.

On 5-10-48 WEST was observed by Special Agents PAUL F. TIERNEY and CHARLES T. HAYNES at the Terminal Station, Atlanta, Georgia, with an individual later identified as IRVING GOFF, Communist Party Organizer of Louisiana. SA CHARLES T. HAYNES of the Atlanta Division took 16 millimeter moving pictures of instant meeting between GOFF and WEST and developed film reflecting instant meeting is on file in the Atlanta Division. T-6 when shown a photograph of individual meeting with WEST positively identified this individual as IRVING GOFF, Communist Party Organizer for the State of Louisiana.

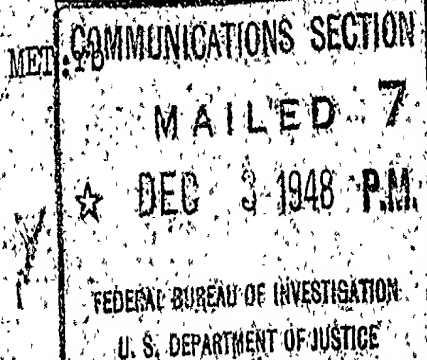

Confidential Informant T-3 advised that EUDICE TONTAK, WILLIAM WRIGHT STAFFORD, both close and constant contacts of HOMER BATES CHASE, District Organizer, Communist Party, District #31, Georgia, and HOMER BATES CHASE told him that WEST had not been cooperative during the past three months while he had been residing on his farm; and that it was their opinion that he had become a "prima donna" in reference to the Peoples Progressive Party of Georgia's work. ~~(S)~~

Confidential Informants T-1, T-3, and T-4, who is a person of known reliability, advised that DONALD LEE WEST was very active in the Peoples Progressive Party of Georgia during October and November of 1948, and that WEST had been contacted by NAT ROSS, Southern Organizer, Communist Party, his brother-in-law, on three or four occasions during the three months period prior to October, 1948. BARFOOT leaving the Party Headquarters with DONALD WEST in WEST's red Jeep. JAMES L. BARFOOT was the Progressive Party candidate for Governor of Georgia. T-5 informed that several days later BARFOOT told him that he and his wife had spent several nights on WEST's farm near Douglasville, Georgia. He informed that SAM WILLIAMS, a Negro Professor in Political Science at Atlanta University, was closely associated with DONALD WEST, and that the two frequently worked together. ~~(S)~~

Confidential Informant T-5 further advised that he returned to his home on October 20, 1948, at about 6:00 p.m. after having been absent all day. At that time T-5's mother told him that HOMER BATES CHASE, DONALD WEST, and NAT ROSS came to his house about 10:30 that morning and stayed until about 2:30 p.m. T-5 advised on November 8, 1948, that he had attended a meeting of the Peoples Progressive Party at 85 Alexander Street, Atlanta, Georgia, on November 6, 1948, and that at this meeting DONALD LEE WEST had submitted a written resignation as Co-Chairman of the Progressive Party in the State of Georgia. As a matter of interest in this case, it is noted from a news item appearing in the "Atlanta Journal", October 13, 1948, that DONALD WEST was not listed as an elector for the Peoples Progressive Party of Georgia, and that those who were listed as electors had signed "non Communist" affidavits as requested under recently enacted Georgia election laws. It is also noted that this news item reflected that a list of electors which had been submitted earlier by the Progressive Party contained the name of DONALD WEST.

~~CONFIDENTIAL~~ Confidential Informant T-6, a person of known reliability, advised that he has noticed no unusual activities around DONALD WEST's farm in recent months. He said that WEST is spending most of his time alone, and has been busy for the past week or so installing a well pump and a running water system in his house. He also informed that Mrs. SHIRLEY T. CAPPS, who also resides on this farm with her husband, is apparently spending week-ends only on this farm. It will be noted that SHIRLEY T. CAPPS is reportedly a teacher in the Atlanta, Georgia Public School System. T-6 further informed that DONALD WEST's correspondence has been unusually light in recent weeks.

Confidential Informant T-5 advised on December 30, 1948, that NAT ROSS and DONALD WEST had visited at his home on that day, and had left at about 5:00 p.m. to go to WEST's place near Douglasville, Georgia. T-5 further informed that ROSS had arrived in Atlanta on December 30, 1948, and would undoubtedly confer with HOMER BATES CHASE.

Confidential Informant T-3 advised on December 13, 1948, that HARDY SCOTT contacted EUDICE TONTAK in an effort to locate DONALD LEE WEST. 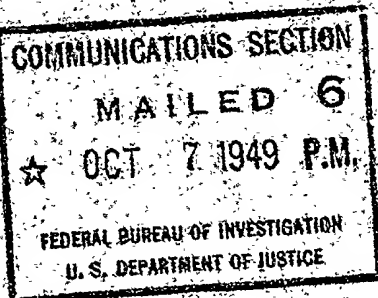

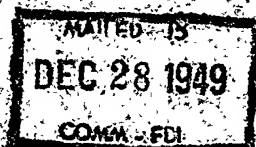

Accordingly, it would appear that West no longer warrants the designation as key figure in the Atlanta office. It is requested that you evaluate this case and advise the Bureau as to your decision. It is believed on the contrary, however, that in view of his past history in the movement his Security Index card should be retained until such time as definite information is obtained indicating a disaffection on his part with the Communist movement.

Mr. J. SPENCE DAVIDSON, Route 4, Douglasville, Georgia, who operates a country store in the community where DON WEST lives, advised that WEST appears to be living a quiet life on his farm and from all reports spends quite a bit of his time in writing.

Mr. DAVIDSON informed that DON WEST, after moving to his present home, attended the Mount Zion Baptist Church, which is in that community, on a number of occasions, and on one occasion led prayer and took part in the meeting. However, after the local members of the church learned that DON WEST is supposed to be a Communist the members cooled off toward WEST and WEST stopped attending church.

Mr. DAVIDSON further informed that CHARLIE ~~HALL~~, Sr., a retired Federal Penitentiary guard and a neighbor of DON WEST, is WEST'S closest friend in the community and has associated with him quite a bit. He also informed that [REDACTED], lives with his father and is employed as a mail carrier in the City of Atlanta, Georgia, and commutes to work. He informed that CHARLIE HALL, Sr. is presently in very poor health and is confined to an Atlanta hospital.

Mr. JEROME H. (CURLEY) ~~WILSON~~, Douglasville, Georgia, advised that he has relatives living in the community where DON WEST resides and has spent quite a bit of time in the community hunting and fishing. He informed that as far as he knows DON WEST has never made any effort to preach Communism to any of his neighbors. He stated that he has heard that DON WEST is planning to leave his farm and go to work for a New York City publishing company.

It has been ascertained that DON WEST frequently received a number of copies of "The Southern Farmer", a magazine published at Montgomery, Alabama.

~~(T-1)~~ informed that he has noted several articles which were written by DON WEST published in "The Southern Farmer".

In connection with WEST'S reported contributions to "The Southern Farmer" magazine, a letter appeared in the "letters to the editor section" of the Atlanta Constitution on September 19, 1949; this letter is signed "K. S., Atlanta", and is quoted as follows:

"What Line?

"I have just read in this month's issue of Southern Farmer an article by D. L. WEST praising a certain Georgia minister for being what Mr. WEST calls a "practical Christian". It seems, according to this article, he earns this praise for attacking our foreign policy toward Russia; believing peace can be ours if we want it (meaning we, and not Russia, are to blame for the threat of war in the world); for "practicing Christian democracy" by fearlessly taking Negroes into his church and in his home; for attacking the KKK, Columbians and other "Fascist" organizations (the Communist Party not being mentioned). Mr. WEST goes on to say this preacher has had the "honor" of being denounced as a Communist, thus indicating this was a sign of his being right.

"I ask you, is this pure Communist-line propaganda? You answer it.

"To be sure one should have the right to criticize his country. But for a minister of the Gospel to turn aside from the faith and join hands with the Communists, who are to the core haters of God and all that is good, only proves that we are in the time spoken of it II Thes. 2:3, the "falling away" among the believers".

(S) Confidential Informant T-3, who in the past has furnished reliable information concerning Communist Party activities in Georgia, advised that in July, 1949, JAMES LAMAR BARFOOT, who was very active in the Peoples Progressive Party of Georgia, and was formerly a known close associate of DONALD LEE WEST, advised him that "DON WEST is provoking CHASE and the entire group of the Peoples Progressive Party".

early part of May, 1949, and told him that NATE ROSS, Southern Organizer for the Communist Party, had, on his last visit to Atlanta, tried to get DON WEST and HOMER BATES CHASE together. T-4 also quoted BARFOOT as stating that he, BARFOOT, and DON WEST were trying to get rid of the Communist influence in the Progressive Party. (S)

(S) [T-4, T-5, T-6, and T-7, of known reliability, advised that DONALD LEE WEST has not been active in Communist Party activities during the three month period ending September 30, 1949. (S)

[T-4, T-5, and T-7 advised (S) that DON WEST has not been active in Georgia affairs of the Communist Party for the three month period ending June 30, 1949.

Confidential Informants T-7 and T-8, of known reliability, advised that to their knowledge DON WEST was not in contact with HOMER BATES CHASE or EUDICE MONTAK, a close associate of CHASE, for the three month period ending March 31, 1949. (S)

EVANS WILDER, formerly of Cartersville, Georgia, and who now resides in Atlanta, was, according to his own admission, recruited into the Communist Party by HOMER BATES CHASE, advised in the spring of 1949 that DONALD LEE WEST was not actively connected with the Communist Party in Georgia.

(S) [T-3 advised that an informant had told him DONALD WEST had stated that he, WEST, had been dropped from the Communist Party because he was "too rugged an individualist".
