This is in further reference to your October 15, 2014, Freedom of Information Act (FOIA) request to the Federal Bureau of Investigation (FBI) for information regarding Alan Bartlett Shepard, Jr. The FBI forwarded documents that originated with the Civil Service Commission for our review and release to you. We sent you an interim response on May 19, 2015.

The enclosed documents have been reviewed pursuant to the provisions of the FOIA. We have deleted information that is exempt from disclosure pursuant to title 5, United States Code, sections 552(b)(6), (b)(7)(C) and (b)(7)(D). Sections (b)(6) and (b)(7)(C) exempt information that could reasonably be expected to constitute an unwarranted invasion of personal privacy. Exemption (b)(7)(D) applies to records or information compiled for law enforcement purposes the release of which could reasonably be expected to disclose the identity of a confidential source.

If you wish to appeal these deletions, you may do so by submitting a request to the Office of the General Counsel, Office of Personnel Management, 1900 E Street, NW, Washington, DC 20415-0001. An appeal should include a copy of your request, a copy of this letter, and a statement explaining why you believe the decision is in error. The appeal should also include "FREEDOM OF INFORMATION ACT APPEAL" in capital letters on the envelope and at the top of the letter of appeal.

He was one of the final selectees and was actually hired in the latter part of March, 1959. Although he worked with our agency, he was actually in the United States Mavy where he serves as a Career Officer. I do not know his rank. Ne was on detached duty from the Mavy to serve with NASA in the space program. (D)(7)(D)

Project Mercury and the Space Task Group-and-Alan and the other astronauts were assigned directly to the Director's office. In this regard, (b)(7)(D) In his work here at Langley Field, his job was to take various education background. and training courses for a future space flight. Also, he was assigned to a specific research and technical area as were the other astronauts. I believe that he was working primarily in flight operations. I did not know him well socially, however I did attend several official functions and office parties which he was in attendance. Alan made the first flight in the Mercury Frogram when he went on his sub-orbital flight in 1961. He has not gone on any other flights since that time..! He was well regarded when he was here.at MASA for he is a very dedicated person to the space program and he also is very conscientious in his work. He is a highly competent person on technical greas as wall as on a professional standpoint in dealing with others. He has an excellent personality and has no difficulty meeting and dealing with others. He is a verypopular person.

He was transferred, along with the other astronauts to the Manned Spacecraft Center at Houston, Texas in June, 1962 when the Space Task Group was transferred there. I know that the astronauts were the last group that actually went to Houston. I have not seen Alan since his transfer, however I have kept up with his activities in my contacts with the people in Houston. I do not know of anyone currently here at Langley Field who would know him very well since his closest associates are in Houston.

I do not know too such about Alan's background except that he is a graduate of the United States Naval Academy and that he has an impressive Mavy flight record. He was very active in the testing of high speed aircraft back in the middle and late 1950's prior to his selection to the astronaut program. He is married and has two children. I met his wife, but I do not know her name. They resided in Virginia Beach, Virginia when they were here. Alan is a person who enjoyed a very good reputation when he was here. His integrity is certainly above and beyond all reproach and I feel that he is an honest person who is completely trustworthy. He is neat and clean in his personal appearance and has no objectionable personal habits.

Since he is one of the original astronauts and has made a space flight, he is naturally a popular parson

family man and know nothing adverse concerning him.

He associated primarily with the other astronauts who were definitely of high reputation. I do not know of any organizations-to-which he belongs. He was interested in all types of activities. He was interested in scuba diving, driving sport care and other strenuous and active sports. His health was extremely good and he is emotionally stable and well adjusted. I understand that he did injure his ear while training in a jungle in Central America two or three years ago. I understand that his ear problem has resulted in his being grounded for future space flights.

I would have no question concerning his loyalty to the United States. I would very definitely recommend Alan for a position involving the security of our nation.

I first met Alan Shepard back in March, .. 1959. When he first came to work here with the NASA in the Space Task Group as one of our original seven astronauts. He was assigned directly to the Director's the Flight Control Branch of Flight office. (b)(A)(D) Operations Division and had the responsibility of the astronauts (D)(7)(D) I had nearly day to day contact with him when he was hore. He spent a great deal of his time on travel visiting Cape Kennedy and many of the contractor's plants across the country. I know him only slightly on a social basis and that would have been at office parties and other gatherings. Alan was the first person to actually go into space under our space program when back in 1961 he went on a sub-orbital flight. He has not gone on any other flights since that time. He remained here with the other original astronauts until June, 1962 when the Space Talk Group was transferred to Houston, Texas to the Manned Spacecraft Center. I elected to remain here. I have had only brief contact with Alan since that time. I have seen him on my visits to Houston and I last see him about one or two months ago at Cape Kennedy.

He is married and has at least one child and he lived in this general area when he worked here at Langley.

He is originally from somewhere in New England and he is a graduate of the United States Naval Academy. He has been in the Navy for most

of his adult life. He is only on detached service from the Mavy at this time. I do not know his rank. He has a distinguished career in the Mavy in the field of flight testing of high speed aircraft. He also has a very commendable combat record. He is a highly proficient individual and good on a technical basis. He is one who gets along with other people and is on the outgoing side. He has a very even temper and good disposition.

I do not know of anything that would be considered derogatory or detrimental regarding his character, personal habits, morals or sobriety. In my opinion he is a high type person in every respect. He seemed to be able to live through the period when he was a nation-wide celebrity and took all of his plaudits in a modest manner. I do not know much about his current activities in Houston, but however I last heard that he was engaged in the management of the astronaut training program in Houston. I do not know any of his personal friends except some of the other astronauts who were here them. I do not know of his organization affiliations nor spare time activities. I never heard of him being arrested or involved in any sort of trouble. His health was always excellent and he is emotionally stable, well balanced and mature.

I consider Alan to be a loyal citizen of the United States and I would recommend him for a position involving the security of our nation.

I know Alan Shepard for a period of approximately three years during the time that he was assigned here at Langley Field as an astronaut with the Space Task Group of this agency. As I recall, he came here in the early spring of 1959 and remained until the Space Task Group transferred to Houston, Texas in the late spring of 1962. Alan was in the United States Navy where he had been a career man and he was on a leave of absence from that service to be an astronaut in the space program. He was assigned directly to the Director's office of the Space Task Group. (D)(A)(D) in the Flight Operations Branch and was responsible for the training of he and the other six astronauts. We arranged for all of their training in the various technical fields. I did not know Alan off the job.

So far as I could determine, he did a very outstanding job when he was here and he was well respected by his supervisors and fellow workers. During the time that he was here he made this country's first suborbital flight in the Hercury spacecraft. He has not made any flights since then. I last saw him at Cape Kennedy about one or two years ago but have had no further work contact with him.

I consider Alan to be a person of extremely good character, personal habits and moral conduct. There is no indication that he makes use of intoxicants. I consider him to be honest and of high integrity and never heard of anything that would be considered adverse regarding his character. He is a very affable person and has the knack of getting along with other people. He was well liked by everyone. I never heard of him being arrested. He associated primarily with his fellow astronauts and some of the medical staff who worked very closely with him and the others. I do not know of any organizations to which he belonged. I do not know where he lives although he is married and has children. He had no health difficulties during the time that I know him and he is emotionally stable and well adjusted. In my opinion hasis an overall outstanding individual. I believe that he is the type of person that does live within his means and pays his bills.

I believe that Alan Shepard is a loyal citizen of the United States and I would recommend him for a position involving the security of our nation.

INVESTIGATOR'S NOTE: MASA, Langley Research Center Personnel and Security Offices maintain no record of subject's period of employment at Langley Field since he was in the military service. Three additional Research Center employees vero contacted, however, they only had a passive knowledge of the subject and could not furnish any information regarding him. Efforts to locate others having knowledge of the subject wore unsuccessful.

I first met Al Shepard in 1959 when we, (b)(7)(D)

Since that time, we have had a very close and warm relationship in not only the forming of our program, but also socially. Since about 1962, I have been (b)(7)(D) as far as administrative procedures go, but we still work on pretty much of an even plane as far as policies and procedures for the actual flight are concerned. During our early days in the program, there was a great deal of discussion, and give and take on ideas as to how to proculgate our program, and in that period of time, I developed the opinion of Ai Shepard that he is an extremely able man, technically, and creatively. Al was chosen to make the first actual sub-orbital flight in the Hercury Program, and he did an excellent job. He has been grounded from space flights for the last few years due to an inner ear problem which cannot be controlled and occurs periodically. Except for this physical problem, he would have flown in our Gemini Program as well. For the last couple of years, he has been chief of the Astronaut Office, and as such, has had administrative responsibilities for the other astronauts. He is extremely confident in management procedures, and is a very intelligent, likeble individual.

Al has always shown a great deal of patience and dedication to his program. He has always used good judgment, and has been accurate in his estimates of problems, and has the respect and enjoys the liking of the other astronauts and the people with whom he deals.

Ai is an honest individual of average moral character and conduct. He has never been in any trouble, has always been discreet, and he and his wife, Louise, enjoy a warm and satisfactory relationship. They have two children, and they, the daughters, are away in school in St. Louis, and for this reason, Al and his wife have been residing, ever since we came to Houston in 1962, in the Hayfair Apartments over on Holcombe Boulevard in Houston. We go to their apartment quite often when Al and I both are in town, and see a great deal of Alan and his wife. Louise's niece is living with them; and they seem to have the respect of the people in the apartment house that I have met. Alan uses intoxicants very little, becomes even more close-mouthed when he has had a couple of drinks, and to

my knowledge, has never had an alcohol problem. He does not gamble, use narcotics or drugs, nor is he sexually perverted or promiscuous. There has never been any conflict of time or interest on his part; his first interest is his work here at NASA. A lot of our association together has been on trips to various parts of the country, and the world, and he has always handled himself as a gentleman and a good representative of the United States and of the space program. He has a great deal of integrity, has a great deal of drive and initiative, and is one of our better astronauts. He used to play golf a great deal, but has not had a lot of time for it in the last couple of years. He has no organizational affiliation outside of professional or business organizations, and he associates only with people of good character and reputations.

Alan Shepard has never been in any trouble with law enforcement agencies, nor in any financial difficulties. I consider him to be a dedicated, loyal, American citizen, and I will recommend him for a position of security responsibility.

I first met Alan Shepard in approximately April of 1959, when the space task group was forming at Langley Air Force Base in Virginia. From 1960 until 1962, we had a very close and continued working relationship on the Mercury Program. Since that time, we have not had a great deal of contact, but we do work closely together when we have a mutual concern for a flight. I have found him to be a very dedicated, very intense individual. He has been grounded from flying for the last few years because of an inner ear disease or condition which is unpredictable in its occurrances. It causes disciness and nausea, and he is not able to fly by himself. If it had not been for this problem, he would have flown on the Gemini Project, just as he flew the first sub-orbital mission of the project. He is extremely competent, well-liked, and highly efficient.

I have always found Alan Shepard to be an honest individual of good moral character and conduct. He does not use intoxicants excessively, gamble or use narcotics. He is emotionally stable and in good physical and mental health, except for that ear problem I previously mentioned. He is quite active in business circles, I believe he is a board directory of a local bank, but outside of this most of his time is spent in the space program, extremely long hours, very extensive traval, and I sometimes think he is too wrapped up in it, but he is very intense, as I have said, and his wife Louise understands this, and there is a good relationship with the family. He has two daughters who are away at school most of the time, and

Alan and his wife, Louise, reside in an apartment in Houston Tather than living in a home down here in the NASA area. He belongs to several professional and business organizations, but I know of no other affiliations. I consider Alan Shepard to be a loyal American citizen, completely trustworthy, and dedicated to the American way of life. I do recommend him for a position requiring security responsibility.

I first became associated with Alan Shepard in April of 1959 when the task group was forming at Langley Field, Virginia. I was () (//)(D) (b)(7)(D)for the task group, and as such, had a great deal of contact during the early formation of the program, and as it was a rather informal beginning, everyone pitched in and did what they could to help form the group. I worked extremely close with Alan Shepard during the entire Mercury program, and up until October of 1963, when I transferred back to Vashington. I was with him a great deal of time. (19)(74)(19)

We worked there at Langley until we moved here to Houston in 1962, and all during this period of time, Al and I have worked very closely together, and we have had a great deal of social contact as well. Al flew the first space shot, and did an extremely good job, and had he not developed an inner ear problem which caused his grounding, he would have flown on the Gemini Program as well. He has been my immediate supervisor for approximately three years; this is more administrative than actual, and I've had an extremely close and warm working relationship with him, as well as an admiration for him as a person. I have always felt confident when he has been in control of any project, and he has inspired myself and the other astronauts to put out to the best of our abilities.

Al Shepard has always been an honest individual. His moral character and conduct is good, and he is emotionally stable, and except for an inner ear problem, he is in good physical and mental condition. He end his wife, Louise, and their daughters enjoy a very close and warm family relationship, and except for the great amount of time that Al devotes to the space program, his other interests lie in a bank of which he is a director, and several financial projects the original seven astronauts have in common. I have been with Al on a great many trips to various parts of the country and the world, and he has always conducted himself as a perfect gentleman and has been a good representative for the United States. He is very personable, makes friends easily, and has no difficulty in expressing himself. He has belonged and does belong to several business and professional organizations, but has no other organizational affiliations to my knowledge. The last time Alan was here in Derry was during the summer of 1966. He came with his wife and children for a few days, I have forgotten how many, but he did not spend a full vacation of several weeks or a month. He never does spend that much time here. He gets home occasionally alone, for a day or two, because his work with the Space Administration requires that he travel a great deal and, when he comes to New England, he usually makes it a point to drop in on his parents. Sometimes I do not see him when he makes these visits, but I hear about it from his parents and, at other times, he comes into the store for something, and is very pleasant, but there is no fanfare about him. She is a very beautiful girl, Alan and she have had a very happy marrieddiffe, and they have two delightful children of their own. Alan has a brilliant mind; and I understand, from his mother, that they can use his valuable experience in the Space Agency but, of course, he will not continue as an Astronaut, or make any flights. He gets dissy or lightheaded spells. He has some sort of ear trouble that has developed. He was approached to run for political office here in New Hampshire, but I understand he would not even consider the possibility.

Alan was a shy boy growing up, and a certain amount of that shyness has stayed with him, and he does not care for publicity. He is capable, and handles himself well, and can be relied upon to make a good showing at any public appearance. He does not have the ease and sense of humor, for example, of John H. Glenn, Jr., who is my favorite among the astronauts. Alan is a much more serious and businesslike type at all times. When he was growing up, he did have interests in skiing, skating, football, and baseball, but he was not a big fellow physically. He associated with two boys, one the son of a minister who left town years ago, and the other boy remained in town until this year, when he moved to Wolfeboro. They were good companions, but Alan never kept contact with them after he left town. He never bothered with girls at all while he was in this community, but he was quite young, as he left here right after high school. His home life was always a happy one. His parents are nice people, and the community, as a whole, thinks very highly of them. Alan was a real boy, and did misbehave at times, but was never in any serious trouble of any kind. He is absolutely honest, of good moral character, and good habits. He is of unquestioned loyalty to the United States. I would recommend him for a position involving the national security.

Louise was very helpful and understanding of Alan becoming an Astronaut. She does not have to worry about him any more, because he developed some kind of a physical condition, which will prevent any future Space travel for him. This was disappointing to him, because he has always been flying. He liked the advanture of it, he was a flyer, and flew jets in the Korean way, and was a Test Flyer.

Alan Junior is a very capable man. He is honest, of good moral character, of good habits, and has never been in any trouble. He at no time used liquor, he was always devoted to his country, and is a loyal American. We would recommend him for a position involving the national security.

I have known Alan Shepard all my life, he graduated from Pinkerton Academy in 1940 with my older brother, who is no longer living in town. I never chumned with Alan, his two closest friends were a minister's son, gone from the town for many years; and another fellow, a plumber, who recently moved to Wolfeboro, New Hampshire, with whom Alan used to ski.

Alan was always a vary good student, and got high marks. He was never in any trouble, but was not the sissy type. He got into scrapes as a boy, now and then, but nothing serious, and he was no different than the average fellow growing up. He was not an outstanding athlete, and his chief interests were skiing and skating sports. The only thing unusual that he did as a young fellow was that he and the minister's son, somehow got a glider, and they flew it for a time, and then cracked it up. The worst criticism that I ever heard of Alan was that, after he went to Annapolis and got his Wingam in the Navy, he celebrated by "bussing" the town in his plane. There was a lot of comment at that time that it was a dengerous thing, to do but, so far as I know, there was never any formal complaint about it. I don't know where he was stationed at that time. I don't recall him being stationed locally while he was in the service. He served in the Pacific, and in Korea; and he was a Test Pilot.

He was married, and never made his home in this town after his marriage, but only came on visits to see his parents, and possibly other relatives and old neighbors. He did not continue any friendships with the fellows and girls with whom he grew up. He would be home occasionally, and see people and say hello to them. He would bring his family on to visit with his parents. Since he made the First Manned Mercury Flight, and after he was given a celebration by the town, he just continued on as usual, to drop in on his parents from time to time, and come up with his family on a visit. He does not make it a point to go about the town and act the hero. He is a pretty average

guy. He has not made any new, close friends in this area, but his visits here are just to see his parents. No one outside of his immediate family is in touch with him after he leaves here and goes back to Texas.

I have seen him occasionally when he has come on on these visits, and he came into the garage once last summer. He was, at that time, going fishing up to the pond where his family has a summer camp, along with his father.

I don't think all the honors he has received have changed him. He just seems like a hard worker, and a good family man. I have met his wife, and Louise is a very pretty girl, and they appear to have a very happy life.

I don't believe that anyone in the town now knows him intimately. I know him personally to speak to, but I did not even know him intimately when he was here.

I think very highly of him. He is certainly a man of integrity, and he has the respect of the people in his public and private life. He is not a fellow who drinks. He has no bad habits, to my knowledge. He has good moral character, and he conducted himself well in public. He is a member of the military, as he is a Navy Commander; and he is a loyal American. He is absolutely trustworthy. I would recommend him for a position involving the national security.

Pinkerton Academy, (DERRY VILLAGE,

MEY HA(PEHIRE).

I knew Alan Shepard, Jr. from the time he entered Pinkerton Academy in 1936, until he graduated in 1940; and I also knew his parents and his neighbors. He left the town really right after he graduated from this school, because he was off to another Preparatory School; then to Annapolis, and making the Navy his career. He was only back home on visits. When he began to achieve fame, just prior to the First Manned Space Flight, because he was to be the Astronaut, we became deluged with reporters seeking information about him, and they were referred to me and, after all the newspaper articles, magazine series, TV commentators, and his own book have said about him, I don't think that there is anything left unsaid, or further to say.

Essentially, at the school here, he was a good student, with high marks and a high IQ. He was a good athlete, participated in all sports; was a leader in the class; and not involved in any trouble at the school. He left this community before he was employed anywhere here. He had no special hobbies, and his interests were normal, except for

the fact that he did show an early interest in flying; and did hangeround Granier Field, a military base not far from here. There was nothing in his background, however, through which one could predict, even in hindsight, that he might be the first Astronaut.

The day of his flight, Hay 5th, 1961, the news services all disappeared from the school, and really missed the big story from the school. We gathered in the Chapel with the students to watch the flight on television. There were delays in the count-down; and the pressure mounted for each individual watching, including the faculty and students. It certainly took a tremendously well-adjusted person, such as Alan, to withstand that pressure of waiting before the blast off. The flight then only took fifteen minutes, and was successful, and everyone was emotionally exhausted who watched it. Although I met Alan afterward, and talked with him, I never told the story to him, but to his father. He came on in June for the celebration given by the town, with a parade in Derry. Later, there were additional celebrations in Manchester. He visited the school on several occasions. He spoke to the Graduating Class. I felt he gave an excellent talk to the students, he told how he had gone to a 1-room school in East Derry prior to coming to Pinkerton Academy, and he stressed how the Space Program had opened new frontiers, broader than ever before, and the necessity for the students to become educated to realize their opportunities.

Alan essentially shane publicity, but when he is forced into the limelight he handles himself very capably, and does an excellent job. His distaste for publicity stems from his father, who is in the insurance business here, and is the cold New Hampshire type; and not leffusive. His mother is a very charming person, and has a nice personality; and Alan resembles her in looks, and has her pleasing charm in his contacts with people. He has a lot of good common sense, -also. I group here in New Hampshire tried to persuade him to run for the Senate, but he declined to do so, because he felt he could do much more for his country on his own job, for which he was qualified. Over the years, he has been coming home on visits. Since his exploit, although I do not see him on all the visits he makes. I do think that he gets opportunities to come home because the Space Agency now has an office in Cambridge, Massachusetts, near the Massachusetts Institute of Technology and, in the course of his work, he may come. up there, and then drop in to see his parents. I did not know he was around recently, nor did anyone else, but a girl told me that she had been to church in Salem, New Hampshire, on a Sunday; and Alan came in and attended the church service, just as he had done in churches of the same denomination which he attended here in town with his parents when he was growing up.

I have met his wife and two children. She was not a local girl, but he met her outside of New Hampshire. They have been married a number of years, and his two children are young ladies now. His wife, Louise, is a very beautiful, charming girl. She is well educated, and does everything in good taste. They are both well-educated people, and show good breeding in everything that they do. Alan's parents are wonderful people. There never was any scandal attached to Alan. He is absolutely honest, of good moral character, and of excellent habits. I have no doubt of his loyalty to the United States, and I would recommend him for a position involving the national security.

Of course, when it was announced that Alan B. Shepard, Jr., Lieutenant Commander in the Navy, was to be the first Astronaut in Space early in 1961, I became very anxious to see him, but he did not come home during that pariod, obviously he would not be allowed to. I watched him on TV, but it was long after the successful flight that they had the celebration for him here in Derry, and there I saw him in person for the first time. I continued to read everything about him, and spoke with his parents about him, but I did not meet him individually until last June, when he came to New Hampshire to have an Honor conferred upon him at the University of New Hampshire Commencement. His mother had invited me:to her home to meet Alan and his wife. It was an open house for the afternoon. The people present were Alan and his wife, relatives, and a few neighbors. The younger of his two daughters was there, the other daughter was said to be attending a wedding in Texas.

Alan is a fine-looking man, rather on the modest side, but very pleasant. His wife, Louise, is a very beautiful girl, well educated, and cultured. I cannot speak too highly of his family and his parents.

I do think that he is an outstanding, capable person; I saw him in the

I am certain that he must be a loyal American. I would have no reason not to recommend him for a position involving the national security.

I did not keep track of him over the years, I knew that he was in the Mavy, and he came home on leave to visit his parents from time to time. His father is in the insurance business here in Derry. I did, of course, see him when the town honored him with a parade after his successful flight as an Astronaut. He handled himself very well on television and personally, during all of the events connected with his . flight. When he was here in Derry for the celebration, I did get the impression that he was not too enthusiastic about the whole thing. I don't think that he welcomed all of the publicity that came to him. He continues to come home from time to time, sometimes with the family, and sometimes on visits of his own. I did not see him this summer, but he was around the summer before for a short period. When his children were little, he would bring them and his wife, Louise, up in the summer to a camp on Island Pond, about five miles from his home in East Derry, which his parents have owned for years.

The excitement around here has died down now about him, and you don't hear him mentioned often. People know now that he is too old to be considered for further flights in Space. He is in his forties. They will always continue to think of him as Derry's outstanding citizen, because he was born here.

He was never in any trouble here; he always lived cleanly and kept himself in good physical shape. I have met his wife, and she is a very fine person; and he has two nice children. He is a good family man, of good moral character. He is not a drinking fellow at all. I have no doubt of his loyalty to the United States. I would recommend him for a position involving the national security.
