- (b)(8) contained in or related to examination, operating, or condition reports prepared by, on behalf of, or for the use of an agency responsible for the regulation or supervision of financial institutions; or
- (b)(9) geological and geophysical information and data, including maps, concerning wells.

ABE FORTAS: WALTER W. JENKINS

[redacted] Central Intelligence Agency (CIA), has advised that captioned individuals are of interest to CIA because of certain sensitive operations and he requested any information contained in Bureau files concerning them. [redacted] stated that [redacted] of the White House staff has given approval for the FBI to release to CIA any information which has been sent to the White House regarding these individuals.

A review of Bureau files revealed the following information:

ABE FORTAS

Fortas was investigated by the Bureau under the Hatch Act in 1942, at which time he was director of the Power Division, Department of the Interior, based on his name appearing as a member of the Washington Committee for Democratic Action. This organization was later cited pursuant to Executive Order 10450. Fortas was interviewed by Bureau Agents under oath in 1942 and denied membership in the Washington Committee for Democratic Action, but admitted former membership in the National Lawyers Guild, which was cited as a communist front by the House Committee on Un-American Activities. While at Yale Law School, from which he graduated with honors in 1933, acquaintances considered him a liberal but not communist. He has served as defense counsel for individuals and organizations whose loyalty has been in question, including the Joint Anti-Fascist Refugee Committee and the National Council of American-Soviet Friendship, both of which organizations have been designated pursuant to Executive Order 10450. Attached letterhead memorandum prepared for dissemination to CIA contains this information. (101-1605-14)

WALTER W. JENKINS

Walter W. Jenkins has been President Johnson's administrative assistant for several years and is presently special assistant to him. The Bureau has had cordial relations with Mr. Jenkins in the past.

No derogatory information was developed during the course of this investigation. Attached letterhead memorandum prepared for dissemination to CIA contains pertinent information. (116-435550)

BILLY DON MOYERS

Billy Don Moyers, also known as William Moyers, is presently Deputy Director of the Peace Corps, but is slated to become an assistant to President Johnson in the near future. In 1961, at the request of the Peace Corps, the Bureau conducted an applicant-type investigation and no derogatory information concerning him was developed. Results of this investigation were furnished to the White House. Pertinent information is being furnished to CIA in attached letterhead memorandum. (161-676)

The "Washington Daily News" on 12/10/63 reported Jack Joseph Valenti as being President Johnson's newest confidential aide. This article revealed him to be a Houston, Texas, advertising and public relations executive. He married President Johnson's former private secretary in June, 1962, with President Johnson giving the bride away. A criminal informant of the Houston Office, who has furnished reliable information in the past, advised in June, 1962, that he had heard that one Joseph Lucia was reported to have paid a large portion of the wedding expenses, including plane tickets to Las Vegas, Nevada. This information has not been corroborated by any other source. Joseph Lucia is a top hoodlum in the Houston Division and is presently under investigation relative to the criminal intelligence program. This information is being brought to your attention only and is not being furnished to CIA inasmuch as our source had no first-hand knowledge thereof. Attached letterhead memorandum states that the Bureau has not conducted an investigation concerning Valenti and our files contain no pertinent information. (62-9-19-331)

RECOMMENDATIONS:

(1) Inasmuch as these four individuals are at the White House, it is recommended that Mr. DeLoach obtain White House approval for the Bureau to disseminate attached letterhead memoranda to CIA.

He described Mr. Valenti as a very hard-working and dynamic person and a very effective public speaker. He stated he is aware that Mr. Valenti and [redacted] are close personal friends. He stated further he is aware that [redacted] is a bookmaker but that he has never believed that Mr. Valenti in any way gambles with [redacted]. He stated further he knows for a positive fact that [redacted] did not contribute money to Mr. Valenti's wedding or his wedding trip to Las Vegas, Nevada. He said, to his knowledge, the friendship between [redacted] and Mr. Valenti is purely social, and Mr. Valenti is entirely worthy and capable of holding any important post with the Government.

The investigation of Mr. Valenti covered inquiries as to his character, loyalty, general standing and ability, but no inquiries were made as to the sources of his income.

On 5-21-65 subject advised that one of his contacts, whom he declined to identify, advised him that  has been working in the residence of McGeorge Bundy, "a State Department official," as a "so-called  that  is a convicted homosexual, that there is a Central Intelligence Agency report indicating that  had endeavored to extort \$1,000 from an official of the Organization of American States who is also a homosexual; and that there is a sex relationship existing between McGeorge Bundy and  may be identical with , who has been the subject of Special Inquiry investigations. He was until 12-30-64  Our investigation indicated he was sexually promiscuous and although there were allegations of his homosexuality, no concrete evidence was uncovered in our investigations. His current whereabouts is unknown.

McGeorge Bundy is the Special Assistant to the President. Our Special Inquiry investigation of McGeorge Bundy did not indicate he had homosexual tendencies.
