BACKGROUND INVESTIGATIONS FOR OTHER AGENCIES
RECORDS CHECKS - CENTRAL INTELLIGENCE AGENCY (CIA)

Previous discussions between your office and FBIHQ had explored the possibility of conducting CIA checks [redacted] through FBIHQ rather than through your office. An experiment was initiated in the 161 classification to determine the feasibility of this procedure.

Based on the success attained in 161 classification matters, discussions were held with CIA to expand this procedure to other classifications. As a result, arrangements have now been established to conduct CIA checks in the 77 and 116 classifications, as well as the 161 classification, through FBIHQ.

In view of this, CIA checks [redacted] in these classifications will no longer be routinely sent to your office. However, where the background information indicates that investigation will be necessary by your office at CIA (for example, because of employment there), a lead will be set for your office to conduct that investigation as well as any other logical record checks [redacted] which will still be submitted by FBIHQ.

FBIHQ hopes that this procedure will reduce some of the administrative burden on your office in these classifications and conserve your resources for use in other aspects of these investigations.

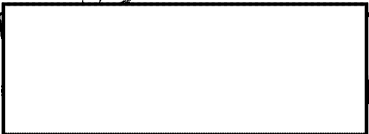

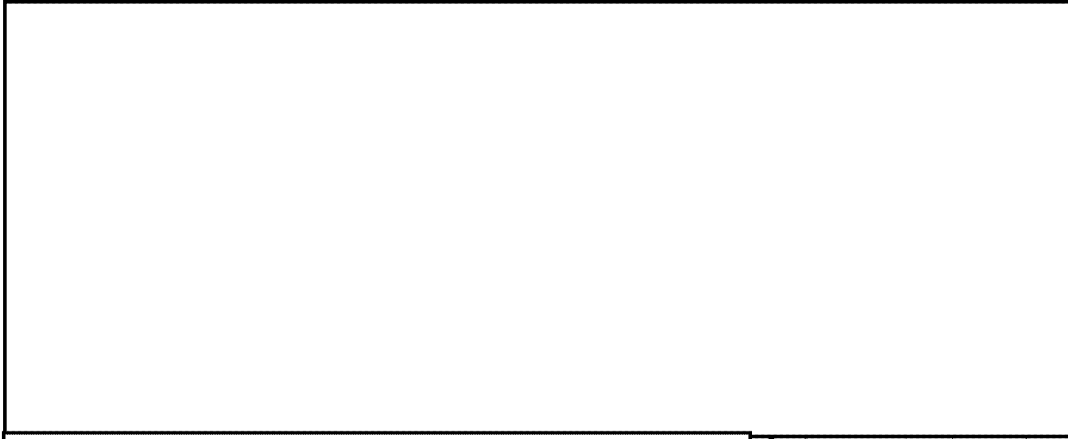

The FBI's role in the conduct of foreign investigations is set forth in the "Implementation Directive for Concurrent Drug Investigative Jurisdiction Between the Drug Enforcement Administration and the Federal Bureau of Investigation." This Directive reinforces the principle that the U.S. Government should present a single point of contact with foreign drug counterparts. In most foreign countries, DEA continues to be responsible for the conduct of drug investigations. Because of this Directive, the FBI's involvement in foreign drug enforcement and intelligence is extremely limited. You may desire to solicit DEA's perspective on this matter.

One priority investigative subprogram within the FBI's narcotics program is comprised of International Trafficking Cartels investigations. These criminal investigations are pursued within the United States, and when leads of a foreign nature are developed, they are referred through FBI Headquarters to DEA Headquarters. These investigations are not intelligence investigations but are directed at specific criminal activity.

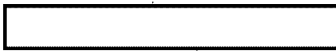

In addition to the International Trafficking Cartels subprogram, the FBI's narcotics investigations have revealed international connections in many other narcotics subprograms. For example, investigations relating to heroin trafficking on the part of the Sicilian Mafia have documented substantial interaction between Mafia members in Italy and the United States. The intelligence information gathered is specific to the particular cases under investigation and geared toward development of evidence of criminal activity rather than more general intelligence information such as that relating to narcotics trafficking patterns in various geographical areas worldwide.

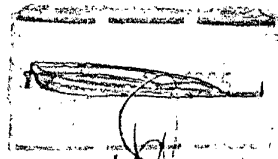

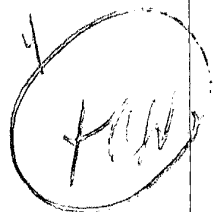

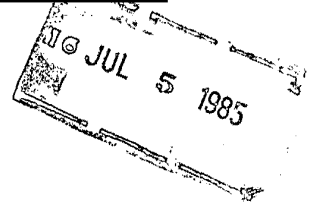

O'Malley of the Intelligence Division made reference to some 17 preventions this year wherein the FBI was able to successfully interdict terrorist acts before they could occur. As you expressed an interest in obtaining additional details, I have had the Terrorism Section of the Criminal Investigative Division prepare the attached memorandum for you.

Please note that the attached memorandum also contains three additional preventions recorded by the FBI this year, but due to the ongoing, sensitive nature of the investigation they are classified "SECRET." These 20 preventions will be published in the 1985 FBI Analysis of Terrorist Incidents and Terrorist Related Activities in the United States in an unclassified form.

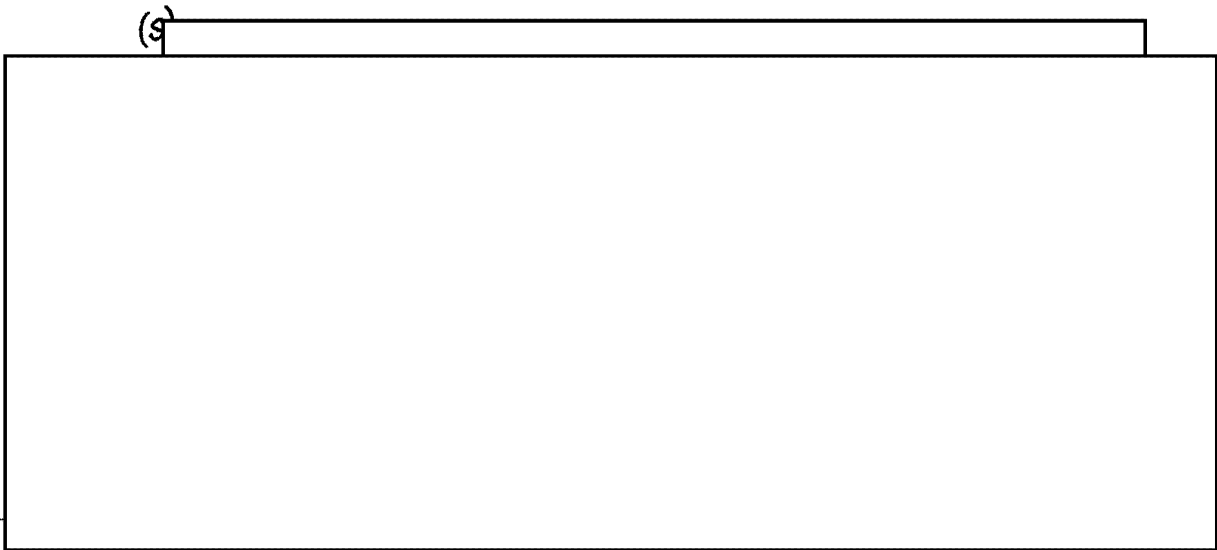

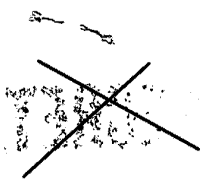
