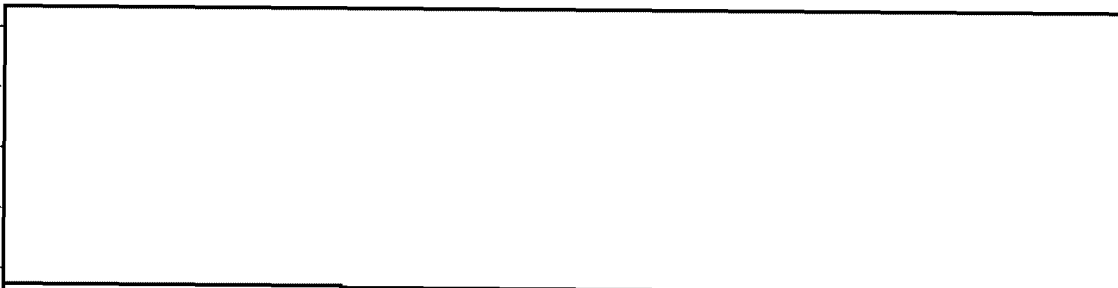

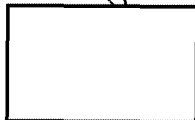

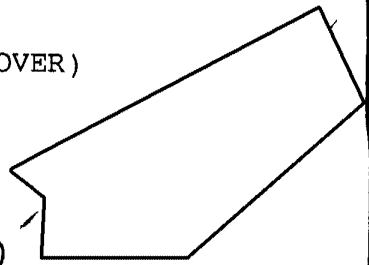

IN ORDER TO ENSURE PROPER COORDINATION AND COMMUNICATION BETWEEN THE FBI AND OTHER COMPONENTS OF THE U.S. INTELLIGENCE COMMUNITY WITH RESPONSIBILITY FOR COUNTERTERRORISM, THE FBI IS ENHANCING THE POSITION OF THE SENIOR INTELLIGENCE OFFICER {SIO} WITHIN THE FBI'S COUNTERTERRORISM SECTION {CTS}. THE POSITION OF SIO HAS EXISTED IN THE FBI SINCE 1987. HOWEVER, IT IS BEING EXPANDED TO BECOME THE OFFICE OF SIO. THIS OFFICE IS DESIGNED TO ENHANCE THE FBI'S COORDINATION AND COMMUNICATION IN THE AREA OF COUNTERTERRORISM ANALYTICAL INFORMATION WITH THE U.S. INTELLIGENCE COMMUNITY. THE OFFICE OF SIO FUNCTIONS WILL BE AS FOLLOWS:

1. TO ACT AS A REPORTS SECTION WITHIN THE FBI TO IDENTIFY AND ENSURE THE DISSEMINATION OF APPROPRIATE INTELLIGENCE INFORMATION FROM THE FBI TO OTHER COMPONENTS OF THE U.S. INTELLIGENCE COMMUNITY WITH RESPONSIBILITY FOR COUNTERTERRORISM.

3. TO REPRESENT THE FBI'S COUNTERTERRORISM SECTION AT
