In order to serve the ever-evolving information needs of the criminal justice community, the FBI is in the process of major organizational and technological change. The newly established Criminal Justice Information Services Division will bring together our identification, National Crime Information Center (NCIC), and analytical/statistical services to provide enhanced customer support. In addition, the FBI is undertaking major investments in technology to revitalize our information services: the Integrated Automated Fingerprint Identification System, the NCIC 2000 project, and the National Incident-Based Reporting System.

As a major consumer of these services, I hope that you or one of your senior executives will be able to attend a briefing on June 16 for the heads of Federal agencies that will be impacted by the changes mentioned above.
