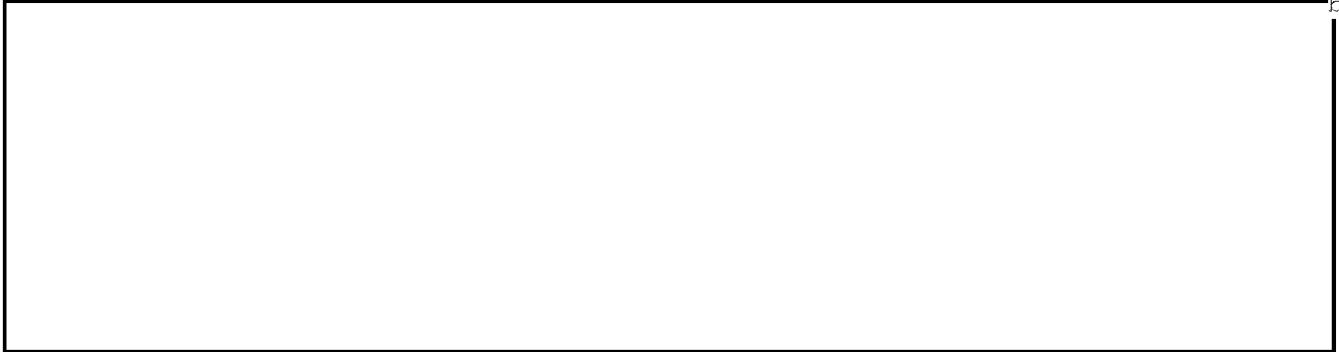

It should be pointed out the FBI's domestic experience has been that virtually all such disclosures occurred due to human factors as opposed to technical operations. There has been a recent "computer hacker" case involving FBI interests where an individual whose interest was simply computer penetration and the challenge and thrill to the commission of the act itself compromised some FBI computer networks. This incident is still being adjudicated.

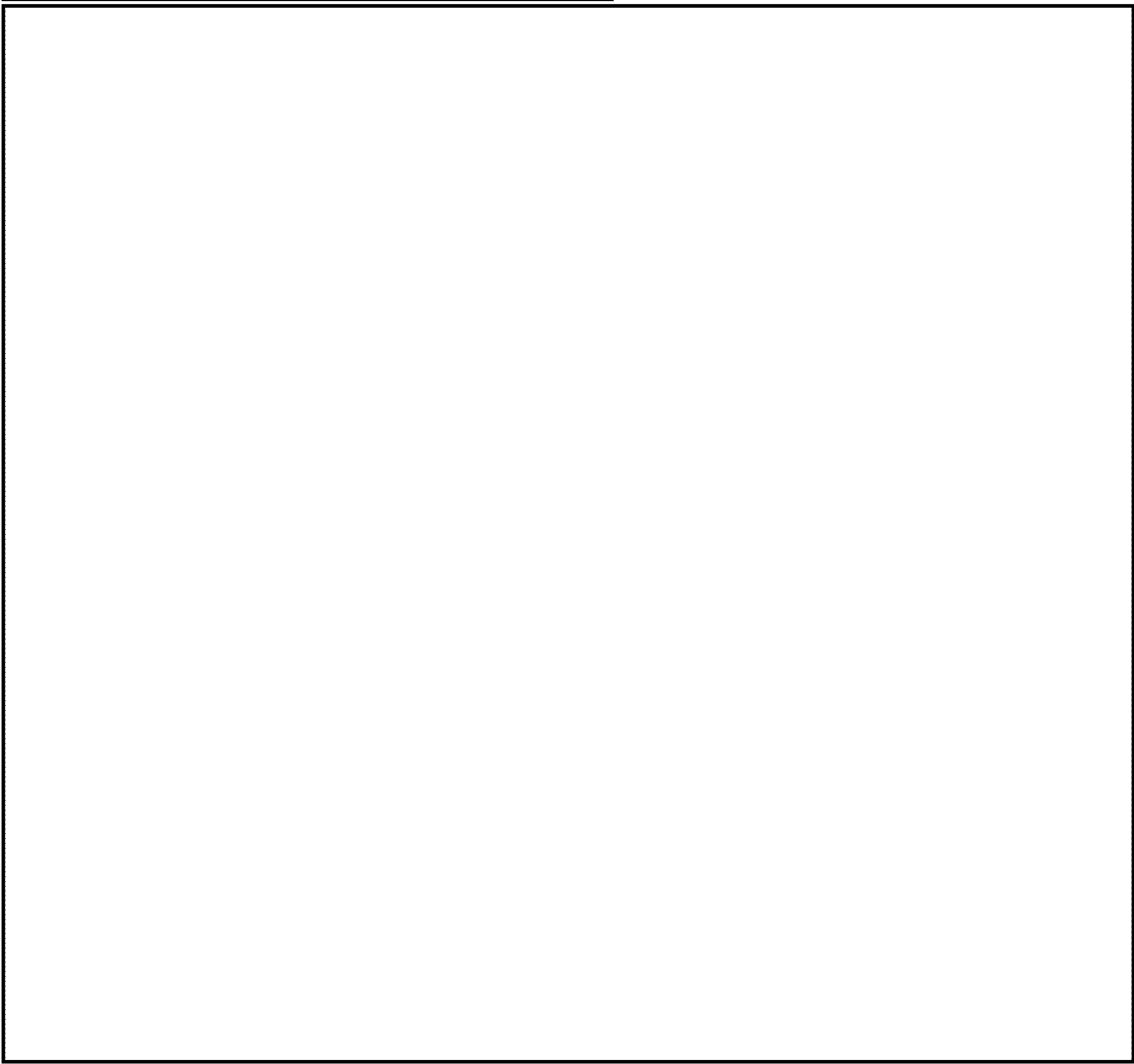

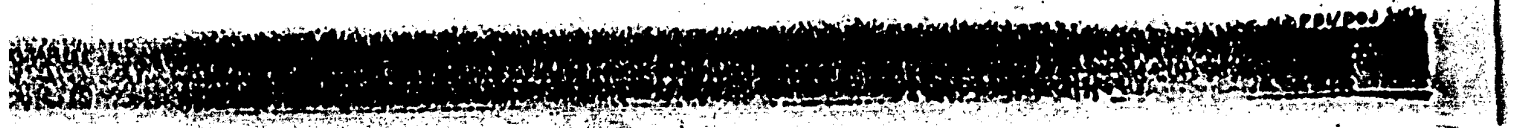
