The first thought is that we had better be more careful when we accuse other Agencies.

That said, it is going to be hard to get at the root problem here (the possibility of **inadvertent** mishandling of something of law enforcement significance vice willful and intentional actions), unless we move out more smartly on several fronts. As we have discussed before, a broad effort at training and briefing CIA (and State) personnel at all levels is necessary for the long term fix. For the shorter term impact, I think that, in the Counterterrorism world at least, the assignment of a senior FBI person somewhere in the environs of [REDACTED]
