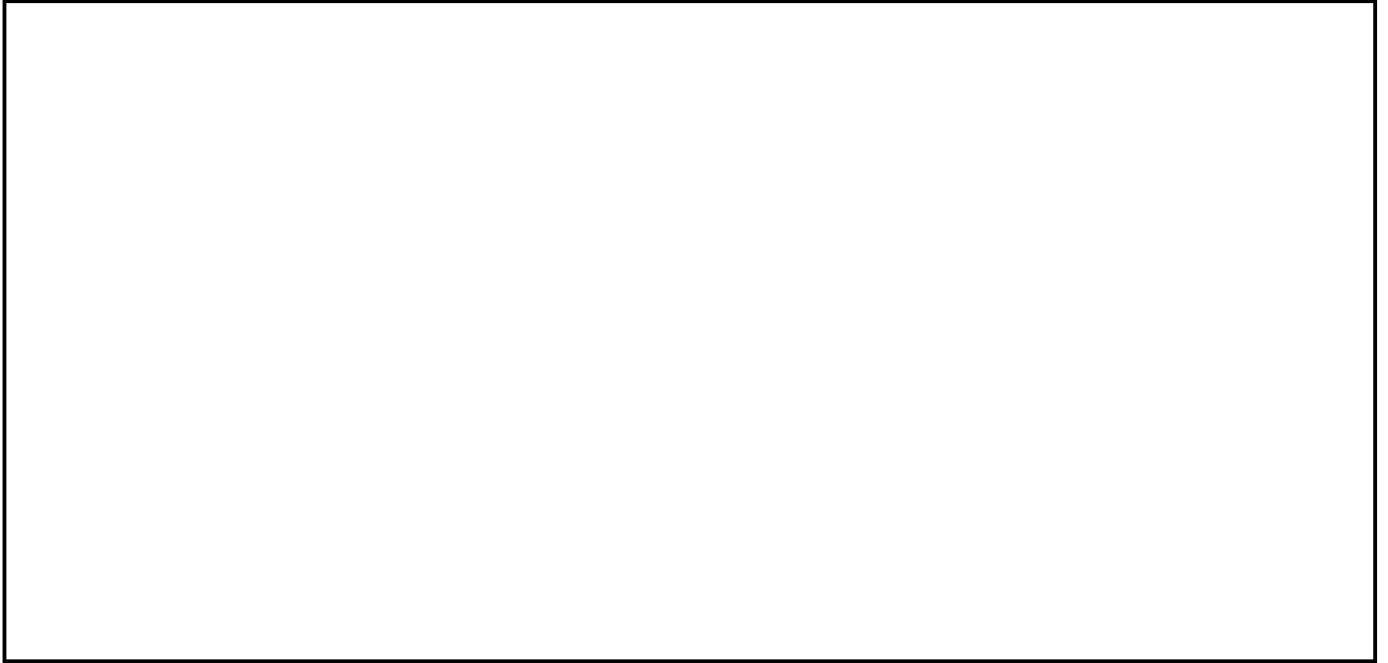

MEMORANDUM FOR MR. TOLSON

On July 15, 1953, Mr. Roy Cohn, Counsel on the McCarthy Committee, called to see me. Mr. Cohn stated that he was particularly concerned about the developments on the McCarthy Committee and referred in particular to the handling of the Central Intelligence Agency matter, stating that this matter was supposed to have been handled by him but that at the instance of Vice President Nixon and Deputy Attorney General Rogers, the discussion of the case had been had with Senator McCarthy by them and that they had conditioned the discussion with the request that Mr. Cohn not be present but rather that Mr. Flanagan, one of the other Counsel of the Committee, be present and that Mr. Flanagan had thereupon proceeded to handle the conference between the members of the Committee and Mr. Allen Dulles, Head of the Central Intelligence Agency.

Mr. Cohn stated that it was imperative that there be a prompt designation of a new Chief of Staff of the McCarthy Committee to take the position held by Mr. J. B. Matthews, who has now resigned. He stated he was still anxious to obtain the services of Mr. Francis Carr, a Special Agent of this Bureau at New York City, and that he was wondering whether I still adhered to the same views which I previously had expressed to him through Mr. Nichols.


I told Mr. Cohn that my views were exactly as previously stated; namely, that I would not agree to any leave of absence nor loan of Mr. Carr; that I would not ask Mr. Carr to take the position with the McCarthy Committee; that I disapproved of Mr. Carr's leaving the Bureau, but that, of course, if he decided to resign I could not prevent his taking whatever position he saw fit to take. I pointed out to Mr. Cohn, however, that I thought the appointment of Mr. Carr by the McCarthy Committee would be a most unfortunate appointment, both for the Committee and for the FBI, because critics of both groups would immediately point out that this established a direct pipeline between the Committee and the FBI. I told Mr. Cohn if such an appointment were made, the FBI would have to be most circumspect in all of its future dealings with the Committee so as to avoid any aspect which would lead to criticism of the FBI in this matter.

Reference is made to the recent publicity concerning Senator Joseph McCarthy's interest in William Bundy of the Central Intelligence Agency (CIA). As you know, it has been reported that Dulles has refused to permit any of his employees to testify before the McCarthy Committee.

On July 10, 1953, Allen Dulles advised Liaison Agent Papich that he felt that he was on safe ground with regard to the position taken by him in that it would be prejudicial to the best interests of the United States to permit his employees to testify before McCarthy. He stated that he has been in touch with the White House concerning this matter and he further indicated that he had the support of the White House in connection with the position taken by him.

Dulles stated, "I would like to know where he gets such information." Dulles obviously was endeavoring to induce some form of comment from the Liaison Agent. Papich immediately advised Dulles that if the latter was under any suspicion that the Bureau might be disseminating such information to Senator McCarthy, he was definitely wrong and off base.

Dulles stated that he definitely did not feel that the Bureau was involved in the McCarthy statements and stated he was sorry if the Liaison Agent received the impression that he was suspecting the Bureau.

[redacted] Central Intelligence Agency (CIA), has advised the Liaison Agent that the CIA has been encountering considerable difficulty in organizing efficient distribution of mail once it is received at the agency. He stated that the CIA has surveyed the situation and has been in contact with other agencies. The net result has been a unanimous observation from other agencies that the FBI has by far the best system. [redacted] therefore, has asked if he and two of his assistants can call at the Bureau and observe the methods being employed in the Records Division. He stated that he was not interested in a complete tour of the Records Division but was particularly interested in the handling of mail at the take-off.

Safeguarding The CIA

One of the ways in which Senator McCarthy undoubtedly hopes to recoup from the Matthews fiasco is by meddling in the Central Intelligence Agency. It is downright condescending of the Senator and two colleagues to assure the CIA director, Allen Dulles, that if he and his assistants appear before the committee "we will not expose their secret, classified operations." If the Senators were to give away any such information, of course, they would be guilty of the most flagrant betrayal of the national interest—something far more serious than anything Senator McCarthy has uncovered.

CIA has, perhaps, the tightest personnel security system in Government. It is ridiculous to think that the purpose of Senator McCarthy's investigation is to check on security or on operations. Rather, the objective has been pretty clearly disclosed as that of seeking out political whipping boys.

It is true that one of the difficulties of an intelligence agency tucked away from other parts of Government is that there is no public scrutiny of its activities. If Congress is concerned about this point, it might be useful to set up a select joint committee to keep tabs on the CIA in the manner of the Joint Committee on Atomic Energy. But beyond this Congress should not go, for the very nature of an intelligence operation in a democracy depends upon forbearance.

There is a heavy responsibility upon the executive branch to maintain good management and to check upon intelligence policies. It is also perfectly proper, in this newspaper's view, to criticize CIA blunders when they come to public attention. But membership in Congress does not automatically entitle a person to national secrets. It is simply inconsistent with the facts of international life to suppose that everyone can be let in on the details of intelligence activities forced upon us as a matter of survival. There would be little point in having an intelligence agency at all if its operations could be blabbed to the winds by any cheap political demagogue seeking publicity.

Secrecy Carried Too Far!

SENATOR MIKE MONRONEY of Oklahoma, an inveterate and politically insensate New Dealer of the old Roosevelt dispensation, took it upon himself to exalt the Central Intelligence Agency as a means of abusing Senator Joe McCarthy when McCarthy thought of questioning an official of the CIA who had given \$400 to the Hiss defense fund.

Monroney's harangue provides a fair idea of the monstrous authority and arrogance of this extravagant secret bureau which is known to have provided several millions of our money to carry on the work of David Dubinsky's two communist political agents, Jay Lovestone and Irving Brown, now operating in Europe. Lovestone had some experience as a practical bolshevik in the days of the bolshevik butcheries in Russia, but Brown's reputation as a bad man of the barricades is a propaganda production foisted on gullible editorial foremen of magazines and newspapers by crafty or gullible hacks of journalism.

Monroney said McCarthy wanted "to explore the innermost secrets of this highly confidential and secret arm of the national security." He reminded the Senate that the National Security Council, composed of President Eisenhower, Vice President Nixon, the Secretaries of State, Defense, Army, Navy and Air Force and the chairman of the National Security Resources Board, had the duty of supervising the CIA.

Few Americans know who these secretaries and the chairman of the National Security Resources Board are. The fact that President Eisenhower fell for Irving Brown as a suitable chief of internal disorder and other hostile activities to be fomented by the United States in friendly countries abroad, does not enhance Ike's reputation as a competent judge of "intelligence" operations.

Appropriations Not Listed

Continuing, Monroney said: "Up to the time of (McCarthy's) demand, Congress had respected the necessary confidential nature and secret operation of Central Intelligence. No listing of appropriation is even provided for in the bills which Congress passes, so secret is the nature of this operation.

The act establishing its policy reads: "In the interest of the security of the foreign intelligence activities of the United States and to implement the proviso that the director of CIA shall be responsible for protecting intelligence sources and methods from unauthorized disclosure, the agency shall be exempt from the provisions which require disclosure of the organization, length of official titles, salaries or

of personnel employed; provided that the Director of the Budget shall make no reports to Congress in connection with the agency."

Monroney said "not even Cabinet members are generally informed as to the full text or origin" of the CIA's reports which go across the desk of President Ike.

"It could hardly be called a New Deal agency and thus subjected to the general suspicion so assiduously built up to create doubt in the people's minds of the loyalty of its then Democratic leaders," he continued.

At this point it is pertinent to note that General Bedell Smith, Ike's chief of staff

in the war, was chosen by Roosevelt for advancement from lieutenant colonel to lieutenant general, chosen by Truman to be director of the CIA, and latterly chosen by Ike to the No. 2 position in the State Department, under John Foster Dulles, whose brother, Allen, succeeded him in the CIA.

Moreover, William Bundy, the CIA man under both Smith and Allen Dulles, who gave the \$400 for the Hiss defense, is a son-in-law of Dean Acheson and a member of the Acheson coterie. His father is an old friend of Acheson and his brother, McGeorge Bundy, wrote a book praising Acheson's foreign policy, defending Acheson's continuing friendship for Hiss and proclaiming a family tie between the Bundys and the Achesons.

Build-Up for Distrust

So when Monroney said popular doubt of the loyalty of leaders of the Roosevelt-Truman Democratic Administration had been "assiduously" built up, he could fairly have added that these leaders, themselves, were the most assiduous builders of that doubt. Truman repeatedly called the Hiss treason a red herring and Acheson said he could not turn his back on Alger Hiss.

Monroney said McCarthy's investigation of Bundy's sentiments toward Hiss and Communists would disclose to "our enemies" information that the Kremlin's spies could not get for themselves, failing, however, to face the possibility implicit in McCarthy's proposal, that the Kremlin already had spies in the CIA disguised as Harvard double-domes of the Acheson-Frankfurter persuasion.

Many such were disclosed by the House Committee on Un-American Activities, including Hiss, himself, an actual Frankfurter plant by his own grudging admission.

Monroney then resorted to a familiar ruse of seduction and evasion often practiced by Eleanor Roosevelt to distract suspicion from her friends and discredit the congressional disclosures. He said the FBI was a better agency to investigate traitorism than McCarthy's committee, but refrained from mentioning the fact that the FBI cannot reveal its discoveries, some of which were suppressed by White House influence during the Roosevelt-Truman regime.

The FBI's discoveries can't embarrass a spy or traitor if they lie secret in the files. The revelations of a congressional committee, on the contrary, raise hell in print and have shown up Monroney's party and Eleanor Roosevelt's as the accomplice of the most appalling treachery in our history.

No Accounting for CIA

However, Monroney did pink himself on the raw when he said, "I do not think J. Edgar Hoover and his well-trained men have wasted the \$470,000,000 that Congress has given them since 1947."

In the first place, as Monroney knows, the FBI (and CIA) are not a bunch of silly, amateurs, at best, and doesn't trust it. In the second place, although Monroney can roll off the end of his tongue the amount that Congress has given the FBI since 1947, nobody in the entire United States outside a secret circle of persons unknown, is permitted to know how much the taxpayers have handed over to the CIA, subject to absolutely no question or accounting, what was done with it or what results were accomplished by a gang of idle adventurers and loafers.



Mr. Gene Fuson of the "San Diego Union" called today. You will recall that Fuson and Fabio Gallo were referred to the Bureau by Vice-President Nixon and Congressman Hillings on July 23, 1953, with information Gallo had concerning alleged defection of prominent Soviet espionage agents. During the course of the interview with Gallo and Fuson on July 28 Gallo made reference to certain information concerning an airstrip built by the Communists in Guatemala. This information was given by Gallo and Fuson to the Central Intelligence Agency on a previous date.

During the conversation with Fuson today he referred to the information furnished to the Central Intelligence Agency and stated that one week after it had been given to them it was in the hands of Walter Winchell. Fuson stated that his boss, Bill Shea, General Manager of the Copley Press on the West Coast and Associate Publisher of the "San Diego Union," told him that Walter Winchell had informed him that the information had been given to him by the Central Intelligence Agency but he declined to divulge the identity of the individual in Central Intelligence Agency who had furnished it.

He received several military decorations for the roles he played in important battles in the Pacific during the last war particularly in connection with the campaigns at Guadalcanal and Okinawa. Files indicate that Del Valle is allegedly very anti-Semitic. In 1941 it was reported that the General's wife had displayed decidedly pro-German sentiments. The Bureau also received a report that General Del Valle had been friendly with James True who is publisher of "The James True Associates" and was one of the defendants under indictment in the mass sedition case which developed during the last war. In 1951 General Del Valle contacted Mr. DeLoach of the Bureau at which time he launched into a tirade against what he termed "Semitic aliens of the Government." On that occasion Del Valle stated that he recently had been appointed to an executive position with the International Telephone and Telegraph Corporation in Buenos Aires, Argentina. By letter dated May 21, 1951, addressed to Mr. DeLoach, General Del Valle transmitted some information concerning alleged Communism in the movie industry. This letter was acknowledged by the Bureau. By letter dated March 10, 1953, Del Valle wrote to the Bureau regarding Radio Free Europe, which organization is supported and subsidized by the CIA. He furnished derogatory information regarding Radio Free Europe and stated that he had called the matter to the attention of Senator Joseph McCarthy. This letter was also acknowledged by the Bureau at which time General Del Valle was thanked for his interest and concern.

Needless to say, the publicity which the CIA has been receiving in recent weeks has upset the officials of that agency. The wide publicity given to the William Bundy matter, Allen Dulles' encounter with Senator McCarthy, the attacks of Westbrook Pegler and now the recent storm created by General Del Valle has placed Allen Dulles in a most uncomfortable position. Officials of the Office of Security in the CIA realize that the agency is vulnerable in other points and they are trying to determine where individuals such as Pegler, Del Valle and Senator McCarthy may strike next. The recent publicity is probably only the beginning, bearing in mind that Congress in its next session very likely will devote more attention to CIA activities.

FAIR ENOUGH

Lt. Gen. Pedro A. Del Valle, U. S. Marine Corps (ret.), has sent me a written charge that the central intelligence agency, then under the administration of Gen. Eisenhower's personal and political ally, Lt. Gen. Walter Bedell Smith, tried to send him on a mission to Tokyo, to "stand up to Gen. MacArthur and perhaps cause his downfall."

Gen. Del Valle wrote me that he had presented a plan to utilize exiles and persons in the countries

behind the Soviet's Iron Curtain against the Red regime and that the joint chiefs of staff called him all the way from Buenos Aires to Washington to discuss it. Instead of going further with his plan, however, the CIA, which was deemed to have jurisdiction, ignored it altogether and thought up the Tokyo job. In his opinion, the purpose was not only to "get" Gen. MacArthur but to ditch his plan.

His letter, minus some irrelevancies, follows:

"I really have been interested in your articles on the CIA because I was a victim of that agency when Beadle Smith had charge in the days of Acheson and Marshall. My experience could be of interest to you and, if so, go ahead and use it.

"While in Buenos Aires (I retired in 1948 and was vice president of the International Tel and Tel and in charge of South America at the time, about 1950), I wrote a plan for the utilization of the exiles and the people in the enslaved countries themselves to combat the Reds in their own territory in a very effective manner. I had gone to a great deal of trouble and had contacted many important personalities among the emigres in order to make sure the plan would make sense and be acceptable to them. The plan was so well liked by the joint chiefs of staff that they asked me to come up to Washington about it and I did, only to find that the CIA had jurisdiction and I was instructed to contact Beadle Smith there.

"The general was then my equal in rank, so I was quite frank about things with him. I had expected to be consulted about the plan or else told it was not acceptable. But they took a different tack and tried to send me to Tokyo as their representative, in order that I might stand up against MacArthur (not yet booted by Truman) and perhaps cause his downfall. He had disputed their jurisdiction over his intelligence affairs.

"My reaction was prompt and violent and I left at once, informing S (Smith) that as a

produced, etc. Allen Dulles caught me on the way out and tried to wheedle me into staying with them. They even sent a colonel to New York to persuade me, the morning of my departure for B. A. to play their game. My refusal was final. I even refused to put in a claim for travel and to this day the CIA owes me that.

"Since then they have sabotaged the proffered efforts of a very distinguished Russian general who was instrumental in persuading many millions of Russians to desert the Reds in World War II. I can give you this story also, if you are interested, and I intend to communicate with McCarthy to give him ammunition for his fight to expose the Reds in CIA.

"If there is any interest for you in these occurrences, which I have sketchily related, please let me know and I shall be glad to answer questions and give more details."

Gen. Del Valle is now retired from the IT and T and is raising cattle near Elkridge, Md. By telephone he confirmed the contents of the letter and expressed his uninhibited opinion of both Eisenhower and Smith as experts on "intelligence." It was not favorable.

He said further, developing the mention of the rejection of the "proffered efforts of a very distinguished Russian general," that Gen. Ridgway, commanding NATO in Europe, had been told this officer's proposal and had referred it to CIA, which had turned it down.

"These people," he said, meaning the CIA, "have hogged everything. They are supposed to be an information-gathering agency, not military."

Gen. Del Valle said the Russian general could have caused great numbers of soldiers in the Russian armies to come over to the side of the Western powers. I referred to the fact that many thousands of Russian soldiers had deserted to the Germans in the war not to fight for national socialism or Hitler but to oppose the Russian tyranny, and had been surrendered to the Reds for punishment by our people when we caught them in the areas occupied by the Western powers after victory.

Gen. Del Valle said the Russian general whom he named could have induced many Russian soldiers of the present army to come over to our side nevertheless. Many Russians killed themselves in 1945-46 rather than return to Russia to be put to death or enslaved for the rest of their lives. Gen. Del Valle named an American general still on active service in a high command as the person who turned the captives over to Russia after VE day. That surrender of an unknown multitude of soldiers and civilians under those conditions has been condemned by some authorities not only as

GENERAL TELLS OF CIA PLOT TO 'GET' M'ARTHUR

Del Valle Says His Aid
Was Sought in '50

BY WALTER TROHAN

Lt. Gen. Pedro A. Del Valle, retired Marine corps officer, Thursday night stood ready to tell Congress that the central intelligence agency attempted to enlist him to plot the downfall of Gen. Douglas MacArthur, then supreme commander in the Far East, in 1950.

From his home at Elkridge, Md., the general confirmed published reports that Lt. Gen. Bedell Smith, then head of CIA and now under secretary of state, and Allen Dulles, now head of CIA and then a CIA subordinate, had sought to have him work against MacArthur.

Del Valle's charges shocked the administration from the White House to Capitol hill. Dulles conferred with President Eisenhower during the day. It is reported that their meeting included discussion of the general's charges.

Pentagon Checks Case

At the Pentagon it was understood a search was being made to determine whether action might be taken against the officer for his disclosures. At the time Del Valle was not in active service, so that he could not be accused of revealing military secrets, it was said.

On Capitol hill Sen. McCarthy (R) of Wisconsin refused to comment on reports that the General would be called to testify before his investigating committee. It was understood, however, that the general's story had been known to Congressional investigators.

Republican members of congress have long suspected that the Truman administration was plotting to get rid of MacArthur long before he was fired by the former President in April, 1951. There were reports of various plots against MacArthur.

Story Ridiculed

Gen. Del Valle's story is the first offer of evidence that any plot was being hatched. At the CIA and State department Del Valle's story was being dismissed as ridiculous, but the general insists he is willing to confront those he accused before a congressional committee.

Del Valle retired from the Marine Corps in 1947. He was in charge of the U.S. Navy's South American division. While there he conceived a plan for using exiles from the Iron Curtain and peoples of enslaved nations to combat the Soviets in their own territory.

The general said the plan was highly regarded by the joint chiefs of staff. He was asked to come to Washington to discuss his plan. When he arrived he was sent to the CIA where he was closeted with Gen. Smith.

Offered Post in Tokyo

"The general was then my equal in rank, so I was quite frank about things with him," Del Valle wrote in a letter for publication. "I had expected to be consulted about the plan or else be told that it was not acceptable."

At the present time the Bureau transmits to the CIA five Law Enforcement Bulletins per month. These copies have been sent to CIA, attention [redacted]

On August 17, 1953 [redacted] of the CIA inquired if the Bureau was in a position to send the CIA fifty Law Enforcement Bulletins per month. He explained that about thirty of such Bulletins would be distributed to various sections at CIA headquarters and remainder would be transmitted to the foreign field stations of CIA. According to [redacted] numerous officials of the CIA have characterized the Law Enforcement Bulletin as an outstanding publication and one of the best products of the United States Government. CIA employees have discovered that the Bulletin contains numerous articles which provide information which can be utilized by the CIA to good advantage in its training programs and in the handling of its operations in foreign countries. [redacted] made particular reference to articles which contained information concerning investigative techniques. He stated that such articles have proved of great value in organizing CIA projects abroad.

With regard to Bulletins which might be sent abroad [redacted] stated that the CIA would like to distribute such additional copies to intelligence and security services in friendly foreign countries. The Liaison Agent told [redacted] that the most practical and efficient manner for such distribution would be to request the interested foreign service to correspond with the Bureau. It was pointed out to [redacted] that the Bureau already sends Law Enforcement Bulletins to various foreign countries and the Bureau does not desire to duplicate any distribution. It is believed some foreign service might receive the impression that a CIA representative is connected with the FBI.

RECOMMENDATION:

It is recommended that consideration be given to furnishing CIA fifteen Bulletins per month which should be adequate for internal use within the CIA. CIA will be advised via liaison channels that in conformity with current Bureau policy and budget limitations the Bureau can only furnish fifteen Bulletins per month.

SUBJECT: GENERAL WALTER BEDELL SMITH

In accordance with the Director's instructions, Liaison Agent Parich contacted General Smith today. Set forth are the results of the interview with General Smith.

Parich made reference to the recent conversation with General Smith concerning the report that an ex-Bureau Agent had been identified as a homosexual as a result of a polygraph examination given to the ex-employee by the CIA. Parich informed Smith that additional data had been developed at the CIA after considerable prodding. His attention was directed to the fact that CIA had possession of information which should have been given to the Bureau long ago but CIA apparently felt that the information should not have been disseminated to the Bureau. It was explained to General Smith that apparently the case seemed to be pinned down but damage had already been done to the Bureau through malicious rumors which were circulating throughout Washington. General Smith then asked Parich why he was calling all this to his attention.

Parich told General Smith that he had respect and admiration for everything that General Smith has done in behalf of his country but the Liaison Agent felt that he was obliged to be frank and blunt. Parich then advised Smith that he had been following this matter very closely and that as far as Parich was personally concerned General Smith undoubtedly originated the rumor. Parich made it very clear to Smith that he was making this as a personal observation based on his knowledge of facts developed so far. Smith was taken back and obviously was very upset and angry. He stated, "I don't know why I deal with you" and then paused for several seconds. He then calmly replied, "Sam, I do not know. It is possible that I did start the rumor." He explained by stating that he has had numerous conversations with various people concerning sex perverts in the Department of State. In this connection he has also talked to people about the use of the polygraph. Smith stated that it was highly possible that in connection with such discussions he may have made the comment that an ex-Bureau Agent had been detected as being a pervert as a result of a polygraph examination at the CIA. Smith reiterated that he could not recall if he had specifically discussed this but he stated, "This is very possible." Smith became rather conciliatory in his tone and stated that if he did make such a statement he had done so not maliciously or with any intention of harming the Bureau. He then proceeded to laud the Bureau and the Director.

Smith asked Papich if he thought any harm was done to the Bureau if he had unintentionally started the rumor. Papich replied that there was no question about it that rumors always do harm, particularly when they are passed around by the wrong people. Papich then commented that the General's intentions might have been good but it was the Liaison Agent's personal observation that the General sometimes "talked too much." The General again became irritated but for some unknown reason quickly subsided and emphatically stated, "I again repeat I may have started the rumor but I did not do so with any intent of injuring the Bureau."

Papich asked General Smith how much information he actually received from the CIA concerning the ex-Agent. Smith emphatically stated that Allen Dulles had made a very brief comment to him concerning a case which involved a polygraph examination given to an ex-Bureau Agent. It was his recollection that Dulles had commented that the examination had produced evidence indicating that the ex-Bureau employee was a pervert. Smith stated that he was not certain of the exact language used by Dulles but to his best recollection it was presented to him as explained above. General Smith then made the observation that he knows Dulles very well and that if Dulles had anything to do with the failure of not disseminating information to the Bureau, it was solely based on the fact that Dulles has a great fear of Mr. Hoover.

Needless to say, the blunt and direct approach made by the Liaison Agent on this matter incensed General Smith; however, it was very obvious that he became conciliatory and palliative by the time the interview ended. His attitude possibly can best be described by his statement, "I do not want to fight Mr. Hoover."

Near the end of the interview Smith made reference to his health which he considered was deteriorating. He stated that he was definitely leaving the Department of State by January 1, 1954. This is possible but it should be borne in mind that Smith "pops off."

On September 16, 1953, Liaison Agent Papich contacted Allen Dulles and furnished him the background of the case as it pertained to relations between the Bureau and the CIA. Dulles was immediately told that the information developed by the Bureau had disclosed the situation of such an alarming nature and grave concern that the Director wished the case called to the personal attention of Dulles. Dulles appeared to be ignorant of the matter and stated that he faintly recalled the case involving an ex-Bureau employee but it was his recollection that CIA had not developed any specific evidence that the ex-Agent was a pervert.

Dulles' attention was then directed to the instances reflecting CIA failure to cooperate with the Bureau by not furnishing the derogatory information in the possession of CIA concerning a former Bureau employee. It was stressed by the Liaison Agent that the uncooperative attitude taken by the CIA naturally was most prejudicial to the relations between the Bureau and the CIA. Dulles was further told that CIA's resistance to furnish data and to identify sources which could be of assistance to the Bureau only introduced additional obstacles which obstructed the Bureau in the checking of a matter which had a most serious bearing on the security of the Bureau's operations. It was then strongly emphasized to Dulles that although the CIA had endeavored to give the impression that the Agency had guarded the information in a most restricted manner, a rumor regarding the case had nevertheless begun to circulate in Washington.

Upon hearing that the Director had personally followed this matter, Dulles became very uneasy and nervous. He readily admitted that his Agency had mishandled the entire matter and he then inquired if anything could be done to correct the harm which might have been done. He was told that the damage had already been done and it was only hoped that the CIA could institute measures which would prevent a recurrence of similar incidents. Dulles advised that he would immediately instruct his Office of Security to take steps to avoid similar situations in the future. Dulles admitted that from his personal knowledge the Bureau had been most cooperative in the handling of matters of a similar type and he fully realized that the CIA should reciprocate with similar cooperation.

Dulles commented that he honestly could not recall the case but it was his personal opinion that [redacted] [redacted] apparently had been afraid of becoming involved with the Bureau by transmitting derogatory information concerning an ex-Agent. Dulles was convinced that [redacted] would never deliberately hold out on the Bureau but undoubtedly had used poor judgment in this case. D. C.

With regard to the rumor which has circulated, Dulles stated that he does not recall discussing the case with anyone, although he had a vague recollection of a brief conversation with [redacted] regarding the case of an ex-Bureau Agent. He could not definitely recall if he had ever discussed the case with General Walter Bedell Smith. Dulles stated that he was most disturbed to hear about the incident because he felt that since he had become Director of CIA he had taken great pains to do everything possible to maintain smooth relations with the Bureau. He realized that incidents of the type described above naturally offended the Bureau and he personally desired to avoid any recurrences in the future. b3

Although there is no assurance of repetition of similar incidents, there is every reason to believe that the CIA now has a clear and unmistakable understanding of the Bureau's position and attitude bearing in mind that [redacted] was left in a most distressing position, the protest was made to Mr. Dulles and you will also recall that General Smith's hand was called on the origin of the rumor.

RECOMMENDATION:

It is recommended that a copy of the referenced memorandum being disseminated to General Smith and the White House be made available to Allen Dulles of CIA for the following reasons, and with the understanding that the dissemination to CIA be made after the data was delivered to the White House and General Smith:

1. There is no doubt that General Smith or the White House will immediately contact the CIA, regarding the information after it is received.
2. The memorandum contains information which refers to a serious security situation within the CIA.
3. If the Bureau does not disseminate this data to the CIA, the Bureau could be charged with failure to cooperate in that information of obvious interest to the CIA was not made available, particularly data bearing upon security within the CIA. In this connection it may be borne in mind that the Bureau has not hesitated to call the CIA's hand when that agency failed to promptly furnish similar information to the Bureau.

You will recall that consideration was given to submitting a letter of protest to Dulles in connection with the manner in which CIA handled [redacted] matter. [redacted]

[redacted] The CIA failure to cooperate was further aggravated by the fact that General Walter Bedell Smith had made statements regarding an ex-Bureau Agent who allegedly was found to be a pervert as a result of a polygraph examination taken at the CIA. This undoubtedly led to the circulation of a rumor [redacted]

In lieu of a letter of protest the Director instructed that the matter be taken up with Dulles via liaison. As you know, Dulles has been out of the country since August 9, 1953, and it is not expected that he will return before September 10, 1953.

ACTION:

When Dulles returns the Liaison Agent will take the following action:

- (1) Dulles will be told that first of all CIA had exhibited a most uncooperative attitude decidedly prejudicial not only to the best interests of the country but to the relations between the two agencies by failing to furnish derogatory information which had been developed concerning a former Bureau employee. It will be pointed out that if the information were true the facts naturally would have a direct and serious bearing on the security of the Bureau's operations, particularly since the ex-employee had been handling most sensitive work.

(2) His attention will be directed to the fact that even after the Bureau had approached the CIA on the matter that Agency was reluctant and even offered resistance to furnish information in possession of the CIA. Dulles will be informed that even after CIA furnished some information that Agency was not inclined to identify its sources, all of which only introduced additional obstacles to the Bureau who was interested in checking on what might have been a serious security risk.

(3) Dulles will be told that CIA's failure to cooperate was further aggravated by the fact that although that Agency allegedly guarded the information on the ex-Agent in a highly sensitive and restricted manner, there nevertheless was a rumor circulated in Washington concerning the case.

(4) Dulles will be informed that the Bureau has been cooperating with the CIA by furnishing that Agency any derogatory information received concerning CIA personnel or operations. The Bureau has disseminated considerable information of that nature and has always expedited the transmittal to the Office of Security, CIA, or to the Director of that Agency depending upon the merits of the case. Dulles will be told that it is difficult for the Bureau to understand why the CIA does not reciprocate with similar cooperation.

(5) It will be emphasized to Dulles that the entire matter has been one of grave concern to the Director who desires to call the case to Dulles' personal attention hoping that steps will be taken to prevent a recurrence of a similar incident.
