Dear Gentleman;

I would like very much to get in touch with the Central Intelligence Agency.

Since I personally don't know how to go about contacting same agency, I would appreciate it very much if you would let me know how that can be arranged, or if possible would you be kind enough to bring this letter to the attention of the agency.
