Reference is made to my memoranda to you dated November 15 and November 20, 1951, reflecting information received from [Redacted] of CIA, that the Bureau Special Agent in Charge in Boston had failed to answer telephone calls from CIA personnel [Redacted]

You will recall that inquiries of former Boston SAC Soucy and SAC Thornton failed to indicate any basis for this allegation.

A further contact with [Redacted] indicated that [Redacted] complaint was ill-founded and that a check by CIA had failed to indicate any specific incidents to substantiate [Redacted] allegation.

[Redacted] was informed that in any matters of this nature brought up by CIA the Bureau must insist upon specific incidents in order to make appropriate inquiries.

This matter has been followed with [Redacted] and [Redacted] of CIA. They have now advised that all possible inquiries by CIA have failed to develop any specific allegations against the Bureau Office in Boston. [Redacted] pointed out that [Redacted]

[Redacted] stated he wanted to apologize to the Bureau for [Redacted] original allegation.

These individuals were advised that the Bureau desired to cooperate with [Redacted] but that in the event some problem arose in this connection the Bureau must insist upon complete and specific facts so that the matter can be nailed down. [Redacted] agreed that it would be handled in this manner in the future.

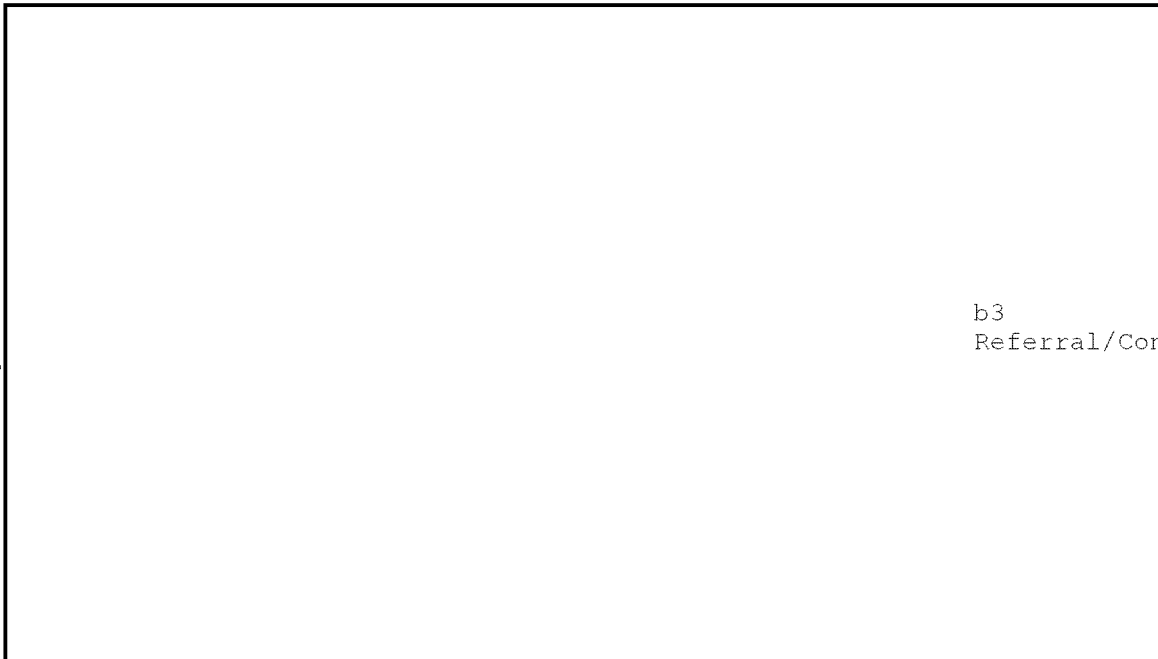

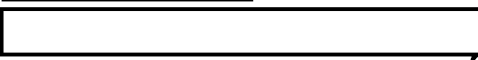

As you are aware, Clerk - Supervisor [redacted] of the Espionage Unit handles these requests.

CENTRAL INTELLIGENCE AGENCY

A system has been worked out whereby upon its receipt by [redacted] a carbon copy of the CIA request is detached and retained by [redacted]. The original request, together with any attachments thereto, is then forwarded by [redacted] to [redacted] of the Records Section. [redacted] has the name of the subject searched and all files checked to eliminate non-idents. The idents and possible ident files are then forwarded to [redacted] together with a search slip prepared on the subject, the original CIA request and any attachments thereto. [redacted] thereupon makes the necessary file reviews and replies to the CIA request. You will note that in following this system we have a record on [redacted] desk of all requests in this category in the Bureau at any given time.

These CIA requests are picked up by our Liaison Unit on a regular basis at the Central Intelligence Agency. In order that the most expeditious attention possible may be given to these requests in the future, it is suggested that our Liaison Unit be requested to forward any such requests directly to [redacted] upon their arrival at the Bureau. This, of course, will eliminate the step of having these requests recorded before being forwarded to the Espionage Unit for handling. However, since they are in the nature of a name check and other name check requests for outside agencies are handled in this manner, it is believed that the particular requests under discussion should receive the same treatment. In this connection, it should be noted that this procedure will permit the Bureau to give more expeditious attention to the CIA requests.

ACTION:

If it meets with your approval, it is recommended that our Liaison Unit be requested to forward these CIA requests directly to [redacted] in the Espionage Unit upon their arrival at the Bureau. At present the Central Intelligence Agency is processing flimsy requests submitted by the FBI on 11-28-51, and dates subsequent thereto which makes the oldest list 44 calendar days old.

Since the communication submitted to the Bureau on 1-3-52, CIA has returned to the FBI [ ] flimsies and has received from the FBI [ ] flimsies which tends to indicate that CIA is losing ground.

This extreme CIA delinquency was discussed by SA L. RUSSELL WHARRY, WFO Liaison Agent to CIA, with [ ] CIA, on 1-4-52, and daily thereafter in an effort to expedite the return of flimsy requests. [ ] stated that he, in turn, discussed the situation with his superior, [ ] and in each instance was instructed by [ ] to personally contact the unit or units responsible for the delay and appraise them of the seriousness of the delinquency and urge them to greater efforts. [ ] said he did as he was instructed but was unable to do more as he was in no position to exert more pressure. b3

[ ] is of the opinion that the interested CIA personnel are now fully cognizant of the situation and are exerting all efforts to produce the requested checks. However, based on past performance, [ ] was unwilling to make any commitments and stated that the hope for improvement might not materialize.

Inasmuch as the situation presently existing at CIA precludes any possibility of meeting deadlines in cases requiring CIA checks and as there are at present approximately [ ] outstanding flimsy requests at CIA and as continuous pressure by this office has failed to improve this CIA delinquency, it is suggested that the Bureau may desire to discuss this problem with CIA on a Bureau level.

Efforts will be continued by the WFO to alleviate this extreme CIA delinquency and the Bureau will be advised of any change.

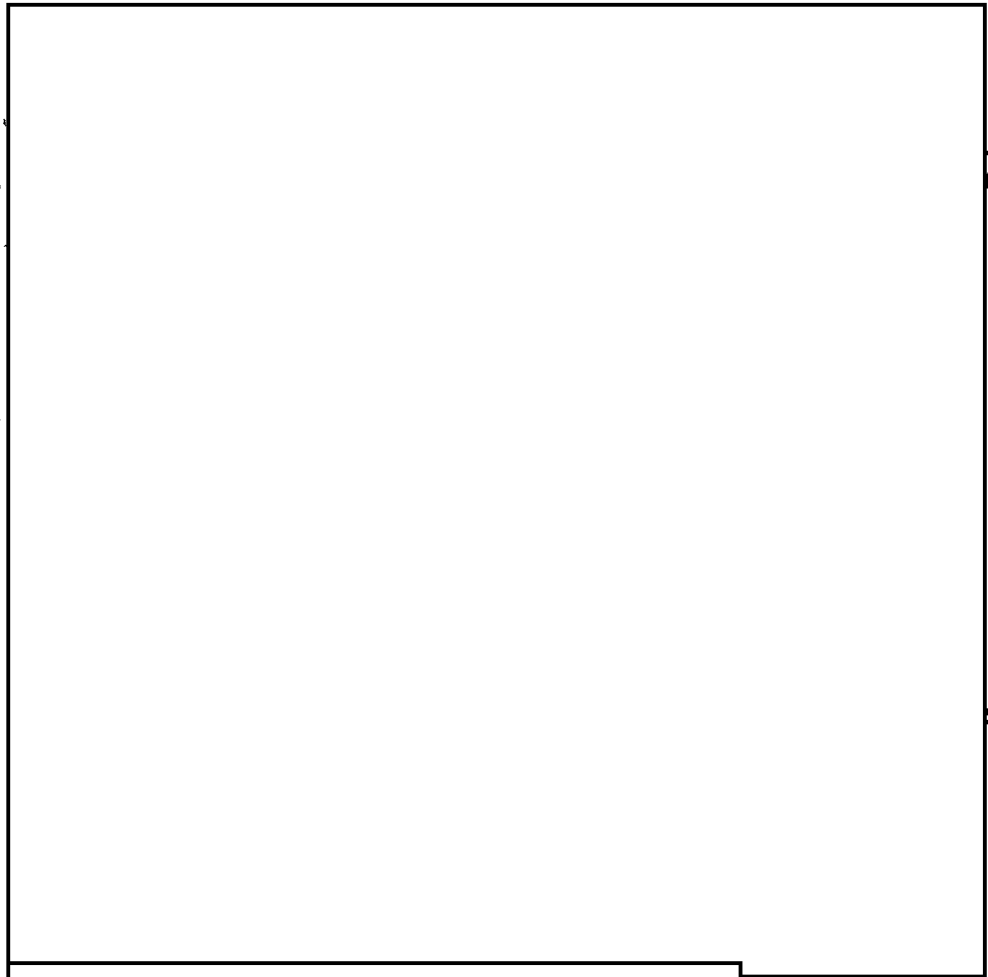

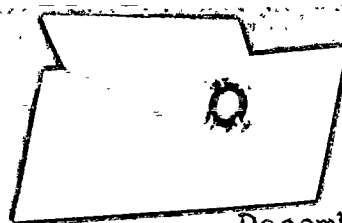
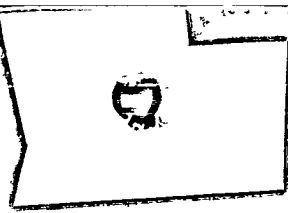

[Redacted] advised that the Central Intelligence Agency periodically holds an Orientation Program for its employees in Washington, D. C. The next such program will be held the second week in April and will be attended by between [Redacted] employees from all the various divisions of CIA.

[Redacted] stated he would like to schedule someone from the Bureau to speak on the organization, work, and functions of the FBI. He stated he thought it would be a great deal of benefit if someone from the Bureau could appear and acquaint their employees with the work and jurisdiction of the Bureau. He advised that one hour would be the desired time and that if we could designate someone, it would probably be scheduled for Thursday, April 10. These meetings are held in the Department of Labor. It would appear to be to the Bureau's benefit to appear before this group and acquaint them with our responsibilities as it would certainly prevent CIA employees from invading our responsibilities through ignorance. Also, it might help in insuring that information of interest to the Bureau which is received by CIA is properly referred to us.

I suggest Special Agent Ralph R. Roach be designated to make this talk. He is our senior Liaison Agent and would be well qualified to deliver such a talk.
