With reference to Mr. Belmont's memorandum dated January 18, 1954, which reports comments made by Roy Cohn to White and conveys the implications that Cohn is getting information which he is not entitled to from the Bureau, since so far as I know, I am the only person who has contact with Cohn, I might perhaps be a little sensitive. To begin with, I have never discussed White with Cohn except on one occasion which I will enumerate later. I frankly did not know that Mr. White was reporting things to Mr. Belmont, although I have seen memoranda referring to White and I knew that White was in the security set-up of the General Electric Corporation (GE). I certainly hope that Mr. Belmont is not laboring under any false assumption that I am engaged in the practice of furnishing the identity of our information from confidential sources to Cohn, as I am not. The Director and you have been informed of the essence of my contacts with Cohn.

Cohn did call me on Thursday, January 14 and he did tell me they were holding hearings in Boston on Friday and Saturday; that they were going to call Professors Wendell H. Furr and Leon J. Kamin and twelve GE employees. Since Mr. Belmont had asked me earlier in the week when the McCarthy Committee was going to Boston, I very promptly told him of Cohn's call. Cohn also told me that he had seen White and since White reports everything to Mr. Belmont promptly, he wanted me to know about the hearings. I merely observed with reference to Cohn's comment on White's reporting to Belmont, "Is that right."

I have never been under any allusions about Cohn's propensity of talking. Certainly his comments about the Director's sending him ties for Christmas is absolutely uncalled for, and I wish there were some way we could hop him on this without divulging the source of our information, obviously, we can't. I have tried to be circumspect in my dealings with Cohn and at the same time not precipitate any blow-up because Cohn is temperamental. He has complained to me in the past about getting the freeze in the New York office and so forth. I have always chided him that he is imagining these things because whether we like it or not, I think we have got to get along with him as long as he is in his present role.

For your information, Heimlich was the subject of a Voice of America investigation conducted by the Bureau in 1949. Information was developed indicating that Heimlich had been responsible for the removal of the "Goebbels Diaries" from the European Command without proper authority and with the intention of profiting from the removal. This allegedly took place while Heimlich was in the U. S. Army. Bureau files also indicated that Heimlich had allegedly furnished classified documents to an unauthorized individual. SUBJECT: CLERICAL RECRUITING BY CIA

For your information I am attaching the "U.S. and US" government column appearing in the Times Herald for November 20, 1953 which contained an item to the effect that "a local agency is interviewing for clerk-typists at grade GS-4 (\$3175) and Civil Service ^{status} is not required. However three years experience and speed of 60 words per minute is needed." and further "the same setup is offering the unusual grade GS-5 starting salary for stenographers if they can take 100 words per minute and type 60 words. These start at \$3410 and do not require status."

Through a contact of mine at the U.S. Employment Service, Mrs. Hilda Morrison, we learned that the agency in question is CIA. She did not have any further information except that their investigation is taking ninety days and CIA will take no one without a release.

I am bringing this matter to your attention because there is no clerk-typist position in the Bureau as high as Grade GS-4 and we have no starting stenographer job as high as grade GS-5. Obviously CIA is either assigning these people to jobs which are over-classified or else the titles of the jobs are not fully descriptive of the duties.

RECOMMENDATION: That authority be given to have the agent handling liaison with CIA endeavor to obtain job descriptions or in lieu thereof detailed information concerning the duties and responsibilities of these two positions so we will be in a position to answer any inquiries which we might receive from any of our employees who might seek release to accept one of these positions.

'Operation Convention' May Bring More Jobs To Washington Workers

BY HOWARD LEWIS

The United States employment service's unique "convention placement service" will go into operation during a big convention week here starting Dec. 27—and many federalites and displaced workers may get breaks in new jobs.

Eleven big organizations with related interests are holding a co-ordinated conclave in D. C., with about 4,000 delegates from all over the nation participating.

USES officials say they have found that a lot of people who attend conventions are looking for new or better jobs, or both, and a lot of representatives of various firms are looking for good help. However, the two often do not get together.

"Operation Convention" here will seek to bring together the two.

One phase will be getting together those people who are attending the convention from outside Washington as jobseekers, and those in the market for new workers.

But, because the conclaves are being held here, Washington workers can get in on it, too.

The groups will need primarily economists and statisticians and workers with specialities in these fields.

Some of the groups represented, for example, will include the American Economic Association and the Industrial Relations Research associations. Representatives from scores of big industries and businesses are expected to attend.

USES will have representatives at a desk in the Statler ready

to try to co-ordinate the requirements of those firms on the lookout for new people with the job needs of those attending from out of town, as well as the needs of Washington people. In addition, the employing agency is asking all bureaus here to list any requirements they may have for people looking for work.

Displaced federal workers with the skills required can get in on the program by applying at USES offices in the old Post Office building, and asking officials there to forward their papers to the convention placement service.

Meanwhile, local USES offices list several job opportunities: A local agency is interviewing for clerk-typists at grade four (\$3,175) and civil service status is not required. However, three years' experience and speed of 60 words a minute is needed.

Also, the same set-up is offering the unusual grade five starting salary for stenographers if they can take dictation at 100 words a minute and type 60. These salaries start at \$3,410 and do not require status.

Several technical writers are being sought. Experience in writing on electronics or electronic subjects is required. Salaries range from \$4,205 to \$5,940 to start and civil service status is not needed.

For these jobs apply at the old Post Office building.

NEW PO HEAD: The new head of the Post Office department's new bureau of personnel, Assistant Postmaster General Eugene J. Lyons, brings a wealth of personnel experience to the strategic PO job. Among his other posts he has been personnel vice president and a member of the management committee of Merck and Company, Inc., manufacturing chemists.

Probe of CIA Is Considered

By JACK STEELE
Scripps-Howard Staff Writer

The Senate Appropriations Committee is considering a full-scale inquiry into the secret operations of the Central Intelligence Agency, the Government's top spy agency.

Chairman Styles Bridges (R., N. H.) confirmed today that some members of his committee have urged such an inquiry based on a series of "complaints" relating to the CIA's effectiveness and efficiency.

None of these complaints apparently involve charges of communist infiltration of the super-intelligence agency.

Sen. Bridges said the committee would discuss the possibility of such an inquiry soon. He said the inquiry, if one is conducted, should not be called an "investigation." He made it plain any such probe would be behind closed doors.

If the committee goes ahead with the plan—which may bring strong objections from the Eisenhower Administration—it will mark the first time that Congress has demanded detailed information about the CIA operations.

Sen. Joseph R. McCarthy (R., Wis.) started an investigation last year of a reported CIA project to utilize communists in some of its activities, but called it off after Administration leaders strenuously objected.

There is some difference of opinion now within the Appropriations Committee, it was learned, on the necessity of a probe of the CIA.

Some members say the committee should give no more "blank check" appropriations to CIA without first finding out whether there is any substance to the complaints about its effectiveness.

Others want to keep on giving CIA the funds it wants without asking any questions, on the theory

that it is up to the President to make sure that the agency is doing its job well.

HIDDEN CASH

The CIA's operations are so secret that even its appropriations are hidden in the budget—in the same way funds were concealed for the "Manhattan Project" which developed the atom bomb. Committee members will only say that it has a budget of "many millions."

Allen W. Dulles, brother of Secretary of State John Foster Dulles, heads the CIA. His predecessor was Walter Bedell Smith, new Under-Secretary of State. Senators who want more information about CIA operations insist their proposed inquiry is not aimed at either Mr. Dulles or Gen. Smith.

Among the complaints are:

- CIA has not done an effective job collecting information behind the Iron Curtain.
- Military intelligence groups have done a better job in the "cloak and dagger" field than the CIA.
- CIA has become a haven for "broken-down generals and admirals."
- Much of the money spent on CIA thus far has been wasted.

MR. TOLSON:

I saw Richard Arens and his associate, Schroeder, of the Jenner Committee. Arens handles the staff for Senator Butler's task force on Communist infiltration of labor on the Internal Security Subcommittee. Arens stated that they have quietly been gathering together considerable information. They are firmly convinced that Jay Lovestone is no good; that they contemplate calling him in as a friendly witness and then start inquiring into his activities. Arens wondered if we could be of any assistance. I told him I frankly did not know exactly what we had which we could make available. I asked if he had ever checked with CIA. He stated they thought this would be futile as they are not on too friendly terms with CIA at the present time. I told Arens I thought the thing to do was to call Lovestone in as a friendly witness and see how far they could go on a friendly basis without indicating any antagonism. I told him in the meantime I would check and see if there was any way we could be of assistance to them.

My curbstone opinion is that we should try to stay out of this, although I think we might summarize what we have on Lovestone. If there are any leads we could give them, we could go this far. I suspect once they start going after Lovestone, quite a ruckus will be raised. I think it would be just as well if we stayed out as Arens is a 'bull in the china shop.'

Governor Sherman Adams called me from the White House this morning and asked me what I thought of [redacted] [redacted] I stated I talked to [redacted] for two hours yesterday and asked him to talk to the Inspector in charge of the Lovestone Case yesterday afternoon and he did spend nearly four hours with him. Governor Adams asked if [redacted] really had any information and I stated I thought he was almost obsessed with the subject that he obviously was a very brilliant and well-educated man, but he does not have specific details. I stated the only thing which worried me about the picture is that [redacted] has certain information regarding the Lovestone matter and he had a great deal of information about the deductions and shortcomings of CIA. I stated [redacted] did say he knew there were individuals on the Hill who would like to have this information but he did not play the game that way, and he also commented about various aspects of Lovestone's activities in the labor situation and how bitter John L. Lewis was against Lovestone. I stated it was my impression that [redacted] was a gentleman who boasted quite a bit and throws a lot of names around, which always made me suspicious of who he really does know intimately.

I told Governor Adams that the previous day a Democratic Senator had been in to see me and showed me a fourteen-page memorandum which had been given to him very confidentially and he would not divulge his source. This memorandum had in it a great deal of the same information [redacted] told me about, although not in detail, [redacted]

I stated the Senator had asked my opinion of this and I had told the Senator I would not advise him what to do but had suggested there was any intention of starting an investigation of CIA on the Hill that I would get their facts first because it would be very unfortunate to start something that fell through and could do a great deal of harm to an Agency that might actually do a great deal of good, of the seriousness of the so-called intelligence operations.

By letter dated February 23, 1954, the Central Intelligence Agency (CIA) requested information concerning the possible utilization of the Battley single fingerprint system.

[Redacted] CIA was interested in conferring with the Bureau in order to evaluate the problem. In accordance with the decision of the Executives Conference on March 1, 1954, a meeting was held with CIA personnel on March 9, 1954. Attending for the Bureau were Messrs. G. J. Engert and E. S. Deiss and S. J. Papich. Present for the CIA were [Redacted]

Messrs. Engert and Deiss presented a brief summary on the patterns, interpretation, and classification of fingerprints.

[Redacted] of the CIA advised the Liaison Agent on March 10, 1954, that the presentation made by Messrs. Engert and Deiss was extremely helpful. In this connection it should be noted that none of the CIA representatives present had any background in fingerprinting. [Redacted] advised that Engert and Deiss exhibited an unusual ability of presenting technical information in a manner which was very clear to the average layman. [Redacted] stated that all CIA representatives who were present were most verbose in their appreciation and praise of the assistance given by the two afore-mentioned Bureau representatives.

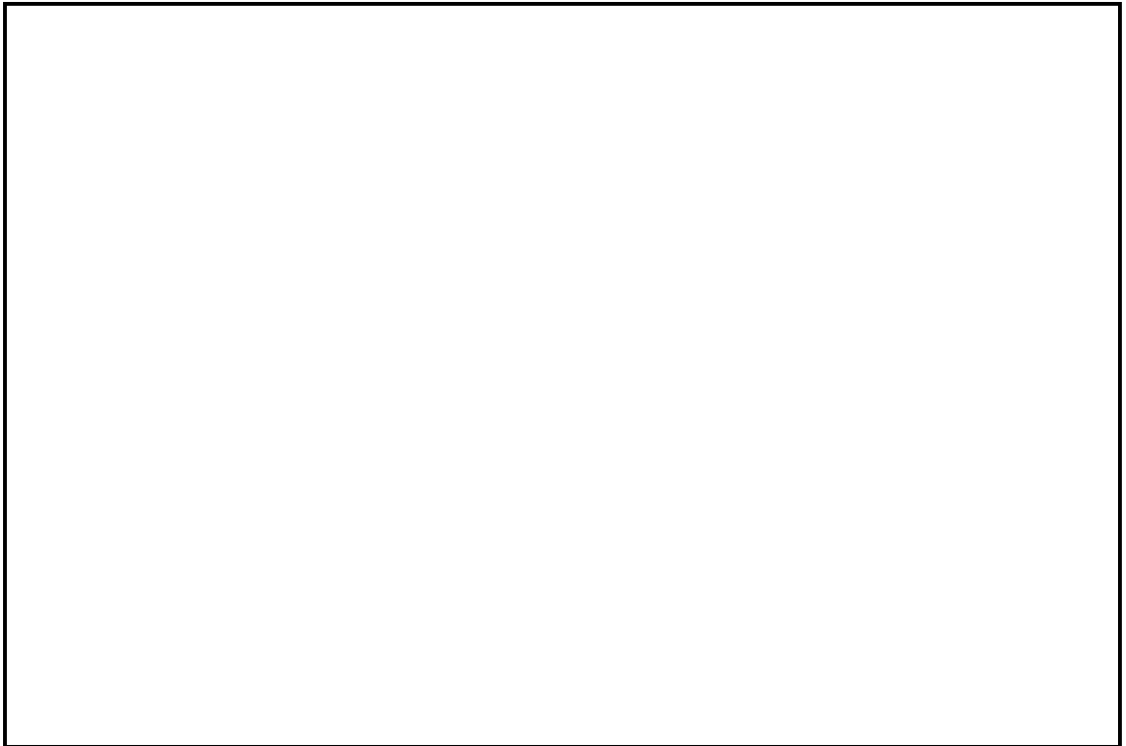
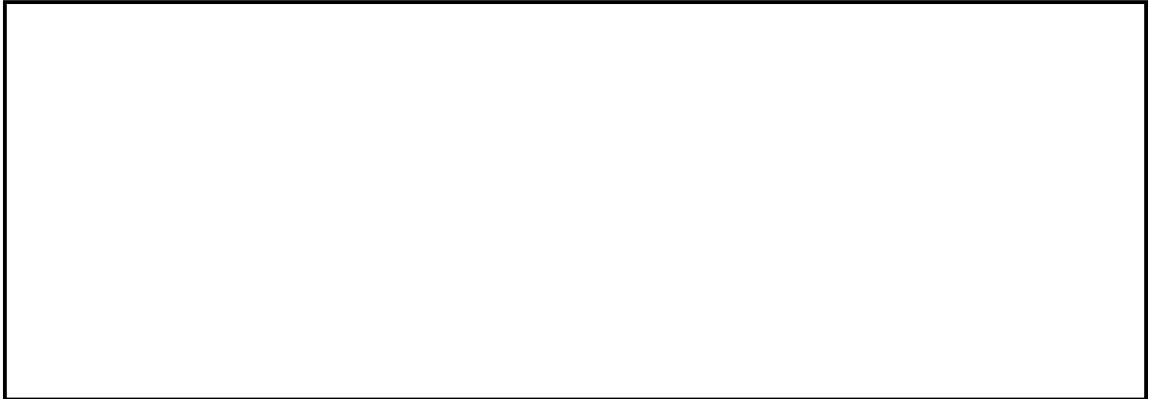

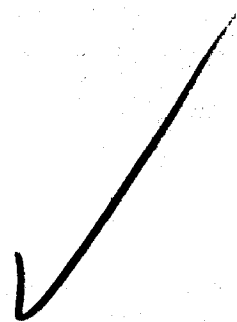
