SURVEY OF CIA BY GENERAL MARK W. CLARK

Reference is made to my memorandum dated November 16, 1954, wherein information was set forth concerning comments made by Colonel John Julius Dubbelde, Jr., of General Mark Clark's group which is surveying the operations of CIA. You will recall that Colonel Dubbelde stated that it was his understanding that the Clark committed would have no reason whatsoever to check on any FBI operations.

The Director's comment was, "I want Belmont to be prepared to handle any and all phases of this. H."

Through contacts in General Clark's group and in the CIA, Agent Papich has been on the alert for any evidence indicating that General Clark will contact the Bureau or that he will be making inquiries concerning any Bureau operations. So far, all information developed has indicated that General Clark is concentrating all of his interests in CIA operations and that he does not anticipate any contacts with the Bureau. It is realized that before Clark completes his survey of CIA, he may encounter some problem which may require consultation or discussion with the Bureau. At this point this is only speculation.

Although General Clark's group has given every indication that the Bureau will not be involved in the survey being conducted, I am having the Liaison Section nevertheless follow this matter very closely in order that the Bureau will be fully and completely prepared to discuss with General Clark any questions which may arise.

In accordance with the Director's instructions I will, of course, be prepared to handle any and all phases of inquiries directed to the Bureau. Material to be used in any necessary briefing of the Clark group will, of course, be submitted for the Director's approval prior to its use.

Reference is made to my memorandum to you dated November 8, 1954, in the above-captioned matter, wherein it was reflected that Colonel John Julius Dubbelde, Jr., of the above group had advised Agent Papich that General Mark Clark desired to be informed if it would be possible for the Bureau to examine the premises occupied by Clark's survey group for the possible existence of telephone taps, microphones, and any other listening devices.

Pursuant to the above request, which was approved by the Director, Agent Papich contacted Colonel Dubbelde on November 10, 1954, at which time arrangements were made for Mr. Papich and Laboratory personnel to confer with Colonel Dubbelde on Monday, November 15, 1954, concerning this security survey and to set up the time and date for conducting same.

On November 15, 1954, Agent Papich had occasion to meet with Colonel John Julius Dubbelde, Jr., of General Mark Clark's group which is surveying the operations of CIA. You may be interested in the following comments which were made by Dubbelde and which may reflect the current thinking of the Clark group.

Dubbelde stated that he and his colleagues were slowly getting started and were getting some idea of the full scope of their work. He stated that briefings already had been afforded to the Clark committee by CIA and for the first time since the organization of the committee, this working staff has had an opportunity to make some headway. He stated that as far as he could see, all of the committee's work will be devoted to CIA operations. He advised that about the end of this month the Clark group will be afforded briefings by the military intelligence agencies. Dubbelde stated that it is his understanding that the Clark committee will have no reason whatsoever to check on any FBI operations but he would not be surprised if it becomes necessary to seek advice or observations from the Bureau concerning some problem which might crop up in connection with the CIA survey. He advised that so far no such matters have arisen.

I am attaching hereto a summary prepared on CIA [redacted]

[redacted] She confidentially gave this summary to me. The summary consists of the bare details of numerous incidents which have been written up in greater detail and which she understood were on file with the Senate Appropriations Committee. She informed me in the strictest of confidence that Senator McCarran had planned to have the Appropriations Committee look into CIA when Congress convened in January. The Senator was thoroughly convinced that CIA had had long enough to show its worth; that it was a failure; that this view was shared by other Senators and that it was McCarran's idea to quietly ease CIA out of existence and transfer the funds and responsibility to the Bureau.

An article by Constantine Brown appeared in the Evening Star on March 23, 1953, from which the following is quoted, "CIA is, of course, by far the most expensive intelligence agency we have had in the history of the country. So far the results obtained by that organization do not correspond to the vast expenditures.....In order to receive full confidence of men who hold the nations's purse strings, Mr. Dulles will have to trim much of the fat in his organization."

Hanson Baldwin, writing in the New York Times, January 29, 1953, in commenting on the estimated number of employees in this organization stated, "Some observers believe that the British Intelligence Service, with perhaps 3,000, and Israel, with perhaps 300, produce end results more accurate than 'our much larger agencies'"

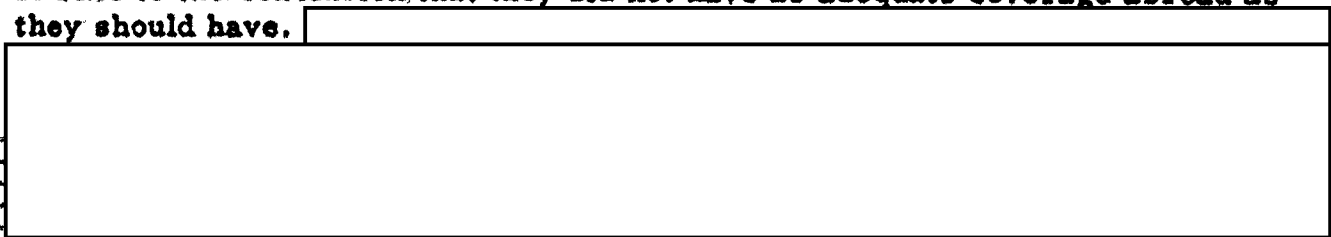

MEMORANDUM FOR MR. TOLSON

On October 6, 1954, I saw Lt. General James H. Doolittle who had been heading a Committee appointed by the President to study the covert operations of the Central Intelligence Agency.

General Doolittle stated that his group had completed their study but that before submitting his report to the President upon the President's return from Denver, he did want to talk to me in view of the contact which this Bureau has with CIA. In our discussion I pointed out to General Doolittle that CIA was, of course, a comparatively new organization and that no doubt some of its weaknesses and defects were due to the newness of its operations and the problems that always come in administrative matters when a new organization is set up to operate on such a broad and extensive scale. I commented that I thought there was too little coordination between the various units of CIA and too strong a stress upon departmentalization, with the result that one branch of CIA did not always know what another branch was contemplating doing. I stated I likewise felt that CIA, as well as many organizations of the Government, needed stronger and better discipline and that this, I believed, could be brought about by a vigorous and active inspection service of comparatively small size. I outlined to General Doolittle the inspection program which is utilized by this Bureau and which has been most effective.

I also commented upon the weak coverage which I believed CIA had behind the Iron Curtain and also in Mexico which was a problem and of vital interest to this Bureau. I stated that frankly espionage agents will arrive in this country and we have no advance word from CIA of their identities, which led me to the conclusion that they did not have as adequate coverage abroad as they should have.

Phil Payne of Time Magazine phoned regarding the visit of Estrada of Venezuela to the Bureau, inquiring if Estrada met the Director.

He was advised that he did not meet the Director in view of previous commitments Mr. Hoover had made but that he was in the building for a tour. Payne then asked if Estrada was the first foreign head of a national police organization to visit the FBI since Dr. Otto John of Germany, and if not, who were the others and from which countries had they come. He was told we had no comment to make as this was something the State Department was more directly interested in than the FBI. Payne stated he had asked the State Department this latter question and the State Department would not answer it, suggesting that they ask the FBI directly. It is obvious from the Time's inquiry that Estrada is being built up as the first national police head brought into the country since Dr. Otto John defected, and, accordingly, the query was answered with a no comment.

Fred Mullen subsequently called advising that Payne had made a similar inquiry of him as to whether Estrada was the first head of a national police to visit the FBI since Dr. Otto John. Mullen stated he thought that there had been several others and that he would like to tell Payne something, yet he would not want to give any names. Mullen was advised that there had been four or five top ranking foreign police representatives to visit the Bureau since Dr. Otto John was in in June, and that while we did not have their full names and titles offhand, he could so indicate to Payne that there had been several people in but that he could not furnish the names. Mullen advised that he would inform Payne that he could not give out the identity as it would be necessary to check through the State Department with the individuals concerned as to whether their consent could be obtained and that the Dept. did not have time to do this.

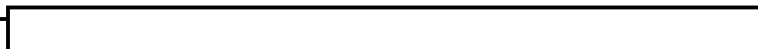

CIA, according to Washington Field Office, making sincere effort to improve this situation but their records are located in several buildings.

Washington Field Office employees contacting these agencies keep a continual check on those record requests which have been delayed an undue length of time and every effort made to obtain them from the agencies as soon as the information is available.

Such agencies as HCUA and CSC return their record check requests within a week or less.

RECOMMENDATION:

It is to be noted that the matter of expediting Bureau name checks at ONI, CIA and OSI was previously discussed by Liaison with those agencies. In view of the information furnished by Washington Field Office in its letter of October 19, 1954, indicating that ONI, CIA, OSI and State Department passport records are behind in their name searches, it is recommended that a representative of the Liaison Section discuss this matter with responsible officials of ONI, CIA, OSI and the State Department. The joint responsibilities of the

Bureau and these agencies under the Federal Employee Security Program should be explained to these officials and they should be requested to take the necessary action to afford the name checks submitted by the Bureau expeditious attention in order that the investigations can be brought to a logical conclusion in the earliest possible time.

It is desired that the results of the contacts with the above officials be furnished to the Investigative Division, particularly what action is to be taken by the various agencies to speed up the name check program, in order that the matter can be closely followed to see if any improvement is made.

DETAILS:

I. Inspection of Employees Security Section  
(September, 1954)

As the result of the inspection of the Employees Security Section in September, 1954, the comment was made by the inspector in a memorandum dated September 23, 1954, from Mr. Harbo to Mr. Tolson that field investigative time in full field investigations showed an increase of 5.95 days in August, 1954, as compared with August, 1953. It was stated in the memorandum of Mr. Harbo that a partial explanation of this was to be found in Washington Field where difficulty was being experienced in obtaining results of name checks from ONI, OSI and CIA. It was likewise pointed out in the memorandum of Mr. Harbo that Washington Field had brought this to the attention of the Bureau by letter dated July 29, 1954. As a result of which Liaison contacted ONI, OSI and CIA and was promised more prompt action on Bureau requests.

II.

A. Washington Field Office letter of July 29, 1954 Referral/Consult

Washington Field letter of July 29, 1954 (Bufile 66-6200-140-282) referred to Washington Field air-tel to the Bureau dated June 7, 1954 (Bufile 62-33413-3629) advising that

Washington Field was unable to appreciably expedite the internal mechanics involved in these other agencies although these matters were closely followed on the daily basis. Washington Field stated that in all cases which require investigation in addition to agency checks, a pending report would be submitted as soon as all investigation other than agency checks had been completed. If the investigation involved only agency checks, a pending report would be submitted when two of the agency checks were completed.

B. Contact With Officials of ONI, CIA and OSI in August, 1954

Based on Washington Field's letter of July 29, 1954, the Employees Security Section recommended and it was approved



(Bufile 66-6200-140-281) that our Liaison representatives contact the appropriate officials at DNI, CIA and OSI in an effort to expedite the results of record checks made by Washington Field, with those agencies.

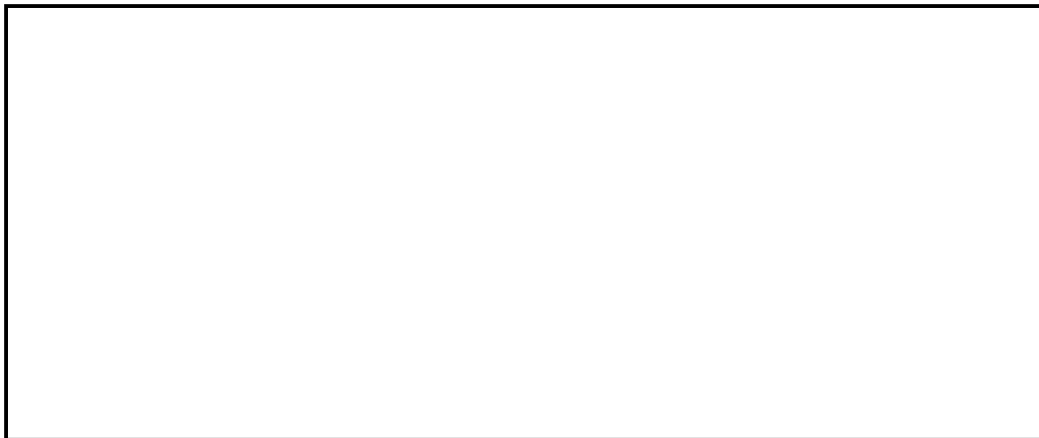
III. Current Situation in Washington Field Office  
Regarding Agency Checks in Applicant and Security  
of Government Employees Investigations

The Washington Field Office by letter dated October 19, 1954, has advised as follows:

**A. Preparation of Requests**

Agency checks are made by means of a flimsy lead sheet prepared on each applicant or EGM case received. Immediately after these cases are opened and assigned, it is processed in the Flimsy Unit where flimsies are at the present time prepared within 24 hours of the receipt of the letter ordering the investigation and are immediately routed to the Special Employee or Special Agent handling the check of the records of the particular agency. The flimsies under normal procedure reach the folder of the employee handling the agency check during the day following the receipt of the letter ordering the investigation. The employees thereafter deliver the flimsies to the particular agency on the following morning which would be the second morning following the receipt of the case in the office. The Washington Field Office pointed out that it is possible to handle the processing of the flimsies in this short time only at such times when the volume does not increase to the proportions during the past summer.

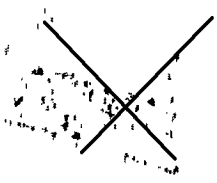

A recheck of the handwritten name [redacted] as [redacted] it appeared on the photographic copy might possibly be [redacted]. There are approximately 175 references to this name. From a review of the index cards, those files were called which indicated a possibility of effecting an identification. This review failed to reflect any pertinent information with the exception that on May 24, 1951, one [redacted] filed an application for position of stenographer with the Bureau. In his application, he stated he was born [redacted]. He was not employed by the Bureau. At the time he filed his application, he was attending Suffolk Law School. (67-486260)

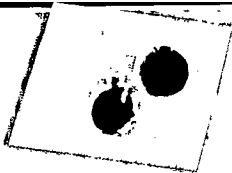

During the week of December 20, 1954, newspapers carried reports that General Mark Clark would be meeting with Senator Joseph McCarthy after the first of the year for the purpose of discussing Senator McCarthy's knowledge of alleged Communist penetration into CIA. As a matter of background, you will recall that in 1953, Senator McCarthy publicly charged that CIA was infiltrated with Communists. From July, 1953, to July, 1954, reports were periodically received indicating that Senator McCarthy planned to initiate hearings concerning CIA. Although Senator McCarthy apparently had collected information regarding CIA, the hearings on that agency never materialized. In July, 1954, while there was still some question as to whether Senator McCarthy would stage his hearings on CIA, the White House announced that General Mark Clark, as the head of a task force for the Hoover Commission, would conduct a survey of CIA operations. Shortly after this announcement, Senator McCarthy was quoted as stating "I have great confidence in General Mark Clark, and will be glad to turn over anything I have to him."

It is known that on September 9, 1953, Don Surine of the McCarthy Committee advised the Bureau that the McCarthy Committee possessed a 150 page factual report containing derogatory information pertaining to CIA and reflecting that

[redacted] These names were not furnished to the Bureau. (62-80750-2211) On February 27, 1954, Surine indicated that the McCarthy Committee was still collecting information concerning CIA. In this connection Surine stated that the McCarthy Committee had been conducting some psychological warfare on CIA and a campaign of terror.

There appears to be little doubt that Senator McCarthy and members of his staff have collected considerable information concerning CIA operations.

I had lunch with Senator "SCOOP" JACKSON today and he tells me that he has had no contact with Senator JOHN L. McCLELLAN (D. Arkansas) since the election. He has been advised, apparently through the Senate Democratic control, that McCLELLAN does not desire to take over Chairmanship of the Government Operations Committee, to which he is entitled by seniority, and noted that JACKSON will probably be the Chairman. He says he is not pushing the point at all to even find out, as he feels that if it were announced or something came out about it now, it would just add troubles on to him before necessary.

JACKSON said that if he does become Chairman or if McCLELLAN keeps the job, he will recommend to him and put some pressure on in order to keep JACKSON's support, that a conference be had with you concerning the future functioning of the Committee. JACKSON noted that there was no question but what all of the major personnel of the Committee would be "bounced" and he felt that as a courtesy to the fact that some of them had been members of the FBI, that he would try to see that they were allowed to resign rather than be fired.

There is no question in my mind but what Senator JACKSON is progressing as a real solid individual and that he has a great admiration for you and the Bureau. He despises CIA; feels that they are a bunch of fools and that there is no reason whatever for them to function in the United States proper, except for their administrative set-up. He says he thinks that any of the work to be done here should be done by the FBI, but upon my pointing out that this would put a tremendous load on us, to a point where it might endanger our efficiency on our statutory duties and responsibilities, he agreed that it probably was not possible for us to do it, but that something should be done about CIA. His ultimate suggestion was that we should take over an efficiency expert and revamp CIA and keep it within bounds.

In connection with his comments concerning CIA, I noted to him that there was considerable "high level" discussion going on as to investigative jurisdiction between us and ONI, G-2, etc., under the Delimitations Agreement. Having formerly been a prosecuting attorney himself, Senator JACKSON said that he thought it was a shame that ONI and G-2 were anything except very small organizations of exceedingly restricted activity, as he felt that the Bureau should handle completely on governmental reservations, etc. I think I discussed the matter enough with him so that he has the correct viewpoint concerning it. Incidentally, JACKSON states that his main major committee is now going to be membership on the Armed Services Committee of the Senate.

Senator JACKSON asked me about any problems which we might be going to have in connection with appropriations, and I told him that I did not know of any and hoped that the routine followed the system of last year, with no Senate hearings. He felt there would be a decided effort to have Senate hearings because of the widespread public comment from administrative sources as to the number of perverts and Party members, etc., that had been ousted by the Republican administration. He felt that the Democratic group as a whole would want to "set the record straight" by having the Director comment on general security problems and the like which would include such data in an appropriations hearing as being the only way that the Senate would have the opportunity of asking pertinent questions.

I pointed out to him the fact that while that would be a very sharp political move, yet in the long run the Bureau could not fail to lose from it because it would put us on the spot no matter how such questions were answered and would be utilizing the Bureau as a political vehicle when we have endeavored so hard to stay out of that situation. He said that personally he understood the point, but that there were some wild eyed people who were on the Appropriations Committee who would not worry about that.

Senator JACKSON said that he would very soon after his return to Washington, try to get to talk with you about these matters, and that he would stay in touch here with me so that if it appeared that there was any definite move along these lines, he would advise me so that we could be prepared for the situation.

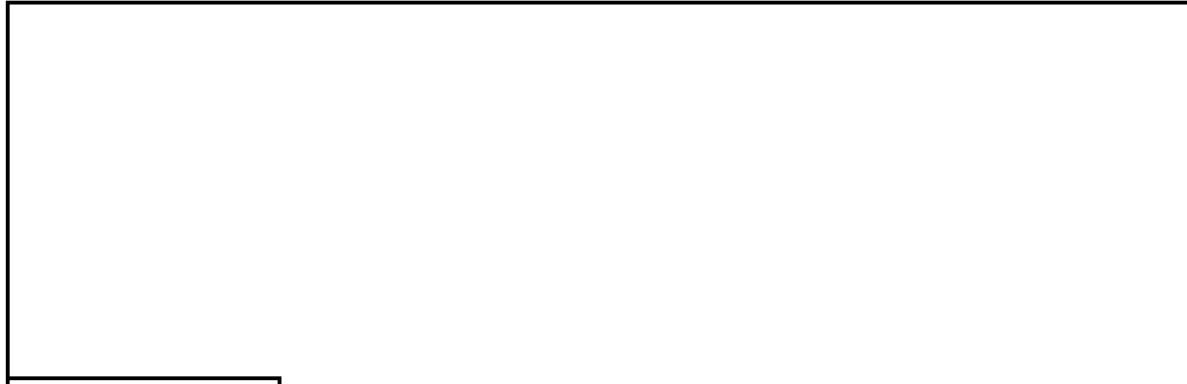
