Reference is made to my memorandum dated April 7, 1955, concerning captioned matter, wherein you were advised that inquiries have recently been made of several agencies to determine if they are desirous of continuing the practice of using T symbols in reports of an intelligence or personnel-type matter prepared by the Bureau. You were advised that Army and Navy Intelligence [redacted] Referral/Consult [redacted] and the Civil Service Commission have no objection to dispensing with the use of a T symbol to report their respective agencies, where information is taken from official files for official purposes.

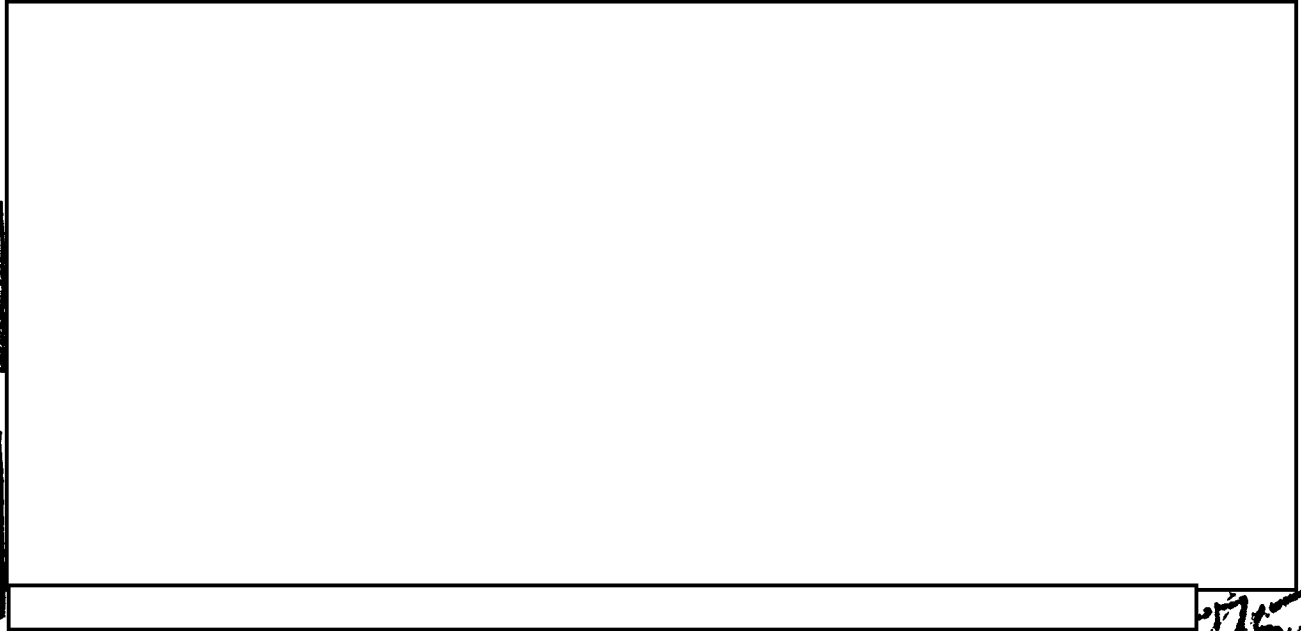

On the afternoon of May 18, 1955, Agent Papich received a telephonic request from the office of Allen Dulles to meet with the Director of CIA on "very important business." Papich met with Dulles at 6:40 p.m. on May 18, 1955.

Dulles stated that his subordinates had been informing him concerning the investigations which had been requested of the Bureau by General Mark Clark. Dulles stated that he thought that he had all of the pertinent facts but that he would appreciate hearing from the liaison Agent exactly what had been happening. Papich then advised Dulles that on May 13, 1955, the Bureau received a letter from General Mark Clark requesting that investigations be initiated concerning several individuals who were listed on Clark's communication. He was informed that Clark asked that investigations be directed for the purpose of checking the character, reputation and loyalty of each. Dulles was advised that General Clark did not furnish any information other than the names and that upon inquiry, the Clark Task Force advised that there was no other information to be furnished. Papich advised Dulles that upon receipt of the list, steps were taken by the Bureau to locate identifying data which was most necessary if intelligence investigations were to be initiated. He was told that in this connection, CIA was contacted inasmuch as some of the individuals appeared to have had past or present connection with CIA. Dulles was then told that during these preliminary steps, the Bureau realized that some problems could arise in the event that complete and thorough investigations were conducted. It was even anticipated by the Bureau that CIA could possibly voice some objections. Dulles was informed that as a result of foregoing

Reference is made to the memorandum from Mr. Roach me dated May 13, 1955, in which it was reported that General Mark Clark indicated to the Director on May 12, 1955, that he would request the Bureau to conduct investigations concerning certain individuals. Clark was informed by the Director that the investigations would be completed within two weeks. Mr. Roach advised that the Liaison Agent would follow this matter very closely with the Clark task force.

At 2:15 P.M. on May 13, 1955, Liaison Agent Papich contacted General James George Christiansen, head of the working committee of the Clark task force, at which time Christiansen stated that he was in the process of preparing a list of names of individuals who were to be investigated by the Bureau. The Agent waited approximately one hour at which time Christiansen made available the enclosed communication dated May 13, 1955. The letter sets out the names of the individuals concerning whom General Clark desires that investigations be conducted.

The list was reviewed by the Liaison Agent in the presence of General Christiansen and many of the names are identical with those which appeared on a list furnished by the Clark committee to the Bureau in January, 1955. At that time the Clark committee submitted a list and requested that the files of the Bureau be checked. That particular request was described in my memorandum to you dated January 21, 1955, captioned as above.

It should be noted that there is no identifying data furnished with the names listed in the enclosed communication. This was called to the attention of General Christiansen. He stated that as far as he knew, the Clark committee did not possess

any other identifying data. According to Christiansen, the individuals listed in the enclosed communication were names furnished to General Clark by Senator Joseph McCarthy. The Wash. Post Senator allegedly had derogatory information concerning these individuals. Christiansen was not aware of the nature of the derogatory information; according to him, the Clark committee does not have possession of such data. He advised that he would make checks of the committee's files in order to definitely ascertain if there is any additional information concerning the individuals listed which might be of assistance to the Bureau. The Liaison Agent explained to General Christiansen that it was most important that the Bureau have adequate identifying data if investigations were to be conducted.

The Liaison Agent explained to General Christiansen that it should be clearly understood that when investigations are initiated by the Bureau the employing agencies would undoubtedly become aware of the investigations. The Bureau, therefore, could anticipate that queries would be made of the Bureau by the agencies. General Christiansen conferred with General Clark concerning this matter and then advised Agent Papich that as far as General Clark was concerned interested agencies could be advised by the Bureau that investigations had been instituted. Christiansen further stated that the agencies could be informed that the investigations were being instituted at the request of General Mark Clark. He also added that copies of the reports of investigation conducted by the Bureau could be furnished to the interested agencies.

directed for the purpose of determining the individual's character, reputation and loyalty. He emphasized the committee was particularly interested in ascertaining if any of the individuals have ever been engaged in any subversive activities.

ACTION:

1. General Mark Clark's request for investigations to be conducted is being referred to the Investigative Division for expeditious handling.
2. The Liaison Agent is following this matter closely for the purpose of obtaining additional identifying data concerning the individuals to be investigated from the Clark committee.
3. Mr. Nichols is discreetly endeavoring to obtain additional identifying data concerning the individuals through appropriate contacts.
4. Inasmuch as employing agencies undoubtedly will become aware of the Bureau's investigations, with your approval, such agencies will be advised by the Bureau through liaison channels that investigations were initiated by the Bureau upon the request of General Mark Clark. The agencies will be advised that copies of the Bureau's investigative reports will be furnished to them.
5. As soon as identifying background information is developed, these investigations will be ordered on basis of completing them in two weeks.

Reference is made to my memorandum dated May 17, 1955, concerning an interview held by Agent Papich with General James George Christiansen, head of the working committee of the Clark task force. As reflected in the memorandum, Papich was to meet with General Mark Clark at 1:15 P.M., on May 17, 1955.

Papich met General Clark at the National Airport. General Christiansen was present at the meeting. Papich briefed General Clark along the same lines followed in the interview which was described in my referenced memorandum. General Clark then stated that he had not realized that the investigations requested of the Bureau would involve such potential problems

He asked the Liaison Agent for personal advice on the matter and the General was informed that the decision for requesting and continuing the investigations was a matter for General Clark and his committee. It was emphasized to General Clark that the Bureau definitely was not going to shirk any responsibility but the Bureau desired to do a complete and thorough job. He was advised that if the Bureau were to conduct complete investigations, the Bureau naturally would be expecting the cooperation of interested agencies, such as the CIA. General Clark was informed that if objections arose on the part of CIA, he should realize that the Clark task force could not separate itself from such a situation. General Clark was advised that he personally is very much involved in the developments to date.

General Clark very obviously was at a loss as to what to say. After some delay, he advised Agent Papich to withhold any further investigation. He stated that he planned to contact

Pursuant to the instructions of Mr. Nichols, Liaison Agent Papich contacted General James George Christiansen, head of the working committee of the Clark task force, on May 17, 1955.

Papich advised General Christiansen that since the receipt of General Clark's request for investigations of several individuals, the Bureau had initiated investigations; in this connection it first had become necessary to collect identifying data concerning the people involved. It was pointed out to General Christiansen that the Bureau had received only names with no other data. He was informed by the Liaison Agent that the Bureau had been in contact with the Central Intelligence Agency (CIA) inasmuch as the CIA appeared to be in possession of information which could be of assistance to the Bureau. He was told that the CIA was making information available but CIA's cooperation was actually of a reluctant nature.

Papich then informed Christiansen that the investigations which have been initiated have led to some preliminary developments which are of a highly significant nature definitely worthy of General Clark's immediate attention.

Papich stated to Christiansen that the Bureau did not wish to get involved in a token type of investigation and that if a job were to be done, the Bureau would do a complete and thorough investigation.

[REDACTED] He was informed that all of this, of course, would take more than two weeks and would require the cooperation of CIA. Christiansen's attention was directed to the fact that CIA had already manifested some reluctance and that it could be anticipated that if the Bureau embarked upon an investigation involving interviews of CIA employees, examination of records, etc., the Director of CIA could be expected to raise objections. Papich advised Christiansen that all of this was being directed to his attention so that General Clark would have a clear understanding of the situation. He was informed that if the Bureau continued with any extensive investigation of a nature described above, the Bureau, of course, would continue to maintain the position that the investigation was being conducted at the request of General Clark.

General Christiansen first stated that he was most appreciative of the Bureau's cooperation in that he was contacted at this stage. He stated that after General Clark received the list from Senator McCarthy, he and General Clark conferred as to what action should be taken. It was finally resolved that it would be satisfactory to submit the names to the FBI for a review of its files. After this was done, General Clark was satisfied. Last week General Clark conferred with General Christiansen and other assistants concerning the final preparations of the report covering the results of the survey conducted by the task force. Senator McCarthy's list came up for discussion and General Clark took the position that the task force report actually would not be complete unless the task force could go on record that the names had been referred to the FBI for investigation. General Christiansen stated that he disagreed with General Clark's viewpoint and he maintained that the committee was in no position to go any further other than to submit the names for a check of the Bureau's files. Christiansen advised that this was a disagreement between him and General Clark and that he was furnishing it to the Liaison Agent on a confidential basis. He then stated that General Clark was arriving at the National Airport in Washington, D.C., at 1:15 P.M., May 17, 1955, to attend the funeral of General Summerrall, former Army Chief of Staff. He asked if the Liaison Agent could meet with him and General Clark at the Airport at which time the Liaison Agent could brief General Clark concerning the above-described developments.

Reference is made to memorandum from Mr. Roach to Mr. Belmont dated May 13, 1955, and memorandum from Mr. Belmont to Mr. Boardman of the same date concerning the request of General Mark W. Clark for investigation of certain individuals apparently connected with CIA in some capacity. Referenced memorandum to Mr. Belmont indicated that on the afternoon of May 13, 1955, General James Christiansen, head of the Working Committee of the Clark Task Force, made available to Liaison Agent Papich a list of the individuals whom General Clark desired investigated. (The additional name of [redacted] was also furnished to Liaison Agent Papich on May 14, 1955.) This list contained absolutely no identifying data but merely names, in most instances only the first and last name. These, according to Christiansen, are names furnished to General Clark by Senator Joseph McCarthy.

The names, as furnished, are being checked through the Bureau's files at the present time; however, due to the complete lack of identifying data, in many instances it is not possible to definitely identify these individuals with information in our files. It is also not known whether these persons are employed by CIA at the present time, either overtly or covertly, or whether they are employed in the Government at all. For example, one of the names is [redacted]

In view of the lack of identifying data, plus the fact that it is not known whether these individuals are employed by CIA, and if so, whether they are in a covert capacity or whether they are in fact employed in the Government at all, Liaison Agent Papich has contacted officials of the CIA on May 14, 1955, for the purpose of obtaining pertinent data regarding these individuals. 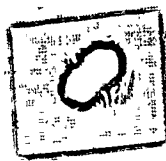

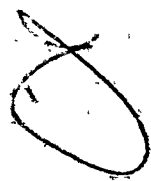
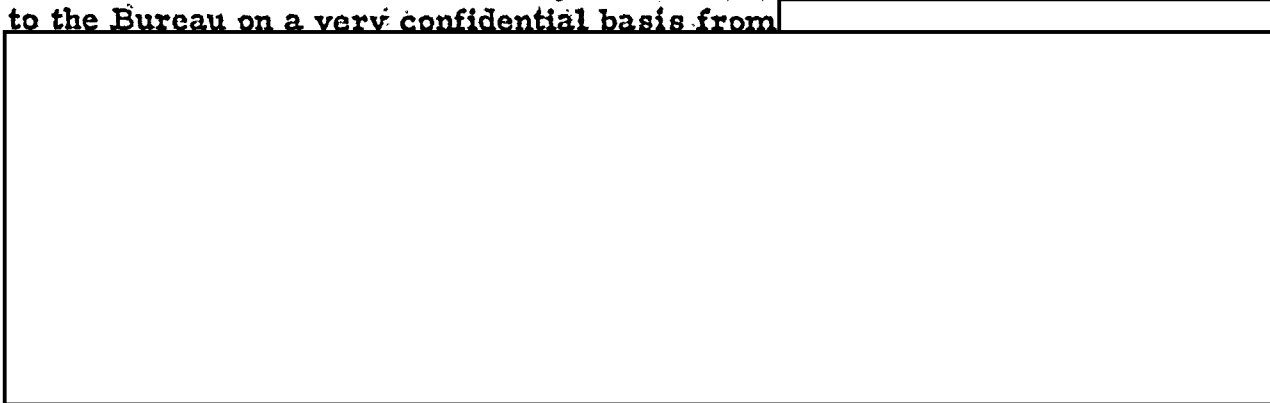

DETAILS:

Reference is made to my memorandum of February 21, 1955. I reported that General Mark Clark, head of the task force which is surveying Central Intelligence Agency (CIA) operations, had stated that in about two weeks he would be seeking an interview with the Director. I advised that a brief was being prepared for the Director's assistance if General Clark called on him. General Clark indicated that he would relay the request to see the Director through the Liaison Agent. General Clark also indicated that if he met with the Director he might have some names of individuals in CIA regarding whom he might like to have Mr. Hoover make some observations. The Liaison Agent has asked Clark's staff to make the names of such individuals available, if such names are to be brought up in any discussion contemplated by Clark.

Set forth herewith are items which may be introduced for discussion by General Clark or they may be items concerning which the Director may wish to volunteer comments to General Clark. These items are being presented in a very summarized form, and for the most part consist of material prepared for the Director for his meeting with General James Doolittle held on October 6, 1954.

CIA Security:

With regard to names of CIA employees which Clark might introduce in a discussion, he undoubtedly will be referring to people who have been controversial because of their security background. In the event that such names come up, it would appear that all we could do is refer Clark to investigations, if they have been conducted by us. Clark can be informed that the CIA is an organization which has thousands of employees. Some have been investigated by the Bureau as applicants for CIA employment. (Bureau has not investigated CIA applicants since 1951.) Other have been investigated by us under the provisions of the loyalty program. There are thousands of CIA employees who have never been investigated by us. In many of these investigations which we conducted we did develop derogatory information. We are not familiar with the interworkings of CIA and we do not know what disposition has been made of all of the cases. We do know that CIA's employment standards differ from ours. We know CIA has employed individuals with backgrounds which would make them unacceptable for Bureau employment.

Larry Richey called to advise that he had informed Mr. Herbert Hoover of our conversation with reference to General Clark's request for us to make the 13 investigations of CIA employees; that he told the Chief that a bird-dog check reflected that this would involve inquiry into projects, investigation in Europe and the Far East and that, obviously, since Clark had asked us to hold up on the investigations we would not undertake any action in the absence of a directive. Larry stated that Mr. Hoover agreed that this was absolutely correct; that since Mark Clark had left this as unfinished business, Herbert Hoover called Sherman Adams, advised him of the Mark Clark request, of Clark's subsequent action in asking that the investigations be held up when it was ascertained that they would involve extensive inquiry and advised Adams that the Hoover Commission would not pursue the matter further and that if the White House wanted anything done that the White House should act accordingly.

This was agreeable apparently to Adams and Richey, therefore, stated we should do nothing further so far as Mark Clark's request was concerned and that if the White House wanted us to make the investigation, he assumed the White House would advise us in due time.

Reference is made to my memorandum dated May 19, 1955, and to my conversation with you on May 25, 1955.

You will recall that General Mark W. Clark had requested this Bureau on May 13, 1955, to initiate investigations of several individuals who allegedly were connected with the Central Intelligence Agency (CIA). I advised you that on May 17, 1955, General Clark asked that the investigations be discontinued. This action was taken by General Clark after he was informed that based upon preliminary information developed the investigations very likely would be of an extensive nature and that objections could be anticipated from CIA. General Clark was informed by this Bureau on May 17, 1955, that no further investigative action would be taken in the absence of any request from him.

Mr. Larry Richey of the Hoover Commission has advised that the matter of the request for investigations of the individuals allegedly connected with CIA has been directed to the attention of Mr. Herbert Hoover by General Clark. Richey stated that Mr. Hoover has become apprised of the fact that General Clark had originally requested the FBI to conduct investigations and that the investigations had been discontinued at the request of General Clark for the reasons described above.

Mr. Richey has been advised by us that the FBI would not undertake any further investigative action in this matter in the absence of a directive. The FBI's position was made known to Mr. Hoover who agreed that this Bureau's position was absolutely correct. According to Mr. Richey,

Larry Richey called by reference from the Director's Office today. He stated that Mark Clark has submitted his final report on CIA to Herbert Hoover; that General Christiansen advised Herbert Hoover that they had requested the Bureau to investigate 13 individuals and it was felt it could be done in two weeks; however, they were now advised that it would take three, four or five months; that Mark Clark was leaving it up to the Commission as to whether the investigation should be conducted and if conducted, to whom should the reports be submitted. Herbert Hoover felt that if we were making the investigation we should submit the reports directly to the White House.

Did we say this?

I told Richey that the facts of the matter were these; namely, that when the Director appeared before the group a request was made of the Director to investigate 13 individuals; that subsequently the names were furnished without identifying data; that as a result of a bird dog inquiry

that we felt dutybound to go back to General Mark Clark and tell him exactly what was involved and be governed by his decision; that this information was communicated first to Christiansen and then to Clark. Clark took the position that we should not proceed any further with the request for the investigations; that Clark would give the matter some thought and perhaps talk to either the Director or perhaps the President. As the matter now stands we are making no investigation of the 13 individuals and that naturally we would not make an investigation until we had the specific directive.

Reference is made to a memorandum dated May 31, 1955, from Mr. Nichols to Mr. Tolson concerning a conversation held on May 31, 1955, between Mr. Nichols and Larry Richey of the Hoover Commission relative to investigations which had been requested by General Mark Clark. Richey informed Mr. Nichols that according to General Christiansen of the Clark task force, the Bureau had been requested by General Clark to investigate thirteen individuals and it was felt that the investigations could be done in two weeks. General Christiansen had advised Herbert Hoover that subsequent to the request the Clark task force had been advised that investigations would take three, four or five months. With regard to the statement that the investigations would take three, four or five months, the Director made the notation "Did we say this? H." The Director also noted as follows: "Liaison should straighten Gen. Christiansen out."

The Liaison Agent was unable to locate General Christiansen on June 1, 1955. On the morning of June 2, 1955, [Redacted] secretary to General Clark, advised Liaison Agent Papich that General Christiansen had already terminated his assignment with the task force but he possibly could be contacted at his home. Papich telephonically contacted General Christiansen and arrangements were made for an interview at 1:45 P.M., June 2, 1955, in the offices of the Clark task force at the General Accounting Office Building. Also present at the time was Colonel John Dubbelde, who has been serving as an assistant to General Christiansen.

Papich advised General Christiansen concerning the statements which he, Christiansen, allegedly had made to Herbert Hoover relative to the requested investigation of thirteen

General Christiansen was told that based upon statements allegedly made by General Christiansen, an impression may have been left with Herbert Hoover and Larry Richey of the latter's office that investigation had not been instituted on the thirteen individuals because the Bureau had advised that the investigations would take three, four or five months rather than two weeks. It was explained to General Christiansen that such an impression, of course, was erroneous and the Liaison Agent wanted to make certain that there was not any misunderstanding with General Clark or any members of his staff and the Bureau felt that it was most important that Herbert Hoover and his assistants not be left with the understanding that the Bureau held up any investigations. Papich directed General Christiansen's attention to interviews held with him and General Clark on May 17, 1955. He was reminded that Papich had made it very clear on May 17, 1955, that under no circumstances would the Bureau desire to leave an impression with anyone that the Bureau was shirking a responsibility. On May 17, 1955, Papich informed both Clark and Christiansen that the Bureau had received information of a preliminary nature indicating that investigation of the thirteen individuals might be of an extensive nature in that it very likely could become necessary to [redacted]

Clark and Christiansen were told that such an investigation would take more than two weeks; the Liaison Agent did not indicate whether the investigations could be completed in any specific time. b3

Papich advised General Christiansen that the Bureau was concerned about the impression which may have been left with the Hoover Commission because, if true, Herbert Hoover was being left with the understanding that investigations of the thirteen individuals were not handled because the Bureau could not complete the investigations within two weeks. Christiansen was told that this, of course, did not present a true picture of what had actually taken place on May 17, 1955. General Christiansen was reminded that the main purpose of contacting him and General Clark on May 17, 1955, was ^{not} to advise that the investigations very likely would exceed two weeks but rather to emphasize that strong objections could be anticipated from CIA once we embarked on investigations which undoubtedly would be of an extensive nature. Christiansen's attention was directed to the fact that Papich had made it clear that if objections arose, the Clark task force could not separate itself from situations which might develop. (These

points were covered in two memoranda each dated May 17, 1955, describing interviews of Liaison Agent Papich with Generals Christiansen and Clark held on May 17, 1955.)

General Christiansen stated that the impression which has been conveyed to the Bureau obviously was not a picture of the true situation and he personally did not understand why the situation had become confused. He then stated that after the Liaison Agent spoke to him and General Clark a letter was sent to Herbert Hoover by General Clark making reference to the list of thirteen individuals. In his letter, General Clark advised that based upon information received by the Bureau it appeared that the investigations would take much more time than two weeks and that, furthermore, the investigations could develop to a point where strong objections could arise from CIA. In his letter, General Clark advised that since the task force was disbanding it was not feasible for the group to follow through with any investigations which might be conducted. Clark then went on record that he was furnishing the list with all information received concerning the individuals to the Hoover Commission for disposition. In the same letter, General Clark advised that he had requested the FBI to discontinue its investigations and not to take any further action in the absence of a request either from General Clark or Herbert Hoover.

General Christiansen advised that subsequent to the transmittal of the letter, he personally participated in a conference in the hotel room of Herbert Hoover. One of the individuals present at this conference was Larry Richey. At that time, the matter of the thirteen individuals was discussed with Herbert Hoover. General Christiansen stated that he briefed Mr. Hoover concerning the matter stating that the Bureau had been requested to conduct investigations of thirteen individuals and that General Clark had asked that the investigations be discontinued when it was realized that strong objections might arise from CIA. General Christiansen stated that at the time of the conference he expressed the opinion to Herbert Hoover that the task force was in no position to go any further and that based upon information received so far, it appeared that the agency involved (in this case CIA) should be responsible for conducting any necessary investigations. General Christiansen emphasized that at no time did he or members of his staff make any statements which would reflect that the Bureau was in any way shirking a responsibility or that the investigations were

not initiated just because it would take more than two weeks to do the job. Christiansen advised that he regretted very much if such an impression was left with anybody and that he personally intended to speak to Mr. Richey in order to make certain that there was no misunderstanding.

General Christiansen advised that his assignment with the Clark task force had officially been completed. He stated that Colonel Dubbelde and [redacted] secretary to General Clark, were remaining in the offices for another week or so. He stated that the reports have already been submitted to Herbert Hoover. One report of a sensitive nature will go to the President and another report will eventually be publicized.




Agent Papich took the opportunity to inquire what disposition was to be made of reports and memoranda which had been given to the Clark task force concerning various individuals. Several months ago the Bureau handled name check requests for General Clark at which time it was agreed that upon the completion of the task force assignment Bureau documents would be returned. General Christiansen stated that this matter had been discussed with General Clark and Herbert Hoover. He advised that since there were unanswered questions relative to various individuals allegedly connected with CIA, it was recommended to Herbert Hoover that the questions be resolved in some way rather than being "buried." Herbert Hoover thereupon instructed that all pertinent documents relative to the individuals be forwarded to the White House for appropriate disposition. Christiansen stated that the Bureau reports and memoranda were given to Colonel Goodpaster of the White House on June 1, 1955. It is Christiansen's understanding that it will be the responsibility of the White House to determine what future action may be taken concerning the thirteen individuals.

Colonel Dubbelde volunteered the comment that he was glad the task force was disbanding. He stated that the report which will receive publicity will undoubtedly create some "fireworks." Immediately thereafter he stated that people like Senator McCarthy very likely will raise some issues.

In January, 1955, General Mark Clark furnished the Bureau a list of names with the request that the Bureau files be reviewed for derogatory information. Most of the individuals listed had a past or present connection with the Central Intelligence Agency (CIA). The Bureau subsequently furnished General Clark information which was submitted in the form of reports and memoranda. At the time of the dissemination the Clark task force agreed that upon the completion of the task force's assignment the documents would be returned to the Bureau. By memorandum dated June 2, 1955, captioned as above, I advised that in accordance with instructions of Herbert Hoover, the Bureau material had been sent by the task force to Sherman Adams of the White House.

General James George Christiansen of the task force advised that it was his understanding that the White House was assuming the responsibility concerning any action which might be initiated in the future relative to the individuals identified in the documents. General Christiansen advised that the task force no longer possesses any information disseminated by the Bureau as a result of the request which had been submitted by General Clark.

ACTION:

The Bureau material disseminated to the Clark task force is now in the possession of the Executive Branch of the Government, namely, the White House. Therefore, if you approve, no attempt will be made to obtain the material from the White House.

By letter dated May 13, 1955, General James George Christiansen, head of the working committee of the General Mark W. Clark task force which has been surveying Central Intelligence Agency (CIA) operations, requested that this Bureau initiate investigations of the individuals identified in the enclosed list. General Christiansen advised that the request was made in behalf of General Mark Clark and he informed a representative of this Bureau that the investigations should be directed for the purpose of determining each individual's character, reputation and loyalty.

General Christiansen only furnished names and advised that the task force did not possess any other information. This Bureau immediately initiated a review of its files for the purpose of developing the necessary identifying data and contact was also made with the CIA. That Agency was contacted inasmuch as many of the individuals listed are known to the CIA because of past or present employment or connection.

It was pointed out to General Clark that this Bureau was only interested in conducting a complete and thorough investigation and that this Bureau would expect cooperation from interested agencies, such as CIA. His attention was directed to the possibility that the CIA would raise strong objections concerning an investigation of CIA employees and operations. General Clark was informed that if objections arose, he and his staff could not cooperate themselves from the situation. General Clark indicated that he apparently did not realize the potential implications when he submitted the request for investigations. After listening to this Bureau's representative, General Clark advised on May 17, 1955, that this Bureau should withhold any further investigation of the individuals listed. He stated that he planned to contact me and that he might also talk to President Eisenhower. He stated that he was leaving Washington, D.C., on May 17, 1955, and that he did not know when he would return. General Clark was advised that under the circumstances the FBI would not take any further action in connection with the request pending word from him. For your information, all investigations requested were discontinued by this Bureau on May 17, 1955.

Surine told me in confidence that these are the cases on which McCarthy has a documented record. In some instances they have documents, which are probably restricted. In each instance they have confidential informants who, in the event of a showdown, would testify as witnesses. Senator McCarthy, however, declined to furnish information to Mark Clark as he did not want to get back to CIA. Surine stated that he would get anything we wanted. I told him that obviously if we were making an investigation, it might be necessary to call our reports to the attention of other agencies; that we certainly would like to have all the help we could get, whereupon, Surine stated if desired he could get together his material and we could use it for lead purposes attributing it to a confidential source.

I think we should start out on this basis and Surine is to come by my office Monday morning on another matter. I will give him the list of the names and tell him to get together his material. I think in this way we would have a pretty good line on what Senator McCarthy has to start out with and we can always go back to him if we need to.

Since we had previously made name checks for General Mark Clark and since he does not know the nature of the allegations pertaining to the individuals in whom he has manifested an interest, their connection with projects which reflect unfavorably upon CIA, etc., it is my recommendation that the highlights of the allegations be orally conveyed to General Clark, without furnishing any information outside the Bureau on the names set forth in my memo as potential leads and possible sources of information should an investigation be ultimately ordered. *I agree, when Clark is next in Washington*

I also feel that the nature of the allegations should be furnished to the Attorney General and Rogers in the same memorandum which advises them that Mark Clark has requested us to hold up our investigation.

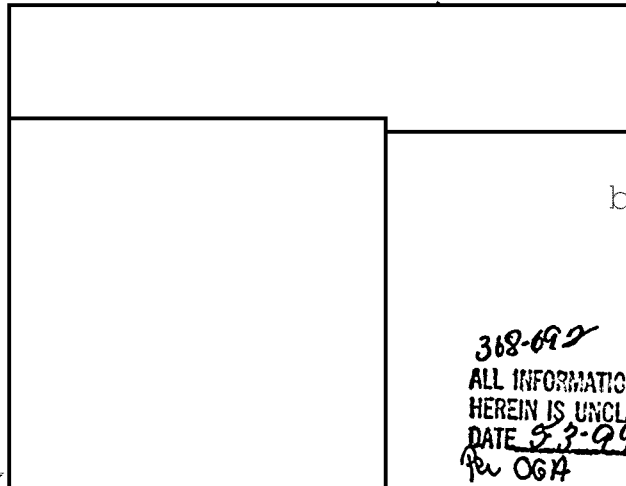

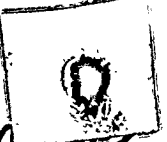
