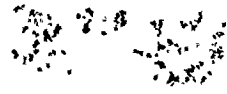

On 8/15/55 one copy each of subject newspaper for 7/31/55 and 8/7/55 were received addressed to "Mr. Alan H. Belmont, 2711 North Yucatan Street, Arlington 13, Va., U.S.A.," postmarked London, England. Each newspaper had portions of one article circled with typewritten notations in the margin of the paper.

Subject newspaper is an anti-Communist newspaper published weekly in the Polish language in London, England. The pertinent portions of the paper have been translated from the Polish and refer to testimony by one Bielecki recorded in the Congressional Record for 1949 and requesting funds from the American Treasury to help anti-Communist forces of eastern and central Europe because "there are various channels through which the people in Poland can be reached." The typewritten notation implied that this disclosure in 1949 was a tip-off which resulted in a CIA operation "Berg affair" being disclosed with unpleasant results for many people. The "Berg affair" was publicized about a year ago by the Communists in Poland as a network of Polish spies financed by Americans.

THE BEGINNINGS OF BERG

The U. S. Congressional Record for 1949, page A-1919, contains remarks by Congressman DEWEY SHORT concerning a reception he gave in the company of 30 Americans in honor of TADEUSZ BIELECKI. Mr. SHORT describes BIELECKI as a "vice-president under PADEREWSKI" and now a president of the National Democratic Party. At this reception, according to the Congressman, BIELECKI appealed for money from the American treasury to help the anticommunist forces of Central and Eastern Europe, because there are various channels through which the people in Poland can be reached. Well, we know how these channels were later put into operation. BIELECKI was compromised. That was the beginning of the "BERG affair."
