Re Mr. Boardman's memorandum to the Director of November 4, 1957, advising of the subpoena served on Mr. Nichols calling for his appearance as a witness for the defense at 10:00 AM, November 12, 1957.

Departmental attorney William Hundley, who is handling the Frank prosecution in the Department, was telephonically contacted on November 4, 1957, and advised of the receipt of the subpoena by Mr. Nichols. Hundley immediately advised that the Department had not been aware of this and he would immediately get in touch with defense attorneys to see if the subpoena could not be cancelled and he would make every effort to prevent the necessity of Mr. Nichols' appearing.

Mr. Hundley subsequently advised on the afternoon of November 4 that he had been unable to reach defense attorney [redacted] but had contacted [redacted] associate [redacted]. Hundley said that [redacted] was not cooperative and said that while he could not speak for [redacted] he was not willing to cancel the subpoena nor would he be willing to enter into any stipulation as to Mr. Nichols' testimony. Hundley advised that he had attempted to reach [redacted] and had been unsuccessful but had left word for [redacted] to contact him and Hundley was continuing his efforts to reach [redacted] to see if the subpoena could be cancelled. He said he would advise as soon as he was able to reach [redacted] and he would also see if anything could be done to eliminate the necessity for Mr. Nichols' appearance.

Hundley advised today, November 5, that he had contacted [redacted] this morning and that [redacted] was not willing to waive the subpoena. [redacted] said that he did not want to enter into any stipulation but preferred to have Mr. Nichols appear for testimony in person. Hundley said that [redacted] would not indicate what he hoped to obtain from Mr. Nichols' testimony but surmised that [redacted] wants to show that the

Hundley said that [redacted] did agree that Mr. Nichols did not need to appear on November 12, 1957, as called for in the subpoena and [redacted] was perfectly willing to have Mr. Nichols not appear until requested by the defense. Hundley said that this would undoubtedly not be before 2 weeks subsequent to Nov. 12 and he would make arrangements with [redacted] for [redacted] to advise him several days in advance of Mr. Nichols' desired appearance and he would then advise the Bureau so Mr. Nichols could be informed of the date he should appear. Hundley said that this matter had been studied in the Department and he did not believe there was any way the defense could be prevented from subpoenaing Mr. Nichols if they insist on it, and as things now stand, they are insisting. He said he would follow this closely and keep us advised and that Mr. Nichols did not need to appear until further advice was received. Mr. Nichols is being advised of this and the subpoena and check for witness fees made out to him will be retained in your office pending further developments.

Mr. Hundley also advised on November 5 that defense attorney [redacted] had indicated that the defense was willing to enter a plea of nolo contendere in this case if the government did not insist on [redacted] filling out a registration statement. The Department has insisted that [redacted] properly fill out the registration statement and only if this is done will they be willing to accept a nolo contendere plea.

On November 1 [redacted] asked to see Hundley in private and at that time advised Hundley that if [redacted] were to fill out the registration statement completely, he would have to name 2 high-ranking political officials in the United States plus 1 high-ranking official in the executive branch of the government. [redacted] said this would be highly embarrassing to the U. S. Government. [redacted] refused to name the high officials he was speaking about. Hundley said that [redacted] requested to see the Attorney General but ended up talking to Mr. Yeagley of the Internal Security Division and [redacted] refused to name the officials to Mr. Yeagley and was informed by Yeagley that [redacted] had to make a full disclosure before the government would agree to the nolo contendere. [redacted] said that he was glad that he had brought this to the attention of the Department and that in view of the Department's position, they would now have to subpoena the officials and bring forth the facts at the trial.

Hundley said that this information was being furnished to the Bureau in memorandum form. He said that he had heard nothing more from [redacted] on this matter and as far as he knew, the high-ranking officials had not been subpoenaed.

NEWSWEEK MAGAZINE ITEM IN PERISCOPE
DECEMBER 16, 1957 ISSUE - Pages 25, 26.**

Late yesterday afternoon, Richard Arens, Counsel of the House Committee on Un-American Activities, telephoned my office advising Mr. McGuire that the December 16 issue of "Newsweek" magazine in the Periscope column had an item that Congressman Francis Walter, over the opposition of the FBI and CIA, got a visa for Noel Fields daughter to come to the United States. (This item refers to [redacted] subject of Bureau file 100-358939, Internal Security-R, who arrived in the U.S. at New York City on October 22, 1957, after both the State Department and the Immigration and Naturalization Service decided she was eligible to come back to the U.S. as a defector.)

Arens stated the comment in Newsweek magazine was in error and that to his knowledge neither the FBI nor CIA had voiced any objection or opposition to [redacted] return to the U.S., nor had anyone that he knew of anywhere in Government made any protest. Arens stated that he wished to suggest that it would not be inappropriate for the FBI to protest this item to Newsweek magazine. Arens was informed that we would make a check into the situation and would let him know, although it was not our policy to voice any protest to any other department of Government whose responsibility it was to make the decision as to whether or not entrance into the U.S. should be granted.

Arens stated he was making a protest to Ralph de Toledano of the Newsweek Washington staff. Upon termination of the conversation, Ralph de Toledano was calling in on another line and advised Mr. McGuire that Dick Arens had just called him protesting the above-referred to item in Newsweek and de Toledano stated on a strictly personal basis that he was highly suspicious of Arens since Arens had told him what he considered a direct lie, namely that [redacted] had been fighting the communists for the past 5 years and since he had told him what he knows to be an untruth he was suspicious of anything else Arens had stated.

De Toledano stated that in discussing this item Arens told him that the FBI was tickled to death that Congressman Walter had brought her into the U. S. De Toledano said that as long as he had known the FBI we had never expressed an opinion one way or another on matters like this and he knew that we would neither protest nor would we be expressing any pleasure as to whether a potential witness for one of the Committees was being brought back to this country.

De Toledano then stated that both he and his wife were very familiar with the activities of [redacted] and had worked very closely with Bob Morris of the Senate Internal Security Subcommittee inasmuch as at one time Morris had considered the possibility of bringing [redacted] back to this country to use as a witness, and after an extensive investigation, both here and in Europe, both [redacted] and he himself had submitted their findings to Morris, whereupon Morris dropped the entire idea of bringing [redacted] back to this country as he felt it would not be in the best interest of the U.S. to have her here. b6 b7C

De Toledano then advised that when Morris sent Ben Mandel to Europe to interview Santo, Mandel, while over there, interviewed [redacted] cold not knowing too much of her activities and background, and that Mandel took an affidavit from her but did not challenge some of her statements. Further that Morris gave [redacted] statement to Mandel to the de Toledanos to look over and they found approximately 10 solid points of discrepancy, which in their minds showed she was lying like "hell." De Toledano stated he had all of these affidavits and would be glad to furnish them to the Bureau for our information, advising he would bring them down in the next day or so for such information as we may glean from them. Mr. McGuire told de Toledano we would be glad to see this material. (We should accept this inasmuch as the Bureau has not interviewed [redacted] to date as we have been waiting until the HCUA is through with her.) b6 b7C

De Toledano continued that he was sure CIA would make no opposition inasmuch as CIA got hold of [redacted] when she first was released from Russian custody and they had long sessions with her. He stated if there was any possibility that [redacted] was straight CIA would not have let her get out of their control, but would have sponsored her return to the U.S. themselves. This makes sense. He stated further that [redacted] claimed in her statements to Committee representatives of the HCUA that she was arrested within 3 hours after her arrival at the Berlin airport. Yet she

told Ben Mandel that she spent several days in Berlin after her arrival looking for Leopold Bauer before she was arrested. De Toledano said these were typical instances of discrepancies and it was his wife's and his opinion that all [redacted] wanted to do was get back to the U.S. and probably that was the only reason she went to England and married [redacted] in order to get the benefit of American citizenship.

De Toledano then referred back to the comment in Newsweek and stated that perhaps while the word opposition was too strong a word, he felt Newsweek had made a fair comment and he saw no basis for Newsweek getting upset about Arens' call. De Toledano then asked if we could advise him for his personal guidance as to whether Arens was correct when he told him that the FBI was tickled to death that Congressman Walter had brought [redacted] back. Mr. McGuire told de Toledano strictly for his personal information and guidance that the Bureau does not make a practice of indicating its pleasure or displeasure as to what any committee of Congress does; that if there was an investigative interest we had in anyone, we had the prerogative to seek an interview whenever we desire and that for his information, [redacted] was the Committee's witness and we had not even yet interviewed her as we had never expressed any interest one way or the other as to whether she was to be brought back to this country or not.

Obviously Arens is upset by the item in Periscope and is seeking to use the Bureau to get into the middle of a situation wherein we might save the Committee's face. Actually the supervisor, Mr. Floyd Jones of the Domestic Intelligence Division handling this case, states that no inquiry from any source including the Department, Immigration, State or from any committee, was made of the Bureau wherein any opinion was expressed either in favor or in opposition to the return of [redacted] to the U.S. Jones stated further that the Bureau did not make any expression to the HCUA or to anyone else as to whether we were pleased or displeased with the return of [redacted] to the U.S.

This is certainly a situation we should stay out of. Accordingly, we will advise Arens that no inquiry was made of the Bureau from any Government source regarding the return of [redacted] to the U.S. and even had there been any request for information regarding her in connection with efforts to seek her return the Bureau would merely have furnished whatever information it may have had in its files for that inquiring agency to use in making up its own mind as to whether it would sponsor or oppose her return.

McCarthy Asks CIA-type Group for Congress

Rep. Eugene McCarthy (D., Minn.) said Friday he will seek legislation which would establish a joint congressional committee on intelligence and information, early this month.

The St. Paul congressman will fly to Washington Monday for the opening of the second session of the 85th congress Tuesday.

"Such a committee would operate in much the same way as the joint committee on atomic energy," he said. "It would have knowledge of procedures and operation of the central intelligence agency (CIA) and other intelligence agencies.

"Then congress would come into possession of such advance information — which the administration had, but did not use — as the coming launching of the Russian Sputnik."

Reference is made to the attached article appearing in the "Washington Post" on today's date entitled "Ike Asks Maps, Arrows To Clarify CIA Reports." The article infers that the President was reportedly annoyed with Allen Dulles, Director of CIA, at a recent National Security Council meeting because of Dulles' allegation that the policy makers within the administration ignored intelligence findings. The article reports that Dulles was directed to shorten his reports since they were entirely too long and should be written in much briefer text. It is believed that this item refers to the Killian Committee's criticism in the past of all the foreign intelligence agencies, State, CIA and the military services, each publishing a daily current intelligence summary. The Killian Committee was critical that none of these bulletins were coordinated with the other agencies and, as a result, some would conflict with others in evaluating the same piece of intelligence. As a result, this matter has been considered at the Intelligence Advisory Committee on a number of occasions in the past few months and because of a final agreement among the agencies involved, CIA, since January 14, 1958, has been publishing a daily intelligence bulletin on an "all source" basis. CIA has set up quite a staff in order to produce this item and where at all possible all items are coordinated with the appropriate interested agency.

The Bureau has been receiving copies of these CIA daily bulletins and they are reviewed daily for items of interest to the Bureau.

Ike Asks Maps, Arrows To Clarify CIA Reports

President Eisenhower has ordered the Central Intelligence Agency to append maps and red arrows to its daily intelligence digests if CIA expects to have them read.

CIA Director Allen W. Dulles, at a top secret National Security Council meeting held within the last few weeks, complained to the President that there was little use of having a mammoth Government agency devote its full energies to appraising foreign intelligence if the policy makers within the Administration ignored its findings.

The President reportedly showed great annoyance with Dulles' complaint and said that the reports were far too ponderous to read. He said that hereafter CIA should append maps of the areas under discussion, with red arrows pointing to the strategic spots. And the President made it plain that there should be headline summaries and much briefer text discussion.

The President then promised Dulles that if the reports became more palatable he would make it a point to order the Administration's top 25 or 30 policy makers to read them daily.

Since then, CIA has detailed several dozen of its personnel to working day and night to redraft its scholarly digests into a more popular format. The CIA employees reportedly are not too happy over their extra-curricular assignment.

The President himself is known to be sent CIA's world-wide intelligence report by armed guard each morning. The summary is brought in to the President by Brig. Gen. Andrew J. Goodpaster, his staff secretary.

To facilitate the Administration's understanding of fluctuating world problems, Nelson A. Rockefeller, chairman of the President's Advisory Committee on Government Organization, last year suggested that the White House's World War II map room be revived. Rockefeller thought it would dramatize both military and economic situations. But former Under Secretary of State Herbert Hoover Jr. vetoed the suggestion and the map room never came into being.

CIA Director Dulles' complaint to the President of being unheard was not his first. In a closed-door hearing before the Senate Preparedness Subcommittee in November, Dulles reportedly told Congressional investigators that Russian advances in missile and satellite technology had been long predicted in CIA's daily intelligence summaries.

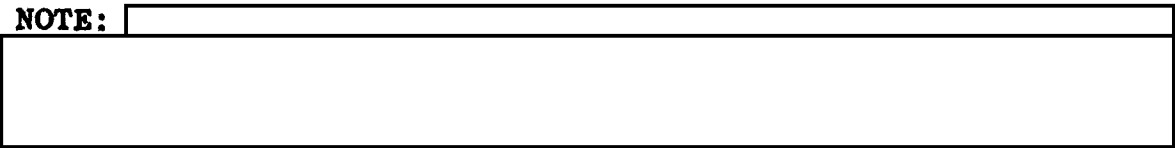

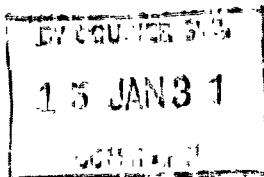

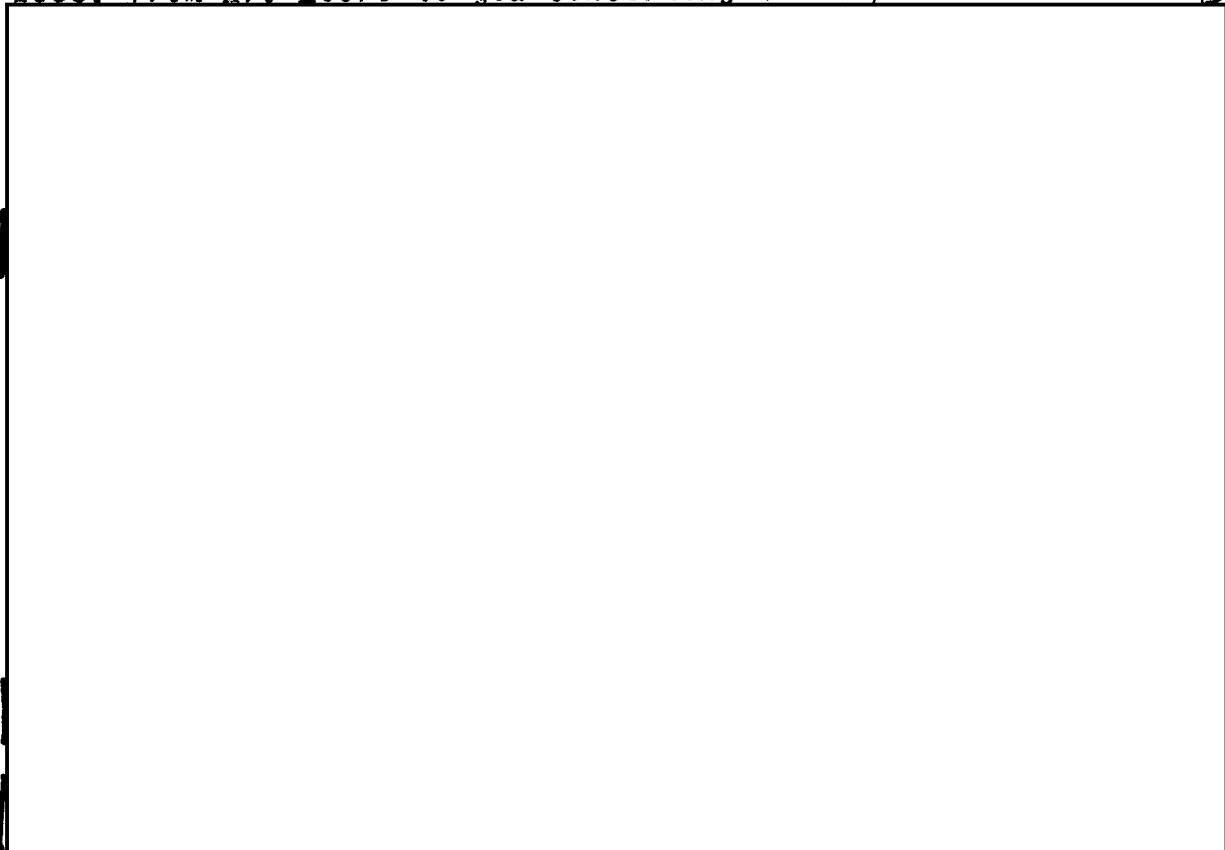

With respect to this matter, you are referred to my memorandum dated January 31, 1958, which is captioned "Possible Launching of a Soviet Earth Satellite or Test Intercontinental Ballistic Missile (ICBM) as Early as 2:30 P.M. (January 30, 1958), or Within the Next Few Days; Guided Missile Intelligence Committee (GMIC). Therein, information with respect to this matter was pointed out to you. This was the only dissemination made of the information that the Soviets would most likely attempt to launch an earth satellite or a test intercontinental missile by [redacted] of the Bureau.

My memorandum February 4, 1958, reported that at a meeting of the U. S. Communications Intelligence Board (USCIB), on January 31, 1958, [redacted] Central Intelligence Agency (CIA), advised USCIB members that on the morning of January 31 he had received a call from General Goodpaster at the White House expressing concern over the fact that "The New York Times" and the "Washington Post and Times Herald," January 31, 1958, had carried articles indicating that the Soviets were launching either an earth satellite or a test intercontinental ballistic missile (ICBM). [redacted] suggested that each agency check to see whether any of their employees had leaked the information. Subsequently, [redacted] called the Bureau to see whether the Bureau would either take over the investigation to determine the source of the leak or coordinate such investigation. He was advised that the Bureau considered this an administrative matter for the agencies involved and one which should be handled by the various agencies.

The attached article, which appeared in the WASHINGTON POST AND TIMES HERALD for Saturday, February 1, 1958, indicates that the Central Intelligence Agency is spending close to \$500,000 annually to translate periodicals and books in the Russian field alone. In comparison, this is a rather interesting figure. The Bureau's translation unit which handles about 30 foreign languages including Russian, Hebrew, Japanese, Chinese and Korean operates on an annual salary budget of \$65,000.

The article continues that last year 6,447 books were purchased, of which 50% to 60%, or about 3,200, were of a technical nature. Translations of Soviet scientific literature made by CIA during fiscal 1957 totaled 32,667 pages. In other words, 3,200 books plus an unknown number of periodicals produced in round figures only 32,000 pages of translation for an average of less than 10 pages of translation per book.

The suggestion is made that about half of the product is scientific. If this inference is true, the cost per page of translation is approximately \$8.00 as opposed to the Bureau's expenditure during the first half of fiscal year 1958 of \$2.00 per page.

CIA Pays Half Billion^{MILLION?} Yearly for Translations

United Press

The Central Intelligence Agency disclosed yesterday it is spending close to half a million dollars yearly to collect and translate more than 1000 Russian periodicals and numerous books.

Contrary to some reports that most of the product has been kept secret, the agency said 95 per cent of the translations and abstracts are available to the public through the Library of Congress or the John Crerar Library in Chicago.

Lt. Gen. C. P. Cabell, acting director of the agency, gave

the first comprehensive report on the CIA's efforts in this field in a letter to Chairman John E. Moss (D-Calif.) of a House subcommittee on Government information.

Cabell said last year 6447 books were purchased, of which 50 to 60 per cent were of scientific or technical nature.

Translations and abstracts of the Soviet scientific literature made by CIA or its contractors during fiscal 1957 totaled 32,667 pages, he said. He said the estimate for the current year is 35,000 pages.

[In Philadelphia, the Nation's major science information services, admittedly prodded into action by Russian achievements, yesterday joined forces to speed the flow of knowledge to American scientists, the Associated Press reported. They formed the National Federation of Science Abstracting and Indexing Services.]

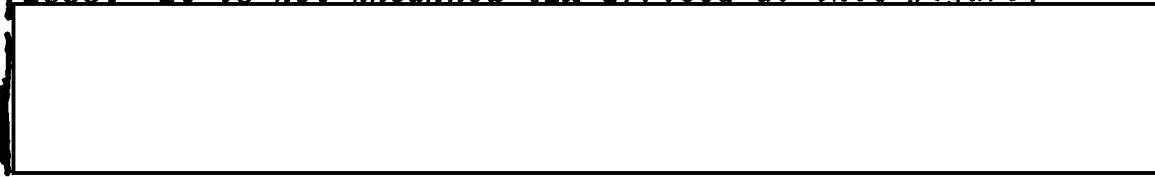

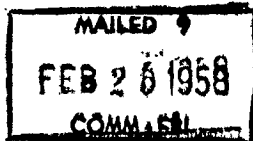

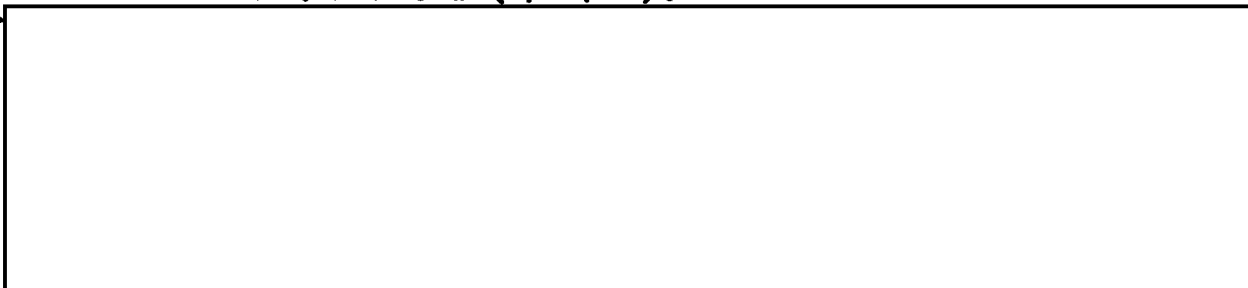

At 1:45 PM, March 14, 1958, Ralph A. Patterson, secretary to Congressman Stuyvesant Wainwright (R-New York), telephoned and talked to Wick. We have had pleasant dealings with Patterson in the past and he has always been friendly. Mr. Patterson said the Congressman has learned from responsible constituents in Bridgehampton and East Hampton, New York, that the two brothers, Samuel and Joseph Liss, are very active in and around that immediate area. It is believed that they were in the past and may be now connected with the Communist Party (CP) or if not, they are certainly "left-wingers." The Congressman asked whether someone from the FBI could come up and talk to him about these two individuals. Wick told Patterson he would see what we could do on this matter although it was not believed we could be of much help.

SAMUEL LISS - Bufile 121-4259:

Samuel Liss is the subject of a Loyalty of Government Employees investigation conducted by this Bureau in 1948 at which time Liss was employed as an agricultural economist with the Farmers Home Administration in the U. S. Department of Agriculture. Reports were forwarded to the Civil Service Commission and as of August 31, 1949, we were advised that Samuel Liss was eligible on loyalty. Our investigation reflected that Samuel Liss was born August 22, 1906, in Odessa, Russia, obtained derivative U. S. citizenship February 27, 1920, Bronx, New York. He received a B.S. degree in 1930, City College of New York, and a M. A. degree in 1932 from Columbia University. He taught economics at City College of New York, 1930 to 1935, came to Washington, D. C., in 1935 as a WPA Statistician, later transferred to Department of Agriculture and was inducted into the Army in 1943. He was honorably discharged in October, 1945. He was reinstated in the Department of Agriculture January, 1946.

Investigation reflected the name of Samuel Liss was on the indices of the Washington Bookshop Association and the American League for Peace and Democracy. He paraded with Washington Friends of the Spanish Democracy. In Hatch Act interview in 1943 admitted attending American League for Peace and Democracy.

Memorandum to Mr. Tolson:

Democracy meetings and supporting the Loyalists; contributed to Commonwealth College [redacted] Samuel Liss [redacted] associated with known communists and an alleged Soviet espionage agent. Wife active in communist front organizations. Samuel Liss' brother, Joe Liss, known to be confirmed communist. Informants stated Samuel Liss [redacted] attended CP recruiting meetings.

Subsequent to notification that Samuel Liss ~~eligible~~ on loyalty, he was noted by surveilling Agents of FBI in company of CP member and this fact reported to interested agency. Department of Agriculture advised us January 8, 1953, that hearing was held on charges preferred against Samuel Liss during which activities of his brother, Joseph, were brought out. By letter dated May 18, 1953, the Civil Service Commission advised that Samuel Liss had resigned or otherwise separated prior to a decision on his loyalty.

JOSEPH LISS - Bufile 100-1027:

Following investigation of Samuel Liss, the New York Office was requested to initiate a security investigation of Joseph Liss in 1951. We had, however, prior to that as far back as 1940, received information concerning the questionable character of Joseph Liss. Joseph Liss was born in Odessa, Russia, on September 2, 1911. He entered this country at the age of two and received American citizenship by naturalization of his father in February, 1920, at U. S. District Court, Bronx, New York. He attended City College of New York from 1929 to 1935 and was married to his wife, Mildred, June 27, 1944. From 1939 to 1940, he was employed by the Columbia Broadcasting System. From October 1, 1942, to June 27, 1944, he was employed by OWI Domestic Radio Bureau, New York City. When OWI's functions were transferred to State, he went along and among references was listed Archibald MacLeish. He was employed from October, 1941, to September, 1942, as a script writer for the program "Report to the Nation" with offices in Washington, D. C. He terminated his Government services with the State Department on August 14, 1944, but immediately thereafter on September 19, 1944, he was reappointed Principal Radio Officer, Office of the Coordinator of Inter-American Affairs, Radio Division, Historical Section, New York City. Shortly thereafter he severed his connection with State and became employed by the Columbia Broadcasting System. As of August, 1953, he was a TV script writer and working as a free-lancer.

Memorandum to Mr. Tolson:

Whittaker Chambers advised that Joseph Liss was a member of the CP as was his wife. Other informants have stated Joseph Liss was a member of the CP while employed at OWI in 1942 and up at least through 1947. He registered with the American Labor Party in 1950 in New York. During an interview in 1954 with FBI Agents, Joseph Liss denied membership in the CP and he claimed that he was not now sympathetic with communism although he had at one time thought it had something to offer.

OBSERVATION:

It is evident that it will not be possible to assist Congressman Wainwright to the extent of supplying him with public source data on both Samuel and Joseph Liss for the reason we have no such data in Bureau files. The majority of information, both in the loyalty case and the Security Matter - C case stems from reliable confidential sources, the identity of which cannot be disclosed.

RECOMMENDATION:

That I personally call upon Congressman Wainwright informing him for his confidential and personal information that we have investigated both Samuel and Joseph Liss both before and after they were employed by the Federal Government. We did, however, tell him the charges were so serious we believed we should protest to CIA. There are such stories as the news account in a Washington paper some months back of a free-for-all in a downtown restaurant between CIA and FBI men. 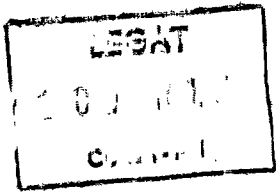

Reference is made to WFO airtel dated April 23, 1958 setting forth details concerning an allegation that [REDACTED] of the Central Intelligence Agency (CIA) had represented herself as being connected with the FBI when she contacted Rudolph Faupl, a representative of the International Association of Machinists. In a signed statement dated April 23, 1958, Faupl stated that he received a telephone call on April 22, 1958, from a female "who identified herself as [REDACTED] of the Federal Bureau of Investigation." Pursuant to instructions, the Liaison Agent contacted CIA on April 24, 1958, for the purpose of discussing this alleged improper representation on the part of that Agency.

[REDACTED] CIA, advised the Liaison Agent that [REDACTED] is a clerk in a CIA office [REDACTED]

[REDACTED] advised that he personally interviewed [REDACTED] and she emphatically insists that she clearly identified herself as being with the Central Intelligence Agency. [REDACTED] told [REDACTED] that she did not use the letters CIA but the entire words [REDACTED] told [REDACTED] that she makes several calls throughout the day and she has no reason whatsoever to misrepresent her connection with CIA.

[REDACTED] advised that the individuals who planned to talk to Faupl are in possession of CIA credentials which they use on a regular basis. [REDACTED] believes that [REDACTED] is telling the truth because he cannot see any possible motive on her part to have used the name of the Bureau. [REDACTED] suggested the possibility that Faupl may have become suspicious and confused because [REDACTED] wanted to make certain that the meeting with Faupl not be held in the latter's office or residence. [REDACTED] stated that this cloak and dagger approach certainly was not a correct entree in initiating a meeting with Faupl. He stated that instructions have been issued by CIA so that hereafter original meetings with labor officials such as Faupl will not be arranged over the phone.

This morning, Mr. Louis Poulton, Attorney with the International Association of Machinists (IAM) (1300 Connecticut Avenue, telephone ADams 2-6309 ext. 307) called SA Fred K. Morgan to report the following information concerning a possible impersonation violation:

At approximately 6:30 p.m. Tuesday, April 22, 1958, Mr. Rudolph Faupl, international representative for the IAM received a telephone call from a woman who identified herself as [redacted] (phonetic) with the Federal Bureau of Investigation. [redacted] advised Mr. Faupl that she wanted to meet him and that a [redacted] (phonetic) would contact him today, April 23, 1958 to arrange the meeting. Mr. Faupl apparently does not know either [redacted] or [redacted] and in further conversation, [redacted] advised Mr. Faupl that the meeting could not be at his office or in his home and also that the meeting should be kept in strictest confidence; she stated that there would be someone at the meeting to make the proper identification. Mr. Faupl was prone to treat the whole thing as a practical joke except that [redacted] seemed to be very serious in her attempts to formulate a meeting with him.

Reference is made to my memorandum dated January 17, 1958, captioned as above, wherein I described an arrangement which was worked out whereby other United States agencies including the Immigration and Naturalization Service (INS) and the Central Intelligence Agency (CIA) would furnish us pertinent data in their files concerning diplomats and representatives of international organizations who receive visas to enter the United States. Under the existing arrangement, INS transmits form (I-57) to interested agencies. Each agency then is required to review its files and transmit pertinent data to us and we, in turn, disseminate the information to the Attorney General for any action deemed advisable by the Department. In the referenced memorandum, I reported that CIA allegedly was looking for a means of excluding itself from any responsibilities in the name checking program which has been in existence for years. An INS representative confidentially advised that CIA was planning to direct a communication to the Attorney General on this matter. By memorandum dated January 21, 1958, from you to Mr. Boardman, the value of the program to the Bureau was described in some detail. We had not been contacted by CIA but the Liaison Agent has been on the alert for any developments.

On April 21, 1958, [redacted] b3
[redacted] CIA, confidentially advised that a letter was in preparation in the Office of the Legal Counsel of CIA, which communication was to be directed to the Attorney General. In this proposed letter, CIA is asking to be excluded from name checking responsibilities under the captioned program. It is [redacted] understanding that the essential argument which CIA presents is that the effort, time and expense involved in the program are not worth the results as far as CIA is concerned. According to [redacted] CIA is pointing out that this program is involving the use of numerous employees who could be utilized on more important work.

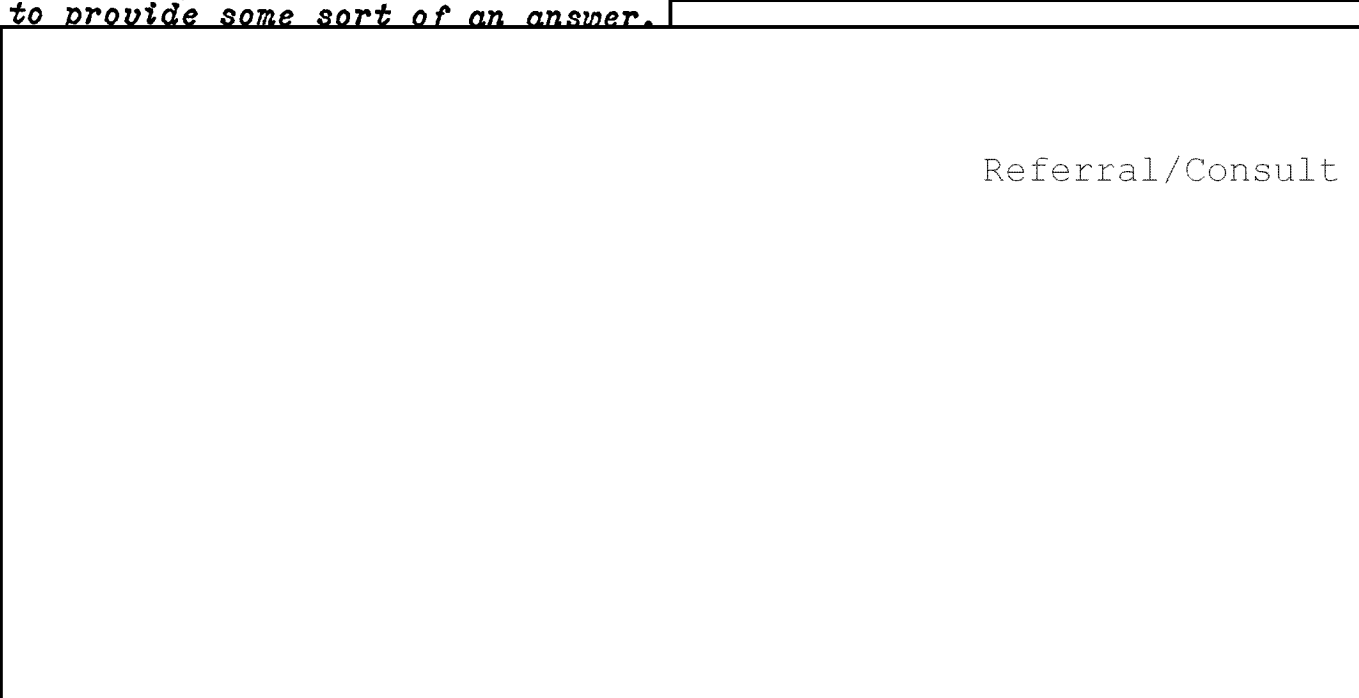

At the Intelligence Advisory Committee meeting of May 6, 1958, Mr. Allen Dulles advised that he was subjected to a very rigorous "going over" by the House Appropriations Committee on the Central Intelligence Agency's (CIA) budget. Dulles said he was asked a number of times by Representative Clarence Cannon, Chairman of the Committee, to submit figures on the cost to the Government of foreign positive intelligence collection. Dulles claimed that in each instance Representative Cannon was advised that he, Dulles, was not qualified to give figures on such activities conducted by the Defense and State Departments; nevertheless, Cannon continued to insist on these figures and Dulles indicated to the IAC that he was obligated to provide some sort of an answer.

On 4/21/58 the President approved National Security Council Intelligence Directive - 2 which provides that Central Intelligence Agency (CIA) may approach non-Governmental U. S. citizens, and aliens in order to exploit their foreign intelligence potential. CIA may contact citizens without instituting a name check provided CIA does not propose to discuss classified information. Prior to contacting an alien, CIA must submit a name check. If it is determined that either a citizen or an alien is being investigated by the Bureau, arrangements for operating the individual will be mutually agreed upon.

RECOMMENDATION:

It is recommended that the provisions of National Security Council Intelligence Directive - 2 be incorporated into the Manual of Instructions, Section 102 (Coordination with Other Government Agencies). Attached for approval are changes in the Manual of Instructions.

SECTION 102

Page 25 E. DOMESTIC EXPLOITATION OF NON-GOVERNMENTAL ORGANIZATIONS AND INDIVIDUALS

Pursuant to the provisions contained in National Security Council Intelligence Directive - 2, approved by the President on April 21, 1948, the Central Intelligence Agency (CIA) may:

1. Approach non-governmental U. S. citizens without conducting a security check in order to determine their foreign intelligence potential or for the purpose of briefing or debriefing them on an unclassified basis. If CIA proposes to discuss classified information with a U. S. citizen, it must first submit a name check request through proper channels. If it is determined that the FBI has operational interest in a U. S. citizen, CIA will coordinate with us prior to further contact. CIA is authorized, in an emergency, to discuss classified information up to "Confidential" with a U. S. citizen without obtaining a prior record check.

2. Contact aliens to exploit foreign intelligence potential. However, prior to this contact CIA will submit a name check to the FBI. If it is determined that we have an operational interest in an alien, CIA will be notified that its exploitation of the alien would interfere with our operations. When this situation arises, a resolution will be effected between the Bureau and CIA.

By letter dated April 28, 1958, the Central Intelligence Agency (CIA) advised that it was interested in receiving on a continuing basis any reports evincing Soviet interest in U. S. travelers upon their return to this country from the USSR, as well as any inquiries regarding such persons made by the Soviets or their representatives.

Inasmuch as such a request was of an unusual and possibly unreasonable nature, the Liaison Agent has checked with CIA in order to ascertain the purpose of the request. If we complied with the request, we would be placed in the position of furnishing CIA information on matters of a sensitive nature such as double agent operations.

On April 30, 1958, [redacted] CIA, advised that as far as she knew the purpose of the communication was to inform the Bureau that CIA desired to be cognizant of Soviet interest in CIA personnel or sources who have traveled to Russia. She stated that she would further check into this matter in order to ascertain if there was any other reason for the CIA request.

On May 6, 1958, [redacted] advised the Liaison Agent that the CIA communication of April 28, 1958, was actually poorly worded in that CIA only wanted to be informed of manifestation of Soviet interest in CIA personnel or sources. The Liaison Agent explained that if our investigations revealed that the Soviets were interested in a CIA representative, we would be in contact with that Agency. The Liaison Agent pointed out that we normally check with CIA, concerning individuals who have traveled abroad and such a check would bring out the fact that the person was employed or connected with CIA. In other words, we already have adequate machinery to handle CIA's concern. [redacted] agreed that this was true and stated it was not necessary to give her agency any kind of written reply on this matter.

On May 19, 1958, [redacted] Central Intelligence Agency (CIA), confidentially advised Agent Papich that some of the officials at CIA were honestly concerned about the outcome of Allen Dulles' testimony before the Senate on May 19, 1958. According to [redacted] CIA realizes that it already has been criticized in the press and the Agency knows that some of the Senators will be "gunning for CIA." [redacted] stated that CIA, nevertheless, was confident that it was in a position to contradict any argument that CIA had not briefed Nixon and his party and that the Agency had not developed intelligence information indicating there would be troubles in Latin America. It is [redacted] understanding that Nixon was given an over-all briefing on Latin America before he departed. The Agency, thereafter, periodically submitted reports concerning the communist plans. [redacted] stated that much of this information was disseminated directly to the Secret Service. Although [redacted] tried to give the impression that CIA was in a strong position, it was obvious that he was somewhat concerned and it is believed that this concern is shared by other CIA officials. [redacted] did mention that CIA would be vulnerable in not supplying intelligence information to predict that (1) the uprisings and riots would have been so intense and (2) that the security organizations in some of the countries were not capable of controlling the riots. (U)

During the discussion in the House of Representatives on the appropriations bill for the Departments of State and Justice and Judiciary, there were several comments made by unidentified Representatives regarding the need to examine the activities of the Central Intelligence Agency (CIA) to determine if they are performing their functions properly. This was provoked by a discussion on the floor of the House today regarding the difficulty experienced by Vice President Nixon on his good-will tour of South America. One Congressman stated that he confidentially ascertained the amount of funds that were available to the CIA and that he was amazed by the amount. No figures were furnished. Several Congressmen wanted to know why the Vice President was not forewarned of the presence of Communist agitation in the South American countries prior to his trip. One Congressman defended the activities of the CIA and he stated that undoubtedly the President and the Vice President had detailed information as to the Communist stronghold in the various South American countries. Further, irrespective of the situation in these countries the Vice President would have gone anyway because his trip was to promote good will.

Congressman Sikes of Florida (D) introduced an amendment to this Bill to cut \$342,000 from funds allotted for Civil Rights Division of Justice. His amendment was rejected. The Bill provides \$490,000 for civil rights matters which includes 29 lawyers and 30 nonprofessional employees.

Page 7956, in the discussion on the appropriations for State, Justice, Judiciary and related agencies for fiscal year 1959, Congressman Preston, (D) Georgia, inquired as to why the CIA didn't have the information about the treatment intended for Vice President Nixon on his South American tour. Congressman Judd, (R) Minnesota, stated "But how is it possible for anybody to know just when the men in the Kremlin will decide to issue the order to go into action in a particular country or area where they have the trained people whom they have been preparing for just such events for years ahead of time?" Mr. Preston advised "The gentleman knows that the FBI has successfully infiltrated every Communist cell in this country. Why, then, is it impossible to penetrate cells in other countries, these youth groups, when we have unlimited funds for use by our CIA agents all over the world? Why have we not penetrated these organizations? Failure to do so indicates incompetence, in my opinion."

Pages 7961-7964, Congressman Frelinghuysen, (R) New Jersey, spoke concerning Vice President Nixon's reception in South America. He stated "How much did our intelligence services know, and if they expected violence why were not more adequate precautions taken? Was there in fact a failure in the functioning of our intelligence services, a failure which resulted in physical danger to the lives of the Vice President and Mrs. Nixon?" He pointed out that he was introducing a bill, H. R. 12534, to establish a joint congressional Committee on Foreign Intelligence. Mr. Frelinghuysen included with his remarks an article which appeared in the April issue of Harper's magazine entitled "CIA: Who Watches the Watchman?" written by Warren Unna. It is stated in the article "CIA's relations with the Federal Bureau of Investigation have also been strained. The FBI, unlike CIA, is under congressional scrutiny. It is directly responsible to the Attorney General, whose Justice Department must answer to the Congressional Judiciary and Appropriations Committees. Moreover, the FBI's

Edgar Hoover regards Dulles' CIA as a considerable departure from his concept of a clean-cut, eyes-straight-ahead, investigating agency, and sees to it that it is given only 'token compliance.' The Hoover conception is reported to be that CIA is replete with white shoes—scions and good families who have been graduated from Ivy League colleges—and a bit on the undisciplined, left-wing side. * * * But Hoover also has a more immediate beef with CIA. The Agency's pay and working conditions are considered far choicer than the FBI's and Director Hoover was not overcome with joy when a good many of his personnel began defecting. A no-raiding pact with Dulles has since been arrived at. On May 14, 1958, [redacted] Central Intelligence Agency (CIA), confidentially advised Agent Papich that he is a member of a CIA committee which is conducting a study designed to produce a retirement plan for CIA employees, comparable to the Bureau retirement program. [redacted] advised that the objective is to provide retirement at age 50 providing that an employee has 20 years of service. He stated that the committee is encountering numerous difficulties in that questions have arisen as to what type of employee would be eligible for such retirement. It has been generally agreed that employees who are on foreign assignment would be eligible. The question has arisen--what, if any, credit would be given to an employee who serves abroad and then has a temporary assignment at headquarters. The question has also arisen as to whether clerks on foreign assignment would receive any benefits under this plan. Another problem arises in connection with retired military officers who, over the years, have been able to find jobs at CIA. [redacted] pointed out that an Army officer with 17 years in the armed services theoretically could come to CIA, serve 3 years and become eligible for the benefits under the plan. The committee members were against this.

According to [redacted] the over-all problem will be to resolve the numerous exceptions to the rule. The committee is of the opinion that when and if CIA's plan reaches the stage of proposed legislation, Congress would be reluctant to pass any Bill loaded with many exceptions.

Ex-U. S. Flyer Named Rebel Aide by Jakarta

JAKARTA, Indonesia, May 28 (AP)—The Army said last night it has captured a former United States Air Force officer who had been piloting a rebel bomber. He was identified as Allan Lawrence Pope, 30, of Miami, Fla.

An Army spokesman said Pope and an Indonesian bailed out of a rebel bomber shot down May 18 in a raid on a government convoy near Ambon Island.

The Army spokesman, Lt. Col. Pirngadie, said Pope was brought to Jakarta and held at an undisclosed place.

He said Pope carried papers showing he is a former United States Air Force lieutenant and a former employe of the Civil Air Transport with headquarters in Taipei, Formosa. CAT is the air line founded by Maj. Gen. Claire L. Chennault of the old Flying Tigers.

Col. Pirngadie said Pope had admitted being paid \$10,000 by rebel leader Lt. Col. Ventje Sumual to fly a United States-made B-26 against government forces.

U. S. Embassy Comments
United States Embassy officials said they knew nothing about Pope and had not been told of his capture.

Lt. Col. Pieters of the Indonesian Army told a conference for Indonesian newsmen that he was in the convoy when it was attacked by the B-26 off Ambon. Antiaircraft fire scored hits and the plane fell in flames, he said.

The two crewmen bailed out over a nearby island, he said, and Pope's parachute tangled in a coconut tree. He fell to the ground, injuring his right leg, Col. Pieters said.

Col. Pieters displayed papers

and money he said Pope had in his pockets. He also showed newsmen United States Air Force parachute equipment which he said Pope used. The Army said Pope has a wife and two children.

\$10,000 a Month

It reported he had been lent by the CAT line to the rebels for three months at \$10,000 a month. He was declared responsible for most of the rebel raids on ships, ports and airfields in Eastern Indonesia.

Col. Pieters said Pope, now held incommunicado, was only one of a number of American pilots flying out of Manado, rebel-held capital of the North Celebes. He declared they had been based at Clark Field, a big American air base north of Manila.

Pope was reported shot down by naval and shore guns while unsuccessfully attacking the troopship Sawega. It was one of 12 ships in an invasion convoy heading for the island of Morotal, which fell to the government May 21.

Pope's companion was Lt. Jan Harry Rantung of Celebes, former sergeant in the Indonesian air force. He also bailed out.
