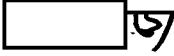

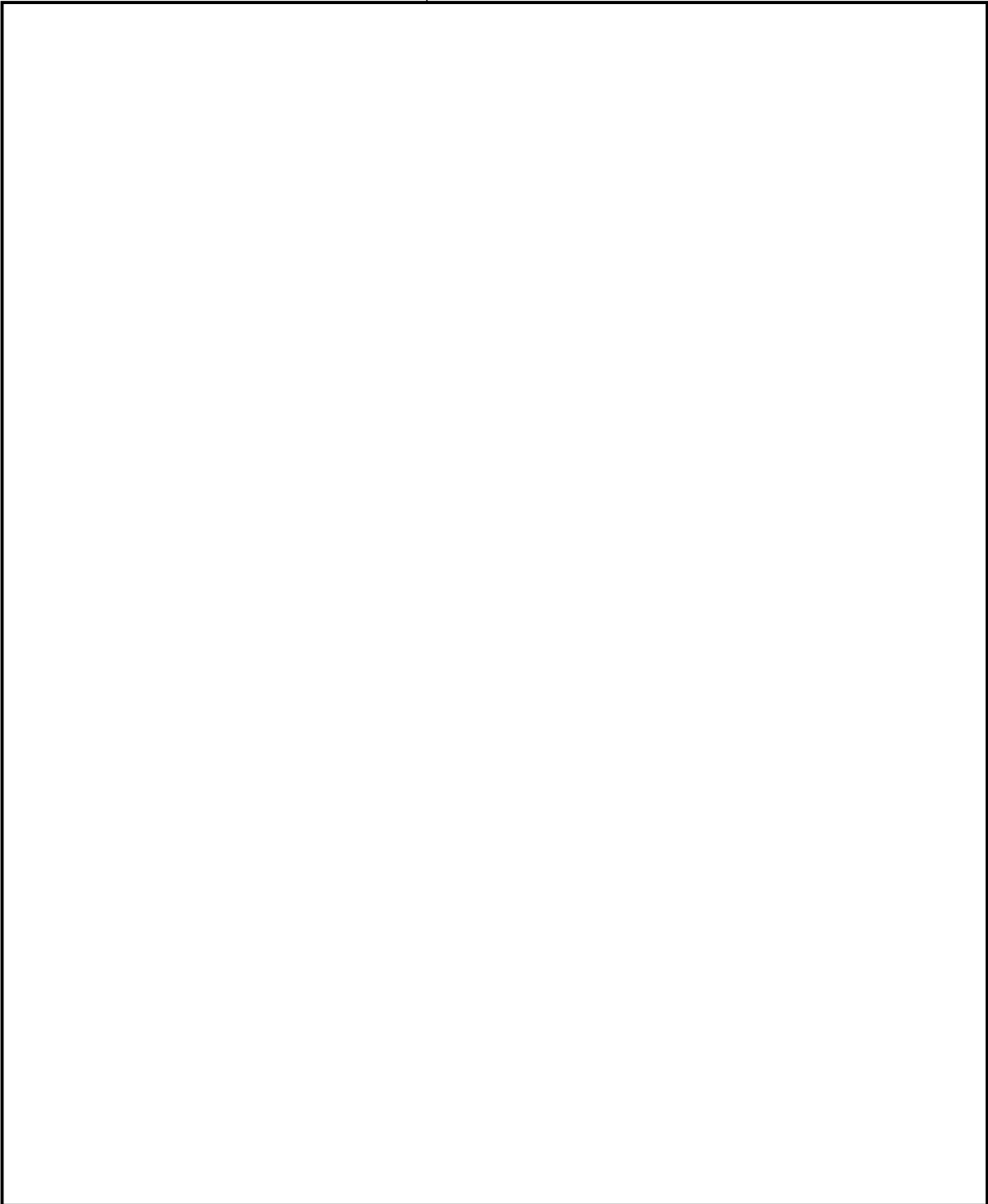

Reference is made to my memo of December 23, 1958, captioned as above. In connection with the policy set forth in referenced memorandum, Mr. Tolson noted: "I cannot see wherein the above is different in any respect to what we are now doing." The Director noted: "It is not clear to me. I would like a succinct listing of just what we are proposing to do, as compared to our present procedures."

Present Procedures:

1. We give leads to our Legal Attaches wherever we have an office which they handle through liaison sources and contacts. We propose no change in this. (u)

2. In handling criminal liaison abroad, we handle direct with the foreign agency and we do not disseminate or advise anyone. No change is proposed concerning this. (u)

3. In security cases it has been our policy to have the Legal Attaches handle leads with foreign agencies where feasible.

4. In security cases we follow the policy of dissemination of information developed by the Legal Attaches both locally by them and here at the Seat of Government, provided it is not against the interests of the Bureau to do so for reasons of security, protection of informants, et cetera. Where we have a "hot" case or an intelligence matter that is closely held by the Bureau either because of the need to protect the source or informant or where we are not ready to break the case, we have not advised other agencies of the requests made by our Legal Attaches of foreign services.
