Files disclose that [Redacted] has been used frequently as a public spokesman for CIA during the past year or so. In March, 1959, he addressed a group of citizens in Columbia, South Carolina, stating that Russia does not want a war and had no economic plans for armed conflict within the next 15 years. He also mentioned that Russia would use its "sputnik" diplomacy to the limit and would stand firm against all pressure in areas now dominated by communism. (62-80750-A)

Legal Attache, Ottawa, advised that [Redacted] was also the principal speaker before the Canadian Institute of International Affairs on March 20, 1959. Our files contain no information on the contents of his address on this occasion. (62-80750-3323)

Liaison determined that Allen Dulles had assigned him this task in order to "roughen him up a bit." The Bureau has never regarded [Redacted] as a friend and while he has been most careful to avoid conflict with us, it is strongly believed that he is not interested in assisting the FBI. Inside Washington

Washington

The House investigation of the super-secret Central Intelligence Agency has uncovered some startling facts.

Among them is an almost incredible story of the CIA forking over more than \$1,000,000 for hidden ore in Japan in exchange for super-secret Communist information, only to find that both it and the ore were virtually worthless, and that the deal had been engineered by an American who pocketed upward of \$100,000.

So far, he has gone scot-free. The House investigators were told that when this case was turned over to the Justice Dept., it was dissuaded from prose-

cuting by the intelligence agency. CIA is now one of the biggest contractors in the government.

In 1958, on the basis of one study in the probers' hands, the intelligence agency was the third largest federal purchaser, topped only by the Defense Dept. and the Atomic Energy Commission. Practically all of the CIA's buying is in foreign countries.

* * *

This agency is the only one in the government whose budget has never been revealed. It is concealed in the funds of other federal bodies. Authoritative congressional sources have estimated CIA's annual appropriation

at between \$350,000,000 and \$500,000,000.

The House investigation is the first full-scale scrutiny of CIA's was set up after World War II.

The inquiry is being made by a special seven-member Armed Services subcommittee, headed by Representative Paul Kilday (D-Tex.), one of the ablest and most respected members of Congress. An expert staff has been compiling data about CIA for months in preparation for hearings at a still-undetermined date.

The General Services Administration, principal purchasing agency of the government, supplied most of the information about the ore deal.

It would be of assistance to them if so. The name of the specific office of the AEC and the OCD should be used in all mail to these offices. Proposed shortened name forms set forth in the enclosed revision should be used in all mail to these offices. Revised for SDC Stenographers' Manual, 1959.

RECOMMENDATIONS:

1. That the proposed shortened name forms set forth on Page 3 be approved for use in addressing routing mail and in carbon copy designations when mail is intended for the offices set forth; that the full address be used in addressing mail and in carbon copy designations for offices not listed in the shortened name forms.

2. That the enclosed revision be approved for use in the SDC Stenographers' Manual.

DETAILS:

The Stenographers' Manual provides that shortened name forms are to be used in addressing routine mail to certain Government agencies and in designating carbon copies for such agencies. These Government agencies are those that receive a lot of mail from the FBI. The approved shortened name forms are:


In connection with the above approved shortened name forms, it is felt that the addresses for other than (1) and (5) above are too short, are incomplete, and should be changed. The above shortened name forms do not apply to the entire agency but to certain offices within these agencies. As reported in the enclosed memorandum from Mr. Frohbose to Mr. Belmont, dated 10/6/59, AEC and CSC have indicated that some difficulty has been experienced in the routing of our mail within their agencies since the adoption of the use of these shortened name forms. These agencies have indicated that it would be of assistance to them in the routing of mail if we included in the address the specific office for which the mail is intended. It is, therefore, suggested that the shortened

name forms for other than addresses (1) and (5) above be changed as follows to include the particular office for which the mail is intended; further, if the mail is not for the particular office set forth in the approved shortened forms, the full address for the agency should be used. The only disadvantage to the proposed shortened name forms is the additional typing required; however, it is believed this additional typing is justified in the interest of clarity and the correct routing of mail and in order to avoid delay in the routing of mail.

SUBJECT: PRESIDENT'S BOARD OF CONSULTANTS
ON FOREIGN INTELLIGENCE ACTIVITIES

As you know, the captioned Board came into existence in January, 1956, when President Eisenhower appointed eight individuals, headed by Dr. James R. Killian, Jr., to monitor the activities of Central Intelligence Agency (CIA) and other agencies gathering intelligence information. Dr. Killian has left the Board, and the chairman is now General John E. Hull, U. S. Army (retired). The acting Staff Director is Pat Coyne.

On 11-4-59 Coyne advised Agent Papich that the Board will be having a meeting within the next two or three weeks at which time several intelligence projects will be discussed. He advised that he knew of no matters to be discussed which in any way involved the Bureau.



The current members of the Board are: Admiral Richard L. Conolly, U.S. Navy (retired), President Long Island University; Colgate W. Darden, Jr., President, University of Virginia; Lieutenant General James H. Doelittle; Benjamin F. Fairless, former Chairman of the U.S. Steel Corporation; Robert Lovett, former top Government
