[redacted], liaison representative from Central Intelligence Agency (CIA), inquired January 7 whether we could make 50 to 100 name searches a month, until July, 1961, in the Identification Division. The names to be searched are those of employees of contractors and subcontractors working on construction of the new CIA building, which is expected to be completed in July, 1961. CIA has been making and will continue to make "agency checks" (including name checks in FBI's general indices) on these people. These are handled by the Name Check Section of the Domestic Intelligence Division and are included in that Section's budget estimates. *[redacted]* said the purpose of these searches is to "establish bona fides" -- part of the program to determine whether these people are legitimate construction workers engaged in their trades for a long time or whether they might possibly be using this occupation to penetrate the CIA.

At present time Identification Division makes about 2 name searches a month for CIA. Identification Division can handle the above-requested volume of name checks for arrest data which would be a total of about 1350 name searches in the next 18 months. Estimated cost of such a name search would be about \$1.00 each, or a total of approximately \$1,350.00 over the next 18 months. CIA will furnish complete name, date of birth and brief description. It is understood that if the name is so common that we would have too many individual records under that name to review, we would advise CIA that a name search in such instance is not feasible.

RECOMMENDATION:

That *[redacted]* be advised that Identification Division will make the requested name searches for CIA. (if approved, Ident will notify *[redacted]*)

By memorandum Frohbose to Belmont dated 1-8-60, captioned "Operating Procedures Responsive to National Security Council Intelligence Directive Number 5 - 'U. S. Espionage and Counterintelligence Activity Abroad,'" it is noted that the U.S. Intelligence Board (USIB) approved the captioned directive on 12-8-59. With regard to our Legal Attache activities this directive, which has been furnished to all Legal Attaches, states "This directive does not apply to any liaison relationship that is concerned with U.S. internal security functions, or the criminal or disciplinary matters that are not directly related to foreign espionage or clandestine counterintelligence." This exception clause was included at the Bureau's insistence to insure that our foreign operations are not subordinate to CIA control. In addition, the Legal Attaches have been cautioned to immediately advise the Bureau in the event problems arise or there is any indication of attempted subordination by CIA as a result of this directive.

Re: RELATIONS WITH CIA

As a result of the Bureau's procedures and policy which have been closely followed and observed by all Legal Attaches throughout the past year, they are fully aware of the necessity for stringent security of Bureau inquiries abroad. Notification to CIA is being made only in those instances where it is absolutely proper and in compliance with established policy and procedures.

RECOMMENDATIONS:

1. In view of the fine results and strict compliance to Bureau policy and procedures on the part of the Legal Attaches, it is recommended the requirement of a monthly report from each Legal Attache be discontinued.

2. It is further recommended the attached letter to all Legal Attaches be approved. This letter notifies the Legal Attaches of discontinuance of the monthly reports and points out the necessity for close adherence to the current policy of notification.

Central Intelligence Agency (CIA)

advised that on 1-18-60, while Dulles was testifying before the Senate Foreign Relations Committee, he was asked a question concerning the advisability of denying U.S. passports to known communists. [redacted] then confessed that Dulles unfortunately took a middle of the road position and this took place because a particular memorandum had failed to reach him in proper time. This memorandum was to provide information which would clearly state CIA's position, namely that denial of passports was definitely in the best interest of the U.S., providing that legislation would not jeopardize the security of sources of intelligence information. In his brief testimony Dulles did point out that it was to the Government's advantage to deny passports, but at the same time the Government should be prepared for a blast from various individuals and organizations who would claim that constitutional rights were being violated.

On Friday night, January 22, 1960, while having dinner with [redacted]

[redacted] there was discussed, among other things, the influence of funds and foundations and research institutions on national policy.

[redacted] stated that in his opinion funds and foundations and research institutes are steadily growing more important relative to the impact which they have not only on national policy matters but also on the thinking of the average citizen. Frequently, said [redacted] these groups create and color issues which are later carried by the American press with its influence over the ordinary citizen. What is not generally known, said [redacted] is that funds and foundations with increasing frequency are the moving forces behind bills introduced in Congress.

[redacted] mentioned two pressure groups directed toward Congress, one being the Foreign Policy Association and the other the American Association of the United Nations. He said they are well financed and the first named Association spends about one million dollars a year on lobbying.

[redacted] stated in his opinion [redacted] of the Russell Sage Foundation is definitely a bad influence from the standpoint of national defense matters. [redacted] further stated that [redacted]

You may be interested in the following comments which were volunteered to Agent Papich on 2-3-60 by Allen Dulles.

Dulles made reference to his recent Congressional testimony and stated that he had found it most difficult to maintain a clear neutral line because certain people wanted to use him politically. He made reference to statements he made concerning U.S. intelligence estimates, and as you know, there has been conflict between the Administration and certain Senators concerning estimates made relative to Soviet missile production capability. Dulles stated that his figures concerning Soviet production varied with that of the Air Force but he maintained that he was sticking to figures which resulted from studies made by the coordinated efforts of not only CIA but also military personnel who participated. Dulles indicated that Senator Symington had given him more trouble than any of the other Senators. Symington, as you know, has been a strong critic of the Administration's views concerning our air power and missile production.

^{MIKE MONT DC} Dulles also mentioned that he recently conferred with Senator Mansfield concerning possible legislation which the Senator might introduce for the establishment of a congressional watch-dog committee. Mansfield, a few years ago, introduced legislation to set up a joint committee which would supervise all of our foreign intelligence activities. Mansfield has told Dulles that he will not introduce any new legislation during this session unless he has the support of Congressional leaders. Dulles advised that he will not personally fight any legislation but he will make an issue if there develops a situation where periodically he will find it necessary to testify to more than one committee concerning CIA's operations. He commented that from a security standpoint this would be very unwise. He further stated that he essentially would not be disturbed about testifying before a watch dog committee once it was well established, but he does not believe there would be any number of problems rising from loose handling of information by staff members of such a committee. He expressed the opinion that legislation for such a committee would not get very far during this election year.

Reference is made to the enclosed news release of February 11, 1960, announcing that Dulles will be testifying before Senator Henry M. Jackson's Committee (Committee on Government Operations - Subcommittee on National Policy Machinery). For your information in July, 1959, the Senate unanimously authorized the Subcommittee on National Policy Machinery to study the effectiveness of existing government organizations and procedures for formulating and executing National Security Policy in the contest with world communism. The reported objective of the Committee is to determine how the United States Government can best organize to create a sustained National effort needed to combat communism. As indicated by Senator Jackson, the question has been raised as to whether existing machinery is adequate to successfully carry out "integrated and effective national security programs." So far there have not been any Committee developments which have involved the Bureau.

Agent Papich has been informed that Dulles is scheduled to testify on February 17, 1960. [redacted] a top Central Intelligence Agency (CIA) official confidentially advised that Dulles's statements will be restricted to the subject of the over-all Soviet threat. He will not be making any statements which he previously has not made before Congressional Committees. His approach to the subject will fall in line with statements recently made by him with regard to Soviet capabilities. According to [redacted] Senator Jackson has asked that Dulles permit some of his statements to be released to the press. Dulles has refused to do this and has taken the position that a bad precedent would be established. [redacted] stated that Dulles definitely will not be making any suggestions or recommendations to change the existing Government policy machinery. Very likely he will read all of his testimony.

Reference is made to memorandum 3-1-60 from Mr. Baumgardner to you. As you know, Assistant Director DeLoach obtained information from his excellent sources in the HCUA indicating the distinct possibility that the Central Intelligence Agency (CIA) may have transmitted Bureau information to the Committee. The specific information pertained to [redacted] whose testimony before HCUA concerning the Seventh World Youth Festival closely paralleled information furnished to us by our top Chicago informant, CG 5824-S; this sensitive information was disseminated to CIA several months ago under appropriate classification.

It was recommended and approved that Liaison take this matter up with CIA, bearing in mind that if the Agency was involved in the alleged dissemination to HCUA, a strong and vigorous protest would be absolutely necessary. The Director's notation was "This is absolutely intolerable and we should vigorously nail it down."

On 3-3-60 Agent Papich informed [redacted] CIA, that the Bureau had learned that classified information which we had disseminated to CIA was now in the possession of a congressional committee. Papich made specific reference to information disseminated by the Bureau regarding [redacted] was told that the evidence in our possession quite clearly suggested that CIA passed Bureau information to a committee. The Agent elaborated by stating, "The finger points at you (CIA)." Papich stated that the gravity of this development could not be overemphasized; that we desired a thorough, complete and factual reply from CIA; that a mere denial was not enough; that if CIA was not involved, we wanted proof.

[redacted] asked how such proof could be obtained if the Agency were not involved. The Agent replied that it was up to CIA to resolve this problem. Papich emphasized that if CIA did in fact pass the information, the dissemination in itself was obviously a cheap and disgusting act, but in this particular instance, the dissemination was jeopardizing the security of highly valuable Bureau informants.

Agency might try to "cover up." The Agent stated that if this were done, CIA's crime only would be further compounded. [redacted] who over the years has been very cooperative with the Bureau, agreed there were people in the Agency capable of doing this, but he doubted any such moves on the part of CIA would be successful in view of Bureau's wide circle of sources and contacts within the Agency. b3

[redacted] advised that he immediately was initiating an investigation and would keep the Agent advised of developments.

RECOMMENDATIONS:

Since we are not in a position to interview CIA employees as might be done in a normal investigation, other tactics will be required to dig up facts. Pushing and prodding CIA will be absolutely necessary, and this will be done. To handle this matter successfully additional information could be extremely useful. The following is recommended:

(1) Mr. DeLoach has excellent and very cooperative sources within HCUA. It is recommended that he obtain the identity of the individual or individuals who disseminated information concerning the Seventh World Youth Festival to HCUA. By acquiring such information, we will be in a much better position to follow developments and concentrate on the area within CIA where the dissemination took place.

(2) It is further recommended that Mr. DeLoach obtain from HCUA samples of CIA information (not Bureau disseminated data) furnished to the Committee concerning the Seventh World Youth Festival. Possession of such information will provide valuable ammunition in countering possible CIA denial of any implication in this matter. Such information will also suggest leads for the Liaison Agent to produce additional information through available sources within CIA.

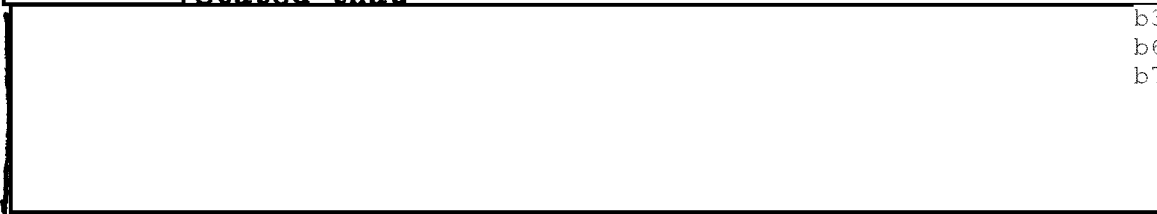

This reply to your 5 November letter has been delayed in the hope that [Redacted] would answer my letter of 28 October. He has not done so. But I have many responses from Seminar members, notwithstanding the fact that a return address was purposely omitted from the mimeographed copy of my letter. Yours was the only dissent out of more than a 10% response.

It seems to me our differences revolve around four issues:

1. First, and perhaps the most important, is what appears to be a woeful lack of understanding at Harvard over the magnitude of Soviet psychological warfare in general (its all-pervading influence over the various facets of American life) and the role in that warfare which the Soviets have assigned to education in particular (infiltration and indoctrination in our schools, colleges and textbooks). If you have any doubts about this, I refer you to the enclosed article, "Academic Freedom or Communist Coddling?", by our Seminar speaker and discussion leader, Dr. Anthony T. Bouscaren.

2. You readily admit that loyalty oaths "are quite appropriately required of people undertaking positions of trust or confidence in the armed services." Yet the very purpose of NDEA after Sputnik was to train more scientists specifically for the armed services. I find it as hard to reconcile this Jekyll and Hyde position as I do the AAUP's consistent support for Communist teachers and its equally consistent antagonism to anti-Communist teachers (Fuchs of American University, Evans of Northwestern, and others).

3. Opposition to the Loyalty Oath comes from only 19 of the 1368 colleges and universities eligible under NDEA, mostly from the Ivy League - the largest colleges and, presumably, the leaders in educational thought and policy. It is natural - indeed, logical - to find Soviet efforts directed where those efforts would do the most good. That 19 of the leading colleges join with the Communists in opposing the NDEA Loyalty Oath clause seems the clearest indication that these efforts have not been without their measure of practical success.

4. When you refer to the Loyalty Oath as "obnoxious interference", "conformity", and "typical of dictatorships", aren't you hitting the wrong target? Aren't those 19 colleges (less than 2% of all colleges) taking the position of "dictating" to their students, many of whom would like to apply for aid and would be proud to take the oath? Are they not "interfering" with their students' freedom of choice in the matter, thus forcing them to "conform"?

One is tempted to wonder whether Ivy League opposition to the Loyalty Oath doesn't stem, basically, from a reluctance to assume responsibility for weeding out their needy Red students - in the face of a demonstrable inability on the part of most of those same Ivy League colleges to weed the Reds out of their faculties.

This time I provide a return address - with the hope that every Seminar Student will (a) weigh these issues, in the light of the lateness of the hour, and (b) find the time and courage to send me his vote one way or the other.

[redacted] was taken on a tour of the Name Check Section and advised of its operations and responsibilities in the handling of name check requests. In addition, [redacted] and Matthes toured the File Review Section of the Files and Communications Division and were briefed on the operations of this Section in relation to the handling of name check requests. During the tour [redacted] stated that he was very much impressed with the efficiency with which the FBI handles a name check request and particularly the promptness with which a request is processed and returned to his organization.

CONSTANTINE BROWN, avowed columnist of the "Washington Star," paid a courtesy visit to the Paris Office on 3/10/60. During his visit, the following comments were made by Mr. BROWN:

He expressed considerable concern over the racial tensions which are mounting in the southern portion of the United States. He expressed the opinion that further use of United States troops, such as was done in the racial crisis at Little Rock, Arkansas, could result in a general deterioration of the internal stability of the United States, bringing the nation to the brink of civil war.

Present during the contact of Mr. BROWN was Lt. Col. RAYMOND R. O'BRIEN, Assistant Air Attache, U. S. Embassy, Paris, former Secretary to Senator STYLES BRIDGES of New Hampshire, and a long-time friend of Mr. BROWN. Lt. Col. O'BRIEN inquired of Mr. BROWN as to whether he considered the Central Intelligence Agency (CIA) to be an effective intelligence agency. Mr. BROWN indicated that he did not and stated that ALLEN DULLES, CIA Director, had no idea of what was going on within his own organization. Mr. BROWN stated that there is an internal struggle for power within CIA between one group headed by [redacted] and a second group headed by [redacted]. Mr. BROWN stated that these two individuals are struggling for power to take over CIA when DULLES leaves. Mr. BROWN indicated that both [redacted] are immature and completely incapable of running such a critical operation as CIA.

Mr. BROWN also commented that CIA has a current budget of approximately 650 million dollars and has cost the United States taxpayers approximately 8 billion dollars since it has been established and has failed to produce information of true value to the nation's security.

Mr. BROWN recalled that ALLEN DULLES recently testified before Congress to the effect that CIA had passed information concerning the Soviet missile capabilities to Gen. NATHAN TWINING of the Joint Chiefs of Staff. Actually, such data was never received by Gen. TWINING and DULLES had merely assumed that since his agency possessed such material that proper dissemination had been made, when such was actually not the case.

As an example of the irresponsibility of [redacted] Mr. Brown stated that a recent party was held at the Italian Embassy in Washington, D. C. During the course of the evening, [redacted] held forth in a loud voice on various occasions, stating his opinions of world affairs. At one point [redacted] stated that the United States should recognize Communist China. This statement, according to Mr. BROWN, was immediately challenged by him and he inquired of AMORY as to when CIA had become a policy-making branch of the Government. On this occasion, [redacted] was also critical of Senator STYLES BRIDGES, commenting, in effect, that Senator BRIDGES wasn't too bad until he married and his wife began to exert undue influence over him. Mr. BROWN stated that he immediately furnished the substance of [redacted] comments to Senator BRIDGES who, in turn, vigorously complained to ALLEN DULLES. Mr. BROWN stated that DULLES, in turn, called him to his office and stated he desired to be furnished the full particulars of [redacted] remarks about Senator BRIDGES, and Mr. BROWN indicated that he informed DULLES that DULLES already was in possession of AMORY's comments and that if he were looking for witnesses, the remarks were made in the presence of GEORGE ALLEN of the U. S. Information Agency. DULLES informed Mr. BROWN that the matter would be taken care of within CIA and BROWN reportedly told Mr. DULLES that he knew the incident would be passed over and no corrective action would be taken.

Mr. BROWN also mentioned an individual named [redacted], not further identified, as an employee of [redacted] who has supervision over [redacted]

[REDACTED]. This individual, according to Mr. BROWN, has a record of 21 Communist Party front affiliations or involvements. He stated the Bureau is in possession of complete details with respect to this individual.

In commenting upon the current political picture in France, Mr. BROWN described this country as a managed democracy with a strong man at the helm of government in the person of General DE GAULLE working for the welfare of France and all its citizens. He contrasted the situation in France with that of the Soviet Union where all power is centralized in the hands of KHRUSHCHEV who uses it to subjugate the Soviet masses.

Throughout his contact with the representative of this office, Mr. BROWN was very complimentary in his references to the Director and the Bureau. He stated that there are two great public institutions in the United States, the FBI and the U. S. Marine Corps, and unscrupulous individuals are trying to destroy both of these organizations. He did not further elaborate on this latter comment.

Mr. BROWN departed Paris for Madrid on the evening of March 10 and indicated he would contact Legat CLARK D. ANDERSON on arrival there.
