

Twelve freedom riders from California arrived Houston, Texas, 9:55 AM, 8/11/61, via Southern Pacific Railroad. road conductor and various passengers reported this group was very noisy and walked throughout train bragging that they would "break the Union Station Restaurant at Houston wide open." There are no facilities at Southern Pacific Station where group arrived. This group was met by six Houston members of Progressive Youth Association (PYA), a local group which also engages in attempts to integrate various facilities.

Entire group from California spent approximately one hour in offices of Houston Attorneys who regularly furnish legal assistance and guidance to PYA. At 11:55 AM, several members of this group proceeded to Union Station and purchased seven one way EX-105

tickets by Missouri Pacific Railroad to DeQuincy, Louisiana, which represents cheapest tickets which can be purchased at Houston for interstate travel. This group later made short trip to Southern Pacific Station, possibly for similar purpose.

At 1:48 PM, twelve freedom riders from California accompanied by four individuals from Houston believed to be PYA members entered the restaurant at Union Station and took seats. Manager of restaurant declined to serve these persons, and they refused to leave restaurant. Manager proceeded directly to Houston Police Department and attempted to obtain arrest warrants through Corporation Court but Houston Police Chief CARL L. SHUPTRINE refused to approve warrants or furnish any assistance to restaurant owner. Restaurant owner then proceeded to Harris County Court House and obtained warrants against above 16 individuals charging them with unlawful assembly.

After restaurant owner returned to restaurant uniformed police officers arrived at the scene and obtained identities of each freedom rider and observed railroad ticket in possession of each rider. All 16 individuals were then placed under arrest and at 3:35 PM were placed in police vehicles and left for Harris County Jail to be photographed, fingerprinted, and booked in.

During above period, there was no threat of violence or any incidents other than routine activities normal for this railroad station at this period. Arrested persons left quietly until actually leaving station when they began singing.

It is not known at this time whether arrested persons will seek release on bond or will remain in jail. It is noted information developed by Los Angeles indicated California group might continue to Jackson, Mississippi, if not arrested at Houston.



and were served without incident by white waitresses. of the United Press International were interviewed by and by an unidentified white female reporter. The Commercial Appeal and Press Scimitar reporters were present but made no effort to interview the group. Both of these are newspapers published locally at Memphis, Tennessee. At approximately 6:50 p.m. the group entered a United Cab Company taxi number 36 (Negro) driven by ______ They They 18 were followed by white Memphis Police Department Officers, land by Negro Police Department Lieutenants Officers They proceeded to Owen College in Memphis, Tennessee, and went into Roger Williams Hall, a dormitory. It will be noted that Owen College is a Negro institution. 

They were approached by Captain Jackson Police Department, who was observed speaking to them. A short time later, the six were escorted from the waiting room to a police patrol wagon parked near the depot.

At 10:45 AM, six Negro males entered the white waiting room, Illinois Central Station, through the front entrance. They walked to the benches just inside the door, at which time Captain Jackson, Mississippi, Police Department, told the group to move on. He repeated this command and asked if they understood his command, at which time they remained standing. He then advised them they were under arrest.

The group was then escorted through the rear entrance of the white waiting room to the police patrol wagon waiting at the taxi loading and unloading ramp. The six Negroes then entered the patrol wagon and were driven away. No incidents were noted to have occurred.

Source stated this group would be traveling on Coach Car Number 205. Source stated the announced intention of this group was to test the segregation laws at Houston, Texas. The group was scheduled to arrive at Houston, Texas, at approximately 9:20 AM on August 11, 1961.



On August 11, 1961, Detective Special Investigator for Office of Chief of Police, Houston, Texas, advised that the above Southern Pacific train actually arrived at Houston, Texas, at 9:55 AM on that date. reported a group of six individuals met this train and he was able to identify these individuals as members of the Progressive Youth Association (PYA), a group which has been very active in recent months in Houston, Texas. Bass pointed out the PYA has staged a number of sit-in demonstrations at various restaurants in Houston, including the Union Station Restaurant where several of them were previously arrested.

sit-in demonstrators, obtaining their identities, and observed railway tickets in their possession. All of these demonstrators were then placed under arrest, were escorted to police vehicles and left the Union Station at approximately 3:35 PM.
stated that during the entire time this group of demonstrators was in the Union Station there appeared to be no threat of violence or any disturbance of any sort and the activities in the station appeared to be normal for that time of day. The arrested persons left the station quietly but began singing as they were driven away from the station.
On August 12, 1961, Detective reported that an examination of Identification Bureau records at the Houston Police Department on August 12, 1961, disclosed that a total of 18 persons were actually arrested at Union Station, Houston, Texas, on August 11, 1961. He stated that eleven of these individuals were "Freedom Riders" from California and seven were Houston members of the PYA. pointed out the seven railway tickets which had been purchased for travel between Houston and DeQuincy, Louisiana, mentioned above, were apparently for use of the seven Houston members of this group inasmuch as the travelers from California reportedly held return tickets from Houston to Los Angeles.
On August 12, 1961, Harris County Assistant Chief Deputy Sheriff confirmed that the above group of 18 individuals had been brought to the Harris County Jail after having been initially processed at the Houston, Texas, Police Department stated that all members of the above group remained in jail and declined to seek release on bail stated the date of the trial of these individuals had not been announced.

pointed out that a review of the above data disclosed the California group consisted of four white males, three white females, three Negro males, and one Negro female, while the Houston group consisted of four Negro males and three Negro females. He stated that all members of the Houston group had been identified previously through their activities as members of PYA.

On August 12, 1961, an article appeared in "The Houston Post" captioned "Eleven Freedom Riders Arrested at Station." This article identified the spokesman for the California group as Robert Kaufman, 23, of Berkeley, Califor-Kaufman was reported to have stated his group was sponsored by the Congress of Racial Equality and the activities of his group were "a definite attempt to test integration in Houston." Kaufman stated his California group held round trip tickets from Los Angeles to Houston and return. This article further reported that all 18 of these arrested persons went to jail rather than post bonds of \$500.00 each. Kaufman stated that his group would not post bonds and would serve out any sentence. All of the demonstrators were identified in this article as students. Kaufman related that his group had visited the PYA before going to the Union Station restaurant.

The above article further reported that two weeks previously Mayor Lewis Cutrer of Houston had met with Negro attorneys and announced that no legitimate travelers would be arrested in the Union Station Restaurant unless warrants were sworn out against them. This article reported that the Houston City Attorney had held that the restaurant

could not legally refuse service to any interstate traveler.
This article also reported Assistant Police Chief
had stated that his officers were only executing
warrants in arresting the above travelers and that the
police department at Houston would not file charges on
people in interstate travel.

On August 14, 1961, "The Houston Post" carried an article captioned "Four Riders Out on Bond After Fight." This article reported that four white California "Freedom Riders" who were part of the 18 persons arrested for Unlawful Assembly on August 11, 1961, were released on bond from Harris County Jail on the evening of August 13, 1961. These four individuals stated they had been beaten by other jail prisoners and desired their release to prevent further beatings.

This article reported the "Freedom Riders" were visited at the jail on August 13, 1961, by George Washington, Jr., one of their attorneys. After learning of the alleged beatings, Washington arranged for bonds of \$500.00 each to be posted for the following four individuals:

Robert Kaufman, 23, Berkeley, California, described as the spokesman for the group; Steven E. McNichols, 22, Los Angeles, California; Joseph M. Stevenson, 18, Hollywood, California; and Stephen H. Sanfield, 24, Hollywood, California.

This article pointed out the four who were released on bond were the only white men in the group from California. It was reported that none of the 14 persons who remained in jail had complained of trouble with other prisoners. The three white women from California reportedly stated that they had been treated well.

This article further reported that Captain W. L. Bond, Jailer, had observed a cut on Kaufman's head and was advised by Kaufman this had resulted from a fall against a table. Kaufman acknowledged that he had made this explanation to the jailer.

On August 14, 1961, Detective Special Investigator for Office of Chief of Police, Houston, Texas, stated that no date for the trial of persons arrested in connection with this matter had been set, but that the Harris County Courts were very crowded and he expected there would be an appreciable delay before they were tried.

On August 15, 1961, "The Houston Post" carried an article captioned "Two Sides Agree Case of Four Freedom Riders Closed." This article reported that Attorney George Washington, Jr., had agreed with officers of the Sheriff's Department on August 14, 1961, that the alleged beating of four California "Freedom Riders" in the County Jail was a closed case. Washington reportedly made inquiries among the 14 remaining prisoners in the jail on Monday, August 14, 1961, and stated none of these individuals had any complaints. Washington was quoted as follows: "We are not disturbed and we are not trying to embarrass the Sheriff's Office. So far as I am concerned the incident is closed."

This article further reported that District Attorney Frank Briscoe stated his office was checking on the legality of the Californians' arrest for unlawful assembly. Briscoe stated he expected to know within about three days whether the charges could be prosecuted.

Greyhound Bus #4533 arrived at the loading platform at 9:29 AM and parked at the extreme east end of this platform in the first parking space.

At 9:31 AM, two white males and two white females were observed to depart from this bus onto the loading platform. The following observations were made at the Illinois Central Railroad Terminal, Jackson, Mississippi, on July 16, 1961:

At 10:12 AM, one Negro male was observed to come down the stairs from the passenger loading ramp, cross the passenger concourse and enter the terminal white waiting room. This Negro went immediately to a bench and took a seat. He was immediately approached by Captain of the Jackson Police Department. Captain ordered the Negro to leave the waiting room, repeated his order and then asked the Negro if he had heard the order. The Negro apparently declined to obey order and he was placed under arrest. Time of arrest was 10:13 AM.

The Negro was escorted from the vaiting room then to a police patrol car parked at the end of the concourse. At no time during the arrest was force used against the Negro. No handcuffs or other restraining device were used and the arrest was quietly affected. The arrested Negro is briefly described as 25 years old, about 5'8" tall and was wearing a blue suit; he was not carrying luggage.

The following observations were made at the Trailways Bus Terminal, Jackson, Mississippi, on July 7, 1961:

At 6:Q5 PM, CST, the regularly scheduled bus from Montgomery, Alabama, arrived at the terminal. Of the passengers alighting from the bus, a group consisting of four Negro males, three white males and one white female walked into the white waiting room of the terminal. They stayed in a group and walked towards the restaurant. At about the time they reached the entrance to the restaurant, they were approached by Captain Police Department, Jackson, Mississippi. He was observed to speak to the group and, after a short period of time, other police department officers were observed speaking to the members of the group separately, taking notes. They then were escorted from the waiting room to a police patrol wagon, which was parked just outside the main entrance of the bust terminal.

There were no incidents in connection with the above matter.

The following observations were made at the Trailways Bus Terminal, Jackson, Mississippi:

At approximately 6:05 PM, Trailways Bus #5143 from Montgomery, Alabama, arrived at the Trailways Bus Terminal. Among the passengers observed leaving the bus were four young Negro males, three young white males and one young white female. These eight passengers entered the terminal white waiting room where they were immediately questioned by Captain of the Jackson Police Department.

The eight passengers left the white waiting room at Captain direction and were escorted by other police officers to a patrol wagon parked at one end of the terminal passenger loading platform.

Though there were a number of citizens present on the loading platform, no demonstrations or unusual incidents were observed. The eight passengers were placed in the patrol wagon without incident.





STUDIES ON THE LEFT (SOTL)

The "Wisconsin State Journal," a daily newspaper published at Madison, Wisconsin, on November 26, 1959 announced that a new scholarly magazine, "Studies on the Left," a historical review dedicated to the leftist point of view, edited by present and former graduate students at the University of Wisconsin (UW), but having no connection with the UW itself, would begin publication soon.

Records of the Wisconsin Secretary of State reflect SOTL was incorporated under laws of Wisconsin July 16, 1959 as a non-stock, non-profit corporation with head-quarters P.O. Box 2121, Madison, Wisconsin. Three issues were published during the period December, 1959 to November, 1960. The first issue contained a policy statement of the editors stating SOTL was primarily a magazine for national circulation designed to give younger men with radical views a place to voice their opinions.

Publicly listed members of SOTL's Editorial Board
have been identified by
sources previously as having participated in the
activities of the Labor Youth League (LYL); while
Editorial Board members
have been identified as active members of
the Communist Party (CP). Another source has identified
as handling the finance and business
affairs of SOTL.

The Communist Party, USA, and the Labor Youth League have been designated by the Attorney General of the United States pursuant to Executive Order 10450.

At 5:26 AM, SA SAMUEL E. VIRDEN, II, observed the waiting room designated for white passengers at the Greyhound Bus Station in Jackson, Mississippi. There were very few persons in the waiting room other than a group of four uniformed officers of the Jackson Police Department together with Captain appeared to be dividing his attention to the white waiting room and the loading dock of the terminal where the buses enter and depart.

At 6:40 AM, Greyhound Bus 4447 arrived from Memphis, Tennessee. A number of passengers got off and from the white waiting room it could be observed that a group of whites and an individual whose race was not immediately apparent entered the waiting room designated for colored passengers.

At 6:55 AM, officers of the Jackson Police Department were observed loading four white males, two white females and one individual mentioned above whose race was not apparent from his appearance, into the "paddy wagon" of the Jackson Police Department, after which the wagon departed the bus station.

The following observations were made at the Greyhound Bus Terminal, Jackson, Mississippi, on July 16, 1961:

At 6:40 AM, Greyhound Bus #4447 was observed to arrive at the terminal and the passengers on board began to leave the bus. Among the passengers a group of seven began to separate themselves from the others; this group, consisting of four white males, twowhite females and one other male, whose race was not immediately ascertainable, waited on the passenger loading platform for several minutes while awaiting the unloading of baggage belonging to some of their number.

These seven individuals then proceeded to enter the colored waiting room at the terminal and were followed therein by Captain and several other uniformed officers of the Jackson Police Department.

Some of the seven took seats at the waiting room lunch counter while the remaining stood beside them. Captain approached this group, asked them if they would move on, then ordered them to move from the waiting room and finally asked them if they heard his order. When several members of the group acknowledged they had heard but declined to leave as ordered, all seven were placed under arrest and were escorted from the waiting room by a side door.

At 6:55 AM, these seven individuals were observed to enter a police patrol wagon parked in front of the terminal. No incidents occurred during the arrest, no handcuffs or other restraining device observed to have been used, and the arrests were quietly carried out.

PIERCE stated that all of the above individuals were tried for violation of Section 2087.5, Mississippi Code. All entered pleas of not guilty through their attorney. All were convicted and sentenced to fourmonths in jail and fined \$200.

According to PIERCE, some of the defendants would be transferred to the Hinds County Jail to serve out their fines and sentences and some would be housed in the Jackson City Jail to assist the Sheriff in overcoming crowded conditions at the County Jail.

PIERCE advised there were no incidents during the course of the above trial.
